Introduction: Topsy-Turvyism

HAT IS HAPPENING TO CHRISTIANITY IN THESE END TIMES IS VERY INTERESTING. Justified mistrust of the so-called "Judeo-Christian tradition" is leading former denominational Christians into a rejection of denominationalism. In the teen years of this millennium, membership in denominational churches has dropped up to 40%.

This is a good thing; but it leads to extremes. For example, here is how C M Hegg describes the situation:



In our modern times there is a growing movement of believers coming out of the Church and into a new understanding of biblical truth. The rise of Christians turning to the Torah as a means for the believer's sanctification seems to be growing rapidly.

Those coming out of the Church are usually struck at some point with the realization that they should be keeping the Sabbath, or that the Torah as a whole is something God wants them to be doing.

Those who awaken to this new found understanding often feel an overwhelming clarity in re-reading their Bibles, but many tend to fall into what I will call the "Christian Lies" syndrome. Many believers find their pastor's biblical truths. The fact is that Judeo-Christianity lack of understanding when it comes to Torah is dying on the vine; but the tendency is to keeping, not only disconcerting, but a blatant overreact and discard too much. disregard for the truth of the Word. They feel lied to, and begin to have suspicions about many things "Christian." This is almost a natural instinct, as so many things begin to change at once.

Sunday gatherings are now on Saturday. Christmas and Easter are replaced with the appointed times of the Lord. Titles like "Christian" are replaced with "Hebrew Roots," "Messianic," and the list goes on.

Within this change many things become suspect. And with no lack of self-made internet scholars to guide the newly awakened believer down the path of ignorance, many missteps are made. Recently I saw some comments on a Facebook post that claimed several points.

First, the term Christian was never used by first century believers, and second, the name Jesus was a pagan name. When I searched a bit further in this post, I found a common belief within the Hebrew Roots movement that goes something like this.

1) Yeshua is the name of the Messiah. The name "Jesus" is an invention of Satan, put in place through the Church in order to take us away from the true Messiah. The name "Jesus" is really a code for "Hail Zeus" and when used, is invoking a pagan deity. The English letter "J" didn't come around until the 16th century. How could this have anything to do with the real name of Yeshua?!?

2) The Apostolic Scriptures (New Testament) were written in Hebrew or Aramaic and therefore the term "Christian" is a translation of what would really be a Semitic word translated into English as "Messianic." The label "Christian" is Greek and would only be used by pagans. Therefore, the term "Christian" or even the title "Christ" is pagan in origin. Source.

This statement shows that some Christians swing too far away from the Word after they have realized that their Judeo-Churchian pastors have been lying to them about various historical and that the Father sent Him to finish are not yet



At the same time, there are those "teachers" who have crept into the fold pretending to be experts on this or that, like the Sacred Names. The Hebrew Roots people reject the name 'Jesus' for the reasons stated above; but there is also a movement to reject the name, Yahweh.

This movement goes to the opposite extreme by suggesting that 'Yahweh' is an illegitimate name and should be 'Jesus' instead.

We are indeed living in strange times; but that is a direct result of the fact that we are living in the Age of Global Deceit, the Age of Laodicea, the lukewarm church. Confusion reigns and few people see the true source of the confusion. In my opinion, both extremes are wrong for historical and linguistic reasons.

John 5:36-43. But I have greater witness than that of John (the Baptist - Eli), for the works which the Father hath given me to finish, the same works that I do, bear witness of me, that the Father hath sent me. And the Father himself. which hath sent me, hath borne witness of me. Ye have neither heard his voice at any time, nor seen his shape--I am come in my Father's name, and ye receive me not: if another shall come in his own name, him ye will receive.

This quotation proves conclusively that Yahshua and the Father cannot be the same person, otherwise He would have said "I come in my own Name." Moreover, Yahshua also said "The Father is greater than I." If Jesus is the Father, then who is it that is greater than He? The works complete. It is important to know their true versus linguistic treachery. The treachery will be names and who they are in relation to each other. thoroughly documented herein.

Old Testament "Word for Word" Exodus Part 24 **Translation by Stephen Howard Anderson**



Chapter 30

1. And you shall make an altar to burn incense 7004 upon: you shall make it of wood of Shittiym.

2. A cubit shall be the length of it, and a cubit the width of it; it shall be foursquare: and two cubits shall be the heighth of it: the horns of it shall be the same material.

3. And you shall overlay it with pure gold, the top of it, and the sides of it round about, and the horns of it; and you shall make a molding of gold round about.

4. And two golden rings you shall make under the molding of it, by the two corners of it, upon the two sides of it you shall make it; and they shall be places for the poles for them to carry it.

movement still use it as a go to source. The notion that the name "Jesus" comes from "Hail Zeus" not only shows a lack of understanding of language as a whole, but literally has zero historical evidence to back it up.

With Hislop and White's work set aside, we are left with the claim that the name "Jesus" is an invention of the Church, and proof of this is that the letter "J" didn't come into existence until the 16th century. So lets investigate this claim.

As everyone will admit, language is something that evolves over time. This is true not only for English, but also for the Semitic languages. Those who claim the name "Jesus" comes from pagan origins do so on the basis of the changes that have come through Greek, French and German creating what was the basis for our modern English language.

What these folks seem to forget is that Hebrew and Aramaic also evolved over time. A perfect example of this would be the Hebrew letter ayin (y) which is also represented in ancient Semitic languages such as Ugaritic.

As in Ugaritic, the Hebrew letter ayin originally had a deep guttural sound that was made in the back of the throat. Over time the Hebrew language changed and now the ayin is a silent letter.

So is it true that the letter "J" wasn't part of the English language until the 16th century? Yes, that is true. Originally, J in the Roman alphabet was another form of the letter I. The letter I had the sound of our modern Y.

During the 16th century in the romantic languages, the I and J shifted and split. The J began to be used for the sound "jeh" and the I shifted to a vowel. Because of cursive writing the J and the I became distinguished and the shift took full form.

This split into our modern English form of J is important for understanding the name Jesus as we have it today. To understand how we get "Jesus" from "Yeshua" we will need to look at the Hebrew and Greek.

The name Yeshua in Hebrew and Greek looks like this (remember Hebrew reads right to left):

ιησους ישוע a u sh Ye Y e s oo s

The "Y" sound in Hebrew (') can only be represented in Greek with the iota and eta diphthong. The "e" sound we hear in "Ye" does not come through in Greek quite the same, but is represented by iota and eta diphthong as well. In Greek there is no "sh" sound, so the Greek speaker came as close as possible with the sigma which has the "s" sound.

The long "oo" sound we have in the Hebrew does have an equivalent in Greek, and that is the omicron coupled with the upsilon, which placed together make the "oo" sound the translators were looking for. Finally, we come form of paganism is extremely ignorant and has to the "ah" sound at the end of the name. The no factual evidence to back it up.

Contrary to the belief this comes from the name Zeus (below), this is exactly how it should be. In Greek, names always take what is called the nominative form. Greek uses case endings to alert the reader as to what form a word is in.



The first thing a Greek student will learn is the nominative form as this is going to be the subject of a sentence as well as the base form for someone's name. The other major difference in Greek from English is that of gender. Greek assigns one of three gender choices to every word. Male, female, or neuter.

And this is where our change at the end of the name comes. In the nominative form, the male case ending is a sigma, σ and a female case ending is an alpha α . The only way the translators could have put an alpha on the end of Yeshua's name to represent that last "ah" sound, is if they wanted to tell their audience He was female.

Obviously, this would not work, and thus the male nominative case ending, sigma, was attached to the end of the name since Yeshua was in fact a man.

With the change in language to the I and J which I mentioned above, the Greek name "Iesus" was changed to "Jesus" as the J was seen as a consonant and not a vowel.

The name "Jesus" is nothing more than a perfectly natural transliteration of the Greek name "Iesus," which in turn is the best possible transliteration of the Hebrew name "Yeshua." The notion that the name "Jesus" comes from "Hail Zeus" or that this name carries with it some

The Apostolic Scriptures Were Written in Aramaic/Hebrew

Among the Hebrew Roots and Messianic circles many consider this to be a fact. Most people will argue that Yeshua and His disciples were Hebrews living in Israel, and of course they were speaking Hebrew. Is there truth to this?

Yes, there is some truth in this. Yeshua most certainly did speak Aramaic and we see this from the Scriptures themselves. It is likely that He spoke Hebrew as well, but evidence shows that Hebrew was mostly used in the Synagogues for liturgical purposes within Judea and for reading Torah, but not much beyond this.

The bigger question is this: "Were the Gospels written in Hebrew or Aramaic?" To this we can most certainly say no. I am fully aware that there is mixed perspectives on this within scholarship. but the vast majority of scholars agree that the Gospels were written in Greek. How can this be?

First, there is literally zero evidence of any Gospel be penned in Hebrew or Aramaic. The earliest manuscript that we have of a New Testament book in Aramaic is the 13th century AD (or later), almost 1200 years or more after the Gospels were written. We do have plenty of 2nd, 3rd, and 4th century manuscripts written in Greek.



Second, we know that Greek was the lingua franca of the day, even within Israel. In the Gospels themselves we can see that Yeshua and Nicodemus were speaking Greek and not

Israel" and certainly Yeshua could have spoken Aramaic, but they spoke Greek with each other.

Third, Yeshua tells His disciples to make disciples of the nations (Matt. 28:19). Hebrew and Aramaic were prevalent within Judea among the Jews, but even the Jewish people in the rest of Israel spoke Greek. Writing in Hebrew would be the last thing a person would do in order to reach people outside of Judea.

2. (Editorial Note: It has been pointed out that there are names that end with alpha in the masculine form. For instance, Eliah comes into Greek as Elias. Although there are several reasons why Greek might have dropped the alpha on the end of the name Iesus, any suggestion I could make would be speculation on my part, as the New Testament writers were not the ones to make these decisions.

The transliteration of these names goes back to ancient Hebrew Greek centuries prior to the writing of the NT. The name Iesus has a sigma in the nominative form, but not in other forms such as the genitive. T JUST SO HAP-**PENS** that I came upon some fascinating Nuremberg Trial documents, published by a John Mendelson in a book titled "Holocaust." These are the transcripts of the inter-

rogations of Julius Streicher, the much" reviled 1920's nationalist leader in Germany and publisher of "Der Stürmer."

The story of Streicher is tragic in that he was hanged at Nuremberg as the only man who was convicted not for what he had done, but for what **Q**: And when did you join the Party? he had written.

The content of these interrogation transcripts is so powerful that I will convert additional excerpts into later ZGrams, but I won't run them back to back. As you read these transcript excerpts, please keep in mind that virtually all of them were translated by Jewish translators in American uniforms and that the translations are tailored so that they fit the aims of the prosecution at the International Nuremberg Tribunal. So take them with a grain of salt and read them with some caution - but even so, they are a remarkable A: Yes, I wish I could express myself openly.

historical record: Testimony of Julius Streicher, taken at Nuremberg, Germany, on 1 September 1946, at 1410, by Col. Howard A. Brundagem, JASDG. Also present: S/Sgt. Howard M. Levi, Court Reporter and Rudolph Pressburger, Interpreter.

Q: What was your official position, if any, in the Nazi party?

A: I was a Gauleiter.

Q: Were you a member of the Party before you became a Gauleiter?

A. Yes.

A: I believe in 1922. I want to say the following before, that the National Socialist Party was dissolved in 1921, and I officially joined it in 1924. I renewed my" membership to the Party. (...)

Q: I understand that you were one of the leaders of the Party in the early days.

essential parts?

A: Yes. Maybe before we write, I want to first make an outline because it came so all of a sudden, I mean the demands.

The program was divided into two main parts, the program for the outside, and the rehabilitation of the nation; and the breaking of the Versailles dictates; the rehabilitation of a social, economical order; and the rehabilitation of the working class, and the creation of a sound working system; and the problem of the racial question. Those are the main points. (...)

Q: What about the teaching of the preservation of the lines of the master race?



Q: Well, go ahead.

A: Before the first World War, I belonged to the Young Democratic Party. The leader of the Young Social Democratic Party was a Mr. Cramer, who worked at Kohn's bank in Nuremberg. I have talked very often at the evening meetings of the Young Democratic Party. I didn't know any racial questions at that time. During those discussions, I received opposition from young lawyers who were talking against me.

This holds true especially when I talked about nationalistic matters. On my way to Rome, I was warned by this Mr. Cramer that I should express myself in those meetings more carefully, since all those young lawyers were Jewish, and I asked him what the word "Jewish" means.

This Mr. Cramer told me: "Streicher, be careful, the Jews are very mighty." This was the first time that I was conscious of the fact that the Jews are no religion but a race. Between Catholics and Protestants you can differentiate, but you cannot differentiate between Protestants, Catholics and Jews, according to the race.

After the first World War I came as an officer from the field, and desired to work again at my old trade. I was a school teacher. Then I saw for the first time the red posters saying that the public should attend the revolutionary meetings.

Time and time again 1 went to those revolutionary meetings, and I was astounded to see that all the speakers were members of the Jewish race. The speakers were inciting the working class and telling them of the good things of former times. I volunteered, last time, for a discussion and took opposition to one of the Jewish speakers.

I told the workers that it was unnatural to be led by members of the Jewish race. I told them that it would be unnatural if a member of the Jewish race would go to Palestine and dare speak in a Jewish meeting against their own nation. (...)

Q: Go ahead with your story.

A: This takes place in the spring of 1919. After this speech and this discussion, the whole room applauded me. I went to the next revolutionary assembly of the Communist Party. Everything was prepared so I didn't have to talk any more.

I again reported for the discussion. At this time I was torn off the speaker's platform. They spit at me and threw me out of the assembly hall. At that time I decided to hold my own meetings and to enlighten the public. At that time, no one had heard anything about Adolf Hitler.

Destiny told me to fight for my people, my race. My first assembly meeting in the Hercules Velodrome was crowded. Ten thousand people were standing in front of the assembly hall, and it had to be kept in order by the police. I spoke at this assembly for three hours.



I told how the German people were enslaved by the treaty of Versailles, and I said that it is impossible that in all states in Germany, Jews were made ministers. I also declared in this assembly that it is up to the German people to govern themselves. I declared that the Jews as a nation by itself would refuse to be governed by ministers of English, French or German nationality. Q: You said "English, French or German"?

A: Nationality. I also declared that if Germany wanted to be free again, the treaty of Versailles has got to be broken, and also the reign of the Jews in Germany. Until the year 1921, I had a big mass meeting in Nuremberg every week. Besides that, I participated several evenings during the week in discussions, in smaller groups.

That is how the mass movement of German workers got together in Nuremberg. In the year 1921, a wholesale man from Nuremberg asked me if I had heard speeches of Adolf Hitler. I got interested and went to Munich, to an assembly in the Buergerbrau of Adolf Hitler. At that time I did not know Adolf Hitler. At that time I heard him for the first time at Munich. He spoke for almost three hours.

The enthusiasm was enormous. I myself was very enthusiastic. After Adolf Hitler was finished with his speech, I arose and forced myself through the crowd to the: speaker's desk. I went towards him and introduced myself. I spoke to him: "Heil Hitler! I heard your speech. I only can be the helper but you are the born leader. Here is my movement in Nuremberg." On that evening I gave the movement which I created in Nuremberg to Adolf Hitler. It carried the name of "National Socialist German Worker's Party."

Harold Stough Notes The Battersea Shield From His Pamphlet Collection By Merike Joosep

Battersea shield.

HE 'BATTERSEA SHIELD' was found in the Thames at Battersea, South London. It was made in the Iron Age, between 350 and 50 BC. The Battersea shield is not actually a complete shield, but only the facing, a metal cover that was attached to the front of a wooden shield.

It is made from different parts of sheet bronze (4 sheets and 3 decorated panels), held together with bronze rivets and enclosed in a binding strip. All the rivets are hidden by overlaps between different components where the panels and roundels were originally attached to the organic backing.

The decoration is concentrated in the three roundels. A high domed boss in the middle of the central roundel is over where the handle was located.

The La Tène-style decoration is made using the repoussé technique, emphasized with engraving and stippling. The overall design is highlighted with twenty-seven framed studs of red glass 'enamel' (opaque red glass) in four different sizes, the largest set at the Centre of the boss.



The dominant repoussé forms on the shield are the palmette and interlocking S-motifs.

The shield doesn't have any sign of battle usage.

OU MAY NOTICE THAT THE POSITION OF NEVADA SHIFTED MORE THAN ANY OTHER STATE BETWEEN 1931 AND 1940. For some reason, deaths from heart disease, diabetes, and cancer rose dramatically in Nevada while the rate of household electrification rose only modestly.

I propose that the construction of Hoover Dam, completed in 1936, was that reason. The most powerful hydroelectric plant in the world at that time, its one billion watt capacity supplied Las Vegas, Los Angeles, and most of Southern California via high voltage power lines that coursed through southeastern Nevada on their way to their destinations, exposing the surrounding area—where most of the population of the state lived —to some of the world's highest levels of electromagnetic fields.

In June of 1939 the Los Angeles grid was connected to Hoover Dam via a 287,000-volt transmission line, also the most powerful in the world at that time.

Two types of cancer deserve additional comment: lung cancer and brain cancer.

As the following graph shows, the percentage of adults who smoke has declined steadily since 1970 among both men and women. Yet lung

cancer mortality has almost quadrupled in women, and is virtually the same in men as it was fifty years ago.



When non-smoker Dana Reeve, the 46-year-old widow of "Superman" actor Christopher Reeve, died of lung cancer in 2006, the public was stunned because we had had it drummed into us for decades that this type of cancer is caused by Smoking.

Yet lung cancer in people who have never smoked—if you consider it as a separate category—ranks today as the seventh most common cause of cancer deaths worldwide, even before cancer of the cervix, pancreas, and prostate.



Brain tumours deserve mention because, obviously, of cell phones. Several billion people in the world are exposing their brains for up to hours per day to microwave radiation at point blank range—a new situation that

began in approximately 1996 or 1997 in most countries.

Yet honest data on brain tumours are difficult to obtain because special interests have controlled

most of the research funding on brain tumours decades. It was clear to me that something was since the advent of digital cell phones two decades ago. As a result, a media war has pitted the independent scientists, who report a tripling to quintupling of brain cancer rates among those who have used their cell phones for ten years or more, against industry scientists who report no increase in cancer at all.

The problem, as Australian neurosurgeon Charlie Teo tells those who will listen, is that all the data on cell phone usage comes from databanks controlled by cell phone providers, and "no telcos have allowed scientists access to their records for these large studies."

I found out firsthand how closely not only the telecom providers, but the scientists they fund, guard their data, when I requested access to some of it in 2006. Yet another industry-funded study was published, this time in Denmark, purporting to show not only that cell phones did not cause brain cancer, but that cell phone users even had a lower rate of brain cancer than everyone else.



In other words, those scientists would have the world believe that people might actually protect themselves from brain tumours by holding a cell phone to their heads for hours per day.

The study, published in Journal the of the

National Cancer Institute, was titled "Cellular Telephone Use and Cancer Risks: Update of a Nationwide Danish Cohort." It claimed to come to its conclusions after an examination of the medical records of over 420,000 Danish cell phone users and non-users over a period of two

wrong with the statistics. Although the study found a lower rate of brain cancer-in men only-among cell phone users than non-users, it found a higher rate of exactly those cancers that Swedish scientists Hallberg and Johansson had reported to be caused by radio waves: bladder cancer, breast cancer, lung cancer, and prostate cancer.

The Danish study did not report rates of colon cancer or melanoma, the other two types of cancer that the Swedish researchers had mentioned. However, the Danish study did additionally find that testicular cancer in men was higher and that cervical and kidney cancers in women were significantly higher among the cell phone users.

I sensed manipulation of the data, because the only type of cancer for which a "protective" effect was reported was the type of cancer these scientists and their funders were trying to convince the public that cell phones did not cause: brain cancer.



It occurred to me that all of the study's subjects had actually been using cell phones for a long time by the year 2004, when the study ended.

The only difference between "users" and "nonusers" was the date of first subscription: the "users" first bought a cell phone between 1982 and 1995, while the "nonusers" didn't buy one until after 1995. And all the "users" were lumped together.

The study did not distinguish between people who had used cell phones for 9 years and people who had used them for 22 years. But according to the study, those who subscribed prior to 1994 tended to be wealthier, and drank and smoked much less, than those who first subscribed later. never heard of any celebrity who had brain I suspected that controlling for length of use might change the results of the study. So I did the natural, normal, accepted thing that scientists do when they wish to validate a study that is published in a peer-review journal: I requested to look at their data.

On December 18, 2006, I sent an email to the lead author, Joachim Schüz, telling him that I had colleagues in Denmark who would like to look at their data. And on January 19, 2007, we were cordially refused permission.

The letter of refusal was signed by three of the study's six authors: Schüz, Christoffer Johansen and Jørgen H. Olsen.

Meanwhile, Teo is sounding the alarm. "I see 10 to 20 new patients each week," he says, "and at least one third of those patients' tumours are in the area of the brain around the ear. As a neurosurgeon I cannot ignore this fact."

Many if not most of us have one or more acquaintances or family members who have, or have died from, a brain tumour. My friend Noel Kaufmann, who died in 2012 at the age of 46, never used a cell phone, but he did use a home cordless phone for years, which emits the same type of radiation, and the tumour that killed him was in the part of his brain beneath the ear against which he held that phone.

All of us have heard about famous people who have died of brain tumours-Senator Ted Kennedy, attorney Johnnie Cochran, journalist Robert Novak, Vice President Joe Biden's son Beau (below).

Yet highly publicized studies assure us that brain tumour rates are not increasing. This is certainly not true, and a little investigation shows why the data cannot be trusted, in the United States or anywhere else.

In 2007, researchers at the Swedish National Board of Health and Welfare (above) found out that, for some reason, one-third of the cases of brain cancer diagnosed at university hospitals, and the majority of cases at county hospitals, were not being reported to the Swedish Cancer Registry.

All other types of cancer were being routinely reported, but not brain cancer.

A 1994 study revealed that difficulties in brain cancer reporting were already occurring in Finland. Although the Finnish cancer registry was complete for most types of cancer, it seriously underreported brain tumours.

Here in the United States, severe problems have been found with surveillance not just of brain cancer, but across the board. The Surveillance Epidemiology and End Results (SEER) program, run by the National Cancer Institute,



depends on state registries to deliver accurate data. But the data are not accurate.

Oliver Cromwell The Monster of England (Jack Lewis - With acknowledgement to the Real History Channel)

THE **ILLUMINATI FRENCH REVOLUTION KICKED** OFF IN 1789, there occurred a revolution, in England, which also led to the decapitation of a sitting Monarch, followed by a reign of terror.

Though the revolution led by the arch-criminal and temporary dictator (from 1653-1658), Oliver Cromwell, was short-lived, what this self righteous psychopath did altered the course of world history in a major way. writings) is very informative:

"I have shared many rewarding experiences with fellow liberals, but find it difficult to understand their acceptance of Oliver Cromwell as champion of freedom. Today, they are undoubtedly filling the neighbourhood theatres, where this 17th-century butcher is being portrayed as a courageous "Liberator."



After Charles I was executed on Jan. 29, 1649 Cromwell was dispatched to Ireland to bring the Royalist Army into submission. That adventure soon became a war to bring about the "ultimate solution" of the Irish Catholic problem.

The land owned by the Irish was confiscated and the order "To hell or to Connaught" gave full warning that any who remained would be put to the sword. In the Church in Droheda, wherein Irish fled for safety, men, women and children were slaughtered. None escaped.

Cromwell's declaration to Irish people, January, 1649, ended in death sentence:

'If this people [Irish Catholics] shall headily run on after the counsels of their Prelates and other Clergy and other leaders, I hope to be free from the misery and desolation, blood and ruin that shall befall them, and shall rejoice to exercise utmost severity against them.'

Cromwell's report on Droheda to Parliament: 'I put all of them to the sword but 30, and they are on their way to Barbados. I believe all their friars were knocked on the head but two; the one of which was Fr. Peter Taaff, brother of Lord Taaff, whom the soldiers took the next day and made an end to him ... and therefore it is good that God alone shall have the glory.

In the same castle we took Popish Priest who was Chaplain to the Catholics in the regiment, who was caused to be hanged.'

'The Lord is pleased still to vouchsafe in his presence, and to prosper his own work in our hands. If God be for us, who can be against us? Who can fight against the Lord and prosper? Who can resist his will? The Lord keeps us in his love.'"

What a sick bigoted blood-soaked bastard!

Cromwell and his intolerant Old Testament 'Puritans' unleashed Civil War but years after Cromwell's revolution was undone, the unpopular 'persecuted' Puritans were the same bunch of psycho fanatics who conducted the Salem Which Trials and hanged 19 women, 5 died in custody and a man was crushed to death under heavy stones.

The Biology of Carbon Dioxide - Its Importance to Health Analysis by Dr. Joseph Mercola (November 18, 2023)

Story at a Glance



BELOW IS SOME IMPORTANT INFORMATION on the importance of CO2 to human health and indeed all life as it regulates distribution of oxygen through the body. Dr. Mercola was instrumental in bringing to notice the work of the late Ray Peat a Biologist pictured above.

All these issues, whether caused by elevated lactate or low CO2, can be successfully treated with CO2 therapies of various kinds, such as CO2 baths (where CO2 is pumped into the tub, much like bathing in carbonated mineral water) or adding CO2 into standard hyperbaric treatment

Simpler ways to raise your tissue content of CO2 include breathing into a paper bag, having an adequate supply of calcium, and supplementing with salt, baking soda or carbonated beverages.

In this 2010 interview, the late Ray Peat, a biologist and physiologist who specialized in the bio-energetic theory of health, reviewed some of the key benefits of CO2 and how it works within the human body. This article is a summary of the key points made in that interview.

I apologize for the video quality. The video was recorded 13 years ago, and appears to have been shot on a cell phone. In 2010 the cameras were not very good. However, the audio is fine, and more importantly, this information is really hard to come by since Peat is no longer with us.

Only 2,000 people had viewed it when I first saw it.

I watched it four times as it is so good. I'm convinced optimising your carbon dioxide (CO2) level is one of the most important strategies you can do to slow down degeneration due to aging.

On that point, I will be interviewing one of the leading breathing experts in the world, Peter Litchfield, Ph.D., who will educate us on why most breathing techniques don't work, as they don't address the underlying triggered breathing habits that lower CO2.

CO2 is Crucial for Optimal Health



CO2 is typically thought of as nothing more than a harmful waste product of respiration, and a "pollutant" that endangers the earth by raising global temperatures. The reality is that CO2 is a pressure down by as much as 30 points, and driver of mitochondrial energy production, and it improves the delivery of oxygen into your cells. It's also essential for most life on Earth, plants in particular. In fact, CO2 appears to be a more fundamental component of living matter than oxygen.

All of this was well-known in decades past, but somehow knowledge about the beneficial effects of CO2 has been suppressed over time.



Importantly, CO2 allows for more efficient energy production in your mitochondria, which is why people who live or spend time at higher altitudes tend to be healthier and have fewer chronic health problems such as asthma. The reason for this is because the pressure of CO2 relative to oxygen is greater at higher altitudes.

A Simple Bio-Hack to Boost CO2

According to Forbes Health, bio-hacking is "a term used to describe various tips and tricks for enhancing the body's ability to function at peak performance — and maybe even extend one's life span."

A bio-hack for mimicking being at a higher altitude in order to boost CO2 is to breathe into a paper lunch bag for a minute or two. The bag should not be too small or too large (an ideal size is 6 inches by 15 inches, or 15 centimetres by 38 centimetres). Breathe into the bag with your mouth and nose covered until you feel better.

With each exhale, you expel carbon dioxide. By re-breathing the carbon dioxide inside the paper bag, you effectively raise your carbon dioxide level.

According to Peat, breathing into a paper bag a few times a day has been shown to bring blood

stabilize it there after a few days of repetition.

CO2 and Lactate Have Opposing Effects.

As explained by Peat, CO2 and lactate have opposing effects. So, where lactate causes problems, CO2 has beneficial effects.

For example, elevated lactate production is a common theme in diabetes, Alzheimer's, heart failure, shock and general aging. It promotes inflammation and degrades mitochondrial function. Conversely, low CO2 concentrations have been linked to epileptic seizures, muscle spasms, inflammation, hypothyroidism, stroke, and clotting disorders.

According to Peat, all these issues, whether caused by elevated lactate or low CO2, can be successfully treated with CO2 therapies of various kinds, such as CO2 baths (where CO2 is pumped into the tub, much like bathing in carbonated mineral water) or adding CO2 into standard hyperbaric treatment.

Under normal resting conditions, the concentration of CO2 controls our respiratory rate. For example, in most animals, including humans, high levels of CO2 lead to faster breathing. Decreases in CO2 below normal can, decrease breathing, even to apnoea.

Peat tells the story of how he told an individual suffering from transient ischemic attacks who'd gone to the emergency room with stroke symptoms and paralysis on several occasions to drink a soda or carbonated water when the attacks occurred, as the bubbles in carbonated drinks are CO2 gas. "That worked for him," he said.



CO2 Promotes Efficient Energy Production

Lactate is the byproduct of glycolysis, or nonaerobic respiration. It occurs when your mitochondria are compromised and are unable to metabolise glucose. Instead of pyruvate going to the mitochondria to be burned, it is oxidized to lactate in the cell's cytoplasm. When this occurs in the presence of oxygen it is called the Warburg Effect, which is major pathway that cancer cells use.

As illustrated in the graph bottom right previous page, glucose can be metabolised in two different ways.

When fat intake is too high, glucose is burned though glycolysis, which uses no oxygen and produces lactate. This is a highly inefficient way to produce energy, as it generates only 2 ATP per glucose molecule. And, in the context of this article, no CO2.

When fat intake is in the sweet spot of 15% to 40%, and glucose intake is high enough, it can be burned for fuel in the mitochondria. This generates up to 38 ATP per glucose molecule. In this process, NADH and CO2 are also produced.



If fat intake is over 40% and the carb intake is below 200 grams per day, the glucose is burned in glycolysis in the cell's cytoplasm, which produces lactate that suppresses glucose oxidation and shifts metabolism to the burning of fats instead.

Lactate also promotes inflammation and fibrosis. CO2, meanwhile, limits the formation of lactate, increases oxidation of glucose, helps trigger mitochondrial formation (i.e., boosts the number of mitochondria in your cells) and boosts cellular ATP concentrations. As explained by Peat, glycolysis products (pyruvate and lactate) compete with CO2 for binding sites inside the mitochondrion. Glycolysis decreases energy production by reducing CO2.

Energy Production Summary

In summary, two key points from all this are:

1. The most efficient way to generate cellular energy is to burn glucose in the electron transport chain of your mitochondria (aerobic respiration). In addition to generating up to 38 ATP molecules per glucose molecule (opposed to the two generated through glycolysis), it also generates an estimated 50% more CO2 than fat oxidation.

In order for glucose to be metabolised in your mitochondria, your dietary fat intake needs to be sufficiently low so as not to inhibit the oxidation of glucose. While there's no hard evidence on how much fat is too much, I suspect you need to restrict fat to 30% or 40%, depending on your individual needs, to optimise your glucose metabolism.

2. There are two possible energy states:

i. A glycolytic stress state in which energy production is reduced by the inhibition of CO2.

ii. An energy-efficient state in which CO2 is produced and lactate is suppressed.

CO2 Protects Against Lipid Peroxidation

CO2 also helps protect against the harmful effects of lipid peroxidation. Lipid peroxidation refers to a process in which free radicals and other harmful oxidants attack lipids (fats) that have carbon-carbon double bonds. Poly unsaturated fats (PUFAs) such as linoleic acid (LA) are particularly prone to this.

The key that many fail to recognize is that lipid peroxidation increases when CO2 levels are low, as CO2 protects the fats from damage. As explained by Peat, when CO2 is low, that's when PUFAs increase their production of lipid peroxides (oxidation products of phospholipids).

Lipid peroxides degrade into reactive aldehydes such as malondialdehyde and 4-hydroxy-2noneal (4-HNE), which damage DNA and proteins, causing them to malfunction. Lipid peroxidation is known to contribute to conditions such as cancer, athero-sclerosis and neuro degenerative conditions, just to name a few. Peat cites one experiment in which they showed mitochondria within the cell as needed to that when you raise the CO2 in human tissues to three times normal, the amount of lipid peroxides went to zero. So, CO2 has a potent antiinflammatory effect and effectively protects against lipid peroxidation.



This is an important piece of information, as most people nowadays consume enormously excessive amounts of seed oils that are loaded with PUFAs, and thus have very elevated levels of stored LA in their cells.

As explained in "Linoleic Acid — The Most Destructive Ingredient in Your Diet," LA is a primary contributor to chronic disease, as it causes mitochondrial dysfunction and promotes inflammation.

Augmenting CO2 in your tissues may be an effective way to limit LA-induced damage while you work to eliminate the excess LA from your tissues and replace it with healthy fats (which can take six or seven years).

How Lactate and CO2 Influence Stress

Peat also goes into an extended discussion involving many separate pieces to explain how lactate and CO2 influence the stress response and other parts of human biology that impact disease, including cancer.

For starters, the cytochrome oxidase enzyme also known as Complex IV in the mitochondrial electron transport chain, which is what uses oxygen — governs your rate of oxygen consumption.

So, the more cytochrome oxidase you have, and the more active it is, the greater your oxygen consumption. Cytochrome oxidase is also responsible for increasing the total number of

accommodate for increased oxygen consumption.

When you saturate a cell with a very large amount of CO2, you rapidly increase the amount of cytochrome oxidase in the cell, and you boost its activity almost instantly.

This shifts the oxidative balance of the cell towards the oxidized state, as electrons are being pulled out of the system. This lowers reductive stress in the cell, which is what you want to do.

In healthy cells, there's a balance between NAD+ and NADH that is critical for energy production. Conditions like cancer or diabetes disrupt this balance, leading to excess lactate and reduced NAD+. Carbon dioxide is crucial because it production, prevents excessive lactate maintaining a healthy NAD+ to NADH ratio.

CO2 also influences the water balance in cells. supporting an oxidized cellular condition with lowered reductive stress that results in proper oxygen utilization. Hyperventilation, or overbreathing, which reduces CO2, typically leads to overproduction of lactate, contributing to stress and disrupting cellular balance.

CO2 in Emergency Care

Peat also discusses the role of CO2 in emergency care that has the potential to save your life or the life of someone you love. Stroke patients are typically ventilated with pure oxygen to prevent hypoxia-induced brain damage, but this isn't the best way to help these patients.

A ventilation strategy called permissive hypercapnia appears to be far better. Permissive hypercapnia refers to a ventilation strategy employing partial pressures of CO2 that are higher than physiological norms. I have been encouraging those in the hyperbaric oxygen community to explore and adopt this strategy in their hyperbaric chambers. As explained by Peat:

"Quite a few people are now, just in the last few years, starting to talk about permissive hypercapnia ... instead of ventilating someone to death [by] giving them pure oxygen. When people aren't getting enough oxygen to the brain,

they'll give them pure oxygen and then hyperventilate them. The idea is to shrink their brain by hyperventilating them, because it shuts down the blood circulation of the brain. But if they're dying of a lack of oxygen to the brain, [that's] not what you want to do ...



I had mentioned [using carbonated beverages during ischemic stroke] in a nutrition class. I had said soda water, meaning carbonated water, but the next week, one of the students said that she had interpreted it as baking soda in water.

Basically, it's the same idea, but she said she gave a spoonful of baking soda to her mother who had been half-paralysed for six months, and 15 minutes after drinking just a glass of baking soda water the paralysis lifted and stayed away."

The reason baking soda worked in this case is probably because CO2 is carried through your bloodstream by sodium bicarbonate (baking soda). Peat goes on to discuss how, in the past, firemen used to carry CO2 for the treatment of shock and respiratory arrest.

Fire departments all over the United States, and many hospitals, were using 5% CO2 to resuscitate babies that had stopped breathing and treat shock cases. It was also used postoperatively to aid in the recovery process.

The Green Agenda's Flawed View of CO2

In closing, Peat also overturned key arguments of the green agenda by pointing out that during the Carboniferous period of Earth's history, when plant and animal life was extraordinarily abundant, carbon dioxide levels were some 20

times higher than they are now, and temperatures were relatively stable.

"The expansion of vegetation will reflect infrared rays back into space," he said, "so it's sort of like the Earth has a thermostat that will regulate for huge changes in in CO2," he said.

Even more importantly, nothing thrives in low CO2 environments — not plants, not animals or insects and, as evidenced by everything discussed above, not humans. If anything, the world may actually need a bit more CO2, seeing how CO2-deficiency states are rampant, forests are dying and plants aren't growing very well. As noted by Peat:

"All animals and even plants suffer from a lack of carbon dioxide. If you lower it, even plants won't do well. In the 1940's, people experimented with poisoning to death rats or mice with 50% carbon dioxide, keeping them dead for an hour and then reviving them, and they had no brain damage. If they gave them extra CO2, they weren't damaged by the absence of oxygen. So, for primitive organisms, it's more essential than oxygen."

The increasingly erratic weather systems we're now experiencing likely have little to do with the CO2 content of our atmosphere, and far more to do with a combination of decades-long weather manipulation and natural solar cycles.
