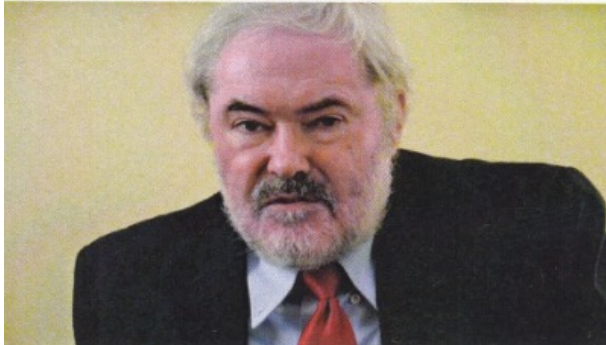

The Origins of Judaism

THE TRUE START OF THIS AFFAIR OCCURRED ON A DAY IN 458 BC which this narrative will reach in its sixth chapter. On that day the petty Palestinian tribe of Judah (earlier disowned by the Israelites) produced a racial creed, the disruptive effect of which on subsequent human affairs may have exceeded that of explosives or epidemics. This was the day on which the theory of the master-race was set up as "the Law".

At the time Judah was a small tribe among the subject-peoples of the Persian king, and what today is known as "the West" could not even be imagined. Now the Christian era is nearly two thousand years old and "Western civilization", which grew out of it, is threatened with disintegration.

The creed born in Judah 2,500 years ago, in the author's opinion, has chiefly brought this about. The process, from original cause to present effect, can be fairly clearly traced because the period is, in the main, one of verifiable history.

The creed which a fanatical sect produced that day has shown a great power over the minds of men throughout these twenty-five centuries; hence its destructive achievement.

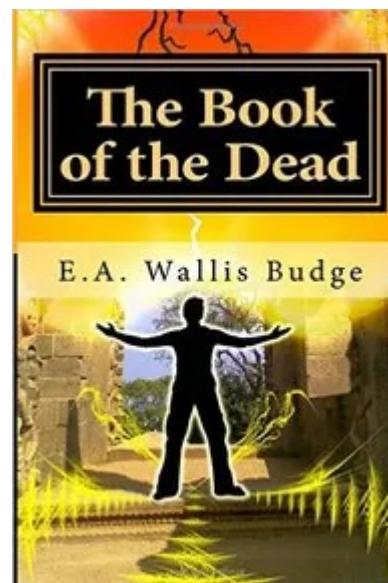
Why it was born at that particular moment, or ever, is something that none can explain. This is among the greatest mysteries of our world, unless the theory that every action produces an equal and opposite reaction is valid in the area of religious thought; so that the impulse which

at that remote time set many men searching for a universal, loving God produced this fierce counter-idea of an exclusive, vengeful deity.

Judahism was retrogressive even in 458 BC, when men in the known world were beginning to turn their eyes away from idols and tribal gods and to look for a God of all men, of justice and of neighbourliness. Confucius and Buddha had already pointed in that direction and the idea of one-God was known among the neighbouring peoples of Judah.

Today the claim is often made that the religious man, Christian, Muslim or other, must pay respect to Judaism, whatever its errors, on one incontestable ground: it was the first universal religion, so that in a sense all universal religions descend from it. Every Jewish child is taught this.

In truth, the idea of the one-God of all men was known long before the tribe of Judah even took shape, and Judaism was above all else the denial of that idea.



The Egyptian Book of the Dead (manuscripts of which were found in the tombs of kings of 2,600 BC, over two thousand years before the Judaist "Law" was completed) contains the passage:

"Thou art the one, the God from the very beginnings of time, the heir of immortality, self-produced and self-born; thou didst create the earth and make man". Conversely, the Scripture produced in Judah of the Levites asked, "Who is like unto thee, O Lord, among the Gods?" (Exodus 15:11).



The Levites

The sect which attached itself to and mastered the tribe of Judah took this rising concept of one-God of all-peoples and embodied it in its Scripture only to destroy it, and to set up the creed based on its denial. It is denied subtly, but with scorn, and as the creed is based on the theory of the master-race this denial is necessary and inevitable. A master-race, if there be one, must itself be God.

The creed which was given force of daily law in Judah in 458 BC was then and still is unique in the world. It rested on the assertion, attributed to the tribal deity (Jehovah), that "the Israelites" (in fact, the Judahites) were his "chosen people" who, if they did all his "statutes and judgments", would be set over all other peoples and be established in a "promised land". Out of this theory, whether by forethought or unforeseen necessity, grew the pendent theories of "captivity" and "destruction". If Jehovah were to be worshipped, as he demanded, at a certain place in a specified land, all his worshippers had to live there.

Obviously all of them could not live there, but if they lived elsewhere, whether by constraint or their own choice, they automatically became "captives" of "the stranger", whom they had to "root out", "pull down" and "destroy". Given this basic tenet of the creed, it made no difference whether the "captors" were conquerors or friendly hosts; their ordained lot was to be destruction or enslavement.

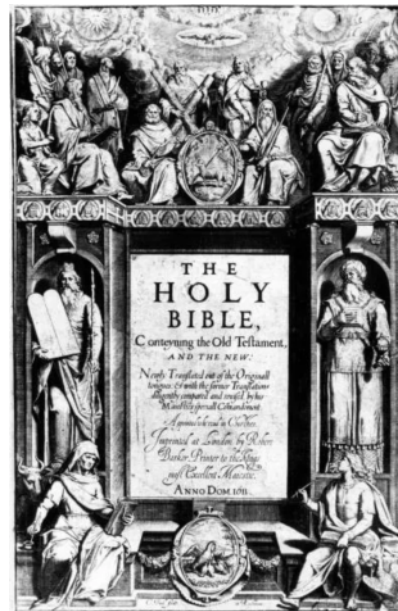
Before they were destroyed or enslaved, they were, for a time, to be "captors" of the Judahites; not in their own right, but because the Judahites, having failed in "observance", deserved punishment.

In this way, Jehovah revealed himself as the one-God of all-peoples: though he "knew" only the "chosen people", he would employ the heathen to punish them for their "transgressions", before meting out the foreordained destruction to these heathen.

The Judahites had this inheritance thrust on them. It was not even theirs, for the "covenant", according to these Scriptures, had been made between Jehovah and "the children of Israel", and by 458 BC the Israelites, spurning the non-Israelitish Judahites, had long since been absorbed by other mankind, taking with them the vision of a universal, loving God of all men.

The Israelites, from all the evidence, never knew this racial creed which was to come down through the centuries as the Jewish religion, or Judaism. It stands, for all time, as the product of Judah of the Levites

Tradition and Scripture



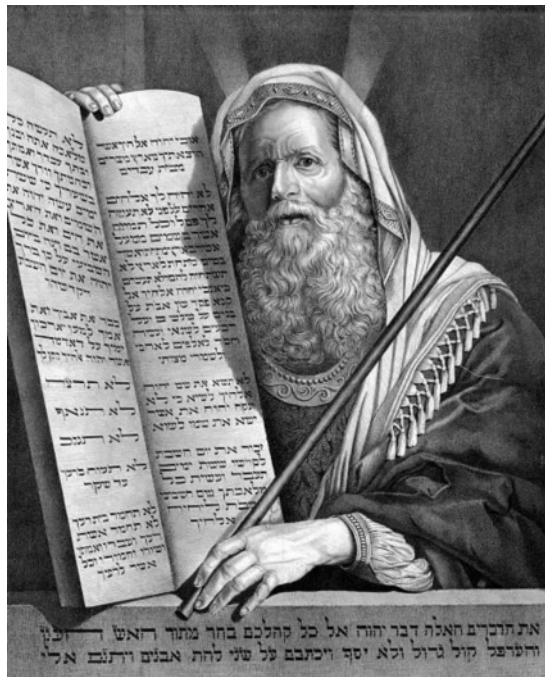
What happened before 458 BC is largely lore, legend and mythology, as distinct from the period following, the main events of which are known. Before 458 BC, for instance, there were in the main only "oral traditions"; the documentary period begins in the two centuries leading up to 458 BC, when Judah had been disavowed by the Israelites. At this stage, when

the word-of-mouth tradition became written Scripture, the perversion occurred.

The surviving words of the earlier Israelites show that their tradition was a widening one of neighbourliness under a universal God. This was changed into its opposite by the itinerant priests who segregated the Judahites and established the worship of Jehovah as the god of racialism, hatred and revenge.

In the earlier tradition Moses was a great tribal leader who heard the voice of one-God speak from a burning bush and came down from a mountain bearing this one-God's moral commandments to the people.

The time when this tradition took shape was one when the idea of religion was first moving in the minds of men and when all the peoples were borrowing from each other's traditions and thought.



Whence the idea of one-God may have come has already been shown, although the earlier Egyptians themselves may have received it from others. The figure of Moses himself (above), and his Law, both were taken from material already existing.

The story of Moses's discovery in the bulrushes was plainly borrowed from the much earlier legend (with which it is identical) of a king of Babylonia, Sargon the Elder, who lived between one and two thousand years before him; the Commandments much resemble earlier law

codes of the Egyptians, Babylonians and Assyrians. The ancient Israelites built on current ideas, and by this means apparently were well on the way to a universal religion when they were swallowed up by mankind.

Then Judah put the process into reverse, so that the effect is that of a film run backward. The masters of Judah, the Levites, as they drew up their Law also took what they could use from the inheritance of other peoples and worked it into the stuff they were moulding.



They began with the one just God of all men, whose voice had been briefly heard from the burning bush (in the oral tradition) and in the course of five books of their written Law [the Torah (Above)] turned him into the racial, bargaining Jehovah who promised territory, treasure, blood and power over others in return for a ritual of sacrifice, to be performed at a precise place in a specified land.

Thus they founded the permanent counter-movement to all universal religions and identified the name Judah with the doctrine of self-segregation from mankind, racial hatred, murder in the name of religion, and revenge.

The perversion thus accomplished may be traced in the Old Testament, where Moses first appears as the bearer of the moral commandments and good neighbour, and ends as a racial mass-murderer, the moral commandments having been converted into their opposites between Exodus and Numbers.

In the course of this same transmutation, the God who begins by commanding the people not to kill or to covet their neighbours' goods or wives finishes by ordering a tribal massacre of a neighbouring people, only the virgins to be saved alive! Thus the achievement of the itinerant priests who mastered the tribe of Judah, so long ago, was to turn one small, captive

people away from the rising idea of a God of all men, to reinstate a bloodthirsty tribal deity and racial law, and to send the followers of this creed on their way through the centuries with a destructive mission.

Captivity and Vengeance

The creed, or revelation of God as thus presented, was based on a version of history, every event of which had to conform with, and to confirm the teaching.

This version of history went back to the Creation, the exact moment of which was known; as the priests also claimed to possess the future, this was a complete story and theory of the universe from start to finish.



The end was to be the triumphant consummation in Jerusalem, when world dominion was to be established on the ruins of the heathen and their kingdoms.

The theme of mass-captivity, ending in a Jehovan vengeance ("all the firstborn of Egypt"), appears when this version of history reaches the Egyptian phase, leading up to the mass-exodus and mass-conquest of the promised land.

This episode was necessary if the Judahites were to be organized as a permanent disruptive force among nations and for that reason, evidently, was invented; the Judaist scholars agree that nothing resembling the narrative in Exodus actually occurred.

Whether Moses even lived is in dispute. "They tell you", said the late Rabbi Emil Hirsch, "that Moses never lived. I acquiesce. If they tell me that the story that came from Egypt is mythology, I shall not protest; it is mythology.

They tell me that the book of Isaiah, as we have it today, is composed of writings of at least three and perhaps four different periods; I knew it before they ever told me; before they knew it, it was my conviction".



Whether Moses lived or not, he cannot have led any mass-exodus from Egypt into Canaan (Palestine).

No sharply-defined Israelitish tribes existed (says Rabbi Elmer Berger above) at any time when anyone called Moses may have led some small groups out of Egyptian slavery.

The Habiru (Hebrews) then were already established in Canaan, having reached it long before from Babylonia on the far side: Their name, Habiru, denoted no racial or tribal identity; it meant "nomads".

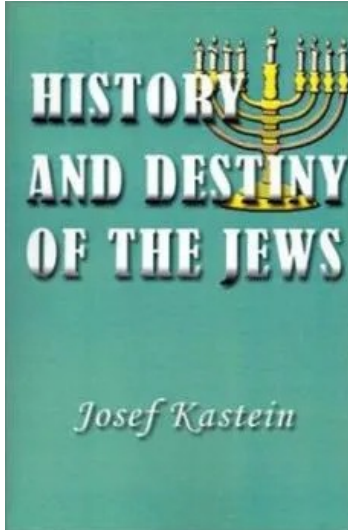
Long before any small band led by Moses can have arrived they had overrun large Canaanite areas, and the governor of Jerusalem reported to Pharaoh in Egypt, "the King no longer has any territory, the Habiru have devastated all the King's territory".

A most zealous Zionist historian, Dr. Josef Kastein, is equally specific about this. He will often be quoted during this narrative because his book, like this one, covers the entire span of the controversy of Zion (save for the last twenty-two years; it was published in 1933). He says:

"Countless other Semitic and Hebrew tribes were already settled in the promised land which, Moses told his followers, was

theirs by ancient right of inheritance; what matter that actual conditions in Canaan had long since effaced this right and rendered it illusory".

Dr. Kastein, a fervent Zionist, holds that the Law laid down in the Old Testament must be fulfilled to the letter, but does not pretend to take the version of history seriously, on which this Law is based.

In this he differs from Christian polemicists of the "every word is true" school. He holds that the Old Testament was in fact a political programme, drafted to meet the conditions of a time, and frequently revised to meet changing conditions.

Historically, therefore, the Egyptian captivity, the slaying of "all the firstborn of Egypt", the exodus toward and conquest of the promised land are myths. The story was invented, but the lesson, of vengeance on the heathen, was implanted in men's minds and the deep effect continues into our time.

It was evidently invented to turn the Judahites away from the earlier tradition of the God who, from the burning bush, laid down a simple law of moral behaviour and neighbourliness; by the insertion of imaginary, allegorical incident, presented as historical truth, this tradition was converted into its opposite and the "Law" of exclusion, hatred and vengeance established.

With this as their religion and inheritance, attested by the historical narrative appended to

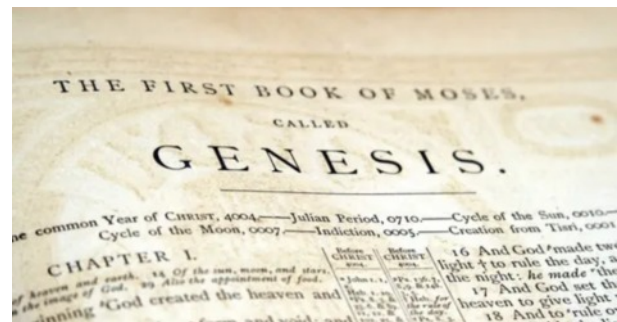
it, a little band of human beings were sent on their way into the future.

By the time of that achievement of 458 BC, many centuries after any possible period when Moses may have lived, much had happened in Canaan.

The nomadic Habiru, supplanting the native Canaanites by penetration, intermarriage, settlement or conquest, had thrown off a tribe called the Ben Yisrael, or Children of Israel, which had split into a number of tribes, very loosely confederated and often at war with each other.

The main body of these tribes, the Israelites, held the north of Canaan. In the south, isolated and surrounded by native Canaanitish peoples, a tribe called Judah took shape. This was the tribe from which the racial creed and such words as "Judaism", "Jewish" and "Jew" in the course of centuries emerged.

From the moment when it first appears as an entity this tribe of Judah has a strange look. It was always cut off, and never got on well with its neighbours. Its origins are mysterious. It seems from the beginning, with its ominous name, somehow to have been set apart, rather than to have been "chosen".

The Levitical Scriptures include it among the tribes of Israel, and as the others mingled themselves with mankind this would leave it the last claimant to the rewards promised by Jehovah to "the chosen people".

However, even this claim seems to be false, for the Jewish Encyclopaedia impartially says that Judah was "in all likelihood a non-Israelitish tribe".

This tribe with the curious air was the one which set out into the future saddled with the doctrine drawn up by the Levites, namely, that it was Jehovah's "chosen people" and, when it had done "all my statutes and judgments", would inherit a promised land and dominion over all peoples. Among these "statutes and judgments" as the

Levites finally edited them appeared, repeatedly, the commands, "utterly destroy", "pull down", "root out". Judah was destined to produce a nation dedicated to destruction.

The First Natives of America ~ Black Moors

AUTHOR AND HISTORIAN CHANCELLOR WILLIAMS SAID "the original Moors, like the original Egyptians, were black Africans." The 16th century English playwright William Shakespeare used the word Moor as a synonym for African.

His contemporary Christopher Marlowe also used African and Moor interchangeably. Black soldiers, specifically identified as Moors, were actively recruited by Rome, and served in Britain, France, Switzerland, Austria, Hungary, Poland, and Romania. St. Maurice, patron saint of medieval Europe, was only one of many

black soldiers and officers under the employ of the Roman Empire. Although generations of Spanish rulers have tried to expunge this era from the historical record, recent archaeology and scholarship now shed fresh light on the Moors who flourished in Al-Andalus for more than 700 years — from 711 A.D. until 1492.

The Moorish advances in mathematics, astronomy, art, and agriculture helped propel Europe out of the Dark Ages and into the Renaissance. The Moors brought enormous learning to Spain that over centuries would percolate through the rest of Europe.

The intellectual achievements of the Moors in Spain had a lasting effect; education was universal in Moorish Spain, while in Christian Europe, 99 percent of the population was illiterate, and even kings could neither read nor write. At a time when Europe had only two universities, the Moors had seventeen, located in Almeria, Cordova, Granada, Juen, Malaga, Seville, and Toledo. In the 11th and 12th centuries, public libraries in Europe were

nonexistent, while Moorish Spain could boast of more than 70, including one in Cordova that housed hundreds of thousands of manuscripts.

Universities in Paris and Oxford were established after visits by scholars to Moorish Spain. It was this system of education, taken to Europe by the Moors, that seeded the European Renaissance and brought the continent out of the 1,000 years of intellectual and technological gloom of the Middle Ages. ~ Atlantablackstar.com.

The Los Angeles Times (June 4, 1990) reported that “When Napoleon visited the Sphinx in 1798, everything but the head was buried in sand—his soldiers reputedly used the Sphinx for target practice.”



While the Sphinx had already suffered nose damage prior to Napoleon, the greatest destruction took place during Napoleon’s occupation of Egypt, as documented by Tony Browder, and testified by the collection of Sphinx portraits he has assembled on page

225 of his book Nile Valley Contributions to Civilization.

These six portraits, drawn over a period of 100 years from 1698 to 1798, are the only current evidence available which shows the progression of the nose destruction. Besides the Sphinx, a large percentage of Africoid Kamite statues are

missing their noses, whereas European-looking figures are intact.



Faces of Africoid sculptures were also altered to appear Caucasoid by Kamit’s European conquerors. A Sphinx statue on display in the British Museum admits that the “face of the stature was reworked” during the Roman occupation of Egypt. Reporting on the “riddle” of the racial identity of the ancient Egyptians, Count C. Volney, a distinguished French scholar who visited Egypt in the late 1700’s, wrote with astonishment “—when I visited the Sphinx, its appearance gave me the key to the riddle.

Americas Were Black People and They Were Not Brought Here on Ships



The transatlantic slave trade is the largest forced migration in history. Black people are indigenous to the Americas. Black Native Americans are not a result of the so called “red Indian” mixing with slaves.

Instead, they were enslaved right here on their own lands. If they were brought on ships, the numbers are extremely exaggerated. It was published that 15,000,000 to 20,000,000 slaves arrived in the Americas between 1540 and 1850 over—a 310-year period (according to US History books). The Stewart Synopsis points out a few questions that should be examined:

The so called “red Indian” comes from mixing with the European colonist and the Asians that were in America before Columbus. The first Native Americans were Mongolian Tartarians. Melville Herskovits, a European anthropologist, was one of the originators of the “Out of Africa Theory.”

Herskovits never had any historical, archaeological, or anthropological proof that Black People of the Americas ever derived from West and North Africa.

1. Over a period of 300 years, is it fair to say that 60,000 slaves were transported annually to the Americas or has the transportation of slaves to the Americas been one big myth?

Consequently, Herskovits crafted the theory that Blacks arrived in America from the transatlantic slave trade, which allegedly brought in more than 10 million African Slaves.

2. The largest seagoing vessel carried 400 slaves but not all of the ships were that large

According to the National Archives of Spain and Smithsonian Records, there was no evidence to prove 70 thousand ships with Black Africans ever sailed to the Americas. Melville carried out the teachings of his mentor Franz Boaz, to make the Original Copper Colour Races of The Americas inferior, and the European presence superior.

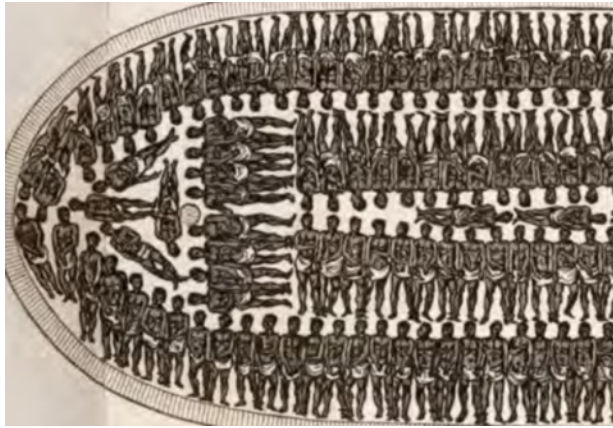
3. Time of passage was 3 – 4 months. That means 200 vessels/ships per year would have to travel carrying 300 people. One ship could make 3 passages per year.

Before this time, Blacks coming from Africa through the Transatlantic Slave Trade story never existed. As a result, Melville’s work has been fragmented and used as propaganda by writers like Harold Courlander and Alex Haley,

The Trans-Atlantic Slave Trade Database says there were 1100 – 1400 voyages made over that 300 year period. If that is the case and each ship carried 400 people, the total number would be 560,000 Africans were transported. It still does not add up.

4. We already know that over 83% of all Americans with African ancestry have Native American blood.

5. Did Native American tribes help slaves escape or were Americans with African ancestry already part of the Native American Nations?

After 20 years the Royal Adventurer—with its 15 ships had transported between 90,000 and 100,000 slaves. That is a long way from 15,000,000 to 20,000,000 slaves who were supposedly brought to the Americas. The recent paper in this journal by
Buxton, Trevor and Julien (MAN, 1938,

47) implies that an Undeformed Negroid physical type inhabited the Virgin Islands in pre-Columbian times. Not only is this implication contrary to previously accepted findings for the Antillean area (as will be shown later), but it also fails to give adequate consideration to the possibility of the skeletal remains representing intrusive Negro burials.

The mere presence of skeletons in a sand or shell mound of Indian origin, lacking careful stratigraphic records, is not certain evidence of primary association with the accompanying artifacts.

Moreover, I venture to say that few physical anthropologists familiar with American Indian skulls would mistake for Indians those illustrated by Buxton, Trevor and Julien; ideally most physical anthropologists would probably be less conservative and say 'Negro' instead of Negroid."

Or is/was the Black/Brown birthrate that more accelerated than the White birthrate? The calculated median of 15 and 20 million would be 17.5 million. Divide it by 400 people—the largest slave vessels That comes out to 43,750 trips.

Can you show me a record where this many trips occurred, or the number of trips calculated by the so-called experts? (Figures exist of 27,000 – 35,000 voyages). The same thing happened with the holocaust in Germany during World War II.

The story goes—Over the course of 300 years, from the 16th to the 19th centuries, the Brazil imported around four million slaves (some 40 percent of the total transatlantic slave trade).

The overwhelming majority came from the former Portuguese colony of Angola, located on the Atlantic coast of southern Africa. On July 9, the United Nations Educational, Scientific and Cultural Organization (UNESCO) named Valongo Wharf a World Heritage site, along with northwest England’s Lake District, the walled city of Ahmedabad in India and the sacred Japanese island of Okinoshima, which doesn’t allow women on its shores.

Of the new sites on the list, none has a darker past than Valongo Wharf. Built in 1811, the wharf

functioned as South America’s leading slave port. It was here that as many as 900,000 enslaved African men, women and children were held before being sold on the Brazilian slave market.

Those who didn’t survive the ordeal—who died during the transatlantic journey or sometime after arriving at the wharf—were buried in mass graves nearby.

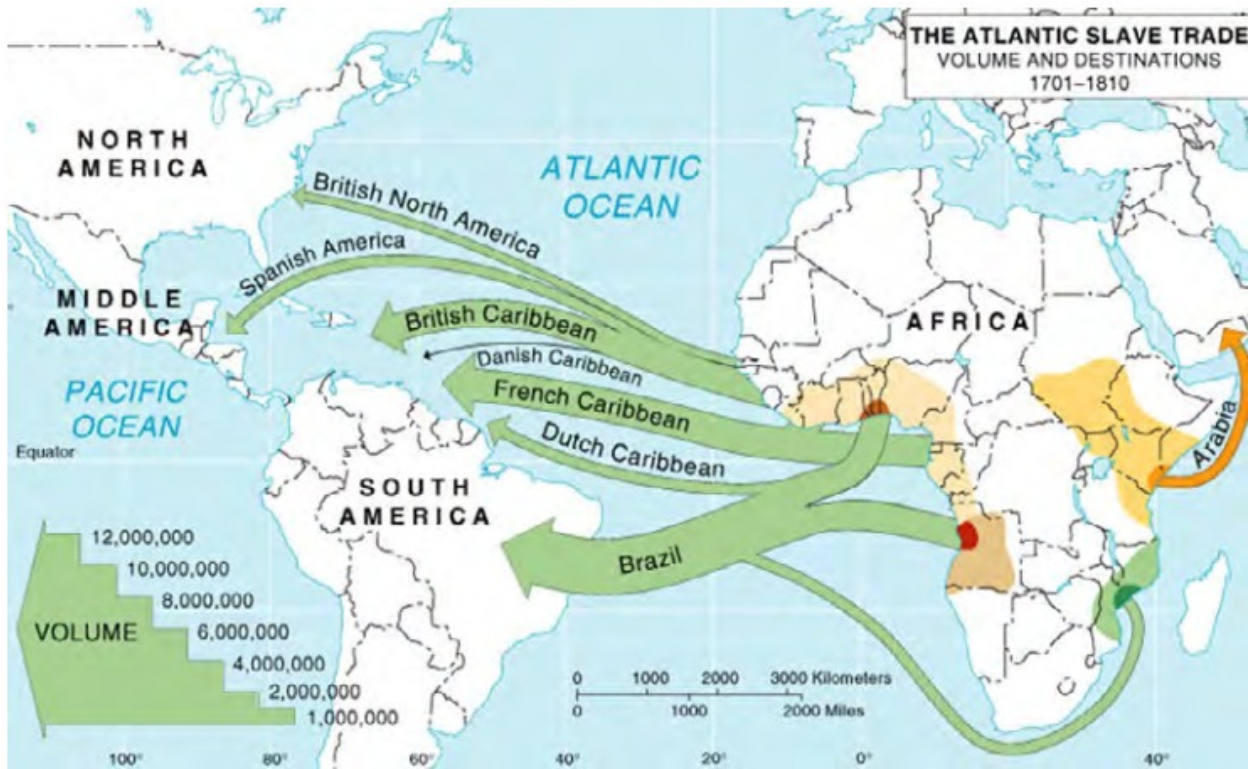

YORK UNDER ITS VARIOUS NAMES AND RULERS, THIS ARTICLE WILL COVER THE PERIOD OF CONSTANTINE. York has had many names such as Erech, Babylon, Strato's Tower or Caesarea, there is one other point of significance of which it is essential to make mention, is that, in the land comprising Syria and Judaea (with Jerusalem in Edinburgh, Antioch in Lincoln and Babylon nicely centred in York), then those place-names must be re-attributed to the actual sites where the events occurred.

ED Note: The Ouse is tidal up to Naburn Locks, three miles below York, but in former times the tides reached the city itself, according to the Official Guide to York, p 20. In early times, a series of forts lined the Humber to York. **Acts, X and XI.**

It can only surmised what may be the true significance of the area that Constantine gave his name to - Constantinople, now Istanbul - so that the history of Judaea and Syria (in reality the history of northern and southern Britain) had to be relocated there.

It is clear from the value placed upon Comyns Beaumont's work by those who have an inkling, especially those in high places in Scotland, that he stumbled onto Comyns Beaumont writings concludes that, as with prehistory, the history of Christianity has been uprooted and replanted in a distant land.

St Peter, Chief of the Apostles, was no stranger to Caesarea. Most of his life after the crucifixion was spent in preaching and converting heathen British as well as in Jerusalem, Antioch and Caesarea.

In his Epistle to the Galatians (2: 11), St Paul mentions that Peter visited the flourishing church of Antioch in Syria, but he does not mention Caesarea. Peter mentions it himself but as we shall see refers to it as “Babylon”, as it could justly yet be termed.

Another reference to the former name of York: “The Church that is at Babylon, elected together with you, saluteth you; and so doth Marcus, my son.” (I Peter, 5: 13)

Why did he use the words “at Babylon”? What possible relationship could he possibly have had with Babylon, for centuries a ruin and totally forgotten?

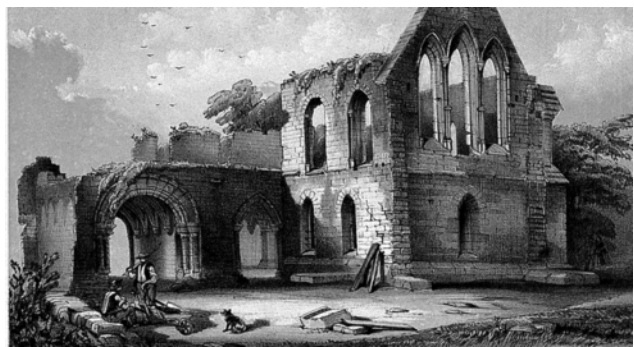
In their dilemma many have proposed that it was merely a synonym for Rome, surely a far-fetched pretext because if Peter had meant Rome why say Babylon? This name challenging - as may have been intended - throws a light upon the inscrutable deception regarding the past history of the world and of the earliest days of Christianity.



St Peter, (Above) who dwelt in Joppa and moved to Caesarea when he escaped from Agrippa, where he founded his church, and addressed his Epistle to the Romans as from Babylon - dwelt in York, it is necessary to revert to St Paul and St Barnabas, for both were labouring in the same regions, especially in “Galatia”.

My readers, of course, can furnish the solution: Caesarea was Babylon, and St Peter's main mission among the heathen was there, in Caesarea, otherwise York.

To be meticulously correct, Babylon was the correct name for the Saint's mission and activity on the left bank of the Ouse, which was Babylon; whereas the right bank, where stood originally Borsippa, was later the Roman capital Eboracum or Caesarea, a colonia.

Also notable is St Peter's School, and, in addition to St Peter's church, there were exceptional privileges which continued until a recent period, entitled the Liberty of St Peter (the enclosure originally to the Minster area); St Peter's Prison; Peter's Pence, and, in connection with the Liberty

of St Peter, an ecclesiastical regnum in regno, whereby the Church authorities within its own bailiwick were an independent body. To cite Allen, the well-known historian of Yorkshire:

“The Liberty of St Peter comprehends all those parts of the city and county of York which belong to the Church of St Peter. The jurisdiction is separate and exclusive, and it has its own magistrates, steward, bailiffs and constables.”



There can be no doubt that the ecclesiastical supremacy of York was unique in the early days of Christianity, and we find all the place names relating to St Peter exist in the vicinity of the present minster sacred to the Apostle, such as Petergate. (Which is a street - above)

The Dungeon (discovered in 1816), on the site of a former chapel of St Sepulchre; also Peter Prison, and the Hall of Pleas for the Liberty of St Peter.

They must have been instituted at an early date when the Liberty was established, yet to contend that the earliest Church of St Peter was erected in the centre of a military fortress, of which no sign or indication has been found, renders its site very doubtful.

A remarkable feature of ecclesiastical York is its ancient city seal. Allen describes its obverse as showing St Peter, with his cross-keys, standing between two angels, each holding a candle, with the inscription

“S B I PETRI PRINCIPIS APOSTOLOR” which may be interpreted as: SEDES BRITANNIS INSULIS PETRI PRINCIPIS APOSTOLORUM

“The See (or seat) in the British Isles of Peter, Chief of the Apostles.

Its reverse depicts an edifice with three towers or turrets and one larger inscribed:

“SIGILLUM CIVIUM EBORACI” (The Seal of the City of Eboracum). The implication of these claims appears unmistakable, for the sense is that St Peter was the Bishop of York and that here was his Seat or See.

It refutes the claim of Rome, which was not recognised by York before the eleventh century. Such a city seal could not have been designed and approved centuries ago without a very strong proof of its correctness as to St Peter.

History indicates how anxious the Vatican became, in the centuries following Constantine, to get York to conform, regarding it as the most important of the primatial cities. It was always ear-marked for an archbishopric directly it joined the Roman communion. And then it beatified St William, in order to eradicate St Peter where possible.

The Clifford Tower - York



York is St Peter's city, and here we find the rock, the two keys design, and evidence of a chapel; in addition, with its three towers or turrets and one larger square in its design, it may, without any straining for effect, explain the reverse of the ancient city seal.

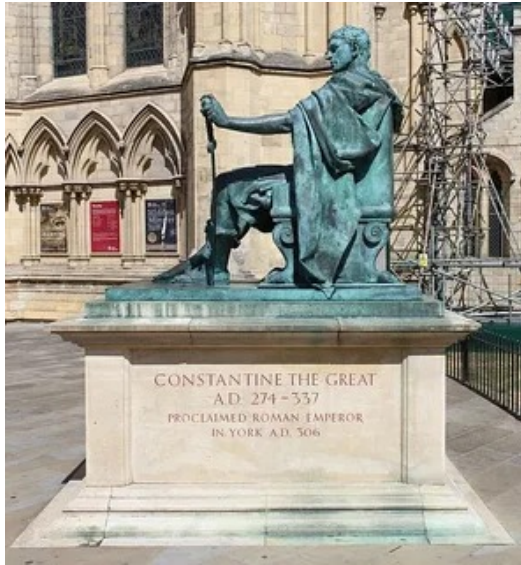
Thus, in the ruined Clifford's Tower, it is possible we may view the first church of St Peter, built according to divine precept, the “Paterna”.

Constantine's Background



It was Constantine the Great who would set the foundation for this seemingly impossible ambition of a universal church.

In 187 AD, Carthaginian Septimius Severus, the father of Constantine (above), married fellow Canaanite Julia Domna while on a trip to his hometown in Carthage. He was 42 and she was 13. In 193, he was proclaimed Emperor of Eboracum (York) and Julia became Julia Augusta.

Their daughter Helena, became the infamous mother of Constantine. It was not the elder son who was murdered that became emperor, but the younger son taking the elder son's name.

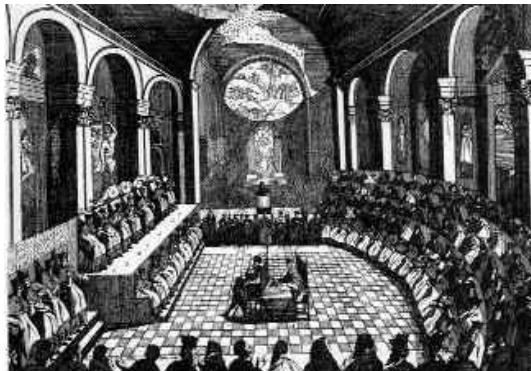
This was to ensure that Jesus, or Esus as it was spelt then, was carried through the Constantine name, and be worshiped down the centuries as a god, by substituting the name of Christ for Jesus, when in fact, he was known by the Culdee Church as Yahsuah, God Saves.

It would be easy remove all references to him in the third person. His disciples referred to Him as Master. Christ Himself told a disciple when instructed to go acquire a Donkey and queried, who shall I say sent me. He answered, saying, tell the man in Antioch, in the street called Straight; "I am that I am sent you."



That city known today Lincoln, there is still to this day a road named, "The Straight", the old A1 used to run through the centre of Lincoln.

After many years, the Constantine church, now as the Catholic Church, got stronger, virtually all churches across the world, of whatever denomination, now use the word Jesus as the name of the Saviour.



The Council of Nicaea presided over by Constantine was a pivotal gathering of Christian bishops in 325, where among things discussed were which books were cannon.

Those books which were accepted as cannon were retranslated from Koine Greek Hebrew to modern block Hebrew which is Yiddish (Language of the Deceiver) which runs from right to left.

Nevern South West Wales

There is an ancient sealed cave at the Pilgrims Way at Nevern.
