Daniel's Seventy Weeks Fulfilled in Yahshua Messiah Part 5 - Pastor Eli James



He Shall Cause the Sacrifice and the Oblation to Cease. Let's look at verses 24-27 in their entirety, to get the whole picture:

EVENTY WEEKS ARE DETERMINED upon thy people and upon thy holy city, to finish the transgression, and to make an end of sins, and to make reconciliation for iniquity, and to bring in everlasting righteousness, and to seal up the vision and prophecy, and to anoint the most Holy.

Know therefore and understand that from the going forth of the commandment to restore and to build Jerusalem unto the Messiah the Prince shall be seven weeks: the street shall be built again, and the wall, even in troublous times. And after threescore and two weeks shall Messiah be cut off, but not for himself: and the people of the prince that shall come shall destroy the city and the sanctuary; and the end thereof shall be with a flood, and unto the end of the war desolations are determined.

And he shall confirm the covenant with many for one week: and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate." – Vs. 24-27.

First of all, there is absolutely no possibility that the anti-Christ confirms the covenant. It was Messiah who confirmed the Covenant with His People, Israel and Judah. Secondly, we must understand that it is Yahweh Himself who will cause the destruction of Jerusalem. This is because of the overspreading of abominations amongst the people there, most of whom were Edomite Jews – not Judahites or Benjamites of the House of Judah. Come, let us reason together: Would the anti-Christ destroy a place

because of "the overspreading of abominations"? Satan does not destroy his own handiwork!!! Obviously, the Pharisaic rabbis continued to use the Temple as a currency exchange; and they continued to sell doves, other sacrificial animals and ritualistic paraphernalia! Since most of Satan's deceptions require centuries to establish, he does not lightly set aside such institutions, especially if the enterprise is cash cow like the Jewish temple! Did not Jesus say, "If Satan cast out Satan, he is divided against himself; how then shall his kingdom stand?" Satan – and the Jews – wanted to PRESERVE animal sacrifice; but the Roman army put the Pharisees out of The Jewish priesthood has been without a Temple in Jerusalem since that time. This is Yahweh's doing!!!

Paul clearly declares that Yahshua's sacrifice was once and for all! There will be no more animal sacrifice for the remission of sins, and any priesthood that tries to reestablish this practice will be spitting in the face of Yahweh!!! As I have stated elsewhere, if the Jews try to reestablish this practice again in Jerusalem, Yahshua's wrath will come upon them in a most furious way! This will be, quite literally, blasphemy against the Holy Spirit!

He Shall Confirm the Covenant With Many for One Week.

The words, "He shall confirm the covenant with many for one week," have baffled many interpreters, because the fact is that Yahshua Messiah's ministry did not last one "week" of years. His ministry only lasted 3&1/2 years. This statement is the only one in Daniel 9 that I have found to be confusing, because it creates a conflict regarding the actual start time of the final week and the actual duration of His ministry.

This contradiction in timing must be resolved. I have struggled with this problem for literally two decades, until it finally occurred to me that the "one week" of Daniel 9:27 is not one of the prophetic 70 weeks of years. It is rather, and more importantly, a reference to the final week of His life, the fabled Holy Week, beginning with the anointing by Mary Magdalene. With

this observation, the contradiction is logically eliminated.

Thus, the statement, "He shall confirm the covenant with many for one week," is a reference to His fellowshipping with His disciples in Bethany and Jerusalem during Holy Week. It would not, therefore, be a reference to the beginning of the 70th "week" of Daniel's 70.



In the very next clause, however, we are told, "...in the midst of the week He shall cause the sacrifice and the oblation to cease..." And this would be a reference to the baptism of John in the Jordan River, which, although occurring in the middle of the final "week," was the beginning of His ministry. Having just reached the age of thirty, Jesus was now qualified to be a priest!

Yahweh's Law says a man must be thirty years of age before he can be a priest, and He would not expect His Son to break that Law!!! The highlight of this baptism by John was the point at which the Holy Spirit, in the form of a dove, descended upon Jesus and Yahweh spoke the immortal words, "This is my beloved Son, in whom I am well pleased." (Matt. 3:17, fulfilling Ps. 2:7 and Isa. 42:1)

This is a highly symbolic event, because it anticipated the return of the Holy Spirit (Shekinah Glory) into the Adamic race. This Spirit was breathed into Adam and Eve by Yahweh, but it was lost by those two of our ancestors when they committed fornication in the Garden. Jesus told us, "I will send you the comforter" (Holy Spirit); but this Comforter could not be bestowed until He paid the price of Israel's sins, under the Old Covenant, and we were washed clean by His sacrifice on the Cross. (John 14:16, 26; 15:26.)

"midst of the week" is a reference to Yahshua's baptism, the beginning of His earthly ministry. The contradiction is thus resolved!

Dispensationalist Confusion

It is also true that this confusion of timing in Daniel 9 has caused the futurists to make another huge mistake. Referring back to the chart above, points 3 & 4, which are in shaded bars, they assert that the "cutting off" will occur mid-week. But that is not what Daniel says!! Daniel says merely that Messiah shall be cut off after the 69th week.

There is no suggestion that the Crucifixion will occur in the middle of this final "week." The "scholarship" involved sloppy this interpretation is glaringly obvious. It simply does not say that Messiah will be cut off in the middle of the week. It says, "He shall confirm the Covenant with many for one week." Both the confirming of the Covenant and the cutting off will occur after the 69th week. That's all it is saying!

The performed futurists have another switcheroo, a bait and switch, a gambit which works very well on those who do not read the Scriptures for themselves! Having confused the two concepts (the "confirming of the Covenant" with the "cutting off"), the futurists are hopelessly lost in a maze of futile speculations! Here, again, the futurists have deliberately rearranged the words to suit themselves!!!

Before expounding further on this point, it is important to note that the verse says "many," not Earlier, I documented how even His "all." closest Disciples did not understand. It was only during the final week of His ministry that He was acknowledged as the Priest-King, Kinsman Redeemer of Israel, the Promised One, the Messiah.

This had always been a matter of dispute during His entire ministry. Even the Apostles doubted and wavered. During His 3½ year ministry, the evidence was being presented by Jesus in His miracles and foreknowledge, but few actually believed that the promised Messiah was walking in their midst!!!!

If I am correct in my analysis, then the "one For us, hindsight is 20/20. For those who lived week" is a reference to Holy Week, and the in Judah and Galilee in those days, the full been a matter of ready understanding. Only those fully familiar with the prophecies could have understood what was happening; and even they had doubts!!! that He was the Messiah.



The day on which He was anointed by Mary Magdalene was the day which began the final week. His ride into Jerusalem on an ass occurred the next day. Later that week, He established the New Covenant at the Last Supper. Soon after, He was arrested and tried for claiming to be what He was: the Messiah, the Son of God. On the last day of the week, He was crucified (sacrificed). Little did the Judahites of Judea realize that their Kinsman Redeemer had come to sacrifice Himself for their sins!!!

The Rationale for the Literal Week **Hypothesis**

After years of trying to resolve this issue of the "one week" conundrum, which is commonly assumed to mean the last prophetic "week" of seven years, I realized that I had stumbled onto a logical solution. This realization has come upon me only in the last few weeks. During my radio discussions with Bill Finck about 2-Seedline on our Christogenos shows on Friday nights, we had talked about examples of Scriptural words which were used **both** literally and figuratively in the same Chapter, and sometimes even in the same sentence.

This was clearly the case in Genesis 2:16-17, where, in verse 16, the literal fruit of trees is meant, but, in verse 17, the "tree" of knowledge can only be a metaphorical "tree." The "forbidden fruit" is race-mixing, not a literal apple!!! Besides, if apples could make us "wise," none of us would be stupid!

meaning of the First Advent could hardly have Pastor Jay Faber, on another show, had pointed out that the words "in the midst of the Garden" in Gen. 3:3 can also be translated as "throughout the Garden," meaning that the people of this particular family tree could be found inhabiting the Garden, just about anywhere.


> These two considerations forced me to look up the words 'midst' and 'week,' as they occur in Daniel 9:27, to see if there is something I might have been missing in the translation! It turns out that the Hebrew word for 'midst' in Dan. 9:27 (#2677, chetsiy) is not the same as the Hebrew word for 'midst' in Gen. 3:3 (#8432, tavek), which can have the connotation of "throughout." Chetsiy simply means "half" or "the middle of two parts." Thus, Dan. 9:27 could only mean the center point of the 70th "week." But it is clear that Yahshua's ministry began with the baptism by John and ended with His crucifixion at the very end of the 490 weeks, on April 3, 33 So, the word 'midst' can only be a reference to the middle of the final prophetic week; and the consensus is that it is a reference to the baptism by John.

> The Hebrew word for "week" is shabua (Strong's # 7620), and it simply means "sevened," or a literal week. Recalling our radio discussion of the alternating literal and figurative usages of the word "tree" in Genesis 1 & 2, I concluded that this is what must be going on in Daniel 9:27. In other words, I concluded that, in Dan. 9:27, we have both a figurative and a literal instance of the word 'week.'

> Thus, the shabua of Daniel 9:24-27 are prophetic "weeks," consisting of seven years each, but the "one week" of Daniel 9:27 could only be a literal week. Therefore, the "one week" mentioned in Daniel 9:27 is a reference to His final week on earth, for He did not actually confirm the New Covenant until this very last week, a literal week of seven days. At the same time, all of the important events, such as the baptism of Jesus, the miracles and prophecies, the sealing of the New Covenant and the Crucifixion, still take place within the last prophetic "week" of seven years. Having thus eliminated the contradiction in my own mind, let us review the events of the confirming of the covenant with many for one week.

Hittites, Amorites, Perizzites, Hivites, and not of the children of Israel,

1 Kings 9:21 – *Their* children that were left after them in the land,

whom the children of Israel also were not able utterly to destroy, upon those did Solomon levy to be thoroughly dishonest. a tribute of bond service unto this day.

1 Kings 9:22 – But of the children of Israel did Solomon make no bondmen: but they [were] men of war, and his servants, and his princes, and his captains, and rulers of his chariots, and his horsemen.

Here we see how those not of Israel but living in the lands of Israel, had to undertake forced labour for the privilege of living in their land.

This is the polar opposite of what happens in the nations of Israel today, when a significant number of those not of Israel, are provided with free income and housing paid for by the Israel taxpayers, and yet they have to undertake no labour to receive this.

Ecclesiastes 5:4 – *When thou vowest a vow unto Yahweh (God), defer not to pay it; for* [he hath] no pleasure in fools: pay that which thou hast vowed.

Ecclesiastes 5:5 – Better [is it] that thou shouldest not vow, than that thou shouldest vow and not pay.

This seems clear, do not lie to Yahweh.

However the Jews who claim to be the Israel of the Bible have a very interesting prayer called the, "Kol Nidre," that they recite on their Yom Kippur, which reads as follows:

"All personal vows we are likely to make, all of the earth! personal oaths and pledges we are likely to take

KINGS 9:20 - between this Yom Kippur and the next Yom [And] all the people Kippur, we publicly renounce. Let them all be _ [that were] left of the relinquished and abandoned, null and void, neither firm nor established. Let our personal vows, pledges and oaths be considered neither Jebusites, which [were] vows nor pledges nor oaths."

> On that basis it would seem that they are not prepared to stand by any promises they make, therefore they are in violation of this passage in Ecclesiastes, and furthermore unable to be trusted in entering into any arrangement with, as the foundation of their faith is their stated desire

> Could this be the reason why historically Christian courts considered the word of a Jew to be worthless?

2 Chronicles 7:14 – If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land.

Once again Yahweh offers his blessings in exchange for Israel obeying his laws.

930 B.C. - 586 B.C.:

Amos 5:15 – *Hate the evil, and love the good,* and establish judgment in the gate: it may be that Yahweh (the LORD God of hosts) will be gracious unto the remnant of Joseph.

In other words, hate the children of Satan, and love the children of Yahweh.

Once again Israel, if you would only follow the laws of Yahweh, then you will receive His blessings.

2 Kings 18:9 – And it came to pass in the fourth year of king Hezekiah, which [was] the seventh year of Hoshea son of Elah king of Israel, [that] Shalmaneser king of Assyria came up against Samaria, and besieged it.

- **2 Kings 18:10** And at the end of three years they took it: [even] in the sixth year of Hezekiah, that [is] the ninth year of Hoshea king of Israel, Samaria was taken.
- **2 Kings 18:11** And the king of Assyria did carry away Israel unto Assyria, and put them in Halah and in Habor [by] the river of Gozan, and in the cities of the Medes:
- **2 Kings 18:12** Because they obeyed not the voice of Yahweh (the LORD) their God, but transgressed his covenant, [and] all that Moses the servant of Yahweh (the LORD) commanded, and would not hear [them], nor do [them].

The most important part of this passage is in what it doesn't say. This is the last historical mention of the kingdom of Israel which comprised the ten tribes of: Reuben; Simeon; Dan; Naphtali; Gad, Asher; Issachar; Zebulun; Ephraim and Manasseh (descended from Joseph).

The disappearance of these tribes of Israel is dated at 721 B.C., and it is from that point that they crossed from the east to the west of the Caucasus Mountains (which is why the white race are also known as Caucasian today), and began their migration into Europe.

See also the words of Jesus Christ in:

Matthew 12:30 – He that is not with me is against me; and he that gathereth not with me scattereth abroad.

- **13.** And lived Qeynan after he begat Mahalal'el eight hundred and forty 702 years, and begat sons and daughters:
- **14**. and were all the days of Qeynan nine hundred and ten 6235 years: and he died.
- **15**. And lived Mahalal'el sixty 8346 five years, and begat Yered 3382.
- **16.** And lived Mahalal'el after he begat Yered eight hundred and thirty 8083 years, and begat sons and daughters:
- **17.** and were all the days of Mahalal'el eight hundred and ninety five years: and he died.
- **18.** And lived Yered a hundred and sixty 8346 two years, and begat Chanoch 2585:
- **19.** And lived Yered after he begat Chanoch eight hundred years, and begat sons and daughters:
- **20.** and were all the days of Yered nine hundred sixty two years: and he died.
- **21**. And lived Chanoch sixty five years, and begat M'thushelach 4968:
- 22. and walked 1980 Chanoch with Elohiym after he begat M'thushelach three 7969 hundred years, and begat sons and daughters:
- **23**. and all the days of Chanoch were three hundred and sixty five years:
- **24**. and walked Chanoch with Elohiym: and he was not 369; because took him away 3947 Elohiym.

- **25.** And lived M'thushelach one hundred eighty 8084 seven years, and begat Lemech 3929:
- **26.** and lived M'thushelach after he begat Lemech seven hundred eighty two years, and begat sons and daughters:
- **27** and were all the days of M'thushelach nine hundred sixty nine years: and he died.
- **28.** And lived Lemech one hundred eighty two years, and begat a son:
- **29** -and called his name Noach 5146, saying, "This 2088 shall comfort 5162 us from our work 4639 and toil 6093 of our hands from the soil that has been cursed 779 by Yahweh."
- **30.** And lived Lemech after he begat Noach five hundred ninety five years, and begat sons and daughters:
- **31**. and were all the days of Lemech seven hundred seventy seven years: and he died.
- **32**. And was Noach five hundred years old: and begat Noach Shem 8035, Cham 2526, and Yepheth 3315.

Chapter 5 Notes

Verse 1. This is the seedline of the Adam. He is a particular adam, and was singled out to become the forefather of what would eventually become the tribes of Yisrael. There were other adamic people in existence at the time, and Adams descendents would take females from them as wives. The father carries the seedline, not the mother. It is a patriarchal descent, quite the opposite from what the Talmudists say. All of Yisrael were adamic racially, but all adamics were not Yisrael. These adamics were the ones Qayin feared, as he was a half-breed, and of different appearance.

Verse 3 - Yashar (Jasher) 2:1

Verse 9 - Yashar 2:10

Chapter 6 Notes


ONSIDER AGAIN THESE TWO **VERSES:**

John 3:16 God so loved the world ...

Mark 16:15 Go ye into all the world ...

Such verses are the basis of the thought that the go and preach the gospel to every creature of Mark 16:15 refers to going to every person of every race on earth. Let us consider some of the words in these verses.

Preach or kerusso means to proclaim, or to announce good news like a town crier. It does not mean "to make disciples" or "to evangelise", as many teach. But where were they to make their proclamations? Was it to everyone of every race? Let us look at every creature. The Greek word *ktisis* is given by:



"original formation, ordinance".

New Words: "Ktizo is used among the Greeks to mean the foundation of a place, a city, or a colony ... It is a significant confirmation of Rom

1:20,21 that in all non-Christian Greek literature these words (ktizo and its derivatives) are never used by Greeks to convey the idea of a Creator or of a creative act by any of their gods. The words are confined by them to the acts of human beings.

This is the creature [or rather, creation] of Mark 16:15. The word ktisis in the Greek is used to indicate the product of human building or formation. In this context it refers to a village, or place where people live. A ktisis is built by man, not God. The disciples were to go specifically to the places or the villages or places where the Israelites lived.

Matt 10:23 Ye shall not have gone over the cities of Israel, till the Son of Man be come. We cannot make "the cities of Israel" mean the cities of every race. Note here that Jesus is speaking of the time of the end.

What is the area of proclamation? Is it not all the Isaiah 45:22 "Look unto me and be ye saved, all world of Israel?

What were they proclaiming? Was it not the At first glance, this appears to have a universal Gospel of the Kingdom?

Failure to understand this is the source of error in the modern popular teaching. Jesus says that it is not given for everyone to hear or to understand. Immediately we have just one exception, then "every" and "all" cannot include that exception, or the other exceptions. If an exception is made about the Edomites who cannot find repentance, or of those Jesus said, leave them alone, then these cannot be part of the "all" being addressed. The word translated as the earth is the Hebrew word "erets" which is mostly translated as "country" or "earth" in the sense of a localised area or that earth belonging to a people [for example, the land, or earth, of Israel]. In context, this whole chapter is about Israel and no other. It certainly is not used in the generalised sense as the universalists who try to prove the expression the ends of the earth means every race or place on Earth.

"Nations" is sometimes translated emotively as "Heathen" to try to add weight to the universal argument. To understand any passage of Scripture it is necessary to look at it as a whole

by going back to the prophecy behind it to see what it fulfilling.

To Abraham:

Gen 12:2,3 And I will make of thee a great nation, and I will bless thee, and make thy name great; and thou shalt be a blessing: and I will bless them that bless

thee, and will curse him that curseth thee, and in thee shall all families of the earth be blessed.

Gen 18:18 Seeing that Abraham shall surely become a great and a mighty nation, and all the nations of the earth shall be blessed in him?

Gen 22:18 And in thy seed shall all the nations of the earth be blessed; because thou hast obeyed my voice.

Gen 26:3 Sojourn in this land, and I will be with three, and will bless thee; for unto thee, and unto thy seed, I will give all these countries, and I will perform the oath that I sware unto Abraham thy father.

To Jacob:

Gen 28:14 And thy seed shall be as the dust of and the earth, and thou shalt spread abroad to the west, and to the east, and to the north, and to the south: and in thee and in thy seed shall all the says]. families of the earth be blessed.

Psalm 22:27 All the ends of the world shall remember and turn unto the Lord: and all the then they which be of faith are blessed with kindreds of the nations shall worship before thee.

> Here are six important verses that are used to support the doctrine of universal racial salvation. Indeed, they do appear to give valid support on the surface. But do they actually say what the religious translators make them say? Is this the problem here? Let us look further.

THE "FAMILIES OF THE EARTH" BEING BLESSED IN ABRAHAM

The major source of error in these blessing passages is what we mean by certain words. We have different words translated as earth and the ground, countries and the land, as also occurs with the words translated nations, families and kindreds. Although an extensive technical Hebrew language exposition is beyond the scope of this paper, there are things that need to be pointed out.

Originally Abraham was told to go from his father's house unto an eretz that God would show him. If eretz here is the whole Earth, then Abraham must have gone to another planet! Abraham was told all The 'Earth' which thou seeth, I will give thee. He was told to arise and walk through the earth. Did he walk across the whole globe? So we have to ask if this 'earth' is the whole earth or the Promised Land. It is not all the 'eretzs of all the races on earth. Abraham was told to get himself out of his present earth and to go to THE earth. There are many references that give confirmation of the meaning. THE earth does not mean the whole globe, but rather that portion belonging to the particular area or person under consideration.

Some awkward questions could be posed here if whole heaven, shall be given to the people of the it was to be taken that all nations had the meaning of "every race on earth":

If those who curse Abraham are cursed, how could those so cursed be part of all nations which were to be blessed?

In Deut 23:6, God commanded Israel that they should not seek the peace or the prosperity of the Ammonites and the Moabites right up to the end of the age. Ezra 9:12 indicates similar treatment of the non-Israelites in the land. This is hardly a blessing on those nations, is it?



When The House of Judah was in captivity in Babylon, is there any evidence of Israel being a blessing to Babylon?

When the House of Israel was in captivity in Assyria, did this make the Assyrians blossom?

In prophecy why are all the forecasts concerning non-Israel nations always detailing them as being

servants to Israel and for them to perish if they refuse this destiny? This is so right up to the end of the age.

The promise to Abraham was to "ALL" nations without any exceptions. "All" cannot include those who are cursed and those God says that He hates. Hence "all" means all the nations of Israel.

Throughout Scripture, Israel was to dwell alone and shall not be reckoned among the nations [Num 23:9]. Prophecy sustains this to the end.

Daniel 7:27 And the kingdom and dominion, and the greatness of the kingdom under the

saints of the most High, whose kingdom is an everlasting kingdom, and all dominions shall serve him.

Isaiah 60:12 For the nation and kingdom that will not serve thee shall perish; yea, those nations shall be utterly wasted.

Zech 14:16,17 And it shall come to pass, that every one that is left of all the nations which came up against Jerusalem shall even go up from year to year to worship the King, the Lord of hosts, and to keep the feast of tabernacles. And it shall be that whoso will not come up of all the families of the earth unto Jerusalem to worship the King, the Lord of hosts, even upon them shall be no rain.

Israel and Judah were scattered among all nations, but are these other nations to be blessed? Jeremiah does not agree.

Jer 30:11—though I make a full end of all nations whither I have scattered thee, yet I will not make a full end of thee ...

This continues after Jesus returns and Israel reigns with God over the other nations. Finally there will be no more death. What a blessing! How Venice Rigged the First, and Worst, Global Financial Crash In 1340 - Part Four

Venice, the World's Mint



ENICE, WROTE BRAUDEL: was the greatest commercial success of the Middle Ages -- a city without industry, except for naval-military construction, which came to bestride the Mediterranean world and to control an empire through mere trading enterprise. In the fourteenth century she was in the ascendant to her greatest periods of success and power. And most importantly, Frederick Lane writes:

Venice's rulers were less concerned with profits from industries than with profits from trade between regions that valued gold and silver differently.

Between 1250 and 1350, Venetian financiers built up a worldwide financial speculation in currencies and gold and silver bullion, similar to the huge speculative cancer of "derivatives contracts" today. This ultimately dwarfed and controlled the speculation in debt, commodities, and trade of the Bardi, Peruzzi, et al. It took all control of coinage and currency from the monarchs of the time.

The banks of Venice were deceptively smaller and less conspicuous than the Florentine banks, but in fact had much greater resources for speculation at their disposal. The Venetian financial oligarchy as a whole, which ruled a maritime empire through small executive committees under the guise of a republic, centralized and supported its own speculative activities as a whole. The "Republic" built the ships and auctioned them to the merchants; escorted them with large, well-armed naval convoys of their empire, with naval commanders responsible to the "Committee of 10" and the magistrates for the convoys' safety. This same oligarchy maintained several public mints and did everything possible to foster centralization of gold and silver trading and coinage in Venice.

As Frederick Lane demonstrates, this was the dominant trade of Venice by no later than 1310. Like today's "mega-speculators" in currencies and derivatives, such as the Morgan and Rothschild-backed George Soros and Marc Rich, the Venetian banks and bullion-dealers were backed by large pools of capital and protection.

The size of the Venetian bullion trade was huge: twice a year a "bullion fleet" of up to 20-30 ships under heavy naval convoy, sailed from Venice to the eastern Mediterranean coast or to Egypt, bearing primarily silver; and sailed back to Venice bearing mainly gold, including all kinds of coinage, bars, leaf, etc.

The profits of this trade put usury in the shade, though the merchants of Venice were also unbridled in that practice. Surviving instructions of Venetian financiers to their trading agents in these fleets, specify that they expected a minimum rate of profit of 8 percent on each

six-month voyage from the exchange of gold and mainland of Italy, to your places beyond the sea silver alone: 1620 percent annual profit.

One astonishing speech to the Council of 10 by Doge Thomasso Mocenigo, from a time after the 1340's financial crash, goes further. Compare the magnitude of these figures to those discussed earlier for the Papacy, for England, for Florence (keeping in mind that the Venetian standard coin, the gold ducat, was roughly comparable to the Florentine gold florin):

"In peacetime this city puts a capital of 10 million ducats into trade throughout the world with ships and galleys, so that the profit of export is two million, the profit of import is two million, export and import together four million [from the two annual voyages, 40 percent profit --PG].... You have seen our city mint every year 1,200,000 in gold, 800,000 in silver, of which 5,000 marks (20,000 ducats) go annually to Egypt and Syria, 100,000 to your places on the 50,000 ducats, to England and France each 100,000 ducats--"

How was this possible? Not by private enterprise, but by imperial Venetian state usury.' The gold from the East was being looted out of China (until then the world's richest economy) and India by the murderous Mongol empires, or being mined in Sudan and Mali in Africa and sold to Venetian merchants, in exchange for greatly overvalued European silver. The silver from the West was being mined in Germany, Bohemia, and Hungary, and sold more and more exclusively to Venetians with bottomless supplies of gold at their disposal. Coinages not of Venetian origin were disappearing, first in the Byzantine empire in the twelfth century, then in the Mongol domains, then in Europe in the fourteenth century.

The Great Pyramid, Khafre & Menkaure Pyramid **Geometry Encoded Into** The New Zealand Landscape (4) By Martin Doutré



IGURE 7: (above) The red triangle is a replica of half the Great Pyramid X 20. It's not quite a 3,4,5 triangle as the Great Pyramid has a slope angle of 51.84-degrees (1.290-degrees less than Khafre).

The line running up the coast proceeds for 9620.86 feet from the Benchmark cleft, at 339.98-degrees azimuth, to the eastern end of a flat cut shadow cleft terrace 63 feet beyond the summit, on the northern slope of the steep coastal hill. From there the line turns 90-degrees and runs for 7560 feet, brushing an important large boulder marker within the Kerr Rd Observatory complex. Although the corner end marker position has not as yet been recorded, the return line back to the Benchmark Cleft exactly dissects the stand of large obelisks that constitute the site's most important position.

The lack of the corner marker is due to the position of Kerr Road itself, as the marker would reside up on the ridge line where the road is situated and seems to have been eradicated during road construction. The fact that Kerr Road Observatory's most important markers are dissected by incoming and outgoing lines lends credence to the corner marker having resided at the theorised position.

The length of the hypotenuse line to the Benchmark Cleft is 12235.79 feet, consistent with 20 X 611.7894615 feet (the calculable length up the side of the Great Pyramid if it had a capstone (which it never did). The azimuth

This means the azimuth angle from the Benchmark Cleft to the pyramid corner at Kerr Road was designed to be 18.144-degrees. The length of the Great Pyramid's base was 756 feet or 9072 inches and 2 X 9072 = 18144. Again, it's the hypotenuse angle that codes the orientation of this giant overland triangle. The distance of 18144 feet would be 1/7200th of the circumference of the Earth under the ancient Egyptian sexagesimal geodetic system. A distance of 18.144 inches would be 1/500th of the base length of the Great Pyramid.

The green triangle is a two-dimensional representation of the Great Pyramid X 10 in scale. Again the apex of the pyramid is tied to the northern Waitapu Valley ridge pillar. The line to the steep coastal hill runs for 6117.9 feet at an azimuth angle of 301.82-degrees and resolves nicely upon the small centre summit plateau. From there the line turns and runs for 7560 feet to the Kerr Road Observatory. The corner marker has not been recorded, as it was undoubtedly eradicated when Kerr Road was built. The return line from the corner runs back through an impressive boulder cairn marker and brushes another sighting pit with a boulder marker on its western edge.

THE MENKAURE PYRAMID **GEOMETRY**

The Menkaure Pyramid, with a base length of 356.4 feet, is less than half the size of the Great Pyramid and marginally more than half the size of Khafre. Like the Great Pyramid it was designed to have a face angle of 51.84-degrees. In order to fix its codes into the New Zealand landscape, the ancient surveyors had to scale it to 40 X its actual size. This is how it looks in the Waitapu Valley region.

angle of this return line was 198.144-degrees. to be 341.04 degrees. The line (yellow) reaches the southern face of a tor mound on the ridge. The coastal line is 9072 feet or 4536 feet X 2. The Great Pyramid was 9072 inches long and 453.6 feet high to the top of its flat altar floor. In this very important height are the codes for remembering the equatorial size of the Earth under a sexagesimal geodetic system. The line turns 90-degrees and runs for 7128 feet to resolve in the near vicinity of several recorded markers. It appears we'll have to return to the Kerr Road site to record more of the markers there, as a definite corner position for this geometry has not yet been verified. This orientation seems to be the likeliest as the azimuth angle from the Benchmark Cleft is 19.2-degrees...a much used ancient number. The distance to the Benchmark Cleft, under this theorised coding, was 11536.60 feet at 199.2degrees azimuth.

> The above orientation of the giant triangle appears to be the likeliest, although there were several other subtle possibilities.

> As far as the smaller version Menkaure representation is concerned (purple) it's a perfect fit on all points. From the ridge pillar of the northern Waitapu Valley the line extends for 5768.3 feet to fall on a boulder cairn north of the coastal hill's tor mound. The azimuth angle of this line is very positively coded at 301.5degrees to provide a return angle of 121.5degrees. This number is a major lunar code that was much used for tracking the progress of the moon during the 6804-day lunar nutation cycle.

> The distance of 12150 feet also extends, in another coded instance, from the Benchmark Cleft to the crown boulder cairn on the summit of a hill at the intersection of Hood and Kerr Roads.

> From the coastal hill the Menkaure line runs for 7128 feet and resolves exactly upon the main obelisk position of the Kerr Road site. It then turns and runs back to the pillar on the ridge at an azimuth angle of 197.82-degrees.

There can be no question about the inclusion of this particular, two-dimensional, Menkaure representation, as at all points the triangle is positively marked to produce the pyramid configuration at 20 X true scale.

It's obviously no coincidence that 4 isolated sites, complete with their own compact array of purpose built structures and separated by a considerable distance (over 2-miles between hypotenuse markers), happen to be situated so conveniently in relation to each other. The increased scale, two-dimensional pyramid geometry for the 3 Giza pyramids could most certainly be demonstrated by using all 4 sites combined. If the ancient people weren't using the sites in this manner, THEN THEY BLOODY-WELL SHOULD HAVE BEEN...because that's what the sites are perfectly set up to do.




Figure 9: (above) This is how the seaward cliff line geometry for the 3-pyramids works out, as it resolves upon the much modified hill about 1.8 miles north of the Benchmark Cleft. The red lines relate to Great Pyramid geometry and these resolve to positions just beyond the summit or right onto the small summit itself. The blue lines relate to Khafre Pyramid geometry and they resolve to the southern side of the summit position or east of it on an assembly plateau. The yellow lines relate to Menkaure geometry and they resolve to a marker just north of a double hump, ridge tor mound or onto the southern inclined face of the tor mound itself. The distance between the most northerly resolving position (Great Pyramid) and the most southerly (Menkaure) is 578 feet. Each small blue circle shown represents the centre of a purpose built structure. These relationships are far too good to have happened by chance!

To determine the resolving corner positions of the pyramid geometry, angle and distance

calculations would have been carried out from the central ridge pillar some 6100 feet SE of the sea cliff hill's summit. There are many varied type markers on the sea cliff hill, each one relating to coded distance or angles when used in conjunction with other associated, distant overland markers. Very good relative accuracy in the placement of markers could nave been achieved by use of manual surveying instruments.




Figure 10: (above) This is the way the corner positions of the pyramid geometry would relate to structures on the Kerr Road Observatory site. The red lines are Great Pyramid geometry and these corner positions would have been eradicated in the construction of Kerr Road. The blue lines relate to the Khafre Pyramid geometry, giving good relationships to positions surveyed. The yellow lines relate to Menkaure Pyramid geometry, providing a solid hit onto the Kerr Road central obelisk position and another yet to be verified, which is close to surveyed structures.

So, let the reader be the judge. These sites have lain in ruination for a very long time and haven't been in use for centuries, but are still more or less intact. Remember, this geometry is in an exact scale to each of the 3 Giza Plateau Pyramids of Egypt. Anyone who chooses to do so can go to the Waitapu Valley region and view the structures, take GPS fixes on their positions and duplicate the analysis written about herein.

Our American Identity (Part 3) By Dr. J. Stanley Barnes



Another Jew, Sigmund Freud, invented psychoanalysis. Though the whole system of thought is purely Freud's own creation and is totally non-medical and non-scientific it has been amazingly seductive, being accepted today throughout Western medicine. New settlers in Ireland at the time of the Assyrian conquest of Israel (ca. 721 B.C.) were called "Tuatha de Dananns" meaning "Tribe of Dan." Early inhabitants of Ireland were called Dan-onians.

Ptolemy was a scholar who lived in the second century A.D. in Alexandria, which was a centre of learning in ancient times. In Ptolemy's map of Ireland we find Dan-slough, Dan-sower, Dansobairse, Dan's resting place, Dan's habitation, and Dan-gan castle (birthplace Duke of Wellington.

In Scotland we find the Don River, the Doon River, and places called Dun-dee, Dun-raven, E-din-burgh, and Dun-oon (scene of the world championship hammer-throwing contest).

Early inhabitants of Norway were the Don-sk people.

Ancient Greece was populated, in part, by the Dan-oi.

A map of Italy at the time of Julius Caesar will show an area near Rome inhabited by Umbrians (from the Latin for "Hebrews") and an adjacent section of Sesones (from the Latin "Simeon"--one of the tribes of Israel.)

History of Trusts From Our Dublin Correspondent

The 1st Trust of the world



NAM SANCTAM is one of the most frightening documents of history and the one most quoted as the primary document of the popes claiming their global power. It is an express trust deed. The last line reads: "Furthermore, we declare, we proclaim, we define that it is absolutely necessary for salvation that every human creature be subject to the Roman Pontiff." It is not only the first trust deed in history but also the largest trust ever

conceived, as it claims the whole planet and everything on it, conveyed in trust.

Triple Crown of Ba'al, aka the Papal Tiara and Triregnum

In 1302 Pope Boniface (left) issued his infamous Papal Bull Unam Sanctam—the first Express Trust. He claimed control over the whole planet which made him "King of the world". In celebration, he commissioned a gold-plated headdress in the shape of a pinecone, with an elaborate crown at its base. The pinecone is an ancient symbol of fertility and one traditionally associated with Ba'al as well as the Cult of Cybele. It also represents the pineal gland in the centre of our brains—crystalline in nature which allows us access to Source, hence, the 13-foot tall pinecone in Vatican Square. Think about why the Pontiffs would idolize a pinecone.

The 1st Crown of Crown Land

Pope Boniface VIII was the first leader in history to create the concept of a Trust, but the first Testamentary Trust, through a deed and will creating a Deceased Estate, was created by Pope Nicholas V in 1455, through the Papal Bull Romanus Pontifex. This is only one of three (3) papal bulls to include the line with the incipit "For a perpetual remembrance." This Bull had the effect of conveying the right of use of the

Unam Sanctam, to the control of the Pontiff and his successors in perpetuity. Hence, all land is claimed as "crown land". This 1st Crown is represented by the 1st Cestui Que Vie Trust, created when a child is born. It deprives us of all beneficial entitlements and rights on the land.

The 2nd Crown of the Commonwealth

The second Crown was created in 1481 with the papal bull Aeterni Regis, meaning "Eternal Crown", by Sixtus IV, being only the 2nd of three papal bulls as deeds of testamentary trusts. This Papal Bull created the "Crown of Aragon", later known as the Crown of Spain, and is the highest sovereign and highest steward of all Roman Slaves subject to the rule of the Roman Pontiff.

Spain lost the crown in 1604 when it was granted to King James I of England by Pope Paul V after the successful passage of the "Union of Crowns", or Commonwealth, in 1605 after the false flag operation of the Gunpowder Plot.

The Crown was finally lost by England in 1975, when it was returned to Spain and King Carlos I, where it remains to this day. This 2nd Crown is represented by the 2nd cestui Que Vie Trust, created when a child is born and, by the sale of the birth certificate as a Bond to the private central bank of the nation, depriving us of ownership of our flesh and condemning us to perpetual servitude, as a Roman person, or slave.

The 3rd Crown of the **Ecclesiastical See**

The third Crown was created in 1537 by Paul III, through the papal bull Convocation, also meant to open the Council of Trent. It is the third and final testamentary deed and will of a testamentary trust, set up for the claiming of all "lost souls", lost to the See.

The Venetians assisted in the creation of the 1st Cestui Que Vie Act of 1540, to use this papal bull as the basis of Ecclesiastical authority of Henry VIII. This Crown was secretly granted to England in the collection and "reaping" of lost souls. The Crown was lost in 1816, due to the deliberate bankruptcy of England, and granted to the Temple Bar which became known as the

land as Real Property, from the Express Trust Crown Bar, or simply the Crown. The Bar Associations have since been responsible for administering the "reaping" of the souls of the lost and damned, including the registration and collection of Baptismal certificates representing the souls collected by the Vatican and stored in its vaults.

This 3rd Crown is represented by the 3rd Cestui Oue Vie Trust

It is created when a child is baptized. It is the parents' grant of the Baptismal certificate—title to the soul—to the church or Registrar. Thus, without legal title over one's own soul, we will be denied legal standing and will be treated as things—cargo without souls—upon which the BAR is now legally able to enforce Maritime law.

The Cestui Que Vie Trust



A Cestui Que Vie Trust is a fictional concept. It is a Temporary Testamentary Trust, first created during the reign of Henry VIII of England through the Cestui Que Vie Act of 1540 and updated by Charles II, through the CQV Act of 1666, wherein an Estate may be effected for the Benefit of a Person presumed lost or abandoned at "sea" and therefore assumed "dead" after seven (7) years.

Additional presumptions, by which such a Trust may be formed, were added in later statutes to include bankrupts, minors, incompetents, mortgages, and private companies.

The original purpose of a CQV Trust was to form a temporary Estate for the benefit of another because some event, state of affairs, or condition prevented them from claiming their status as living, competent, and present, before a competent authority. Therefore, any claims, history, statutes, or arguments that deviate in as pronounced by these canons, is false and automatically null and void.

A Beneficiary under Estate may be either a Beneficiary or a CQV Trust. When a Beneficiary loses direct benefit of any Property of the higher Estate placed in a CQV Trust on his behalf, he do not "own" the CQV Trust; he is only the beneficiary of what the Trustees of the CQV Trust choose to provide. As all CQV Trusts are created on presumption, based upon original purpose and function, such a Trust cannot be created if these presumptions can be proven not to exist.

Ref Britain's exit from the EU

My Lords—, I despair I really do, you are what passes for our most senior judges yet your knowledge of the English Common and Constitutional Law appears to be woefully inadequate to the high offices you hold. I do not wish to teach you to suck eggs. But it appears I must.

Parliament which contrary to common thinking today does not reign supreme that honour falls to Her Most Britannic Majesty Queen Elizabeth the II, CONTRARY to the view expressed by the House of Commons the 1689 Bill of Rights did not transfer Sovereignty from the lawfully anointed King to the House of Commons. And on the 8th March 1784 95 years after the Declaration and Bill of Rights King George III forced a vote in Parliament as to where ultimate Sovereignty lay with him as the lawfully anointed King or with the House of Commons as the elected house. 



Skara Brae And Its Many Mysteries Scotland: The Orkney Islands by Alexis Brett



ESTLED ON A SMALL ISLAND JUST NORTH OF THE SCOTLAND mainland lies an ancient site that is just begging to be explored.

Skara Brae, (a prehistoric village that was built before the Egyptian pyramids), has been listed as one of the "Heart of Neolithic Orkney" World Heritage Sites, and it illustrates a perfect example as to why the Orkney Islands have often been referred to as "The Egypt of the North."

Because of the many mysteries surrounding both the abandonment and the discovery of Skara Brae, researchers have coined the site as "one of the most remarkable discoveries in modern archaeology" as it contains one of the best preserved Neolithic villages known to mankind. "Skerrabra"

Skara Brae is approximately 5,000 years old and is located about eight miles away from the small town of Stromness on the southern shore of the Bay O' Skaill. Although it was originally thought that the site was a Pictish village, researchers now believe that the settlement was actually an Orcadian village that was inhabited between the years of 3200 and 2200 BC.

Even though it was deserted thousands of years ago, the village still remains in mint condition and to this day researchers still can't pinpoint exactly why the last inhabitants left; which only adds to the mystery surrounding Skara Brae.

Skara Brae was discovered in 1850 after a severe windstorm "ravaged" the Orkney mainland and uncovered the land that was sheltering the abandoned settlement for thousands of years.

The first person to discover the site was William Watt of Skaill, who at the time resided at the Skaill House which is located no more than 200 metres away from Skara Brae. (Ironically enough the Skaill House is also said to be haunted as there have been reports of people seeing a ghostly figure of a woman wearing a shawl in one of the windows).

The Skaill House was built in 1620, and even though the Skaill family owned the house for two hundred years before the discovery of the village, none of its former residents had realized just what was sitting in their backyard underneath the piles of sand and dirt.

But it wasn't until 1925 when another storm revealed even more of the village, and it was at that time when researchers truly realized the treasure that had been literally under their noses the whole time. A sea-wall was then built to protect the newly discovered settlement, and soon after scientists uncovered a village with eight different houses, each of which were linked in the settlement, (like elaborately-decorated together by underground passages.

A day in the life of Skara Brae



It is believed that Skara Brae was big enough to hold about 50 to 100 villagers at any given time, and that it was inhabited for approximately 600 years.

Because the village was built into mounds of "pre-existing rubbish" the village sunk underground and protected the village from any unwanted visitors and/or predators. Not only that, because the mounds of hills provided a much needed insulation for the homes, the people were also protected from the infamous Orkney windstorms which could last for days or even weeks at a time.

The walls of the village were built with sandstone slabs and the houses were covered with thatched roofs and possibly whalebones. Each of the houses were also designed identically with a fireplace in the centre as well as two beds, dressers and storage units, and even a small fish-filled bait box made of stone that was built into the floor. The fireplace was used for cooking and heating and the stone beds were filled with bracken and heather for comfort, and they were also covered with animal skins for warmth as well.

The only building that differs from the rest is said to be the "Village Workshop" after numerous tools and stone-made weapons were uncovered when researchers were digging throughout the room. There is also another separate area which is believed to have been used as a modern-day compost as the inhabitants seem to have used it to store garden and waste materials.

Researchers also believe that the original occupants were very skilled in working with bone and stone because they found different items, tools and artefacts that were left behind pottery, needles, shovels, picks and weapons).

The villagers also used volcanic pumice that could have been washed up on the shore from Iceland to help shape the bone tools and stone balls, and over 2,400 inscribed beads and hundreds of bone necklaces were found in one of the stone cupboards as well. It is believed that many of these objects resembled one's symbol of status or may even have been used for ritualistic purposes. It is also thought that the dressers which were sitting directly across from the doorway were used to "show off" any prized possessions and/or hunting trophies whenever a visitor entered the home.

Although it is assumed that those who lived within the walls were a part of a tight-knitted community, experts still can't decide as to whether there was a hierarchy among the villagers or whether the villagers were equal. And even though there hasn't been a lot of evidence revealing any sort of religion and/or tradition within Skara Brae, researchers have associated the Skara Brae way of life with the traditional Orcadian beliefs in that the worship or ancestors, gods and spirits was more than likely the norm for the community.



After spending a great deal of time studying the surroundings of the settlement, it is also believed that the original inhabitants were farmers who raised cattle and sheep and possibly grew barley and wheat on the fertile land nearby. Their diet consisted of deer, seabird eggs and various other types of seafood like mussels, shellfish, oysters, crab, cod and saithe.



Given the fact that the sky covering the Orkneys remains dark for over half of the year, it is also said that the villagers more than likely used to gather within the homes of Skara Brae around a bonfire and tell stories and sing songs. (And because the village was windowless, the interior of the village researchers also believe that most of the rooms and passageways must have been extremely dark and smoky due to the fact that only one bonfire was placed in the centre of each room.

An abandoned mystery

Because many belongings and artefacts were left behind in the village and stored carefully away in the cupboards, some believe that Skara Brae was abandoned because of an "apocalyptic" event and/or disaster which forced the villagers to flee their home.

However, it is now thought that Skara Brae was abandoned because of coastal erosion as well as changes of the weather, especially because the villagers would have had to have been locked up inside their homes for weeks or even months at a time because of strong winds and storms which now are associated with the Orkney way of life.

Not only that, because Skara Brae is located next to the ocean, it would have been extremely difficult to maintain the village with the salt water splashing across the land and destroying the homes, and scientists now believe that the ocean was once much further away from the village than it currently is today.

So what happened to the inhabitants after they deserted their homes?

The answer is still unclear; however it is known that after Skara Brae was abandoned around 2200 BC and records show that the Vikings didn't actually settle in the Orkneys until about 787 AD. And because researchers are struggling to determine exactly what happened to Skara Brae's original inhabitants, it only adds more fuel to the mysterious fire surrounding the ancient village. But thousands upon thousands of tourists are drawn to the Orkneys each year not only to check out the haunting site for themselves, but to also view several other ancient sites scattered around the Orkney mainland as well.

Believe it or not, Skara Brae is just one of many examples of the haunting and mysterious sites on the Orkney mainland. Just five miles away are two stone circles - the Standing Stones of Stenness and the Ring of Brodgar - both of which can be compared to the likes of Stonehenge. (It is believed that the Orcadians at that time used both of the stone to monitor the stars, worship the gods, or perhaps even to mark the gravesites of authoritative figures in the village, but their purpose still remains debatable).

And not just seven miles away from Skara Brae also lies Maeshowe, the ancient tomb which was believed to have been built around 2700 BC. To add mystique to the site, researchers also discovered that sometime in the mid-12th century a group of Vikings entered the tomb and started to tag the walls with graffiti. (Some of the many tags include "Thorni bedded Helgi" and "Ofram the son of Sigurd carved these runes").

These are just some of the many examples as to why anyone who has a passion for archaeology and history should not only visit Skara Brae, but the other several ancient sites scattered around the Orkney mainland as well.

A Megalith At The Centre Of Brighton From Our Sussex Correspondent





OME YEARS AGO, WHEN SPEND-ING A WEEK IN BRIGHTON and taking a short cut to the station through a small alleyway called Zion Gardens, near the Clock Tower, I suddenly came across a megalith standing firmly on the edge of the pavement. It took me completely by surprise, but from my experience in tracking down these stones one gets accustomed to recognising wherever they are.

They belong to the class of what are known as Sarsen Stones, i.e. stones that do not belong or are not indigenous to any particular area. I have never heard of any circles or avenue of stones in the Brighton area, but later when I came to live in Brighton I began to read up the history of the place and discovered that the mound on which stands the Church of St. Nicholas was originally a megalithic centre, crowned with a Bronze Age tumulus (burial ground) and that avenues of stone led up - at any rate - from the south and east; and that what is now Church Street leading directly from the Old Steine marked one of the routes leading to the mound.

Originally Old Steine was the point of confluence of two rivers which flowed from the high ground up by Hollingbury and terminated by way of what is now the London road and Lewes road until reaching the port or entrance to Brightlingstone at the site of the Pool or harbour where Pool Valley now is.

The mound of St. Nicholas, in common with many others of its kind, was the sacred gathering-place for the community. In those days (as I have often stated) the People Who erected this site were well aware of the purpose for which it was brought into being and in their ritual would

co-ordinate with the dual forces of nature, the centripetal and centrifugal, the feminine and masculine movements. There is more than an outward reason for styling St. Nicholas Church as the mother church of Brighton, for not only has it always been so but it is the parish church of the town and not St. Peter's, which has been wrongly so called and really belongs to Preston. So now we take up the story where it comes into line with my partner's psychometric interpretation as given on the spot on a later visit.

It must be borne in mind that Miss Campbell knew nothing whatsoever about the site or my findings before going there. I had, of course, told her nothing about the place prior to visiting it and we entered the churchyard just as we might if visiting any other place. This is the interpretation which she gave me:

"This was formerly a sun-worship site, but I do not so far pick up any great ritual. I feel that this was a magnetic centre to which people were drawn, and as they performed their simple act of worship to the sun as solar deity and felt the warmth of His Being within themselves, so they came to feel one with the Solar Being and to recognise His Absoluteness.

According to Arthurian literature expert Peter Field, Camelot used to stand at the site of an ancient Roman fort called Camulodunum in Slack, West Yorkshire in the UK, which would have been an ideal spot in 500 AD, when King Arthur is argued to have existed as a real-life military expert tasked with defending England from invaders.

"It was quite by chance. I was looking at some maps, and suddenly all the ducks lined up," Field, who taught at Bangor University in the UK from 1964 to 2004, told the BBC.

Field presented his findings during the official launch of Bangor University's Stephen Colclough centre for the history and culture of the book last week.

His hypothesis is yet to be peer-reviewed, so to be clear, a whole lot more research needs to be done before we can read too much into it.

RETIRED PROFESSOR FROM ogists have been unable to confirm if King Arthur and Camelot existed outside of the legends at all.

As Bec Crew explained for us earlier this year:

"Despite the fact that the mythological figure has been wildly popular for centuries, no one's actually been able to prove he existed. But what makes Arthur so intriguing is the way we can tie certain historical places and events to him."

But if we take a big leap and assume Camelot did exist, where was it?

Previous research has suggested that it could have been in places like Caerleon in South Wales or Cadbury Castle in England. But so far, there's not been enough archaeological evidence to tie any physical place to the legend.

"I believe I may have solved a 1,400 year old So Field did additional research based on the historical forts of the time and compared them to the legend of King Arthur. He says the site that best fits Camelot was the modern-day village of Slack.

> Looking at Slack today, you'd be hard-pressed to find a reason why someone would want to build a stronghold in what looks to be a mere clearing, but Field says the location was once of great military importance.

To add to Field's hypothesis, in Roman times, the fort at Slack was thought to be named Camulodunum, which researchers think might have changed linguistically over the years to become Camelot.

And that could explain why the first mention of Camelot only surfaced in literature many years after King Arthur's suspected rule.

"If there was a real King Arthur, he will have lived around [500 AD], although the first mention of him in Camelot is in a French poem from the Champagne region of France from 1180 [AD]," said Field.

"There is no mention of Camelot in the period between those dates, known as the Dark Ages, when the country was at war, and very little was

It turns out that Slack, which is seemingly in the recorded. In this gap, people passed on information, much got lost in transmission, and people may have made up facts or just messed up known information."

> Without some type of physical proof in the form of archaeological remains, we won't be able to confirm if Field is onto something here. But he's not the only researcher seeking out the legendary artefacts.

> Earlier this year, a team of British archaeologists uncovered a series of massive walls that appear to be from the Dark Ages at a location thought to be tied to the Arthurian legend.

> The researchers suggested that these walls were once part of the palace where King Arthur was born, and they're currently excavating the site to uncover more details.

> But while it's fun to think that the King Arthur of legend - who had a roundtable and hung out with a wizard named Merlin - did actually exist, some experts claim that the Arthurian legend might actually be a hodgepodge of different British rulers coming together into a single, unified story.

> So far, Field - who's been researching Slack for the past 18 months - hasn't mentioned taking his idea further into a physical dig at the site.

> But hopefully, his hypothesis will prompt further archaeological study at this site or others like it, so we can finally get some real clues into the enduring mystery of King Arthur, or the real-life kings who inspired the legend.






