# Daniel's Seventy Weeks Fulfilled in Yahshua Messiah

## Part 4- Pastor Eli James



### The futurist makes this assertion:

The error of interpretation is that Shea assumes that the one who makes a firm covenant with many is the

anointed one, but the text indicates that it is the prince whose people shall destroy the city and the sanctuary.

Here, the futurist is completely mistaken. This is another gross error. In the light of the entire foregoing discussion in this sermon, the futurist doesn't know what he is talking about. There can be only **ONE ANOINTED ONE**; and that is Jesus Christ. The Judahites of Judea would never consider anointing the leader of an invading army. The idea is patently absurd. What other covenant could possibly be implied here? The "covenant" must be with Israel, so the futurist must supply the historical record of this "covenant," just as we have provided the documentation of Artaxerxes' decree.

Of course, he provides no such documentation, so his analysis is nothing but uneducated speculation. Jesus told us to be wary of these false prophets. The futurists make matters even worse by insisting that the leader of this invading army is none other than the anti-Christ. But Daniel 9 says **ABSOLUTELY NOTHING ABOUT THE ANTI-CHRIST!** This is pure invention on the part of the false prophets of Judeo-Christianity!

### Sorting Out the Language of Daniel 9:25-26

#### Let's look at what Daniel 9:26 really means:

**26 And after threescore and two weeks shall Messiah be cut off**, but not for himself: [This is exactly what happened. The Messiah was cut off after the 69th week, shedding His Blood for

Israel.] and the people of the prince that shall come shall destroy the city and the sanctuary [The Messiah is not referred to as "Prince" in verse 26. Here, the KJV translators got it right!! The lower case 'prince' is a reference to General Titus of the Roman Army.

It was under Titus that the Temple was completely demolished in 70 AD. Again the futurist is guilty of an outlandish interpretation, which is nothing but pure speculation]; and the end thereof shall be with a flood, and unto the end of the war desolations are determined. [The war between the Romans and Judeans was an especially bloody war. At least 1.5 million Judeans were killed in the fighting from 70 AD until 133 AD.]

**Verse 26 says that Messiah shall be cut off** and then **ANOTHER** "prince" [Hebrew #5057, *ragid*, meaning "commander, prince, chief" – not Messiah the Prince, as in Verse 25] will destroy the city and the sanctuary. This is a brief prophecy contained within the verse, namely, that a future "prince," who will appear after Messiah has come, will destroy Jerusalem. This is exactly what Titus and the Roman army did in 70 AD.

To fail to understand this historical sequence of events is to display egregious ignorance regarding the known history of that time. But the futurist nonsense does not end there.

To further confuse matters, futurists mix up the timing of Verse 27 with their already confused timing of verses 25 and 26. This is the origin of the division of the 70<sup>th</sup> week into two periods of 3&1/2 years. Verse 27 says nothing of the kind.


### The Historicist View Confirmed Daniel 9:27:

**27** And he [Messiah] shall confirm the covenant with many for one week: and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate.

Again, these events happened exactly as prophesied. Yahshua confirmed the Covenant with His people, Israel, during the final week of the 70 weeks prophecy.

The usual interpretation of this verse is that, in the midst of the last prophetic “week” of 7 years, Jesus was baptized by John, and He began His ministry, which was to announce and establish the New Covenant, which would abolish the sacrificial ordinances that were practiced by the Levitical priesthood since the days of Moses. The Last Supper was the actual event at which the New Covenant of Jeremiah 31:31-37 was instituted.

All of this was **FINISHED** on April 3, 33 AD.



But the futurists twist this language to mean the appearance of “the abomination of desolation” at the end of days. But the construction, “abomination of desolation” is NOT referenced in Daniel 9:27. The “abomination of desolation” was a term applied to Antiochus Epiphanes (above), the Greek invader who had sacrificed pigs on the altar of the Temple during the days of the Maccabees.

**Daniel 9:27** is clearly saying that Messiah shall confirm the Covenant of ritual sacrifice for one week, **UNTIL HE HIMSELF ABOLISHES THAT PRACTICE WITH HIS OWN SELF-SACRIFICE – MESSIAH HIMSELF BEING**

**THE LAST SACRIFICE UNDER THE OLD COVENANT!!!** (I Cor. 5:7-8; Hebrews 10:1-18.)

During His final week on earth, at the Last Supper, Jesus declared the **NEW COVENANT**. So, at the Last Supper, Yahshua officially declared the fact that the Temple sacrifices and oblations would cease! This occurred in 33 AD, just before the Crucifixion. It would take until 70 AD before the “overspreading of abominations” in this Temple by the Edomite Jews would be stopped by General Titus of Rome. By twisting the construction, “overspreading of abominations” into “abomination of desolation,” the futurists have performed a subtle trick, a clever little piece of sleight of hand, the old “switcheroo,” substituting a phrase which has a completely different meaning from what Daniel is actually saying! Aside from the fact that both phrases contain the word ‘abomination,’ there is nothing equal about them!

Daniel is telling us about the destruction of the Temple, because of the **OVERSPREADING OF ABOMINATIONS THEREIN**, which was at that time under to control of the Edomite Pharisees, who had usurped the priesthood of Israel, wrenching it away from the House of Judah, and who had continued to practice their ritual sacrifices, imitating the rituals of the true Judahites, until Titus put an end to their abominations.

The Roman Army was actually doing God’s work, bruising the head of the SERPENT, by putting Satan’s priesthood out of the business of ritual sacrifice. This is actually a partial fulfilment of Gen. 3:15, in which the seed of Eve will eventually CRUSH the head of the Serpent.

In a brilliant piece of historical research, Clifton Emahiser puts it this way:

“The death of Yahshua was not the bruising of the head of the serpent, but the bruising of the heel of the Messiah for He rose again—In Romans 16:20, Paul told the Romans that they would soon tread upon the head of Satan.

By Yahshua using the Romans as his representatives to do this, suggests very strongly, with this “bruising,” He was **NOT** acting in a singular individual sense. No doubt, this

bruising took place when the Roman army besieged Jerusalem, for the majority of “Jews” there at that time were of their father, Satan.



**Romulus and Remus**

“Those who know the story of the establishing of Rome, understand it was founded under the sign of the wolf, Romulus and Remus. This is the insignia of Benjamin. In other words, many of the Roman soldiers under Titus were Benjmaites. Also, Zarah-Judah had settled in that same area at one time and probably had a bigger role than imagined, and was in all likelihood part of that Roman army.”

With all of the Apostles, except Judas, being Benjamites of Galilee, and the Roman garrisons containing at least some Benjamites and Zarah-Judahites of the Dispersion, it becomes obvious that “the people of the prince” in Dan. 9:27 were Roman Israelites! Praise Yahweh! This has **NOTHING** to do with any anti-Christ! It would eventually be these Israelites of the Dispersion, who would crush the head of the Jewish serpent in 70 AD!!!! They were brought back to Judea by Yahweh Himself to do the job!!! I can’t wait for that job to be finished, once and for all!!!

Dear reader, I hope you are appreciating the fact that these prophecies of Daniel have been fulfilled to the letter, while the futurists can only dance around the prophecies like so many Injuns!!!

The consummation is a reference to the Day of Judgment, when all abominations will be destroyed; and nothing will be left of the modern “abomination of desolation,” which is none other than the Zionist Israeli State, under **THEIR PRINCE of Mystery Babylon, Rothschild.**

### **The “Third” Temple**

We know that the rabbis of Israeli fully intend to reestablish the ritual sacrifices in a proposed

“O Jerusalem, Jerusalem, you that kill the prophets, and stone them which are sent to you, how often would I have gathered your children together, even as a hen gathers her chickens under her wings, **AND YOU WOULD NOT!!!! BEHOLD, YOUR HOUSE IS LEFT UNTO YOU DESOLATE.** For I say to you, **YOU SHALL NOT SEE ME HEREAFTER, TILL YOU SHALL SAY, ‘Blessed is He that comes in the name of the Lord.’”** ((Matt. 23:37-39.)

Don’t hold your breath, waiting for the Jewsrailis to adopt Christianity!!!!



**1 Samuel 8:8** – *According to all the works which they have done since the day that I brought them*

up out of Egypt even unto this day, wherewith they have forsaken me, and served other gods, so do they also unto thee.

**1 Samuel 8:9** – Now therefore hearken unto their voice: howbeit yet protest solemnly unto them, and shew them the manner of the king that shall reign over them.

**Samuel 8:10** – And Samuel told all the words of Yahweh (the LORD) unto the people that asked of him a king.

**1 Samuel 8:11** – And he said, This will be the manner of the king that shall reign over you: He will take your sons, and appoint [them] for himself, for his chariots, and [to be] his horsemen; and [some] shall run before his chariots.

**1 Samuel 8:12** – And he will appoint him captains over thousands, and captains over fifties; and [will set them] to ear his ground, and to reap his harvest, and to make his instruments of war, and instruments of his chariots.

**1 Samuel 8:13** – And he will take your daughters [to be] confectionaries, and [to be] cooks, and [to be] bakers.

**1 Samuel 8:14** – And he will take your fields, and your vineyards, and your oliveyards, [even] the best [of them], and give [them] to his servants.

**1 Samuel 8:15** – And he will take the tenth of your seed, and of your vineyards, and give to his officers, and to his servants.

**1 Samuel 8:16** – And he will take your menservants, and your maidservants, and your goodliest young men, and your asses, and put [them] to his work.

**1 Samuel 8:17** – He will take the tenth of your sheep: and ye shall be his servants.

**1 Samuel 8:18** – And ye shall cry out in that day because of your king which ye shall have chosen you; and Yahweh (the LORD) will not hear you in that day.

**1 Samuel 8:19** – Nevertheless the people refused to obey the voice of Samuel; and they said, Nay; but we will have a king over us;

**1 Samuel 8:20** – That we also may be like all the nations; and that our king may judge us, and go out before us, and fight our battles.

**1 Samuel 8:21** – And Samuel heard all the words of the people, and he rehearsed them in the ears of Yahweh (the LORD).

**1 Samuel 8:22** – And Yahweh (the LORD) said to Samuel, Hearken unto their voice, and make them a king. And Samuel said unto the men of Israel, Go ye every man unto his city.

Here we can see a significant part of Israel's history.

Israel have failed to follow Yahweh's laws on and off for hundreds of years, so Yahweh allows them to have a king of their own.

However he warns that it will not be without costs. There will be the matter of the king taking Israel's sons and daughters and the charging of taxes on Israel, i.e. a tenth here, a tenth there.

**1 Samuel 16:1** – And Yahweh (the LORD) said unto Samuel, How long wilt thou mourn for Saul, seeing I have rejected him from reigning over Israel? fill thine horn with oil, and go, I will send thee to Jesse the Bethlehemite: for I have provided me a king among his sons.

Following Yahweh granting Israel a king, Israel chose Saul, who as we can see above was subsequently rejected by Yahweh.

Yahweh then told Samuel to anoint a king he had chosen from the sons of Jesse the Bethlehemite.

**1 Samuel 16:11** – *And Samuel said unto Jesse, Are here all [thy] children? And he said, There remaineth yet the youngest, and, behold, he keepeth the sheep. And Samuel said unto Jesse, Send and fetch him: for we will not sit down till he come hither.*

**1 Samuel 16:12** – *And he sent, and brought him in. Now he [was] ruddy, [and] withal of a beautiful countenance, and goodly to look to. And Yahweh (the LORD) said, Arise, anoint him: for this [is] he.*

**1 Samuel 16:13** – *Then Samuel took the horn of oil, and anointed him in the midst of his brethren: and the Spirit of Yahweh (the LORD) came upon David from that day forward. So Samuel rose up, and went to Ramah.*

David is anointed as Israel's second king, only this time he is a king of Yahweh's choosing.

As we know Israel are the pure white race, this was clear from the fact Adam was of, "ruddy face," but yet again it is pointed out here that David was, "ruddy."

**2 Chronicles 20:34** – *Now the rest of the acts of Jehoshaphat, first and last, behold, they [are] written in the book of Jehu the son of Hanani, who [is] mentioned in the book of the kings of Israel.*

So we have: The Book of the Law of Yahweh; The Book of the Wars of Yahweh; The Book of Nathan the Prophet; The Book of Gad the Seer; The Prophecy of Ahijah; The Visions of Iddo; and The Book of Jehu.

Many people believe the Bible is the be all and end all of Yahweh's word, but if these books are unimportant, then why are they mentioned in the Bible, why are they being withheld from us today, and who is withholding them?

# Old Testament

## “ Word for Word” Part 3

#### Genesis Chapter 4

4 1. [Note - Verse 1 is considered corrupted - see Chapter Notes] And the Adam knew 3045 Chawwah his woman, and she conceived 2029, and bare 3205 Qayin 7014, and said, "I have acquired 7069 a man 376 by [Yahweh]."

2. And again 3254 she conceived, and bare his half-brother 251 Hebel 1893. And Hebel became a tender 7462 of a flock 6629, and Qayin became a tiller 5647 of the soil 127.

3. It came to be 1961 after 7903 a time 3117 that brought Qayin of the fruit of the soil as a gift offering 4503 to Yahweh.

4. And Hebel brought also 1571 from the first-born 1062 of his flock, from the fattest 2459. And gazed 8159 Yahweh upon Hebel and his gift offering:

5. But to Qayin and to his gift offering He did not gaze. And was kindled 2734 the anger of Qayin very much 3966, and fell 5307 his countenance 6440.

6. Said Yahweh to Qayin, "For what 4100 is kindled your anger? And for what has fallen your countenance?"


7. Surely 3808 if 518 you do well 3190 there is uplifting 7613, but if you do not do well, at the door 6607 sin 2403 lies down 7257: and to you is his longing 8669, and you 859 he shall rule 4910."

#### The first murder - see John 8:44

8. And said Qayin to Hebel his half-brother, "Let us be in the field." And rose up 6965 Qayin against 413 Hebel his half-brother, and murdered 2026 him.

9. Said Yahweh to Qayin, "Where 335 is Hebel your half-brother?" And said Qayin "I do not know: the keeper 8104 of my half-brother am I 595?"

10. And He said, "What 4100 have you done? The voice 6963 of the blood 1818 of your half-brother calls out 6817 to Me from the soil!"



11. And now 6258 cursed 779 are you from the soil that has opened 6475 its mouth 6310 to take 3947 the blood of your half-brother from your hand 3027.

12. When you till the soil it will not again 3254 give you its strength 3581; a tottering 5128 wanderer 5110 you shall be in the land."

13. Said Qayin to Yahweh, "Greater 1419 is my punishment for iniquity 5771 than I can bear 5375.

14. Behold 2005, You have driven Me out 1644 this day from upon the face 6440 of the soil 127; and from Your presence 6440 shall I be absent 5641; and I shall be a tottering wanderer in the land; and it shall be that all who find 4672 me will slay 2026 me."

15. And said Yahweh, "Therefore 3651 any that slays Qayin, sevenfold 7659 vengeance 5358 shall be taken upon him." And put 7760 Yahweh upon Qayin a sign 226, lest 1115 smite 5221 him any who find 4672 him.

16. And went forth 3318 Qayin from the presence of Yahweh, and dwelled 3427 in the land of Nod 5113, eastward of Eden.

### Qayin's Seedline

17. And knew Qayin his woman; and she conceived, and bare Chanoch 2585: and it was, he built 1129 a city 5892, and called the name of the city by the name of his son 1121 Chanoch.

18. And born to Chanoch was Iyrad 5897: and Iyrad begat 3205 M'chuyael 4232: M'chuyael begat M'thushael : w'M'thushael begat Lemech 3929.



19. And took Lemech two 8147 women: the name of one was Adah 5711, and the name of the second 8145 was Tsillah 6741.

20. And bare Adah Yabal 2989: he became the forefather 1 of the dwellers 3427 in tents 68, with livestock 4375.

21. And the name of his brother was Yubal 3106: he was the forefather of all such as wield 8610 the harp 3658 and reed instruments 5748.

22. And Tsillah, she also bare Tubal-Qayin 8423, an instructor 3913 of all fabricators 2794 in bronze 5178 and iron 1270: and the sister 269 of Tubal-Qayin was Naamah 5279.

23. And said Lemech to his women, Adah and Tsillah, "Hear my voice; women of Lemech, give ear 238 to my speech 565: for a man 376 I have slain by my wounding 6482, and a lad 3206 by my blow 2250.

24. Because if sevenfold avenging for Qayin, truly Lemech seventy 7657 and seven 7651."

### End of the seedline of Qayin

25. And knew the Adam again 5750 his woman, and she bare a son 1121, and he called his name Sheth 8352: because appointed 7896 Elohiym another 312 seed 2233 in place of 8478 Hebel, that was murdered by Qayin.

26. And to Sheth, also he begat a son, and called his name Enosh 583: then 227 they began 2490 to call upon 7121 The Name of Yahweh.

### Chapter 4 Notes

**Verse 1** - This verse is considered corrupted! The word use and mistranslations have been skewed by scribes.

Chawwah had been seduced by the Enchanter back in the garden, and was carrying his child when she and the Adam were ejected by Yahweh. she had taught the Adam about sex back in the garden, and he had her again when they were outside. A man can still have sex with a pregnant woman, so he did.

Her pregnancy was recent, so he did not suspect anything YET. Chawwah acquired a male child with...? It is listed in several texts (Septuagint - (LXX)- and the Syriac) that [Yahweh] is incorrect here, and should be Shadday 7706, as the mighty one. The Enchanter was a fallen "angel", and was certainly mightier than an adam. The very word "man"376, which is iysh, should tell you it was not the child of Adam. **Verse 8** - Qayin, son of the Enchanter, was a murderer from the beginning. John 8:44 is specific about this. Qayin is the forefather of the "synagogue of Satan" seedline. Their inclinations follow their Patriarch, The Enchanter. Reference Chapter 6:1-4 of B'reshiyth (Genesis); Yasher 1:18-25; Matt.23:35; Lk.11:51; Jn.3:12.

**Verse 10** - Yashar 1:29; Heb.12:24

Verse 12 - Hebrew word-play at work here. Tottering wanderer in Nod - na vanad nod. Great stuff! Yashar 1:32

**Verse 14** - There were other adamics out there, and non-adamics too! Qayin was afraid of them, as he was the son of a fallen one, and different from all. The adamites would, by instinct, hate him.

**Verse 15** - Yahweh put a sign on Qayin, so his decendants may also look different from the seedline of Adam. Hmm... I wonder what that sign was. Perhaps a "beak"?

**Verse 17** - Who did Qayin build a city for? Why, his non-adamic offspring, of course.

**Verses 20-22** Many merchants, musicians, and craftsmen; but NO farmers. That curse goes right down the seedline. Refer to verses 11 and 12. 4:22 Yasher 2:24,25

**Verse 23** - The full story of what happened here is in Yashar 2:26-35. I urge you to get a copy, and it will fill in a lot of "blank spots" for you.

**Verse 24** - This is the last mention of the seedline of Qayin until 15:19, where the word 7017 Qeniy appears, and is plural for the use with "tribes". Eventually these people were absorbed into the Canaanites, and disappeared as a distinct people. Their seedline polluted even the cursed seed Canaanites, and we see them today as the "synagogue of Satan". Refer to verse 15.

**Verse 26** - The Name of Yahweh was known. The Talmudists of the "synagogue of Satan" took it out to hide it, so we could not call upon His Glorious Name. They have failed. It is not "Lord", but YAHWEH. < H W H Y < < H W H Y <



# The Misuse Of The Words, “All”, “Every”, “Whosoever”, ETC.

## INTRODUCTION

**G**REAT STRESS IS PLACED BY PREACHERS upon the words, “all”, “every” and “whosoever” in verses such as, “Go ye into all the world”, “Preach the Gospel to every creature” and so on. These present a false application of Scripture simply because such words and phrases are wrongly used. This misuse of these words has to be considered.

This false application contradicts Jesus’ statement and instruction to His disciples:

**Matt. 15:24**, “*But he answered and said, I am not sent but unto the lost sheep of the house of Israel*”, and:

**Matt. 10:6** “*Go not into the way of the Gentiles, and into any city of the Samaritans enter ye not: But go rather to the lost sheep of the house of Israel*”

Because of this contradiction we need to find out why this appears to be so, and why the popular interpretation about going to all races contradicts this statement and this command of Jesus.

There are different words translated as “all”, “every” etc. in both Hebrew and Greek, and so we need to investigate those that are misused to promote forms of universalism. In the New Testament, the Greek word *holos* is used as “the

whole”, whereas the more frequently used word *pas* is used to indicate “a part” as being all of either a greater or a lesser part. It is the making of *pas* to have the same meaning as *holos* that causes the error.

Where translators have so often translated *pas* as “all”, “every” or “whosoever”, it means “all of that part”, or “every one of that part”, or “whosoever of that part”. The word, “whosoever” is frequently translated from the word *pas* that is also translated as “all”. We will see that any untaught person who says, “Where my Bible says “whosoever will may come”, it means “any person of any race”, that person is either untaught or is misled.

So we have to answer the main question, “does “all” usually mean “all of everything” or “all of that part being spoken about only”. Does “all the world” mean the people in the entire planet, or just all of those people in that part of the planet being spoken about? We will see that there is a weight of Scripture that shows that words such as “all” are strictly confined to “all” of each context only. In simple terms, “all the world” is better put as, “all that world”, thus excluding every other world = kosmos.

The words for “all”, “every”, “whosoever” etc. are often singular, NOT plural. Thus they refer to: “all” the one [group],

or “the whole” of the class,  
or “the entire” of the class.

To grasp the use of this particular “all” in Greek and Hebrew, consider:

**Deut 28:10**: “And ALL the peoples of the earth shall see that thou art called by the name of Jehovah, and they shall be afraid of *you*”.

Here, “all the peoples of the earth” does **NOT** include Israel. In the same way, “go ye into all the world” is **NOT** inclusive of every race. Failure to understand this is the source of error in the modern popular evangelical teaching.

Because of the importance of this matter, any person seeking truth can look through a concordance (Young's is easiest) to satisfy themselves as to the right application of this word "pas" that is translated as "all" etc.. Some examples are given further on to show how to do this.



## Herod

Jesus says that it is not given for everyone to hear or to understand. Speaking to His disciples about the Edomite leadership of the Judean nation He said, "Because it is given unto you to understand the mysteries of the kingdom of heaven, but to them it is not given" (**Matt. 13:11**).

Immediately we have just one exception like this, then "every" and "all" cannot include that exception, or the other exceptions. If an exception is made about the Edomites who cannot find repentance, or of those born as tares about which Jesus said, "Leave them alone", then these cannot be part of the "all" being addressed. Jesus did not preach to certain peoples, as we have seen. Jesus said He was sent to Israel and to save "His people" from their sins. Are we to be wiser than Jesus?

When we consider the volume of Scriptures detailing the exclusiveness of Israel, if we had no mind-set or previous pre-conditioning, we would have to agree to the following:

They are all consistent statements of fact, (not inferences).

They all relate to Israel alone, as a race, no other race being included.

Israel alone is God's inheritance, as is stated.

There is no conflict about redemption applying to Israel alone.

That certain covenants and promises referred to were made only with Israel.

That Israel is a holy, i.e. set-apart, race (What is commonly called **The Chosen Race**).

That the Statutes (*choq*) and the Judgements (*mishpat*) were given to Israel alone as a servant nation.

That the word "Jews" is not mentioned in any of these Scriptures.

That there are different "seeds", and that Abraham's seed is genetic.

That none of these Scriptures can be 'spiritualised'.

If we come to this conclusion about a unique Israel racially, there will immediately be a dilemma between:

What the Scripture teaches in direct statements showing the exclusiveness of Israel through both Testaments.

What is inferred from indirect verses as used by universalists. Universalists may use what appear to be direct statements, but there are certain words that have been given new meanings and tenses. Sometimes completely wrong and deceptive meanings have been placed on words and some of these have become accepted modern teachings.

To these manufactured word meanings, "types" are added to fit the interpretation. This is the common way of teaching, but this is not teaching that is based upon the Cornerstone or the given foundation of the Law, the Psalms and the Prophets - (**Eph. 2:20**)

What we think we see manifest in terms of Christian experience in other races- Both psychology and deliverance from demonic activity, and protection whilst other races are amongst Israel, have application here. But, redemption can only apply to Israel.

Now we can look further into some individual verses, and words in those verses.

### “EVERY CREATURE”.

As said above, **Mark 16:15** is misused in that it appears to be saying that the Gospel is for every race. Which “world” were the disciples to go into? This is a fair question. When the disciples were sent to the lost sheep of the House OF ISRAEL, to whom and to which “world” were they sent? When Jesus said in **Matthew 15:24**: I am not sent BUT unto the lost sheep of the House of Israel, to what race was He sent? Are we to say Jesus was wrong and that He was sent to every race? Are we to say Jesus was wrong in sending His disciples only to Israelites? If they were told go ye into all the world, why did they not go to the Negroes, the Chinese or the Indians? Why did they choose only one direction

and proceeded to where the Children of Israel were? The location of the House of Israel at that time can be easily established historically.

**Matt 11:1**— he departed thence to preach in their (the disciples) cities.

**Matt 10:5-7** Go not into the way of the Gentiles, and into any city of the Samaritans enter ye not: but go rather to the lost sheep of the house of Israel. And as ye go, preach (proclaim), saying, The kingdom of heaven is at hand.

The disciples were instructed specifically not to go to certain peoples. The disciples of Jesus went out from Galilee knowing exactly where to find these “lost” sheep. They were not so “lost” that they could not be found!



### How Venice Rigged the First, and Worst, Global Financial Crash In 1340 - Part Three

#### Privatisation

**T**HE BLACK GUELPH BANKERS of Florence did not simply loan money to monarchs, and then expect repayment with interest. In fact, interest was often “officially not charged on the loans, since usury was considered a sin and a crime among Christians. Rather, like the International Monetary Fund today, the banks imposed “conditionalities” on the loans.



The primary conditionality was the pledging of royal revenues directly to the bankers -- the clearest sign that the monarchs lacked national sovereignty against the Black Guelph “privateers.” Since in fourteenth century Europe, important commodities like food, wool, clothing, salt, iron,

etc. were produced only under royal license and taxation, bank control of royal revenue led to, first, private monopolization of production of these commodities, and second, the banks' “privatization” and control of the functions of royal government itself.

By 1325, for example, the Peruzzi bank owned all of the revenues of the Kingdom of Naples (the entire southern half of Italy, the most productive grain belt of the entire Mediterranean area); they recruited and ran King Robert of Naples' army, collected his duties and taxes, appointed the officials of his government, above all sold all the grain from his kingdom. They egged Robert on to continual wars to conquer Sicily, because through Spain, Sicily was allied with the Holy Roman Empire. Thus, Sicily's grain production, which the Peruzzi did not control, was reduced by war.

King Robert's Anjou relatives, the Kings of Hungary, had their realm similarly “privatized”

by the Florentine banks in the same period. In France, the Peruzzi were the cooperating bank (creditor) of the bankers to King Philip IV, the infamous Franzezi bankers “Biche and Mouche” (Albizzo and Mosciatto Guidi).



The Bardi and Peruzzi banks, always in a ratio of 3 to 2 for investments and returns, “privatised the revenues of Edward II and Edward III of England, paid the King's budget, and monopolized the sales of

English wool. Rather than paying interest (usury) on his loans, Edward III gave the Bardi and Peruzzi large “gifts” called “compensations” for the hardships they were supposedly suffering in paying his budget; this was in addition to assigning them his revenues.

When King Edward tried forbidding Italian merchants and bankers to expatriate their profits from England, they converted their profits into wool and stored huge amounts of wool at the “monasteries” of the Order of Knights Hospitalers, who were their debtors, political allies, and partners in the monopolization of the wool trade.

It was the Bardi's representatives who proposed to Edward III, the wool boycott which destroyed the textile industry of Flanders -- because by 1340 it was the only way to continue to raise wool prices in a desperate attempt to increase King Edward's income flow, which was all assigned to the Bardi and Peruzzi for his debts! Genoese bankers largely controlled the royal revenues of the Kingdom of Castille in Spain, Europe's other supplier of wool, by 1325.

In the first few years of the 100 Years War, which began in 1339, the Florentine financiers imposed on England a rate of exchange which overvalued their currency, the gold florin, by 15 percent relative to English coin. Edward III, in

effect, now got 15 percent less for his monopolized wool. Edward tried to counterattack by minting an English florin: the merchants, organized by the Florentines, refused it, and he was defeated. By this action, the Bardi and Peruzzi themselves, in effect, provoked Edward's famous default, and demonstrated his complete lack of sovereignty at the same time.

Even the famous account, by banker and chronicler Giovanni Villani, of Edward III's default which triggered the final crash, acknowledges that his debt to the Bardi and Peruzzi included huge amounts he had already paid -- the curious arithmetic of the IMF to Third World debtors today:

“The Bardi found themselves to be his creditors in more than 180,000 marks sterling. And the Peruzzi, more than 135,000 marks sterling, which—makes a total of 1,365,000 gold florins—as much as a kingdom is worth. This sum included many purveyances made to them by the king in the past, but, however that may be—”

Even larger revenue flows came to the Vatican in the collection of its church contributions and tithes. Under John XXII, the Black Guelph Pope from 1316-1336, “papal tithes skyrocketed,” reaching the apparent value of 250,000 gold florins per year. All were collected by agents of the Venetian banks (for France, the largest source of papal revenue) and the Bardi bank (for everywhere else in Europe except Germany). They charged the Vatican sizable “exchange fees” to transfer the collections.

“Only they (the Venice-allied bankers) had the reserves of cash at Avignon in France, (temporary seat of the papacy for about 70 years) and in Italy, to finance papal operations. They transferred collections from Europe, and loaned them to the Popes in advance. Thus, Venice controlled the papal credit, and the continuing hostilities between the papacy and the Holy Roman Emperors.

## Perpetual Rents

In Italy itself, these bankers loaned aggressively to farmers and to merchants and other owners of

land, often with the ultimate purpose of owning that land. This led by the 1330's to the wildfire spread of the infamous practice of "perpetual rents," whereby farmers calculated the lifetime rent-value of their land and sold that value to a bank for cash for expenses, virtually guaranteeing that they would lose the land to that bank. As the historian Raymond de Roover demonstrated, the practices by which the fourteenth century banks avoided the open crime of usury, were worse than usury.

In the Italian city-states themselves, the early years of the fourteenth century saw the assignment of more and more of the revenues of the primary taxes (gabelle, or sales and excise taxes) to the bankers and other Guelph Party bondholders. From about 1315, the Guelph abolished the income taxes (estimi) in the city, but increased them (estimi) on the surrounding rural areas into which they expanded their authority. Thus, because the bankers, merchants, and wealthy Guelph aristocrats did not pay taxes -- instead, they made loans (prestanze) to the city and commune governments. In Florence, for example, the effective interest rate on this Monte ("mound" of debt) had reached 15 percent by 1342; the city debt was 1,800,000 gold florins, and no clerical complaints against this usury were being raised.



The gabelle taxes were pledged for six years in advance to the bondholders. At that point, Duke Walter of Brienne, who had briefly become dictator of Florence, cancelled all revenue assignments to the bankers (defaulted, exactly like Edward III).


Thus were the rural, food-producing areas of Italy depopulated and ruined in the first half of the fourteenth century. The fertile Contado (county) of Pistoia around Florence, for example, which reached a population density of 6065 persons per square kilometre in 1250, had fallen to 50 persons/square kilometre in 1340; in 1400, after 50 years of Black Plague, its population density was 25 persons/square

kilometre. The famines of 1314-17, 1328-9, and 1338-9 were not "natural disasters."

Some of the famous banks of Tuscany had failed already in the 1320;s: the Asti of Siena, the Franzezi, the Scali company of Florence. In the 1330;s, the biggest banks, with the exception of the Bardi, (the Peruzzi, Acciaiuoli, Buonacorsi) were losing money and plunging toward bankruptcy with the fall in production of the vital commodities which they had monopolized, and which their cancer of speculation was devouring. The Acciaiuoli and the Buonacorsi, who had been bankers of the Vatican before it left Rome, went bankrupt in 1342 with the default of the city of Florence and the first defaults of Edward III. The Peruzzi and Bardi, the world's two largest banks, went under in 1345, leaving the entire financial market of Europe and the Mediterranean shattered, with the exception of the much smaller Hanseatic League bankers of Germany, who had never allowed the Italian banks and merchant companies to enter their cities.

Already in 1340, a deadly epidemic-- unidentified but not bubonic plague -- had killed up to 10 percent of many urban populations in northern France, and 15,000 Florentines had died out of 90-100,000 that year. In 1347, the Black Plague, which had already killed 10 million in China, began to sweep over Europe.



# The Great Pyramid, Khafre & Menkaure Pyramid Geometry Encoded Into The New Zealand Landscape (3) By Martin Doutré

## THE KHAFRE PYRAMID GEOMETRY IN THE NEW ZEALAND LANDSCAPE.

2-dimensional pyramid design, will be explained as we proceed.

**W**E'LL START OFF BY ASSESSING THE KHAFRE PYRAMID 3,4,5 triangle geometry first, as it extends between markers on all 4 sites and sets up a template for creating additional geometry of the Great Pyramid and Menkaure Pyramid of the Giza Plateau. In antiquity the pyramid geometric encoding system was designed from the Waitapu Valley's northern ridge and a pillar marker was erected there to establish a pivotal centre for the tri-pyramid geometry.

Figure 6: The geometry shown in this picture is based upon GPS fixes on ancient structures such as cairns, standing stones, tor mounds or sighting pits. These coordinate positions were later translated from World Geodetic System 1984 configuration to New Zealand Map Grid configuration. The NZMG coordinates were then introduced into AutoCAD to provide precise distance and angle information related to the positions of ancient structures.

Initial conclusions related to just how these Khafre related triangles were designed to sit on the landscape concentrated on the angle of the "opposite" running up the coastline. As it turns out the deciding factor was the azimuth angle of the hypotenuse in each case. These determining hypotenuse codes, for correct orientation of each

The blue 3,4,5 triangle runs for 9450 feet from the Benchmark Cleft at an azimuth angle of 339.73-degrees to within 24 feet of a sighting pit at the southern end of the summit of the modified and steep coastal hill SSW of Puketapu Observatory. The summit plateau is only 65 feet long and less than 15 feet wide. The resolving position sits on the gentle southern slope of the summit.

At this point the line turns 90-degrees and runs for 7087.5 feet to the Kerr Road Observatory plateau at an azimuth angle of 70.14-degrees. At Kerr Road Observatory the corner position falls 42 feet short of a large boulder marker, but amidst peripheral marker stones associated with it. The return line, running for 11812.5 feet back to the Benchmark Cleft, is at an azimuth angle of 197.01-degrees. This means that the hypotenuse angle running from the Benchmark Cleft to the pyramid corner on Kerr Road lies at 17.01-degrees azimuth.

The return degree angle is the key to knowing how to orientate the 2-dimensional representation overland, as the number 1701 is one of the primary lunar codes of antiquity. There were 4 periods of 1701-days in the 6804-day lunar nutation cycle. Indeed, the angle from the Benchmark Cleft up the sea cliff coastline to the resolving position at a sighting pit of the seaward tor hill was 340.14-degrees. This would have been symbolically read as 340.2-degrees (1/2 of 680.4) and relate once again to the lunar nutation cycle.

This 3,4,5 triangle was a replica of half the Khafre Pyramid X 20. Khafre was Egypt's pyramid of the moon and contained all of the lunar coding, as well as the principle of 3,4,5 triangulation, used in building work since time immemorial.

A full, two-dimensional Khafre Pyramid replica at X 10 scale was also built into this template

(yellow). The apex point for the smaller scale pyramid was the large boulder pillar marker on the northern ridge of the Waitapu Valley. From the marker one side of the pyramid ran for 5906.25 feet to the assembly area plateau of the coastal hill at an azimuth angle of 303.27-degrees. It then turned and ran for 7087.5 feet to resolve onto a double sighting pit with a central hump at Kerr Road Observatory. The azimuth angle to this position from the ridge pillar (5906.25 feet distant SSW) was, again, 17.01-degrees.

## Our American Identity (Part 2)

**W**RITING CA. 95 A.D., JOSEPHUS updates the known identity "lost sheep" House of Israel in these words: "There are but two tribes in Asia and Europe subject to the Romans, while the ten tribes are beyond Euphrates till now and are an immense multitude." (*Antiquities, Book XI, Ch. V., 2*)

That is why Jesus could be confident as He instructed the disciples, "but go rather to the lost sheep of the house of Israel. And as ye go, preach saying; The kingdom (government) of heaven (God) is at hand" (**Matthew 10:6, 7**).

The disciples were specifically charged to proclaim that concise message: the coming of the government of God upon the earth. In order for the disciples to speak to the "lost sheep of the house of Israel" they would necessarily travel far beyond Palestine to wherever the "lost sheep" had migrated across seven centuries. And when the disciples finally reached those lost Israelites,

they obviously would need to recognize them, despite all the changes the years had wrought. This would require the leading of the Spirit of God, and that resource was provided before the disciples left Jerusalem after our Lord's ascension.

The call of Jesus to the disciples was in these familiar words, "Follow me, and I will make you fishers of men" (Matthew 4:19). It is almost universally assumed that Jesus was speaking in very general terms and had no particular group or nation of men in mind; but Jesus, unlike most of us, knew the prophecy found in Jeremiah, where God, speaking of the "children of Israel" said, "Behold, I will send for many fishers, saith the Lord, and they shall fish them..." (**Jeremiah 16:16**).


It is the plan of the Almighty to reach all nations of men through a particular ethnic group, for "...the Lord thy God has chosen thee to be a special people unto himself, above all people that are upon the face of the earth-- know therefore that the Lord thy God, He is God, the faithful God, which keepeth covenant and mercy with them that love him and keep his commandments to a thousand generations." (**Deuteronomy 7:6, 9**).

If we arbitrarily estimate twenty five years for a generation, this promise of God guarantees God will remember His people for twenty- five thousand years, which leaves us at least twenty thousand more years to go before we may say that God will forget any of the people of all

twelve tribes of Israel. This means that not only will God remember the tribe of Judah, but that God will just as surely remember those of us who are descended from any of the other tribes of Israel. We will see that this includes all those of Celtic, Anglo-Saxon, Germanic, Scandinavian, and related stock. It also includes certain population groups now found in Italy, Spain, and the Slavic countries of Eastern Europe.\*

\*Evidence for this revelation will be found in a later section of this writing.

**The 48th and 49th chapters of the book of Genesis** (beginnings) set forth the destiny of all the tribes of Israel from the time of the death of Jacob Israel till the coming of God's kingdom on earth. The course of human history has evolved in accordance with the inspired prophecies of the dying patriarch Jacob Israel. All of us who are descended from white European roots are included there, though few of us have been aware of it. Powerful vested interests have suppressed the truth because they have wanted salvation to be exclusively either through their institutions or for their race.



Jacob Israel had twelve sons, one of whom was Joseph. He, in turn, had two sons, Ephraim and Manasseh. Jacob Israel adopted those two grandsons to inherit on the same basis as each of the other eleven sons, so that in a sense, there were then to be not twelve, but thirteen tribes. Manasseh would become, in effect, a "thirteenth" tribe, and the number thirteen would one day be peculiarly theirs, dating from the time of their political independence, and would be found on their national seal and the basic unit their currency.

But the other son of Joseph, Ephraim, was to be given even greater prominence, would one day be the centre of a commonwealth of nations, and would provide the one language which would be the tongue of commerce and diplomacy for all nations in the last days.

Speaking of Ephraim and Manasseh, Jacob Israel said, "—let my name be named on them" (**Genesis 48:16**), thus indicating that as the dual bearers of his name, the nations descended from them would hold the birthright, which was title to material and financial blessing. First **Chronicles 5:2** confirms "—the birthright was Joseph's" (through Ephraim and Manasseh).

This destiny to become wealthy through divine approval is stated in **Deuteronomy 33:13-16** in terms of "land" and "precious fruits" and wealth, to one day be derived from "the ancient mountains" and the "fullness" of the earth, such as mineral wealth and world leadership in the production of food such as wheat and corn.

When Jacob Israel conferred the birthright upon the sons of Joseph, this carried the right for them especially to bear the name of Israel. This is reflected centuries later, when at times the whole house of Israel was called by the name of Ephraim.

Also, we may note that as brothers, Ephraim and Manasseh would one day be the fathers of nations which had an especially close relationship, having the same language, people, principles of government, legal bases, drama, and religious tradition.

The only nation today which has fulfilled the prophecy concerning Ephraim is Great Britain. The only nation which has fulfilled the prophecy regarding Manasseh is the United States. Since Manasseh means literally "forgetfulness" it is not surprising that few Americans have any awareness of their heritage and their wonderful promise.

It is well to bear in mind that the term "nation" in the Bible is not synonymous with the modern concept of the nation-state. In the Bible, a people (nation) is racially homogeneous, which nature proves is the way to internal harmony, security, and continuing creativity and progress.

This is why the Bible condemns race mixing. Human beings are subject to the same laws of genetics as are dairy cattle, race horses, grain crops, and, in fact, every living thing. God established the laws of heredity, and man can only break himself when he tries to break those laws. To pretend that radically opposing ethnic groups can permanently exist as one nation is a fatal humanistic illusion.

This is why America is today paying heavily for the terrible sin of human slavery. **[Abraham Lincoln and the American Colonization Society would have sent the blacks back to Africa, but the Rothschilds had him assassinated before he could in this way solve the race problem that was created by the Jews and slaveocracy of the South. – Eli]**

The gospel by Jesus was the announcement that God will establish His government on earth.

The disciples of Jesus were and are charged with responsibility to take that message to the scattered peoples of the "lost" house of Israel.

The white people of Europe and related nations around the globe are the unrecognised lost tribes house of Israel.



Chief among these nations in these last days is the tribe of Manasseh, known to itself and to the world as the United States of America.

The America destiny began with the inspired words of Jacob 'Israel as he lay dying and

pronounced God's future for the descendents of Manasseh: "...he also shall become a people, and he also shall be great..." (**Genesis 48:19**)

In those few cryptic words is revealed the divine source of American world leadership today, as

that role was amplified in many later Biblical writings, including Ezekiel **36:10-11**:

"And I will multiply men upon you, all the house of Israel, even all of it. And the cities shall be inhabited, and the waste shall be builded; And I will multiply upon you man and beast; and they shall increase and bring fruit; and I will settle you after your old estates, And will do better unto you than at your beginnings; and ye shall know that I am the Lord."

This prophecy applies to all the white European non-Jewish people.

Ezekiel's primary message is addressed to "the house of Israel" and so applies to the Aryan (European, non-Jewish) nations and their relatives wherever they have migrated around the world. The promises that "the cities shall be inhabited" and "the waste shall be builded" applies to the building of Christian civilization in what became the United States of America and Canada.

**[Note: The Jews had no part in building the waste (wilderness) areas of the twelve tribes. As a non-agrarian breed of parasites descended from Cain through Canaan and Esau, the Jews are identified as the "fugitives and vagabonds" (Gen. 4:12) of the Cain-Satanic seedline. Unlike the Israelites, who built nations as they migrated, the Jews have never had a homeland of their own. They are always aliens and intruders among us. – Eli]**

In the above prophecy of Ezekiel is the clear promise of a growing population and developing wealth. It is said that a wealth begins with the products of the earth. Since the first days of creation, North America had the potential for the development of mineral and agricultural wealth, but virtually nothing was developed here until white northern European Christians came to this continent with a vision of themselves as the Israel of God.

They saw this virgin land as the new Promised Land wherein they would be the New Jerusalem, the people who are the Temple of God. "...ye are the temple of the living God; as God hath said, I will dwell in them, and walk in them; and I will be their God, and they shall be my people" (II Corinthians 6:16).

Their eyes were not on the old covenant or the old Jerusalem; they knew themselves to be the Israel under the new covenant and bearing the promise of a new land. God had told them, "I will take the children of Israel from among the heathen, whither they be gone, and will gather them on every side, and bring them into their own land— Moreover I will make a covenant of peace with them; it shall be an everlasting covenant with them: and I will place them, and multiply them, and will set my sanctuary in the midst for evermore" (**Ezekiel 37: 21,26**).



All of that prophecy is now fulfilled, awaiting only the coming of Christ to reign as Lord over His people.

The facts of American history amply reflect her divine origin and destiny. In the year 1620, the Pilgrims of Plymouth Colony on Cape Cod signed the Mayflower Compact, affirming their purpose in the words, "...for the glory of God, and advancement Christian faith..."

In the year 1638, the Reverend Thomas Hooker of Connecticut delivered a sermon based of **Deuteronomy 1:13**, "Take you wise men, and understanding, and known among your tribes, and I will make them rulers over you." Here was set forth simply but clearly the Providential plan for human government under God. In direct response to that sermon, some months later the colonists drew up the Fundamental Orders of Connecticut, significant because it was actually the first constitution forming a government in all human history. It came nearly a century and a half before the United States Constitution and had a direct bearing upon our national constitution.

On Jul 4, 1776, the Declaration of Independence was set forth, in the words of that document, "...with a firm reliance upon the protection of Divine Providence."

On April 22, 1864, by Act of Congress, the motto "In God we Trust" was first directed to be imprinted on a unit of American Currency, the two-cent piece. This is the fact, despite the lying claim of anti-christ that this was not done till the middle of the twentieth century.

On the reverse side of the one-dollar bill is shown both the obverse and reverse sides of the Great Seal of the United States. The reverse side

of the Great Seal bears two mottos: *Annuit Coeptis*, meaning "He (God) has favoured (or prospered) our undertakings" and *Novus Ordo Seclorum*, meaning "The new order of the ages." Our forefathers knew they were the true Israel of God and that they were founding a divinely inspired New Order to express the government of God on earth. Remember that the announcement of the coming government of God was the "good news" preached by Jesus.

The Pledge of Allegiance to the flag of the United States includes recognition that we comprise "... one nation, under God."

Billions of tax dollars provide Zionists with the highest per capita foreign aid of all the nations on earth. Jews are not rich enough—they must drain off billions of dollars in wealth produced by the American people for the benefit of other Jews in a foreign nation which falsely calls itself Israel. It is time for the truth to be told. Since the Jews control the media, an one who raises questions about the validity if actions are

England and America have taken into all the world the finest earthly examples of political freedom under law, the ideal of free public education, the blessings of science, industrial expertise to raise the standard of living of billions of people, medicine, literature, drama, and above all the gospel of Christ.

Most of the missionaries taking Christ as a blessing to all people are sent out by the English-speaking nations, and they are the countries which have led the world in the printing of Bible and providing funds for world evangelisation. Christ is "A light to lighten the nations (the true meaning of "Gentiles"), and the glory of thy people Israel." (**Luke 2:32.**)

The blessing of Christ is being taken to all the world by white European and America related nations. "And the remnant of Jacob shall be in the midst of many people as a dew from the Lord, as the showers upon the grass..." (Micah 5:7) bringing refreshment, nourishment, and growth. By their fruits you shall know them. The true Israel consists of those who fulfil the prophecies. After the death of Solomon, the united kingdom of Israel was divided into two distinct political units, (1) the "house of Israel" in the north consisting of ten tribes, and (2) the "house of Judah" in the south, consisting of two tribes, Judah and Benjamin.

In the late eighth century B.C. the northern "house of Israel" became subject to the political and military power of neighbouring Assyria, culminating in about 722 B.C. in the fall of Samaria, the capital city, and the deportation of all the productive people of that society into the region today comprising Iraq and Iran, the land Medes and Persians. Those people then migrated north and west into the wilderness that became Europe. Their identity was lost to history because they were known by different

names in various places and times. They forgot their roots and adopted the religions of the primitive peoples they encountered on their travels.

**Second Kings 18:13** records a successful invasion of the house (kingdom) of Judah by Assyria about 700 B.C. in which the invading armies captured "all the fenced cities of Judah" except Jerusalem.

The Assyrians' record of that invasion says the Assyrian armies captured forty-six cities of the house of Judah and that Assyrians "brought away" 200,150 people.

Those Judaite prisoners in Assyria moved eastward into the mountains of Central Asia where they were known as the Yoti, but about the time of Christ the migrated into Europe and settled in the Danish Islands and in Jutland, or Judahland.

These people of the house of Judah became ancestors of the Germans today. Though they are of the house of Judah (the tribes of Judah and Benjamin), they are far different from the Jews of today.

The Jews through the centuries have mixed with Edomites, Khazars (Mongolian), and North African stock, so that the Jews of today have little blood of Abraham in their veins while the Germans of today could (if they knew the facts) trace their ancestry to the house of Judah centred on Jerusalem. Perhaps this fundamental conflict of identity explains the ancient tensions between Jews and Germans.

About one hundred years after the exile of two hundred thousand Judaites by the Assyrians, the house of Judah was invaded by Babylon. Only a relatively small number ever returned to the area around Jerusalem, the rest remaining in Babylon. These {non-Israelite} people in Palestine and Babylon became the ancestors of the people known today as the Jews.

The book of Esther records that in her time many people of other races adopted the Jewish religion, which added thousands of people who became known as Jews but were not descended from Abraham (Esther 8:17). **[The most correct way of stating this is that the non-Judahites of the time contrived a bastardised, Babylonian version of the Mosaic Law, which is today known as the Babylonian Talmud. – Eli]**

According to Josephus, the Jewish [sic, Judahite – Eli] historian, writing 95 A.D., about 150 B.C. a Judean leader named John Hyrcanus led a Jewish [sic, Judahite – Eli] army; which captured many cities of the Idumeans (Greek form of Edomites) and compelled them to follow the Jewish [sic. Judahite – Eli] religion. The men were all circumcised and all the Edomites were forced to adopt the Jewish [sic, Judahite, Mosaic – Eli] ceremonial and dietary laws.

From that day on, all those Edomites were counted as Jews {sic, Judeans, not as Judahites or Israelites – Eli}, though racially they were descended from Esau. Significantly, these descendants of Esau have always deeply resented that God's salvation plan was carried down through the line of Jacob Israel rather than Esau, their forefather; and the Edomite Jews have bitterly resented Jesus of Nazareth, rejecting the Crucified One as Messiah. Interestingly, "Edom" means 'Red.'

In the eighth and ninth centuries after Christ, a basically Mongolian people called Khazars (or Chazars) lived in the area north Black Sea and the Caspian Sea. Their King Bulan decreed that all Khazars adopt the religion of the Pharisees as an instrument of political unity. Arnold Toynbee, the eminent British historian, places this mass conversion to Jewry as taking place across the period 750-870 A.D.



This Khazar empire became the backbone Jews who migrated into the Slavic nations of eastern Europe and from there into the United States about the turn Twentieth century, bringing with them the mentality of socialist revolution, which has always included terrorism.



# The Celtic Cross Was A Sophisticated Navigation And Measuring Instrument

**I**N 1997 CRICHTON MILLER made an astounding discovery that will change our concepts of the historical and religious past forever. Crichton's background and life experiences play a fundamentally important part in this revelation; he is a qualified yachtsman and navigator with an interest in ancient history and religions.

Through the results of intensive research, Crichton proposes that our present system of beliefs and science was inherited from ancient mariners that sailed the oceans of the world in prehistory. He further proposes that the abrupt end of the last ice age, 12,500 years ago, was part of a cataclysm that destroyed of a large part of the flora and fauna of Earth. The most likely humans to survive this cataclysmic event were those who were at sea.

Crichton proposes that the event likely produced a *tsunami* (a large wave that travels extremely fast) and that such a large tsunami would be more easily survived at sea, where the effect would be limited to a large swell on the surface of the ocean. The effects of a large tidal wave on a coastline, however, would be horrendous. The giant wall of water would have been turned into a breaking wave as it reached shallower depths, annihilating all before it as it rushed up the beach with churning debris.

Crichton suggests that the sea level around the globe rose with the melting ice caps. Archaeological evidence of earlier civilizations is almost impossible to find since it is now below

300 feet of new sea water which changed the topography of coastlines, where most advanced civilizations were based. However Crichton proposes that there is other evidence of earlier civilizations and that this evidence has been left intact in stone and myth for us to decipher.

Crichton believes that these pre-cataclysmic civilizations were maritime based. These ancient sea-going people had developed a form of geometry and mathematics that was linked to astronomy and astrology and developed out of their nautical lifestyles. To successfully travel on the world's oceans and seas, you must be able to know your position and direction.

Navigators recognized that the Sun was directly overhead at mid-day. To find the longitude (East and West position) these navigators had to know the approximate time, both locally and at a *prime meridian* (an arbitrary North-South line from which the plotted position would be calculated). Today the *prime meridian* is at Greenwich (0 degrees longitude), but Crichton proposes that the original prime meridian was at Giza in Egypt from which all local times and distances were calculated.

If this is true, this theory could explain the observed similarities in structures and astronomical orientations in many locations all over the Earth. Crichton proposes that these locations as watch stations. This network of astronomically aligned structures has long been investigated, but in the face of no real evidence, the similarities of these global sites is deemed coincidental.

Many investigators and writers have commented on various bits and pieces of evidence that could not be explained. Explorers have brought volumes of information to the public attention. This information has only deepened the sense of mystery and, in some cases, has convinced a large section of the population that aliens must

have been involved in these sites. Crichton does not believe that aliens were involved; instead, he prefers to think that *we* are the aliens because we do not understand the way our ancestors thought and lived.

In his book [The Golden Thread of Time](#) Crichton shows that, in comparison to the ancients, we have become very dualistic and have divorced ourselves from nature and the cosmos. Were this not so, we would be able to see what they left behind quite clearly and our civilizations would not be on the brink of disaster through conflict and the destruction of our environment. To prove his point, he has been fortunate in discovering the instrument that the ancients used to measure the stars and the very planet on which we live.

### The Navigation Instrument

This instrument can tell the time, find latitude and longitude, measure the angles of the stars, predict the solstices and equinoxes and measure the precession of the equinoxes. The instrument can also find the ecliptic pole as well as the North and South poles, it can make maps and charts, design pyramids and henges and, when it is used in combination with these observatory sites, can record and predict the cycles of nature.

What is this ancient icon that all humanity sees daily and does not recognize? It is the cross.

A form of the cross is on all Christian churches and many gravestones; it is in literature and song and can be seen hanging round the necks of the faithful all over the world. The teachers of the Christian faith use it, kneel before it, wear it as part of their raiment and yet they do not recognize it for what it is.

The cross is a maritime treasure trove of wisdom and it was likely a vital tool for constructing and designing the pyramids. Crichton has discovered the remnants of a cross hidden by the House of Amen in the Great Pyramid of Khufu at Giza. This amazing cross is capable of measuring angles to an accuracy of three arc minutes.

Crichton proposes that the cross is much older than the pyramids since it is also responsible for the construction of Neolithic henges in Europe that predate the pyramids by thousands of years. He has also found that this knowledge was rediscovered and kept secret by the Knight Templars and other "secret societies" throughout the Middle Ages.

This great secret probably led to the destruction of the Amerindian civilizations at the hands of the Conquistador when they found them measuring the stars with a form of the cross, called the *Staff of Power* by the Maya.



To show the comparison of this ancient technology, please look at the photograph of a Celtic cross [pictured on left] in the graveyard of Crichton Churchyard, near Roslyn Chapel in the Scottish borders.

You will see that the cross forms an upright with cross bars set at 90 degrees to each other. In

the centre of the cross is an object that looks like the hub of a wheel.


According to Crichton, our ancestors never designed things without purpose and the first purpose of using stone, as a medium, is that of preservation. The second consideration the ancients had was to incorporate and preserve important knowledge for their descendants. In keeping with the concept of *not casting pearls before swine*, they hid esoteric messages in certain images that they carved so that future seekers could find what he or she was ready to understand.

In the present discovery, Crichton proposes that these early stone masons carved a particular object in the ancient cross that closely resembles a wheel and is designed to rotate between cross bars on a hub. If this is the case, as observation seems to confirm, we must then ask **why?**

Crichton observes that in some of the older crosses, early masons incorporated a serpentine design around the wheel and also made the arms of the cross more wide at the outer edge than on the inner. Why?

The answer to these questions only came to Crichton when he was experimenting with different methods possibly used by the Egyptians to survey the Great Pyramid and align it with the stars. All constructions require preliminary surveying. The Great Pyramid was an enormous undertaking of civil engineering. Using the simplest of materials and the accepted mathematical techniques of the Egyptian era, Crichton assembled a theodolite, which could carry out the tasks required.

With the addition of a scale rule and a plumb line, the instrument resembled cross and was extremely accurate, fulfilling the required task and much more.



Not long after his discovery, while carrying out further research, Crichton reviewed the records of the Dixon Relics that were discovered in the North shaft of the pyramid's Queens chamber in 1872. Crichton observed that there were further relics still in the shaft and that these could be seen quite clearly in photographs taken by Rudolph Gantenbrink (1994) with his famous miniature Robot *Upbaut 2*. Crichton assembled the relics in a logical format and the astounding result was a cross and plumb line of incredible accuracy.

This artefact is capable of measuring all possible angles. Coupled with sufficient astronomical knowledge, it reveals how the ancients kept time

and measured the stars, the position of the Sun, Moon, planets and how they used these measurements to sail the oceans of the world.

Crichton has discovered and published this rich source of understanding in his book The Golden Thread of Time [ISBN 0-9541639-0-7]. Many of these revelations have never been seen by the public before and are a *must see* for those who seek truth and understanding. To further make his point be taken seriously, Crichton Miller applied for a patent on the cross and plumb line and the patent was finally granted in November 2000 as an "astronomical, surveying and navigational instrument" by The British Patent Office. The result of this patent is the instrument you see below. As you can see, it is a faithful representation of the Celtic cross in (Figure 1).

This resurrected version of the cross is made so that modern people may understand it and compare it with the cross (in figure 1) or with any Celtic cross in any part of the world. The working cross is marked in degrees round the edge and the wheel spins freely on a hub. The cross arms are perforated with viewing holes to allow the observer to read the angles.

The bottom of the wheel is weighted so that it will always point to the centre of the earth. The scale around the outer edge of the wheel runs from 0 degrees at the bottom to 90 degrees clockwise and anti clockwise, so that horizontal measurements can be taken in any direction through the viewing holes.

You can see the advantages of this instrument immediately when you look at the photograph below of an observer measuring the angle of the sun as it rises in the east at dawn. As the world spins round, the sun appears to rise from the horizon and its angle of ascent may be read from the scale directly. This angle changes, as the seasons progress throughout the year, and time and place may be determined from the results of observing stars, planets and constellations.


Crichton considers himself fortunate to have discovered the gift of the cross and to be able to pass this information to his fellow man. According to Crichton, "The cross should be completely understood by as many as possible,

for it was the foundation of the very roots of ancient civilization, wisdom and understanding." Crichton believes that, in these current, dangerous and confused times, we could do well seeking some deeper knowledge of what our ancestors knew and begin to enjoy the hope and

## Origin Of The Name Dublin, Ireland's Capital City And The Pale By Kevin Flanagan



### Ancient Dublin

**I**RELAND'S CAPITAL CITY gives us an interesting example of an Irish place name where the commonly used English form and the native Irish form bear no relationship to each other.

Unlike many Irish place names, Dublin is not transliterated from or related to the Gaelic name for the area: *Baile Átha Cliath* and each name describes different things.

In fact, if the original Irish form was correctly transliterated, Ireland's capital would be called something like Ballyaclee.

As a settlement Dublin is said to have been first occupied by Viking traders c.988AD. Sailing their longships up the River Liffey (originally called *An Ruirthech* or the 'stampeding one') they came upon a dark tidal-pool at the site where the River Poddle and the River Liffey met and which they appropriately named *Dyflin*, meaning 'black-pool', which later took the Irish form *Dubh Linn*.


Meanwhile, the native Irish referred to this place as *Baile Átha Cliath*, meaning the 'Town of the Ford of Hurdles'.

This actually described an important river crossing (not too far from the current site of Father Matthew's Bridge) where four roadways (*slighe* or *sli*) met at a point on the Liffey allowing for low-tide crossing by way of a series of hurdles of interwoven saplings.


### So why is it known as Dublin and not Ballyaclee today?

From the 12th century Dublin was controlled by the Anglo-Normans who, despising anything overtly Gaelic, chose to retain the Viking version of its name, albeit in an anglicised form, and it became the more dominant name over time.

It was during this time that the area would come to be known as *An Pháil Shasanach* - the English Pale.



The Pale was an area stretching as far north as Drogheda, County Louth, and as far south as Dalkey, County Dublin, including parts of Counties Meath and Kildare within its boundary. The word pale derives from the latin *pālus* meaning a 'stake' or a 'pole' but more specifically a 'fence' or 'boundary restriction'.

It represented the division between the Irish and English cultures and legal systems and gave rise to the phrase 'beyond the pale'; a term created by the English to mean 'unacceptable' or 'uncivilized behaviour' in reference to the customs of the native Irish people.

Dublin remained a centre of British rule in Ireland until the creation of the Free State in 1921 when it became the new seat of Dáil Éireann, the Irish Parliament.

On a separate note, problems with smog persisted until the 1980's, earning Dublin its still commonly used nickname 'the Big Smoke'.

The ship Lusitania was sunk off the Irish coast on May 7th 1915. The inquest damned the experienced pilot of the Lusitania, Captain William Turner for not following the established defensive custom of avoiding the U. Boats that gathered in the shallow waters off the Irish coast. In fact he almost ran into them, despite knowing in advance where they lay.

The inquest also stated that although the Lusitania could outrun the subs, it was going at a much slower pace, and not zig-zagging as Admiralty practise dictated in its orders, especially as the destroyer escort H. M. S. Juno had been instructed to abandon the Lusitania some while previously.

Winston Churchill was in charge at the Admiralty, the intelligence received by him. Lord Rothschild, his mentor and benefactor, who also had access to all the admiralty documentation, and his war team pointed to the fact that the many German émigrés to America had been effective in keeping America out of the war. The worry to Churchill was simply that the U.S.A. would remain isolationist, or worse. Although America could swing either way, it may yet support Germany.

So a plot was hatched by Churchill, a 33<sup>rd</sup> degree mason, in the naval Masonic lodge, and Admiralty H.Q. with the bosses of Cunard, and the War Dept. to sacrifice Capt. William Turner, the Lusitania, and 1198 crew and passengers.

The passenger ship that was barred from carrying any armaments, would be loaded with both heavy and light armaments with ammunition, within sight of the many German dock workers. This plan to load weaponry was known to be reported back to the German embassy, which it was. The German reply was to place advertisements in the newspapers of the U.S.A.

and repeat the warnings to both governments of the ships vulnerability, that any ships carrying weapons would be classed as warships.

British and U.S. forces officially dismissed this as scaremongering.

Churchill planned the sinking of several ships, among them the H.M.S Hampshire and the Lusitania, counting on American feelings being high. Yet the U.S. authorities were in on it, but like Pearl Harbour and 9/11 it suited their purposes to turn a blind eye.

So Capt. William Turner was under orders to continue with the voyage. Even though the destroyer escort was recalled, he was told to go slow. His path was plotted by the Admiralty to put the ship "in direct danger", the words used in Admiralty documents.

Naval apologists have suggested that the captain may not have known of the weapons on board, but the first mate not only knew, but was issued with a side arm, so if he knew why not captain William Turner?

Certainly statements by a New York celebrity, Mrs. E. Jacobs, say many in the Jewish community knew that it contained weapons and would be sunk.

The single page cargo manifest was signed by Capt. Turner, but a supplementary cargo manifest 24 pages long was produced after sailing time; this caused a row with the harbour master. This 24 page cargo manifest was destroyed in the mass culling of incriminating war documents pulled together from various

sources in the 1960's. Much other incriminating documentation was destroyed 2 years ago, on the orders of Tony Blair.

Be assured it contained a list of light to very heavy weaponry.

The ship went down in under 18 minutes from one German torpedo. One torpedo[1] was seen as giving long enough for the passengers and crew to reach the lifeboats, yet we are told from the very few survivors, that after impact, a huge explosion occurred on board, away- from the point of impact.

It was always the intention of the Churchill / Rothschild alliance that the Lusitania would be a sacrifice to bring in the U.S.A. to join the British war effort against Germany.

Underwater explorer and investigator, the highly reputable Robert Ballard, is alleged to have told a reporter with intelligence back-grounding, that the ship wreck he saw on the seabed, had a small torpedo entry hole, but significant and unconnected explosive damage which had sunk the ship.

The inference from this and other info, being a controlled explosion on board was designed to insure the ship sunk.

Rothschild, whose banks loaned the British the finances for all wars at colossal interest rates, was part of a syndicate with J.P Morgan who was threatening to buy up the North Atlantic shipping lines, including Britain's White Star, so the Lusitania would have been rendered useless anyway.

And in 1903, Cunard boss Lord Inverclyde took the threats seriously and lobbied the Balfour administration for a £26 million loan to build the Lusitania and the Mauritania. Britain agreed to pay the annual sum of £150,000 to keep the ships available for war. This was down to Rothschild lobbying against Germany for some considerable

time previously, while Nathan Rothschild plotted the downfall of the Russian royal family and the revolution, confiscating the Romanov wealth and bank accounts. Critics have said that Rothschild representatives planned the war to bring about their plans for profit and world government. Rothschild would have followed the rule that "profit is all". The same Hebrew root word is behind the terms for both god and money; "shekels and Shekinah", which explains the worship of money.



## A Short Legislative History of Ireland Under The Crown Cotty Coddington



**T**HERE HAVE BEEN A NUMBER OF DISTINCT LEGISLATIVE PERIODS IN IRELAND. A basic knowledge of them is useful in understanding the development of Statutory law. What follows is an outline of the parliaments that have promulgated, statutes affecting Ireland.

### Establishment of the Parliament of Ireland

By the Treaty of Windsor in 1175, Ard Rí Ruaidrí Ua Conchobair recognised Henry II as his overlord. Thus was established the Lordship of Ireland.

In 1210 King John came to Ireland, before his departure he compelled the barons to swear that they would observe the laws and customs of England in Ireland.

When King John accepted Magna Carta on 15th June 1215, this established the principle that the King could not overrule the law and thus led to the rise of Parliament as a law making body. A Statute of 1236 passed by the Parliament of Ireland was repealed only in 1983. By an Act of 1468 the Irish parliament asserted that it must ratify English statutes in order for them to be valid in Ireland.

### Poynings' Law

On the 13th October 1494 Edward Poynings arrived in Ireland, with instructions from King Henry VII to reduce the Lordship of Ireland to "whole and perfect obedience". A Parliament met in Drogheda on the 1st December 1494, and lasted into 1495. It was this assembly that passed "Poynings Law" which states that: no parliament shall be held in Ireland "till the Lieutenant and council of Ireland shall first certify the King under the Great seal of such causes and acts as them seemeth should pass; then the King and his Council, after affirming such causes and acts to be good and expedient for the said land, shall send his license thereupon, as well in affirmation of the said causes and acts as to summon the said parliament under his Great seal of England: that done, a parliament shall be holden after the form and effect afore rehearsed, any parliament holden hereafter contrary to these forms to be void and of no effect."

The freedom of the Irish Parliament to legislate was greatly fettered by Poynings' Law. The Kingdom of Ireland was established in June 1541, when a parliament specially summoned for the purpose conferred upon Henry VIII the title "King of Ireland". In its original form Poynings' Law required all proposed bills to be submitted before a licence was issued. During the reign of Philip and Mary, an amendment made possible the introduction of new bills after Parliament had met.

### "Sixth of George I"

In 1707 the Parliaments of England and Scotland were united and the Parliament of Great Britain

was established. The Parliament of England had asserted a right to legislate for Ireland, but this had been resisted by the Irish Parliament. In 1719 a dispute arose as to the appellate jurisdiction of the Irish House of Lords and the British Parliament in March 1720 passed the Dependency of Ireland Act, 1719, an "Act for the better securing the dependency of the Kingdom of Ireland on the crown of Great Britain"



### Legislative Independence

The legislative curbs on the Parliament of Ireland gave rise to opposition amongst the ascendancy classes throughout the eighteenth century. The establishment of the Volunteers following the American War of Independence eventually led to the successful assertion by Henry Grattan of the independence of the Irish Parliament on the 16th April 1782.

### Act of Union

The independent Irish Parliament did not last long after the French Revolution and the United Irishmen. The Government bought itself a majority in the Parliament and on the 28th March 1800, an Act of Union between Great Britain and Ireland was finally accepted. On 2nd August the Parliament of Ireland met for the last time.

## **United Kingdom of Great Britain and Ireland**

The Parliaments of the United Kingdom sitting from 1801 to 1922, passed a great body of law that still applies in Ireland.

### **Irish Free State**

The Constitution of Saorstát Éireann was enacted by Dáil Éireann on 25th October 1922 sitting as a Constituent Assembly. It provided that the laws in force at the date of the coming into operation of the Constitution would continue to be in force

and effect until the same, be repealed or amended by the Oireachtas.

### **Constitution of Ireland**

The Constitution of Ireland came into effect on 29th December 1937. Article 50.1 states “Subject to this Constitution and to the extent to which they are not inconsistent therewith, the laws in force in Saorstát Éireann ... shall continue to be of full force and effect until the same or any of them shall have been repealed or amended by enactment of the Oireachtas.” (The Royle Oireachtas)

## **The Hitching Stone** **By Tanya Noon and P. Coppens**



**An enigmatic boulder on the moors of Yorkshire reveals an intriguing mythological dimension, which is now mostly forgotten.**

### **What is the Hitching Stone?**

The Hitching Stone is a massive, one thousand ton boulder which stands on the moors above our family home at Cowling on the Yorkshire Pennine hills. The stone (pictured above) is believed to be the largest of its kind in the county.

It currently marks three parish boundaries but in earlier times probably marked tribal boundaries. Certainly the cup and ring marks cut into it suggest that it has been a land mark of great significance since at least the Bronze Age. We know that until comparatively recently it was a

meeting place and the site of fairs and horse racing. A nearby farm is still known as Fair Place.

The Hitching Stone sits all alone, a geological oddity, on the crest of a hill. Estimated to weigh 1,000 tons, it measures 29 feet long, 25 feet wide and 21 feet high. The stone is of glacial origin and almost certainly originated on Earl Crag. On the north-western side, there is evidence of a “tube”, which runs throughout the length of the rock. Geologists believe it is caused by a fossilised tree (called *Lepidodendron*) that has since eroded away, leaving the “tube”.

### **The Southern face**

The sides of the Stone are oriented towards the four cardinal points. On the western side is the most impressive feature: sometimes labelled a “hole”, it is better described as a “chamber”. It sits about eight feet from the ground and holes in the stone have been carved to allow the agile to climb into it. A chain on the left hand side provides additional help.

There are markings on the walls and roof. It appears that the chamber was once enlarged. Looking out towards the west from inside the chamber, the shape of Pendle Hill looms on the horizon. The chamber also emits a low resonating hum. This created by the wind blowing over the mouth of the hole, which therefore acts as an organ pipe.

From a distance, the western side of the stone looks like a face. The southern side of the stone looks like a seat. The “seat” itself normally has a pool of water, around four feet wide by eight feet long... perhaps being three feet deep at the far end – all of this obviously subject to the weather, which, it being Yorkshire, is nevertheless quite often wet.

The Stone also formed the centre of many meetings and initiations. One local legend recorded by John Gray (1891) recounts the initiation of neophytes. The chamber assumed the role of the so-called Druid or Priest Chair. The “Druid Chair” is normally a smaller type of stone, shaped in the form of a chair. In France, this type of structure is often known as a “Fauteuil du diable”: the Devil’s Seat. As mentioned, from its Southern angle, it does look like a seat...

The Hitching Stone was also the site of a Lammas fair until 1870, with the racing of horses nearby. Lammas, or loaf-mass day, was the festival of the first wheat harvest of the year, on which day it was customary to bring to church a loaf made from the new crop. The festival occurred on August 1, and therefore is one of the so-called quarter days of the “Celtic calendar”, which is closely linked with the solar calendar, based on the equinoxes and solstices.



The name of Lammas originated from the 'Feast of Lughnasadh' or Lugh, the Celtic sun god. Lammas was also the time

when Saint Catherine was celebrated. Her instrument of martyrdom is a wheel. As a consequence, the wagon wheel is linked with Lammas, which could explain why horse races were held nearby, at the time of the Lammas fair. As part of the festival, a wagon wheel would be tarred, taken to the top of a hill, set on fire and rolled down, symbolizing the decline of the Sun God. That decline is also linked with the autumn equinox, which of course ties the Hitching Post into its equinoctial alignment.

The Hitching Stone is not a one off. It forms part of a sacred landscape, in which Pendle Hill seems to be an important ingredient. As it sits to

the west, it means that it is aligned to the equinox setting of the sun (March 21 and September 21), thus forming the backbone of a possible calendar system. However, much closer to the Stone itself, other parts of this “sacred landscape” can be identified. From the top of the stone one can see another rock, half a mile to the north-west, known as the ‘Winter Hill Stone’... This stone got its name as it is said that the winter solstice sunrise (December 21) appears from behind the Hitching Stone on the horizon.

It seems that the only “missing ingredient” therefore is the stone that would mark the summer solstice sunrise, or sunset (June 21).

Other prominent rock outcrops, such as the Wolf Stones and Maw Stones, may once have been part of the sacred geography. A straight boundary line still connects the Maw Stones with the Hitching Stone. The Kid Stone may have been used as another prominent marker.

The term “Hitching Stone” itself is quite intriguing and brings memories of a similarly named stone in Machu Picchu, in Peru. The Intihuatana stone (meaning “Hitching Post of the Sun”) has been shown to be a precise indicator of the date of the two equinoxes and other significant celestial periods. Like the Yorkshire Stone, the Intihuatana is designed to hitch the sun at the two equinoxes. However, the two are – unsurprisingly – not totally alike. The Peruvian stone works for midday on March 21st and September 21st, when the sun stands almost directly above the pillar, creating no shadow at all. At this precise moment the sun "sits with all his might upon the pillar" and is for a moment "tied" to the rock. At these periods, the Incas held ceremonies at the stone in which they "tied the sun" to halt its northward movement in the sky. There is also an Intihuatana alignment with the December solstice (the summer solstice of the southern hemisphere), when at sunset the sun sinks behind Pumasillo (the Puma's claw), the most sacred mountain of the western Vilcabamba range, but the shrine itself is primarily equinoctial. That, of course, is apparently what the Hitching Stone is as well: primarily connected with the equinoxes, though incorporating key alignments to the solstices.
