WHAT IS BALAAM'S DOCTRINE? (3)

GOING ASTRAY

WE might have our own ideas about what "going astray" means. There may well be many applications, but the

Apostle Peter identifies one way of going astray in particular. We can be certain about this way! Please take note that this is a New Testament statement:

2 Peter 2:15 *Which have forsaken the right way, and are gone astray, following the way of Balaam the son of Bosor, who loved the wages of unrighteousness.*

Here we find another mention of unrighteousness that is connected with Balaam's teaching. We cannot avoid the connection, in context, with sex and "eyes full of adultery"-[verse 14] and "cursed children" [verse 14]. These teachers' "promise of liberty" [verse 19] is to be avoided *at all costs*. *To indulge is to have an "end that is worse than the beginning"*, says the apostle Peter.

The Apostle Jude brings up the theme also, saying:

Jude v 11 *Woe unto them! for they have gone the way of Cain, and run greedily after the error of Balaam, for reward, and perished in the gainsaying of Core.*

Here we see an attempt to profiteer outside of God's purposes. In Jude, we find again the warning is one of woe over Balaam's doctrine through which the promoters of false doctrine hoped for reward to satisfy their greed.

WHOREDOM

Throughout the Old Testament, there is much reference to whoredom. When God complains

about this whoredom, it is because of Jerusalem's whoredom with other races [Ezekiel 16]. The results of mis-using God's gifts were lewdness and abominations through breaking their covenant with God [v59]. There are two main words, zarah and taznuwth, which are translated as "whoredom". Both have a lot in common but the latter word is exclusive to Ezekiel who associates whoredom with non-Israel races twenty one times. Zarah comes from a prime root meaning "highly fed, and therefore wanton". It is used 105 times. There is mention of "strange women" (non-Israel stock), that is, nokriy and nekar as explained in the chapter, "Pilgrims, Strangers and Israel" of the book, "The Exclusiveness of Israel".

Solomon knew the dangers, and he fell into the trap nevertheless. It was foreign wives that caused his downfall and descent into idolatry.

Prov 23:27 *For a whore is a deep ditch; the strange woman is a narrow pit.*

"Ditch" and "the pit" are not the same thing. The ditch can be got out of more easily! ("Narrow" here connects with the adversary, in Hebrew). Complete separation (divorce) from foreign wives and children is the only way to climb out of the pit an Israelite has dug for himself. There is a biblical difference between an Israelite having sex with a harlot who is also an Israelite, and all sex with strange women who are foreigners!

Prov 23:33 *Thine eyes shall behold strange women, and thine heart shall utter perverse things.*

Prov 5:20 *And why wilt thou, my son, be ravished with a strange woman, and embrace the bosom of a stranger?*

These three verses tell about "strange" women of a foreign race.

Speaking about whoredom Hosea says to Israel: **Hos 4:14** - *therefore, the people that doth not understand, shall fall.*

It must happen! They shall fall! Let there be understanding!

2 Chron 20:20; *believe in the Lord your God, so shall ye be established; believe his prophets, so shall ye prosper.*

All through Scripture, we can find such warnings presented in different ways. They all add up to the same answer from both Testaments. Racial intermarriage leads to idolatry. It always has been so; God's judgement is upon it. While there may appear to be examples in Scripture where Israelite men married non-Israelite women, it can be shown that this is not so. Let us take Ruth as an example. Her mother-in-law's kinsman, Boaz, together with all the elders of the city, had no hesitation in helping Ruth in accordance with Israelite law. Furthermore, Ruth married Boaz and this is the line that gave rise to Jesse and David and it is the line from which Jesus claims His human ancestry. This is sufficient to establish that Ruth was an Israelite who, along with many, many others, were living in the Plains of Moab. The Israelites had taken it from Moab as part of Israel's advance into the Promised Land. All the Moabites in that area had been exterminated, so Ruth, as an Israelite, was a "Moabitess" in the territorial sense, just as a Galilean was an Israelite who lived in Galilee rather than in Judea.

But, who will believe today? Who wants to prosper in God? It seems most prefer for Jesus to have something against them.

HARD SAYINGS?

The whole subject of race is a problem to most Christians. Most try to get over the problem by using one of the following methods:

Teaching the doctrine, and actively promoting it.

Just going along with it.


Spiritualising it away, saying that all believers of all races are the nation of Israel.

Believing/teaching that Israel no longer exists.

Saying there is both a natural and a spiritual Israel - a nation and a church respectively.

Many will admit to not feeling at ease over any mixed race marriage, but they are afraid to express the disquiet even if they do see that racially mixed marriages do not work out well. Today, in this Biblical time of Man's Day, racism is classed as a sin of major proportions. To be labelled racist is supposed to be a bad label; everything racist is supposed to be wrong. The racist person himself is considered to be evil. The very fact that this is the teaching of the anti-Christ world government indicates that this teaching must be anti-God. This attitude is being brought into the churches. It is a platform of the World Council of Churches and those who preach a social humanistic universalised gospel.

BALAAAM'S DOCTRINE IS THE NORMAL TEACHING



It is painfully obvious that Balaam's doctrine is the standard teaching in our Churches, Bible Schools and Seminaries. It has been advocated on Christian radio, television and the press. The false prophet Balaam is heard **a d v o c a t i n g** racial mixture, multi-culturalism and a one world **multi-racial**

church. We have Promise Keepers and other well-funded organisations advocating "breaking down the barriers" between races in the sense that there is no differences between the races as far as God is concerned. As in Balaam's time, so in our time; Moabites and Ammonites are still attacking Israel with their false doctrine. The Canaanite is still in the house of God too, but when Jesus returns there will no longer be found the Canaanite in the House of the Lord (Zech 14:21). The word from those days still applies:


In the Old Testament, God is presented as being absolutely racist and racially selective. God told Israel to destroy whole nations, exterminating men, women, children and their animals. That Israel as a nation did not do so is the reason that many of these problems still exist today. The question has been asked, "Has the unchanging God changed?" He cannot change, can He? God is shown as being totally racist in the Old Testament. What He has said will surely come to pass, even if some church-goers think He has changed and that His Word will not come to

pass. We can no longer hold the doctrine of Balaam and be blessed by God. Jesus holds this against the Churches, so we can see that the New Testament is as racist as is the Old Testament.

QUESTIONING GOD.

The vogue today, as ever, is to question God. Election is what Romans chapter 9 is about. We also might like to say that there is unrighteousness with God [verse 14-18] when God says that He "will have mercy on whom He will have mercy, and ... and that whom He will He hardeneth". Why then should we resist God's will? Why should the churches reply against God?

Rom 9:20,21 *Nay but, O man, who art thou that repliest against God. Shall the thing formed say to him that formed it, Why hast thou made me thus? Hath not the potter power over the clay, of the same lump to make one vessel unto honour, and another unto dishonour?*



Paul goes on to show that there actually are vessels (people) "fitted for destruction" and that there are also vessels of mercy, which He had "afore prepared unto glory". This chapter of Romans confirms the Old Testament sense of being of race, not of individuals. The whole context still isolates Israel from other races. We have to settle whether or not there are these racial differences today. If not, then Balaam's Doctrine could not apply today. The rising tide of racial strife through the world shows that there are these differences. The attempts by world leaders to mix the races are not working and cannot work. We are seeing anti-discrimination legislation attempting to enforce multi-cultural concepts. With this, we are seeing growing anti-(so-called "right wing")-Christian sentiment on the part of humanistic governments.

So, what about the other races? Can we still declare that all races are treated the same way by God? In Roman 9 we find mention of Pharaoh, a non-Israelite, who was raised up by God for a purpose, that through God's power, God's name might be known throughout the Earth. God then has different purposes for the different races. Who are we to argue still with God? Paul's sayings are hard sayings. When Jesus spoke some hard sayings [John 6:60], many of His disciples walked no more with him. Will you also go away?

PRACTICAL CONSIDERATIONS

We can believe that God will hold the doctrine of Balaam against us, or we can continue to follow Balaam's doctrine. The current multi-cultural doctrine has no basis in the Law, the Psalms and the Prophets. In the churches it is based upon:

The popular interpretation of Galatians 3:26-29 which ignores that this book is written to Israelites who had been under the Law. This was covered in the chapter "Galatians And Israel Exclusive" in "The Exclusiveness Of Israel"

The popular meaning of the word "Gentile" [see the chapter entitled "That Unfortunate Word "Gentile" in "The Exclusiveness Of Israel"]].

The popular wrong application of "God so loved the world" and "Go ye into all the world", where the context "world of Israel" is extended to try to include all races.

The disbelievers try to hide behind every type of argument. The majority spiritualise the subject away by saying the promises were not to the genetic seed of Abraham, but to the spiritual seed of Abraham. The great error in this is that there is no prophetic foundation for this view. It does not have foundation in the Law, the Psalms and the prophets; therefore it is not valid. The popular thought is to spiritualise the whole matter and to make it a matter of conversion and non-conversion.

So, what is to be done from a practical point of view? What are we to do if we agree with Jesus and continue in the Apostles doctrine?- [Acts 2:42]. Is it not clear? Mixed-race marriages are increasingly common in our churches. Many have the racial mixtures in their immediate

families. This is not easy to deal with in the light not allowing the Doctrine of Balaam. The answers come from knowing who we are, and in not arguing with God. The message of the New Testament is to believe Jesus and obey God. These are actions to be taken by individuals and hence it is as individuals we must respond. Everyone in Israel is given the opportunity, at some time or other, to hear and respond to things of the spirit. If, like Esau, the decision is to turn away - so be it for that individual. If, like Abraham, the decision is to believe and to prove it through the deeds of one's life - so be it for that individual. One thing is certain: for everyone who chooses to believe, stumbling blocks and difficulties will appear in the course of life. Understanding our roles as individuals, understanding our society and the forces that afflict it, together with successfully holding fast to the truth is the challenge for those whom Revelation identifies as over-comers. To the over-comers go the rewards. To put it bluntly in the modern idiom, those who reject God will fry!



Rev. 21:7-8 He that overcometh shall inherit all things; and I will be his God, and he shall be my son. But the fearful, and unbelieving, and the abominable, and murderers, and whoremongers, and sorcerers, and idolaters, and all liars, shall have their part in the lake which burneth with fire and brimstone: which is the second death.

In this verse, the word translated as "whoremongers", is that which is also translated as "fornicators" elsewhere in the New Testament.

TO CONCLUDE

Tolerance is sometimes called a Christian virtue, but truth is totally intolerant of untruth. This

paper has endeavoured to make what the doctrine of Balaam is very clear and that it is a doctrine that Christians should not tolerate. When Balaam spoke prophetically, it is recorded that he spoke the words that God put into his mouth; this was not the same thing as the counsel he offered Balak. In his prophecy he entrenched the blessing that was established upon Israel who had no enchantment against them. This blessing was for "the last days", that is, following the First Advent. In blessing Israel, Balaam said:

Numbers 23:9 --- lo, the people shall dwell alone, and shall not be reckoned amongst the nations.

Alone means only in the sense of being "in a class of its own". Israel is still very much unlike all the other nations. Israel is peculiar and Israel remains exclusive from the other races in the Word of the Lord. It is God's decree that Israel will always be this way. But how many Israelites will believe Jesus and obey God so that they attain the eternal life to see it?

PLEASE NOTE: Expressions of racial differences are not expressions of racial hatred. Today within the humanist European Union, provision in the form of 'rights' is extended to differing races so that their religions, culture and customs can be expressed and practiced. "Racism" refers to racial hatred, and none is expressed, suggested or intended in this paper.

The Parasite's Dilemma Extracted

(Since it is not worth voting for either Bush or Kerry (both are scary!!), I am celebrating Election Day by exercising my Constitutional Right to Freedom of Speech. The following article

should set the world's political situation in its proper perspective.)

The Parasite's Dilemma

THE purpose of today's study is show how Judaism, over thousands of years, has refined and defined the concept of a parasitic culture. What emerges from this study is a definite pattern of grandiose deceit and tribal self-worship trying to impose itself upon a resistant outside world. This primitive form of tribal self-worship, due to its nearly total insularity (separate language, separate food, customs, literature, art, etc.), has managed to survive into the modern world and even find its most fruitful soil in the age of democracy, an age which ideologically repudiates tribalism. Yet, by skilful manipulation of the "anti-Semitism" myth, Jewish tribalism is tolerated and even condoned by the most verbose democratic ideologues (hypocrites) of our time.

The reasons for the survival of this religious tribalism are numerous; and there is no end to the number of lessons to be learned from the study of its methods, both physical and psychological, of insulating its adherents from the liberating influences of the outside world. It is this insularity -- this rabbinical demand for tribal loyalty -- which has kept Judaism alive down through the centuries in spite of its lack of a homeland.

Crucial to maintaining the rag-tag cohesiveness of the Jewish tribal society is its mythology. This mythology makes several claims about Jewishness besides that of being "chosen" by God. This mythology centres on the Talmud and other "holy" books which give the rabbi the psychological tools with which to corral his flock

and fence them in while they are led to believe that they are, in spite of their insular life-styles, cultural and intellectual world leaders.

By maintaining separate, Jewish, courts of law, the Kehilla, or Jewish ruling clique, asserts punitive powers even unto the death of those who would resist it. The typical punishment for offending the Jewish ruling clique is ostracism, and for a person who looks, thinks, and acts Jewish, this is well-nigh a spiritual death sentence. The rabbis know this very well. The little Jew is trapped in the most cleverly designed psychological web. That is the main function of the ghetto, both mental and physical.

As a separate community within a host nation, the Jews must of necessity accommodate themselves, individually and collectively, to the larger society. The Jewish ruling clique continually agitates for special privileges for the Jewish mini-state so that they can argue before their subjects what a good job they are doing for the little Jew. The truth, of course, is that the Kehilla and the Rabbinate thrive on the maintenance of the dynamic tension between Jew and non-Jew, manipulating the circumstances for all they are worth in order to:

- 1.) deepen the individual Jew's sense of Jewish separateness and
- 2.) maintain their political and economic power as fat cats in the mini-state, and
- 3.) act as influence peddlers and vote-block deliverers to select politicians.

This is exactly how the Pharisees operated in the days of Jesus Christ.

As the reader may well appreciate, the kehilla and the rabbinate are the past masters of this psychological game plan, having well over 2,500 years of experience at religious and cultural mind control, texts such as the Talmud offering lessons for the rabbi to sharpen his manipulative skills.

Every once in a while, the kehilla's demand for special privileges is rebuffed by the host nation. When this happens, Jewish pride and honour are

at stake; and physical violence often results. This is what happened in Tsarist Russia. If the rabbis decide to pursue the procurement of these special privileges, they will heighten the Talmudic propaganda and whip their flock into a frenzy; and thus begins **the oft-repeated Jewish cycle of steadily advancing prosperity followed by pogrom and/or revolution.**

This cycle can be described as consisting of the following stages:

The Pleomorphic Life Stages of the Parasitic Nation:

- 1.) Dormancy
- 2.) Attachment
- 3.) Growth
- 4.) Agitation (Irritation of the host organism)
- 5.) Rejection by the host and conflict
- 6.) Victory or defeat

With defeat, logic tells us to expect that the dormancy period will repeat as the next step for a particular Jewish community and that the entire cycle will repeat itself. This is exactly what happens. What happens after a victory by the parasite is the death of the host nation, as exemplified by the Terror of the French Revolution and the mass genocide of Christians in Bolshevik (Jewish-ruled) Russia. Within a given Jewish community, whether it be in China, America, or Israel, this cycle will be active at one stage or another depending on its maturity.

Perceptive readers will notice that this cycle of Jewish development parallels that of a biological parasite which latches on to a host organism and feeds itself off of whatever nutrients the host might provide. If the biological parasite becomes an irritant, the host will do all in its power to rid itself of the parasite. The same is true of the host nations in their relationship to the Jewish mini-states within them: their presence is tolerated until it becomes too painful to endure any more. Historically, the main reason for throwing off the parasite has been the Jewish practice of usury (lending money at interest) and foreclosure. Once these *Oberjuden*, or Super Jews, their banking class, establish themselves, then they work ceaselessly to get the Jewish masses to flock into the victim country with their vice-

rackets: gambling, pornography, prostitution, sweat shops, and other forms of Jewish "culture."




The Jewish cultural cycle utilizes many important factors besides mythology, tribalism, and special privileges, which go into its design. A major characteristic is the internal power struggles that go on (in true tribal fashion) between the rabbis and secular leaders, between and among the rabbis themselves, between and among local and international kehillas.

A major tribal feature of Judaism is the regrouping of infighting factions against a perceived enemy in spite of irresolvable differences between the infighting groups. It is herein that Judaism has earned its claim to fame in that it has been able to establish a tribal culture extending over the entire globe, with the international kehilla (comprised mainly of the richest bankers, merchants, entertainment moguls, gangsters, members of the World Jewish Congress and other powerful groups such as B'nai B'rith and the ADL) doing its best to rein in all of the various national and local Jewish communities.

Since Judaism is a tribal religion based on mythology, it matters little whether facts contradict the myths. The myths are sacred, all important, dogmatic, and theologically unchallengeable. Those who dare to challenge the established myths are either severely rebuked or ostracized by organized Jewry.

Of course, **all religions**, to some extent, resort to the tactics of myth-making and insularity against other groups; but it is the purpose here to make a specific study of Jewish traditions and tactics in this regard, especially since these myths are being used to justify a genocidal war against innocent Arabs and Christians in various parts of the world.

Jewish parasitism, for all those who care to investigate (including Jews), is one of the main topics of my book, **The Great Impersonation: How the Anti-Christ Has Deceived the Whole World**. It reveals the true and semi-secret nature of Judaism, **from its ideological beginning in Babylon** to its present expression in today's international culture. Judaism's ideology is today applied with force in such seemingly diverse movements as communism and finance capitalism. Upon closer inspection, we find that both movements are led by powerful Jews who take time out to vacation together and talk business just as if they were not enemies at all -- and they aren't. (Trotsky, the revolutionary, and Schiff, the banker, are one example. Marx, the communist, and Engels, the industrial capitalist, another.)



This convergence of revolutionary overthrow and finance capitalism within Judaism was clearly understood by Henry Ford, who in 1920 wrote: "*In Germany, therefore, as in Russia, distinction is made between the methods of the rich and of the poor Jews, because one method affects*

the government and the other the morale of the people, but both converge on the same objective. It is not only desire to escape oppression that actuates the lower classes of Jews, but desire to gain control -- for the spirit of mastery pulses strong within them. German convictions on this question have reached the place where they may be expressed thus: Revolution is the expression of the Jews' will to power. Parties such as the socialists, democrats and freethinkers are but tools for the Jewish plan to power. The so-called "dictatorship of the proletariat" is really and practically the dictatorship of the Jews." -- **The International Jew, Volume I**, p. 29. And you thought Henry Ford just built cars.

Resentment against Jewish methods and practices is a fact of life. There is more to it than mere envy. If the Jews are indeed the "Chosen People", then why in God's name don't they act like it? Why, if they are the Chosen People, aren't they leading us toward peace through the enactment of God's Law instead of into chaos? Why do they not practice God's Law as outlined in the Old Testament? Why is their claim not acknowledged by the man in the street who has

experienced the negative effect of Jewish chauvinism firsthand? There should be something about their collective and individual comportment which would sway people into giving them the respect that a "godly race" of people would command. The Jews do not command such respect because they are not the chosen people.

A main feature of Jewish parasitism is the fact that the parasite always depends upon its host for survival. History shows that the Jews, since they do not farm and since they do not engage in manual labor, are incapable of producing their own food and incapable of creating the infrastructure that a true nation or civilization requires.

White Christian civilization, in particular, has always been a rich feeding ground for this parasitic breed. The rabbis have trained them well to cheat Christians out of their hard-earned cash. Usury has always been their main diet. In general, Jews flock to the merchant trade -- which includes banking -- before all others. The merchant trade allows them access into cultures which would otherwise forbid their presence. Just as biological parasites have their favourite places to congregate in the human body, Jews congregate in the merchant trades (the stomach). Once this parasite has gained a strong foothold, the Jew moves into politics (the muscles), education (the brain), entertainment (face), publication (hands), pornography and race-mixing (sex organs), etc., etc.

As long as the host allows the parasite to attach itself, the parasite thrives, often at the expense of the host's life. In the plant world, parasitic plants can choke the life out of trees, thus killing the trees and themselves. In the ocean, the remora will attach itself to a shark. This can be fatal to the shark if there are enough remora to drink its blood. In human affairs, the Jew has destroyed many civilizations by overfeeding and sucking the economic life-blood of the host nation until it starves. Post-Versailles Weimar Germany is a perfect example of the ravenous Jewish appetite for economic destruction. Had the Jews not committed this egregious crime against the German people, Hitler would not have had any ground for vengeance.

The Great Depression here in America is another good example of how Zionist Jews pulled out of the stock market, then stole America's gold,

stopped lending money (thereby worsening the Depression) in order to destroy State and local banks and then foreclose on all of that indebted farmland which became suburbia after WWII. The profits they realized on this deal were immense...and the suffering of the American people likewise.



During the Two World Wars, Zionist Jews reaped huge fortunes. Bernard Baruch, the Warburg brothers, the Rothschilds, and many other Jewish families, through their banking and war production companies, made billions while Christians were slaughtered on

the battlefield. Bernard Baruch, FDR's chief advisor before and during WWII, also ran numerous war-profit companies. One of the reasons that FDR demanded unconditional surrender was because this would drag out the war to the bitter end, thus maximizing profits: kind of like a football game going into triple overtime. The concession stands keep making money.

The Zionist parasite, in both WWI and WWII, was able to enlist the military force of America in subduing its arch enemy, Germany, because the German people had gotten wise to Jewish treachery. Before WWI, the Kaiser gave the Zionists everything they wanted; but the Zionists, seeing an opportunity to steal Palestine from the Arabs, stabbed Germany in the back via the Balfour Declaration. The Balfour Declaration guaranteed America's entry into the war on behalf of Zionism, so that the British would wrest control of Palestine from Germany's ally, Turkey. Britain had an agreement with the Arabs that Palestine would go back to them once the Turks were driven out; but the Balfour Declaration cut the Arabs out of the deal and gave Palestine to the Jews instead. When Lawrence of Arabia understood how the Brits had betrayed the Arabs on behalf of the Jews, he went on a speaking tour denouncing the whole affair. When he wouldn't shut up, he died in a tragic motorcycle accident.

Today, the Jewish parasite has grown fat and powerful. He sits upon the nations like Jabba the

Greek Not the Original New Testament Language

VERY early in history, even before the Messiah, Greek had become a world language. Alexander the Great

conquered the lands east and south of Greece, establishing Hellenistic culture and society as far as the Indus River and south into Egypt.

The *koine* or common Greek dialect prevailed, becoming dominant in the wake of Alexander's exploits. Greek survived the ravages of Roman persecution, as well as the crusades, and continued to be spoken up to the time of the Muslim conquest of the Mediterranean area.

Following the destruction of Jerusalem in 70 C.E., Rome crushed the Bar Kochba rebellion in 135 C.E. The Roman army destroyed anything Jewish, especially religious scrolls and books, including their Torah. This was followed by the Catholic inquisitions in Europe, eradicating anything Jewish. The crusaders made fair game of the Jews, ruthlessly destroying any vestiges of Hebrew writings.

Thus, between the suppression carried out by the Romans and the later Crusades, any Hebrew copies of both Old and New Testament writings were lost. Only Greek copies survived. Neither are there any original Hebrew Old Testaments manuscripts, only copies of copies of copies.

An increasing number of competent Bible scholars now agree with scholar Charles Cutler Torrey (**Documents of the Primitive Church**) that the New Testament in whole or part was first written in Hebrew and only later translated into Greek. (Write us for a list of renowned Bible scholars who uphold an original Hebrew New

Testament, as well as the mini study, *Was the New Testament Originally Greek?*)

In the September 12, 1986 issue of *The Washington Times*, David Bivin notes that Yahshua, like His contemporaries, most likely spoke Hebrew, Bivin, the director for the Jerusalem School for the Study of the Gospels, also believes that the original account of Yahshua's life was written in Hebrew, not Greek or Aramaic. In addition, he and his Jerusalem scholars agree that by considering the Evangelists Hebraic, many textual difficulties are cleared up, strongly suggesting that the Evangelists were first written in Hebrew.



1 Even Martin Luther recognized the Hebrew roots of the New Testament. He wrote in **Tischreden**, "Although the New Testament was written in Greek, it is full of Hebraisms and Hebrew expressions. It has therefore been aptly said that the Hebrews drink from the spring, the Greeks from the stream that flows from it, and the Latins from the downstream pool" (translated by Pinchas E. Lapide in **Hebrew in the Church**, p.10).

Where is the justification for changing the Savior's Name? Even in a Greek context, there is no **J** or **J** sound in the *Koine* or in any Greek dialect known. The Greek New Testament of the Bible provides the basis for our present Latin and English translations. Obviously the **J** came from another source, as Greek has no phonetic equivalent of the letter **J** in its 24 characters of the alphabet. Neither does Hebrew. The words judge, journal, jack, jam, jet, jog, etc., likely would all be spelled beginning with the Greek *iota* (English **I**) and would be pronounced as "ee." In English the letter **j** would be replaced by the letter **i**. We would read iudge, iournal, iack, iam, iet, iog, etc. Some orthographers

would prefer that these examples begin with today's letter **y** instead of **i**.

We cannot ignore the fact that there was no letter **J** in ANY language until around the 15th century, and therefore must conclude that the name "Jesus" never existed before 500 years ago. Let us not forget that we read from a Hebrew Bible. It is the account of Yahweh's dealing with His people Israel. Yahweh spoke to a people who understood Hebrew. Yahweh is the Mighty One of the Hebrews. Remember also that there was no Jew before the time of Abraham, Isaac or Jacob. So the Sacred Name is not Jewish.

The seeker of truth must not shy from the Hebrew roots of true Biblical faith, for we are children of Abraham, a Hebrew (Gen. 14:13). Hebrew means to "cross over," and we are to "cross over" the falsity and error of this world and join in pure worship of Yahweh and His Son Yahshua.

Savior's Name Explained in Bible Versions

Inspired Scripture calls attention to a singular Name wherein rests our eternal salvation.


The following Bible versions have these footnote explanations on Matthew 1:21, the verse where the angel tells Joseph (Yowceph) what to name the Redeemer of mankind:

- "Jesus' (Hebr. Jehoshua) means 'Yahweh saves'"—**The Jerusalem Bible**.
- "Jesus' is the Greek form of Joshua, which means 'the Lord saves'" —**New International Version**.
- "Jesus,' from the Greek form of a common Hebrew name (Joshua) derived from yasha, 'he saves'" —**Harper Collins Study Bible**
- "She will give birth to a son, and you are to name him Yeshua, [which means 'Adonai saves'], because he will save his people from their sins" —**Jewish New Testament**, David Stern, translator.
- "Heb. *Yoshia*, reflected in the name Yeshua (Gr. Jesus)" —**The Original New Testament**, Hugh J. Schonfield.
- "Jesus: The Greek form of 'Jeshua'.... The full significance of the name 'Jesus' is seen

in the original ‘Yehoshua,’ which means ‘Jehovah the Savior,’ and not merely ‘Savior,’ as the word is often explained” –**Weymouth’s New Testament in Modern Speech.**

- “Jesus Christ. The name ‘Jesus’ is from the Greek (and Latin) for the Hebrew ‘Jeshua’ (Joshua), which means ‘the Lord is salvation.’ ‘Christ’ is from the Greek for the Hebrew ‘Meshiah’ (Messiah), meaning ‘anointed one’” —**Ryrie Study Bible**
- “Jesus, Yeshua, meaning ‘Jehovah Is Salvation’” –**The Kingdom Interlinear Translation of the Greek Scriptures.**

The following commentaries add their observations on the Savior’s Name:



- **Matthew Henry’s Commentary** (on Matthew 1:21): “Jesus is the same name with Joshua, the termination only being changed, for the sake of conforming it to the Greek.”
- **Interpreter’s Bible** (Note on Matthew 1:21): “Jesus for He shall save: The play on words (Yeshua, Jesus; yoshia, shall save) is possible in Hebrew but not in Aramaic. The name Joshua means “Yahweh is salvation.”
- **Barnes’ Notes** (Note on Matthew 1:21): “His name Jesus: The name Jesus is the same as Saviour. It is derived from the verb signifying to save. In Hebrew it is the same as Joshua. In two places [Acts 7:45 and Hebrews 4:8] in the New Testament it is used where it means Joshua, the leader of the Jews [Israel] into Canaan, and in our translation the name Joshua should not have been retained.”

The prefix *Yah* is the short or poetic form of YAH-weh the Heavenly Father’s Name as found in HalleluYAH and in names of many Biblical personalities, as we will see. Thus, the Savior’s Name begins with the prefix “Yah” that begins Yahweh’s Name, as revealed in Psalm 68:4: *“Sing unto Elohim, sing praises to his name: extol him that rides upon the heavens by his name JAH [YAH], and rejoice before him.”* “Shua,” the last part of the Savior’s Name, carries the primary meaning of “salvation.” Thus, Yahshua means “the salvation of Yah.”

When Israel crossed over the Red Sea, Moses sang a song of thanks to Yahweh in Exodus 15. The saving name appears in verse 2, “*Yah become my salvation,*” which was to be Yahshua!

The following reasons clearly show why the name Jesus could never have been the Savior’s Name:

- There is no letter J or equivalent in Hebrew.
- There is no letter J or equivalent in Greek.
- There was no letter J in English until about 500 years ago.
- “Jesus,” an etymological hybrid from Greek and Latin, has no inherent, etymological meaning in Greek or Latin, not to mention Hebrew or English.
- Joseph (“Yowceph” in Hebrew), a Hebrew, was told by the angel Gabriel that Mary (Miriam), a Hebrew, would give birth to One Who would “save His people Israel from their sins,” Matthew 1:21. Only the Hebrew name “Yahshua” means “Salvation of Yah” (“Yah”shua). He Himself said that He is come in His Father’s Name (“Yah”weh/”Yah”shua) and “you receive me not,” John 5:43.
- Mary, a Hebrew, was told the same thing that Joseph was, Luke 1:31.
- Would a celestial being announce the coming Savior to those who spoke Hebrew (or Aramaic), proclaiming a Romanized, Grecian name beginning with a letter J that did not exist, but would originate in a European tongue 1500 years later? Remember it was to Israel, a Semitic people

who spoke and understood Hebrew, that His saving Name was first revealed.


- Would HEBREW parents give their baby a hybridized GREEK name devoid of any meaning – especially such an important name that would identify the very Savior of the world?

How Did ‘Yahshua’ Become ‘Jesus’?

It is necessary that we understand the prefix “YAH” has come to us in the form “YEH” (a type of which is found in “Yeshua” commonly used for Yahshua). It is also manifest in the names JEHovah and Jesus.

Almost any scholarly reference work will acknowledge that Rabbinic tradition has suppressed the true Name Yahweh centuries before the Messiah came at Bethlehem. Writing Yahweh’s Name in the Hebrew, Jewish scribes inserted a *shewa* (:) instead of the proper *qamets* (T), thus changing the vowel sound “ah” in “Yah” to “eh.” This was done to conceal the sacred Name, thus yielding the improper Yehovah and Yeshua.

This is practiced even today by such groups as the Jews for Jesus, who contend that “Y’shua” is the Jewish way to say “Jesus.” This may have been done to avoid offending the Jews and their proscription against even the short form YAH.



Strong's Hebrew Dictionary clearly shows the erroneous vowel pointing of YAH to YEH in the first column of page 48 where the resulting “YEH” is obvious. In every name in this column, a *shewa* (:) appears under the Hebrew letter yod (y:), and the pronunciation

given following the Hebrew spelling begins with the prefix “YEH.”

Using the “e” instead of the proper “a” is another ploy of the Adversary to do away with the family Name YAH, the first syllable of both Yahweh’s and Yahshua’s Name.

This explains how the “e” came about in the name Jesus. The next letter in Jesus, s, results

from the fact that Greek has no “sh” sound, only “s” (*sigma*) sound. This was incorporated into the Latin text. The “u” in Jesus comes from the u in Yahshua. **The New International Dictionary of New Testament Theology** explains, “*Iesous* is the Greek form of the Old Testament Jewish name Yesua [Yahshua], arrived at by transcribing the Hebrew and adding an s to the nom. to facilitate declension.”

The final “s” in “Jesus” is the Greek nominative masculine singular ending. Matthew 1:8-11 contains the genealogy of Joseph’s line, where we can find similar examples of “s” added to produce Greek-inflected Hebrew names: Uzziah becomes Ozias; Hezekiah becomes Ezekias; Jonah becomes Jonas, etc. The errors that we find among names in most versions can be traced to translators. The early Christian translators relied upon the Greek translation called the Septuagint as their source of the Hebrew Scriptures.

Is it not significant that even though these Hebrew names were Grecianized, that they still are recognizable? Why then in English versions does Yahweh’s Name become changed to a completely foreign “God,” while “Yahshua” mutates into “Jesus,” a substitute that is not even close to the original?

Why the change, when even the name of the Adversary – Satan – retains its original Hebrew form and close pronunciation? (Saw-tawn, **Strong’s Hebrew Dictionary** No. 7854).

Adam Clarke’s respected comments on the inferior early translations are informative: “Through the ignorance and carelessness of transcribers innumerable mistakes have been made in ancient names. These also have suffered very greatly in their transfusion from one language to another, till at last the original name is almost totally lost...Besides, neither the Greeks nor Romans could pronounce either the Hebrew or Persian names; and when engaged in the task of transcribing, they did it according to their own manner of pronunciation,” **Clarke’s Commentary**, vol. 3, pp. 393-394. Clearly, some over-zealous scribe tampered with the text of the King James Bible and what we have is a New Testament in which the Name of Yahshua has been adulterated and almost obscured.

For an example of this, look at Acts 7:45 in the King James Version. The sentence reads,

“Which also our fathers that came after brought in with Jesus into the possession of the Gentiles whom [Elohim] drove out before the face of our fathers, unto the days of David.” But the account is actually speaking of the Old Testament Joshua, the son of Nun!

Another example is found in Hebrews 4:8, *“For if Jesus had given them rest, then would he not afterward have spoken of another day.”* Many study Bibles will have notes on these two verses pointing out that the more correct name is JOSHUA the son of Nun.

Certain translations other than the King James have corrected this error and inserted “Joshua” in the text. Thus, we can see that this name is the same as that given by Moses to his successor in Numbers 13:16. It is also the name of the Savior (corrected with the “Yah”). This shows how the translators overzealously changed all the “Yahshua’s” to “Jesus”—even when it referred to someone in the Old Testament not the Savior.

Go to **Strong’s** Hebrew Dictionary and peruse page 47, taking special note of the second name from the top of the right column, No. 3050, YAHH. Notice this is the correct spelling and pronunciation of the short form YAH and includes the *qametes* under the *yod*: (**3050**. hy **Yahh**, yaw).

Although author James Strong is noted for his classic concordance, his understanding of the Name was lacking and he used the erroneous Jehovah. However, his is correct in listing No. 3050 YAHH, spelling it with the vowel a instead of e and the double hh to bring out the “ahh” sound.

The importance of the short form YAHH takes on additional significance when we read John 5:43, *“I am come in my Father’s name....”* We understand this to mean that He came in the authority and power of the Heavenly Father. Yet, we must understand that His Name Yahshua also included His Father’s Name, YAH. It is the short form, the prefix of the Name Yahshua! (Followers of Yahshua will be carrying that Name in the Kingdom, Eph. 3:14-15; Dan. 9:19).

The custom of reading a substitute name when the Tetragrammaton was encountered in the Hebrew Scriptures was carried over into the Greek translation of the Hebrew Bible, the **LXX** (Septuagint). The translation was said to have been made by seventy Hebrew translators for the King of Egypt who wanted a copy of this great book of the Hebrews for the grand library of Alexandria in Egypt. The letters **LXX** (meaning “70”) are often used as an abbreviation for the Greek Septuagint translation of the Old Testament.

Harold Stough Notes The Girl Who Was Killed by Jews In Germany

MANY legends across Europe relate to the Satanic deeds Khazars masquerading as “God’s chosen”! The following legend is from Jacob and Wilhelm Grimm’s *Deutsche Sagen* (1816 - 1818).

In the year 1267 in Pforzheim an old woman, driven by greed, sold an innocent seven-year-old girl to the Jews. The child soon died from the torture, and they weighted her down with stones and threw her into the Enz River.

hand above the streaming water. A number of people, including the Margrave himself soon assembled. Some boatmen succeeded in pulling the child out of the water. She was still alive, but as soon as she had called for vengeance against her murderers, she died.

Suspicion fell upon the Jews, and they were all summoned to appear. As they approached the corpse, blood began to stream from its open wounds. The Jews and the old woman confessed the evil deed and were executed. The child's coffin, with an inscription, stands next to the bell rope near the entrance to the palace church at Pforzheim. The palace church dating from the 11th century is one of the few remnants of the

old palace of the Margraves of Baden-Durlach in Pforzheim.

Children of the members the boatmen's guild unanimously pass the legend from generation to generation that at that time the Margrave rewarded their ancestors by freeing them from sentry duty in the city of Pforzheim "as long as the sun and the moon continue to shine." At the same time they were given the right to be represented by twenty-four boatmen, carrying arms and musical instruments, who parade and stand watch over the city every year at the Carnival celebration. This privilege applies even to this day.

human affairs. If he rejects those Truths, he will bring retribution upon himself.




The Holy Graal

U.K. Licensee for the popular American board game, Monopoly. As it happened, 'games and pastimes' was a category of item qualified for insertion into

'CARE packages', dispatched by the International Red Cross to prisoners of war.

Under the strictest of secrecy, in a securely guarded and inaccessible old workshop on the grounds of Waddington's, a group of sworn-to-secrecy employees began mass-producing escape maps, keyed to each region of Germany or Italy where Allied POW camps were regional system). When processed, these maps could be folded into such tiny dots that they would actually fit inside a Monopoly playing piece.

As long as they were at it, the clever workmen at Waddington's also managed to add:

1. A playing token, containing a small magnetic compass
2. A two-part metal file that could easily be screwed together
3. Useful amounts of genuine high-denomination German, Italian, and French currency, hidden within the piles of Monopoly money!

British and American air crews were advised, before taking off on their first mission, how to identify a 'rigged' Monopoly set -- by means of a tiny red dot, one cleverly rigged to look like an ordinary printing glitch, located in the corner of the Free Parking square.

High Treason

According to the old laws of England which are still in force, many current British politicians qualify for hanging and their laws are null and void.

THE BRITISH NATION is bedevilled today by alien organisations that have established themselves within our Christian Nation and aim to take us over, to destroy our Christian culture and force us to follow their preconceived designs. Unfortunately they have infiltrated themselves into our educational and religious systems and have educated many adepts among our people who unknowingly carry out their will. Many of them have been advanced to high places.

Laws Against Establishing A Foreign Power In England

Firstly it gives the subject immunity or freedom from action or suite and secondly to protect the safety of the subject and his goods, lands and possessions from violence, unlawful molestation and wrong. This the subject gains by right and by law. Subjects are protected by the King, by the law and by the King's writ.

'Praemunire doth fortify Jurisdictionem Jurium Coronae Suae of the Kingly laws of the Crown against foreign jurisdiction and against the usurpers upon them as by divers acts of parliament appears.... A man who by judgement given against him upon writ of Praemunire Facias etc. is out of the King's protection. For such of these crimes for which any shall have this judgement, to be hanged by the neck until he be dead and shall forfeit all his lands and chattels.'

Misprision Of Treason

Misprision of Treason is an offence or misdemeanor akin to treason or felony. It is the neglect of duty by a public official who conceals a knowledge of treasonable actions or designs. At an assize it may warrant the same penalty as High Treason. A subject of the Crown is also

bound to inform the magistrates if he knows that High Treason is being contemplated.

Establishing An Imperium In Imperio: The Jews

The Jews had been in England in Anglo-Saxon times dealing in slaves. Jews however came into England with the Norman Conquest. They made themselves a threat to the people of this country by (1) clipping the gold coinage and turning the clippings into bullion for sale overseas (2) dispossessing good Christian Englishmen of their lands and property by high interest rates in usury (3) by the ritual murder of young Christian boys by crucifixion and drawing off the blood for ritual purposes; particularly Hugh of Lincoln in 1255; a child sacrificed in Nottingham in 1279; and the ritual murder of a boy in Oxford by the Jew Isaac de Pulet in 1290 (Patent Roll. Edward I, mem. 21 21st June, 1290; Public Records Office).

On the 18th of July 1290, by a royal decree, King Edward I in his council expelled all Jews forever from England. Writs were sent out to the sheriffs of the English shires informing them that by royal edict all Jews were to leave the English realm before November 1st 1290, anyone who remained were to be executed. The population and parliament reacted with relief and great joy (Calendar of Close Rolls, 18 Edward I, Public Records Office). In his book Edward I (London, 1988) page 343, Michael Prestwick states that at a Parliament summoned to Westminster in that July a subsidy was granted and was collected. This subsidy was a thank offering for the Jews' expulsion.

The Jews Present Begging Letters To Cromwell

Various Jews made begging petitions to Oliver Cromwell to get him to revoke the Edict of Expulsion; but Cromwell, being only a commoner, could not revoke a royal edict and knew this. In February 1658 Cromwell is said to have made an oral commitment to Antonio Fernandes Cavajal, the leader of the Jews (buried under the name of Abraham in the Jews' cemetery, London 1659), assuring his protection.

This was in defiance of the recommendations of the council that the Jews should only be permitted the standing of ordinary aliens. This is the situation today (lecture by Lucien Wolf to the Jews College Literary Society in 1877).

Joan Comay, wife of the Israeli Ambassador to the Court of St. James and to the United Nations wrote in her book *Who's Who in Jewish History After the Period of the Old Testament*, published in 1974:

'Manasseh [ben Israel] returned to Holland in October 1657, deeply distressed at what he considered to be the failure of his mission. Cromwell remained on friendly terms with him and granted him a pension of £100 a year. Although Edward I's edict of expulsion was not formally revoked as Manasseh had hoped, the resumption of Jewish worship achieved the same practical result. The edict has actually not been revoked to this day.'

Because of the expulsion of the Jews from Europe, the Jews sent an appeal for advice to the Sanhedrin on the 13th of January 1489. The reply came back from the Prince of the Jews in Constantinople. It advised the Jews of Europe to adopt the tactics of the Trojan Horse: to make their sons Christian priests, lawyers, doctors etc. and to destroy the Christian structure from within. Thus, by 1990, we have had one known Bah-Mitzvahed bishop in the Church of England, Bishop Hugh Montefiore, numerous Jewish Queen's Counsels in the legal profession and at least seven foreign Jews in the House of Lords.

It may be disputed that these old edicts have fallen into disuse and are no longer applicable. At a celebration to commemorate the conquering of England by William Duke of Normandy in 1066 held at Caen, the Mayor of

Bordeaux assured all those present that the town of Bordeaux had faithfully paid the levy on wine placed on the town throughout the whole period of 900 years. An attempt had been made to have the levy annulled but this could not be done since the Queen of England is still Duke of Normandy, and Count of Aquitaine.

Israel Moses Sieff with his Political and Economic Planning (P.E.P.) tried to get rid of ancient territorial boundaries for the new county councils. Although the new county councils are in operation, all law officers functioning in Lancashire are appointed by the Duchy and County Palatine of Lancaster and not by the Lord Chancellor of Parliament. The courts are Duchy courts and all offences are against the Duke's peace. The County Palatine of the Duchy of Lancaster is outwith the jurisdiction of parliament under the wills of Henry II, Henry III and Henry IV, and certain acts of parliament are inapplicable within the Duchy. A similar position is found in the Principality and County Palatine of Durham.

Being prohibited aliens by the Edict of Expulsion Jews have no right to sit in our houses of parliament, nor on our local government councils. They have no right to be in the judiciary nor to hold office in the executive of government nor in the police force. All purported laws and purported acts of parliament in which Jews have taken part in the voting are illegal, unconstitutional: null and void.

Contrary to the Statutes of Praemunire traitors we elect to parliament have allowed the Jews to establish an Imperium in Imperio, the 'Board of Jewish Deputies,' which have gained to themselves powers to influence the policies of British governments to their own universal advantage. The Daily Telegraph of 19th January 1972 stated: "The Zionist Congress is the head of the world's political movement." World's Works – Inner Mountain Jewish News on 1st March 1976 stated:

‘This world organization has a highly centralized form of government, this consists of an international committee including representatives from all countries that have a local organization. But the real control is vested in what is known as the Inner Actions Council. This is a compact body of only seven men and it is dominated by the Jews of Europe.

Muslims Attempt To Set Up Another Imperium In Imperio

It is the function of the Attorney General to advise governments and government departments (see Whitaker's Almanac). Succeeding Attorneys General have failed to advise governments of the implications of the contents of Magna Carta, the Petition of Rights, the Bill of Rights and Habeas Corpus. This is a dereliction of duty. Another attempt to establish an Imperium in Imperio by aliens, a felony of Praemunire, was reported in the Daily Telegraph of 15th July 1990. It was stated that the Muslim leader Kalim Siddiqui called for a special relationship between Muslims here and the government of Iran.



He launched a manifesto to politicise Britain's Muslim community which aimed to establish an Islamic parliament, to persuade Muslims to discriminate in favour of other Muslims, to place the names of all Muslims in Britain on a computer database and to raise five million pounds to establish a Muslim parliament in Britain.

To do this is to commit the felony of Praemunire punishable with death by hanging. The culprits are those subjects of the Crown who have allowed this situation to arise. It is up to the government to give all Muslims their marching orders out of this country or incur the penalties laid down for Praemunire, allowing aliens to establish an Imperium in Imperio.

In bringing this matter to the attention of fellow subjects of the Crown I am under the Queen's protection for as Fitzherbert wrote (Vide 7 Co. 8, 9, Calvin's Case ANT 130a, Sect 199) "Every loyal subject is in the Queen's Protection."

The Purported Race Relations Acts

The so-called Race Relations Acts are conspiracies to use acts of parliament to enforce the racial integration of subjects of the Crown with Negroes and Asiatics especially brought here for the purpose. They are acts of racial hatred against us by prohibited immigrants. The Race Relations Act of 1965 was introduced to parliament by the Russian Jew Frank Soskice, purported Labour Attorney General. Further Race Relations Acts were devised by the Board of Jewish Deputies.

The Jewish Chronicle stated that amendments must be made to the Race Relations Act since the 1965 Race Relations Act was not working the way they wanted it to. The 1976 Race Relations Act was passed in the Commons by default, with only 132 of the 635 members present; 124 Labour and Liberal traitors voted for the bill with eight Tories against.

To terrorize the masses it was required to establish a network of so-called human rights agencies, the 'Race Relations Industry.' Ivor Benson writes that:

'the task was to penalize the instinctive responses of the local resident population in the presence of inassimilable neighbours who have been forced upon them... Hereto there are rich pickings for decadent, deracinated elements who help to impose the tyranny, like human dregs who rule the roost and spend millions of the tax-payers' money in Britain's innumerable inner-city ghettos. Nor should we omit to mention the zealous active connivance of politicians and bureaucrats whose greed for personal advancement is rationalized with a spurious humanistic ideology.'

There are three phases in this Jewish imposition of race mixing:


Phase One: Inassimilable population elements are introduced into all-White communities of the West as legitimate immigrants, supposedly because their labour was needed.

Phase Two: Public opposition is circumvented by introducing them as refugees.

Phase Three: Which came into effect right from the start, is a massive and sustained campaign of

mental terrorism aimed at suppressing every form of popular dissent and opposition. The campaign of terrorism has taken two forms, one aimed at the leadership and the other at the masses. Immigration



The massive immigration of Islamics and other coloured peoples is illegal and the British people, subjects of the Crown, were never consulted about whether they wanted their country to become a multi-racial, multi-cultural society.

Mrs Margaret Thatcher deceived

the nation in 1979 when she declared that Britain was becoming swamped with immigrants, using the fears of the subjects of the Crown to gain votes and giving the impression that she would stem the flow. Having got her party into government she did nothing about it, only allowed vast numbers more into the country. Multi-racialism and multiculturalism has been illegally and unconstitutionally imposed on this nation and the Jewish power controlling the government will ensure that the nation will never be consulted.

The Purported Public Order Act Of 1986

The so-called Public Order Act of 1986 is a conspiracy to use an act of parliament to enable investigators to enter the homes of subjects of the Crown to gain evidence to initiate action in the law courts against those offending against the purported Race Relations Act. This Act was

placed before parliament by the purported Conservative Home Secretary, the prohibited Jewish immigrant from Lithuania, Leon Brittan, also known as Leon Brittan, assisted by his cousin, another Lithuanian Jew, Malcolm Rifkind, also known as Malcolm Rifkind. This bill was primarily to prevent subjects of the Crown from discussing and revealing the Jewish take-over of our nation.

The Purported Nationality Act

The so-called Nationality Act is a conspiracy to use an act of parliament to take away our rights as subjects of the Crown. This act makes the place of birth rather than the genetic and racial identity of the individual the criteria for nationality. Britons from Australia and Canada visiting the continent from Britain were surprised on their return to be presented with documents to sign marked "Alien" while Pakistanis and other Asians passed through with British passports as British nationals.

This Act purports to replace ancestry, that for generations has been the practical definition of the British subject, by the definition of an accidental place of birth. Thus it seeks to encourage the development of a nation of half-breeds and to swamp and destroy the British people and their customs.

In *The Common Law of England*, 198. N2, Sir Edward Coke states:

'Persons born beyond the seas, if their fathers or paternal grandfathers were natural born subjects, are likewise made so, though with an exception of some unfavourable persons.... Liegeus is ever taken for a natural born subject... Liegeance, a liegando, being the highest and greatest obligation of duty and obedience that can be. Liegance is the true and faithful obedience of a liegman or subject to his liege lord or sovereign. Alliegence is born of faith: alliegence is the essential law.'

Until William Whitelaw's Nationality Act we have been subjects of the Crown and under the protection of the Crown. This Act purports to deprive us of this and make us merely British citizens. This Act together with the European Communities Act and the Treaty of Rome aims at destroying the British Monarchy as soon as possible. It is High Treason.

By signing the United Nations Charter in 1946 and passing an act before parliament so-called British politicians were obliged to carry out the terms of the Charter. This entails the mixing of the races of the world to form a degraded population and the eradication of the British and other White races. These the planners regard, together with Christianity, as the main obstacles to the establishment of a totalitarian one-world government.

The United Nations Charter was drafted by Alger Hiss, a convicted communist and Soviet agent together with Andrei Gromyko, a senior Soviet official. Alger Hiss occupied the directional chair at the organizational conference of the United Nations. These people are aiming at genocide of the White race.



According to this Nationality Act the Queen is no longer our Queen and we are no longer her subjects. If we are no longer the subjects of the Crown this Act deprives us of the protection of the Crown, for according to the patent rolls of the Statute of

Northampton 1328 it is the duty of the Queen to protect her subjects despite parliament; thus we are protected from a possible anti-White anti-British parliament. This Act purports to deprive the Queen of her titles, lands and prerogatives. We no longer go to war for the Crown but for parliament. This is High Treason.

A letter from the Home Secretary dated 31st May 1988, which appeared in the Independent newspaper on Monday 17th June 1988, made it plain that Her Majesty the Queen is prepared to place at the disposal of parliament all her remaining prerogatives: the power to make war or peace, to ratify treaties, to grant honours; the list is formidable embracing just about all those powers which remained to the monarch after the glorious revolution of 1688. The signature at the bottom of the letter is that of Douglas Hurd. The person who drew the Home Secretary into

weighty correspondence is the cryptic left-winger, Tony Benn. Benn laid before parliament his Crown Prerogatives Bill to deprive the Crown of all the remainder of her prerogatives.

The Purported European Communities Act

The European Communities Act of 1972 and the Treaty of Rome aims at destroying the British monarchy as soon as possible.

This is High Treason the penalty for which is death by hanging and this is still on the statute books. Likewise any subject of the Crown who knows that High Treason is being carried on and fails to report it is guilty of Misprision of High Treason, the penalty may be death: to deprive the Queen of her Crown or any of her dominions. Article 189 of the Treaty of Rome is irreconcilable with the Oath of Allegiance. There is an absolute constitutional case that there is no statute authority for the executive acts that have bound the UK to the EEC, nor for the British Nationality Act. Both are contrary to the interests of the Crown and people.

The High Court of Great Britain disallowed an Act which was passed by our House of Commons and House of Lords and received the Royal Assent. This Act was the Shipping Act of 1988. The High Court referred the case to the European Court. This was the first case in the history of parliament that an Act passed by both houses of parliament with the Royal Assent and the regulations under it have been set aside. A British Court has interfered with an act of parliament in the interests of a foreign court. This is High Treason.

We can claim that the Queen carry out her coronation oath and protect us from alien and foreign-made laws.

We are legally not in the Common Market nor are we constitutionally a multi-racial multi-cultural society. Traitor Edward Heath carried out the plans of international Jewish financiers and multinational companies, the Imperial Institute for International Affairs and the Rothschilds to deceive the Queen in her grants. Many of us have taken the Oath of Allegiance to the Crown, her heirs and successors and demand protection from foreign-made laws made by aliens in Europe.

The History Of The Pharma-Cartel From Our West Midlands Correspondent



THE SUPREME COURT of the U.S. finds John Rockefeller and his Trust guilty of corruption, illegal business practices and racketeering. As a result of this decision, the entire Rockefeller Standard Oil-Trust, the world's largest corporation of its time, was sentenced to be dismantled. But Rockefeller was already above the Supreme Court and did not care about this decision.

1913: In order to disperse public and political pressure on him and other robber-barons, Rockefeller uses a trick called "philanthropy", whereby the illegal gains from his robber-practices in the oil business are used to launch the Rockefeller Foundation. This tax haven was used to strategically take over the health care sector in the U.S.

The Rockefeller Foundation was the front organization for a new global business venture of Rockefeller and his accomplices. This new venture was called the pharmaceutical investment business. Donations from the Rockefeller Foundation went only to medical

schools and hospitals. These institutions had become missionaries of a new breed of companies: the manufacturers of patented, synthetic drugs.

This was also the time when the first vitamins were discovered. It soon became clear however that these natural molecules had live-saving health benefits and that they were able to prevent many chronic health conditions. The first books appeared with research, subsequently abandoned, about the health benefits of vitamins. These newly discovered molecules had only one disadvantage: they were non-patentable.

Thus, in its first years of existence, the pharmaceutical investment business already faced a mortal threat: vitamins and other micronutrients promoted as public health programs would prohibit the development of any sizable investment business based on patented drugs. The elimination of this unwanted competition from natural micronutrients therefore became a question of life and death for the pharmaceutical business.

1918: The Rockefeller Foundation uses the Spanish flu epidemic – and the media (that it already controlled by this time) – to start a witch-hunt on all forms of medicine that were not covered by its patents.

Within the next 15 years, all medical schools in the U.S., most hospitals and the American Medical Association all essentially became pawns on the chessboard of Rockefeller's strategy to

subjugate the entire health care sector under the monopoly of his pharmaceutical investment business.

Disguised as a "Mother Theresa", the Rockefeller Foundation was also used to conquer foreign countries and entire continents for the pharmaceutical investment business – just as Rockefeller himself had done a few decades previously with his petrochemical investment business.

1925: On the other side of the Atlantic, in Germany, the first chemical / pharmaceutical cartel is founded in order to compete with Rockefeller's quest for control of the global drug market. Led by the German multinationals Bayer, BASF and Hoechst, the I.G. Farben cartel was founded with a total number of employees surpassing 80,000. The race for global control was on.

1929, November 29: The Rockefeller cartel (U.S.A.) and the I.G. Farben cartel (Germany) decided to divide the entire globe into interest spheres – the very same crime Rockefeller had been sentenced for 18 years earlier, when his trust had divided up the U.S. into "interest zones".

1932 / 33: The I.G. Farben cartel, equally insatiable, decides no longer to be bound by the 1929 constraints. They support an uprising German politician, who promises I.G. Farben to militarily conquer the world for them. With millions of dollars in election campaign donations, this politician seized power in Germany, turned the German democracy into a dictatorship and kept his promise to launch his conquest war, a war that soon became known as WWII.

In each and every country Hitler's wehrmacht invaded, the first act was to rob the chemical, petrochemical and pharmaceutical industries and assign them – free of charge – to the I.G. Farben empire.

1942-45: In order to cement its global leadership with patented drugs, the I.G. Farben cartel tests its patented pharmaceutical substances on concentration camp inmates in Auschwitz, Dachau and many other sites. The fees for conducting these inhumane studies were transferred directly from the bank accounts of Bayer, Hoechst and BASF to the bank accounts of the SS, who operated the concentration camps.

1945: I.G. Farben's plan to take control of the global oil and drug markets has failed. The U.S. and the other allied forces won WWII. Nevertheless, many U.S. and allied soldiers had lost their lives during the conflict, and the allies' reward was little compared to the rewards of others. The corporate shares of the losers, I.G. Farben, went to the Rockefeller trust (U.S.A.) and Rothschild / J.P. Morgan (U.K.).



1947: In the Nuremberg war crimes tribunal, 24 managers from Bayer, BASF, Hoechst and other executives of the I.G. Farben cartel were tried for crimes against humanity. These crimes included: leading wars of

aggression, instituting slavery and committing mass murder. In his final pleading, U.S.-Chief Prosecutor Telford Taylor summarized the crimes committed by these corporate criminals with the following words: "Without I.G. Farben, the second World War would not have been possible".

Amazingly, the real culprits for the death of 60 Million people in World War II – the I.G. Farben executives – received the mildest verdicts. Even those executives directly responsible for the crimes in I.G. Auschwitz only received a maximum of twelve years in jail. Surprised? You shouldn't be.

By 1944 Nelson Rockefeller had already entered the executive branch of the U.S. government. He started off as Under-Secretary of State and ended up a few years later as Special Adviser of President Truman for Special Affairs. In other words, at critical junctures of the 20th century, the Rockefeller interests took direct charge. They decided the post war shape of the world and the distribution of its wealth.

As such, under the influence of the U.S. State Department, the verdicts in Nuremberg against the I.G. Farben managers can easily be explained. In return for taking over the corporate shares of I.G. Farben, and thereby global control of the oil and drug business, Nelson Rockefeller made sure that the real culprits of World War II were not hanged. In fact, and as we shall see, they were needed.

1949: The Federal Republic of Germany was founded. This was the first time in history that the constitution and society of an industrialized nation could be planned and modelled as a fortress of the pharmaceutical investment business – a transatlantic outpost of the Rockefeller interests.

Within only a few years, the I.G. Farben managers sentenced in Nuremberg were released from jail and put back into their previous positions as stakeholders of the Rockefeller interests. Fritz Ter Meer, for example, sentenced to twelve years in jail for his crimes in Auschwitz, was back as chairman of the board of Germany's largest pharmaceutical multinational, Bayer, by 1963!



1945 - 49: The role of the Rockefeller brothers was not limited to their taking over the global monopolies of the oil and drug businesses. They also needed to create the political framework for these businesses to thrive. Under their influence, therefore, the United Nations was founded in 1945, in San Francisco. To seize political control of the post war world, three countries – leading drug export nations – had all the say, and 200 other nations were rendered mere spectators.

Founded as organizations to allegedly serve the wellbeing of the people of the world, the UN's subsidiary organizations, such as the World Health Organization (WHO) and World Trade Organization (WTO), soon turned out to be nothing more than the political arms of the global oil and drug interests.


1963: On behalf of the Rockefeller interests, the government of the pharmaceutical banana republic Germany spearheaded one of the most infamous efforts ever made within the United Nations. Under the pretense of consumer protection, it launched a four-decade-long crusade to outlaw vitamin therapies and other natural, non-patentable health approaches in all member countries of the United Nations. The

goal was to simply ban any and all competition for the multi-billion dollar business with patented drugs. The plan was simple: copy for the entire world what had already been accomplished in America in the 1920s – a monopoly on health care for the investment business with patented drugs.

Since the marketplace for the pharmaceutical investment business depends upon the continued existence of diseases, the drugs it developed were not intended to prevent, cure or eradicate disease. Thus, the goal of the global strategy was to monopolize health for billions of people, with pills that nearly cover symptoms but hardly ever address the root cause of disease. The deprivation of billions of people from having access to life saving information about the health benefits of natural health approaches, whilst at the same time establishing a monopoly with largely ineffective and frequently toxic patented drugs, caused disease and death in genocidal proportions.

This epidemic of unnecessary disability and death by the pharmaceutical business with disease is unparalleled in history.

Linus Pauling and other eminent scientists deserve credit for having kept open the door of knowledge about the health benefits of vitamins and other effective natural health approaches. If it were not for them we would already be living in a health prison today, guarded by the gatekeepers of the pharmaceutical business with disease in medicine, politics and the media.



Linus Pauling should also be credited for having identified the significance of Dr. Rath's early research in vitamins and cardiovascular disease, and for having invited Dr. Rath to join him during his last years to continue his life's work.

1990 - 92: These years will go down in history as the beginning of the end of the pharmaceutical business with disease. In a series of scientific publications, in some of which Dr. Rath invited Linus Pauling to join him as co-author, Dr. Rath identified micronutrient deficiency as the primary cause of diseases. These diseases include heart attacks, high blood pressure, diabetic circulatory problems, cancer and even immune deficiency diseases, including AIDS.

Like a Sherlock Holmes of science, Dr. Rath traced the real cause of these diseases, and found that they had been deliberately nebulized or even hidden away from millions of people for one purpose only: to feed the insatiable greed of the pharmaceutical business with disease.

Note: I. G. Farben was a Rothschild Company.

The Pyramids of Scotland by Jeff Nisbet



regarding my report about an intriguing Scottish leyline configuration I'd discovered:

For those unfamiliar with the term, leylines are the curiously exact alignment of ancient archaeological sites, conjoined over many miles, that academics dismiss as mere coincidence and that those who discover them cannot explain the “why” of. Crossing mountains and large bodies of water as they do, leylines never seem to follow the easily trod path—only the straight one.

I was studying the Knights Templar at the time—that enigmatic order of warrior monks barbarously suppressed in France during the early 1300's for believing in things that contradicted Vatican dogma at a most inconvenient time.

I had noticed a geometrical connection between two pre-eminent Templar sites in Scotland—their earliest-known headquarters in the tiny village of Temple and that famed architectural repository of Templar and Freemasonic lore, Rosslyn Chapel. Each could be connected to a third by straight lines drawn through two small islands to the northeast in the Firth of Forth—the islands of Craighleith and Fidra. Each connected to the Isle of May, 20 miles further out, where one tradition tells us the Templar fleet landed after escaping from France. Historian Stuart McHardy has recently suggested that “the May,” as it's locally known, is in fact the Isle of Avalon where legendary King Arthur is buried. Glastonbury supporters, staunchly supportive of their own pet site's long-held Avalonian connections, are not impressed.


Exactly midway between Craighleith and Fidra was a tiny island known locally as “the Lamb,” which would enter the equation later.

MOHAMED AL FAYED, owner of Harrods, listed his ten favourite books on the Manchester Guardian's website. One of them is “The Scotichronicon: A History Book for Scots,” described simply as “Scotland's debt to Egypt revealed at last.”

The legend claims that Scota was daughter to the pharaoh who pursued the Children of Israel out of Egypt on their Exodus to the Promised Land. Gaythelos, an exiled prince of Greece, was Scota's husband. Shortly thereafter, the couple is forced to lead an Exodus of their own out of Egypt—going first to Spain, then Ireland and, finally, to Scotland, which was named after Scota. Their bloodline flowed down the centuries through all the high kings of Ireland and Scotland. But Gaythelos' pedigree was more ancient still—stretching back many more generations to Old-Testament patriarch Noah, eldest survivor of the Biblical Flood.

On March 27, 2000, I received the following comment from an eminent UK archaeologist

I had then drawn three additional interconnected lines.



The first stretched exactly due south from Craighleith to the Cistercian Abbey of Melrose. Founded contemporaneously by Abbot Bernard of Clairvaux, the Cistercians and the Templars are thought by many to be two arms of a single order. Interestingly, I

later discovered that if the line is continued far to the south of Melrose it arrives, unerringly, at Glastonbury.

The second line headed in a northwesterly direction from Melrose, exactly through both Temple and Rosslyn, to a place called Crossford, where it intersected the third line.

That third line headed due west from Craighleith, passing through Dunfermline Abbey along the way. Robert the Bruce, quasi-hero of my “Mystery of Bannockburn” article (AR#31), was buried at Dunfermline, but his heart was removed and carried on an ill-fated journey to the Holy Land. Brought back to Scotland from Spain, which is as far as it got before the “infidel” horde put a stop to its passage, the heart was interred at Melrose, just a day’s ride shy of a reunification with Bruce’s body. History does not tell us why.

My leyline configuration buzzed with a significance that seemed to preclude mere coincidence. But a cautionary finger had been raised on my leyline investigation, so I put it on the back burner—but not for long.

While researching my Bannockburn piece, I often viewed a computer simulation of the eastern sky as it would have appeared on the day of battle. Countless times I observed the three equidistant “belt stars” of the constellation Orion rise invisibly in the daylight sky, and at some point I noticed they were rising over Fidra, the Lamb, and Craighleith. Throwing caution to the wind, I decided that the Lamb deserved some attention—sanity be damned.


I then drew a line from the May, through the Lamb and the exact midpoint between Rosslyn and Temple, just to see where it might lead. It led to a tiny spot called Tara, far away in Ireland, where the high kings of that land were crowned—kings descended from Scota and Gaythelos.

Curiouser and curiouser!

On a wall of Rosslyn Chapel’s underground crypt, the oldest and holiest structure in the building, is what’s been called a “working Masonic drawing.” It is shaped more like an obelisk than a pyramid, and yet it sang a siren song to me. The central line of the drawing passes through three pyramids—as viewed from above!

Why despoil a holy place, forever, with a drawing that could have been more easily scratched in dirt? Is that not curiouser still?

When it is visible, Orion is the most spectacular constellation in the sky—and little wonder. Of all the constellations, Orion is the least abstract—and is strikingly humanoid in shape. But of all its seven main stars, the belt stars have received the lion’s share of attention over the millennia. Called simply “three in a row” by native North Americans, their relative positions have been recently correlated, by researcher Robert Bauval, to the groundplan of the pyramid complex at Giza.




Orion and nearby Sirius, the brightest star in the sky, are inextricably linked to both the ancient Egyptian belief system and the mysterious symbolism inherent in today’s bizarre Freemasonic rituals, practiced since the brotherhood’s earliest days, but now little understood—even by Freemasons, themselves.

Could the key to what has long been referred to as “The Lost Secrets of Freemasonry” have been hidden in the light of day, east-southeast of Bannockburn, on June 24, 1314?

On a wild hunch, I decided to bring Orion and Sirius down to Earth, laying the three belt stars

exactly on top of the three islands in the Firth of Forth. Incredibly, Sirius lay on tiny Inchcolm island, farther west in the Forth, where Walter Bower had written his *Scotichronicon*. In Richard Hinckley Allen's "Star Names: Their Lore and Meaning," the author cites a Hindu astrological tradition which personifies Sirius as a hunter who shoots a three-jointed arrow which pierces Orion through the waist.

It's interesting that Walter Bower's surname derives from the craft of bowmaking? Could it be that Bower, finishing his book, let fly an arrow of forbidden knowledge towards a more enlightened future?



The other stars in the Orion/Sirius configuration, however, were not so accommodating. Bellatrix, the star that marks Orion's right shoulder, lay insignificantly in the sea, far from the May, the island my "compass" had suggested played a major role in what looked increasingly like a message from the past.

On another wild hunch I enlarged the stellar group, pivoting it on Craighleith, until Bellatrix lay on the May.

The result was riveting!

Sirius now lay on Torphichen, headquarters of the Knights Hospitaller—the Catholic military order that "absorbed" the remnants of the outlawed Templars and, by the grace of Rome, acquired most of their property to boot. Recent research, however, suggests the Templars may have continued to maintain a secret autonomy within the Hospitallers.

But that's just the beginning.

A line drawn from Bellatrix through Orion's left shoulder (Betelgeuse), led directly to Dunsinane Castle, immortalized in Shakespeare's "Macbeth."

Keith Laidler, author of "The Head of God," relates an interesting tale about Dunsinane. He cites an 1809 newspaper article reporting that a large stone of "the meteoric or semi-metallic kind" had been discovered hidden beneath the castle. The stone was sent to London for study, but disappeared en route. Laidler goes on to say that it was Scotland's real Stone of Destiny, and that the stone upon which British monarchs have since been crowned is a substitute. This real stone, he claims, is the Throne of Akhenaten, the heretic pharaoh who tried and failed to establish monotheism in Egypt shortly before the Biblical Exodus. That stone began its journey to Scotland with Scota, who Laidler says was Akhenaten's daughter, while Akhenaten led the Exodus to the Promised Land under the name given to him in the Bible—Moses!

Could today's Christians and Hebrews be linked to a common Egyptian patriarch? The implications are staggering!

But where did Betelgeuse lie—the star between the May and Dunsinane?

My map showed a featureless landscape. But subsequent research revealed that an ancient stone circle, now "lost," had once existed to the west of the nearby hamlet of Dunino. If the lost circle proves to lie under Betelgeuse, archaeologists will have a merry time losing it again.

The stars at Orion's feet also lay in interesting locations.

Rigel, Orion's right foot, stood on the lands of Yester. Built in 1297 by the "Wizard of Yester," Hugo de Gifford, Yester Castle stands over a sizable underground cavern known as the "Goblin Hall," where Hugo practiced his "magic," and passed to the Hay family in the 14th century. Father Richard Hay later wrote a history of the Sinclairs of Rosslyn. Lord William Sinclair, it's said, actually moved his castle to free up the chapel's building site. Location was everything, I guess—even back then!

Saiph, Orion's left foot, stood between the towns of Musselburgh and Prestonpans, on land once owned by the Cistercian monks of Newbattle, and later associated with the Templar-connected families of Seton and Kerr. Besides hosting one of Scotland's first Masonic Lodges, the area also hosted the first meeting of the North Berwick Witches—accused in 1590 of plotting to murder Scotland's first officially Masonic king by the "abomynable cryme of wytychcraft." The

trumped-up case helped kick off over 100 years of witch persecution in Scotland, barely covered in mainstream histories.

Here's the kicker:

A line drawn from Rigel, through Saiph, led directly to Bannockburn, site of the great Scottish battle for independence where, on Midsummer's Day, 1314, a great message was hung invisibly in the dawn—a message meant to *eventually* reveal that we've been fooled for a very long time.

Surprise, surprise!



Last April I drove out of Edinburgh to take photographs of the three belt-star islands, and was struck by the shape of North Berwick Law, the peak that stands just to the south of Craigeith. It looked remarkably like a pyramid, so I made some calculations.

According to Hancock & Bauval's "Message of the Sphinx," the bottom of the square pit in the center of the Great Pyramid's subterranean chamber lies 610 feet below the pyramid's summit platform. North Berwick Law stands at 613 feet!

Care to split some very fine hairs, anyone?

From the top of North Berwick Law the islands of Craigeith, the Lamb, and Fidra lie stretched along the coast like pearls on a string. The questions cannot be avoided: How could they possibly be positioned, each to the other, like the Giza pyramids? How could they lie below the rising of Orion's belt in the Bannockburn dawn? How could North Berwick Law be pyramidal? How could natural geological features be so conveniently where they are in the first place without divine intervention? And why, in that small corner of the world, do the voices of myth

and history join to sing a siren song to people like me, and maybe you?

Perhaps I can suggest answers to some of those questions, and raise new ones.

Risking the hoots and hollers of academia, I propose that North Berwick Law and the islands of the Forth are where they are due to large-scale "terraforming"—i.e. shaping the landscape to suit a purpose that is only now emerging from the mists of time.

On a mid-17th-century map of the area, supposedly based on the original but now mysteriously lost drawings of late-16th-century mapmaker Timothy Pont, the three belt-star islands are shown. But there are curiosities about their presentation. The orientation of the grouping is wrong, and the Lamb is called "Long Bellenden."



because the Lamb is not long at all. In fact, it is the shortest of the three islands. Could it have been shortened to "sharpen" the aim over the vast distance from the May to Tara? Might not the islands have been one long island at some point, carved from the mainland by a cataclysm the ancient "myth

makers" would only hint at, and then cut into three? And might not North Berwick Law have been "shaped" from the tailings of such an enormous excavation? Just take a look at Fidra, sliced almost in two and bored clear through, and ask yourself if it was shaped by God, Nature, or the helping hand of man!

I realize I stand on shaky ground here, but not without consideration—and I welcome your arguments. Be warned, however, that this article could have been a lot longer. The simple grid shown here has blossomed into greater bloom—and I'm loaded for bear!

History tells us we're the greatest civilization ever to walk the face of the earth. Wars have been fought since time immemorial over matters of faith—each side believing that God is on their side. But what if the things that make us swing our swagger sticks are wrong? Who'll forgive us for the damage we've done, fool unto fool, believing in lies?

Orion was brought down to earth in Scotland, and then later nailed in place by tales of a legendary stone, a holy chalice, a magical sword, a battle the world would not soon forget, and a once-and-future king named Arthur.

Much care was taken, over dangerous times, to make us think. Perhaps now, more than ever, it's time we did.

Where Are The 'Lost' 10 Tribes? An Interesting Comment Posted On The Baptist Board Website (USA) - 2004 From Our East Anglia Correspondent



The Reverend Dr Dean Jean Jacques Abbadie (left) the greatest scholar in Europe of his day, 1654-1727, and of an old Huguenot family, in his *Le Triomphe de la Providence et de la Religion*, published in Amsterdam in 1723, stated:

"Unless the Ten Tribes have flown into the air, or have been plunged to the centres of the earth, they must be sought for in the north and west, and in the British Isles".

The writer of this Bible and secular study feels a very special affinity with Dr Abbadie, as his own family ancestors too were French Huguenots, Protestant Christians who had to flee from France to England several centuries ago to escape dreadful persecution or death because they believed the Bible as the Word of God, and not the Papal (Roman Catholic) doctrines. Remarkably enough, Dr Abbadie applied for English denizenship in 1687, as did some of the writer's own Huguenot ancestors (the Seguin's) in the same year, (obtaining naturalisation subsequently): Dr Abbadie soon afterwards became the pastor of the London French Protestant Church known as The Savoy, with

some of the Seguin's as members of his church congregation. Hence the feeling of close affinity. I find it very remarkable to know that three hundred years ago a French Huguenot 'B.I.' taught my ancestors, and now in my own generation I likewise teach these precious truths. The reference in Dr Abbadie's statement to the Ten Tribes being in the north and west, and in the British Isles, is quite simply due to the fact that as a scholar, he knew that, e.g. the prophecies of Isaiah which are addressed to Israel 'in the isles' pertained to the BRITISH ISLES, for, as Hebrew scholars have noted, those isles are clearly identified in the Hebrew language of Scripture. One small example relating to Israel being in isles north-west of Palestine is at Isaiah 49/12; it should be understood that the Hebrew language has no equivalent for 'north-west', but instead would be 'north AND west'. Ferrar Fenton renders the verse "Look! these came from afar! these from the north-west!" The whole chapter is a wonderful example of the LORD's unfailing faithfulness to His covenants with Israel, here shown to be in isles north-west of Palestine.

Professor Odlum, formerly of Tokyo University, says: "The proof that the Anglo Saxon people

are the House of Israel in a national and official sense is as clear to my mind as the noonday sun is to the eyes of mortals". King George 6th, broadcasting to the nation on the eve of 'D-Day', June 6th 1944, said: "We dare to believe that God has used our nation and Empire as an instrument for fulfilling His High purpose". And the Rt. Hon. Winston Spencer Churchill, British Prime Minister, speaking to the United States Congress in 1942, said: "He must indeed have a blind soul who cannot see that some great purpose and design is being worked out here below of which we have the honour to be faithful servants".



In the Times newspaper of 7th May 1919, the late Lord Fisher, Admiral of our Fleet, stated: "Why we win, in spite of incredible blunders, is that we are the 'lost' Ten Tribes of Israel". Professor Piazzzi Smyth, late Astronomer Royal for Scotland, said: "The effect of the discovery of the identity of the Anglo-Saxons

with Israel is two-fold. First, it causes us to behold and acknowledge therein the accomplishment of a true miracle, and of the mightiest kind through the ages, consummated in our own days. Second, it causes the Bible to become for us, as it was for the tribes of Israel of old, an infallible Book for national guidance in politics, as well as a collection of inspired instruction for each individual soul in religion". William Tyndale, the Protestant martyr, and translator of our English Bible, stated: "The properties of the Hebrew tongue agree a thousand times more with the English than with Latin". Canon Lyson compiled a list of four thousand Hebrew words from English dictionaries and stated: "The Hebrew is the structure on which the English language was built". Professor Max Muller of Oxford University stated that English contained eight hundred Hebrew roots. The Rev Jacob Torillin, in his Comparative Vocabulary of Forty-Eight Languages, states: "About one fourth of the words in our own Saxon tongue bear an affinity with the Hebrew in primary or secondary degree. Not only in words does this affinity exist... but in the arrangement of ideas and in the single structure of the sentences it also has a near

agreement". The Rev. Eliezer Williams. Vicar of Lampeter (1784) states: "The roots of the ancient British, or real Welsh, words, may be regularly traced in the Hebrew (language)... Scarcely a Hebrew root can be discovered that has not its corresponding derivative in the ancient British language". Alex. Geddes, LL.D., says: "Luckily for an English translator of the Bible, he will not be often under any great necessity of departing much from the arrangement of the Hebrew, especially in the poetical parts of Scripture, where the two idioms are so congenial as to appear almost like twin brothers".

In the 1976 swine flu outbreak, many who got the flu shots developed permanent nerve damage. Llanrhaidr (*Llanrhaeadr*) Church



This extract from "The History of Wales" by Caradoc Clancarvan (1832) is another example of our rich Hebrew heritage hidden away in Parish Churches scattered across the UK

Llanrhaidr, or "The Village of the Fountain," is situated on a small eminence in the middle of the vale, between Ruthin and Denbigh. The church, which is dedicated to Saint Dyvno, who lived about the close of the sixth century, is rather a handsome structure, with a large and elegant east window, remarkable for a fine painting of the genealogy of Christ, executed about the year 1533, and containing all the names of the kings of Israel and Judah up to our Saviour. The Patriarch is represented upon his back, with the genealogical tree springing from his stomach. In the churchyard is a tomb-stone, with an inscription for John ap Robert, of Perth, a descendant of Cadel, King of Powys, who died in the year 1645, at the advanced age of 95. Here are some almshouses for eight poor widows, founded by Mrs. Jones, of Llanrhaidr, in 1729, and each has her garden and two shillings

a-week. From an eminence in this parish, called Cader Gwladus (or Gwladus's Chair), there is a beautiful view of the vale between Denbigh and Ruthin, and at the foot of this rising ground is Dyfnog's well (Ffynnon Saint Dyfnog). The fountain is enclosed in an angular wall, decorated with small human figures, and before it is the well for the use of pious bathers. It is generally called Llanrhaiadr yn Cynmeirch and Llanrhaiadr yn Nyffryn Clwyd, to distinguish it from Llanrhaiadr yn Mochnant.

The Well



According to tradition St. Dyfnog lived at the site of the well spring named after him in the 6th century, doing penance by standing under the torrent in his hair shirt belted with an iron chain. The festival of St Dyfnog is 13th February.

The well became known for its healing powers. By the late middle ages this spring was among the most renowned Welsh holy wells, attracting numerous pilgrims and bardic poems in its praise. The strength of the spring was a notable feature. In the 16th century Leland noted "a mighty spring that maketh a brook running scant a mile"

Lhuyd (1698) records "a bath, much frequented, the water heals scabs, itches etc, some say that it would cure the pox."

By the early 18th century it had developed such that Browne Willis refers to "the famous well of St Dyfnog, much resorted to, and on that account provided with all convenience of rooms etc, for bathing, built around it."

Towards the end of that century Pennant visits, reporting that "the fountain was inclosed in an angular wall, decorated with small human figures, and before the well for pious bathers."

During the middle ages the well generated considerable wealth for the area, and the creation of the sixteenth century Jesse Window in the church was supposedly financed by revenue from the well, although there is an alternative tradition that it was relocated from Basingwerk Abbey following its dissolution.

The site's proximity to St Winefride's Well at Holywell was advantageous, since St Dyfnog's was frequently included in the itinerary for pilgrimages to St Winefride's.

The buildings, including the reported marble linings to the pool, and statues have now disappeared, leaving just the stone lined remains of the bathing pool. Remaining too, however, is evidence of the landscaped woodland path created to the site in the nineteenth century including a number of small stone bridges which cross the stream that descends from the well.

There are actually two springs that feed the well, having variously, and sometimes confusingly been known as Ffynnon Dyfnog and Ffynnon Fair. Lhuyd in 1698 states that Ffynnon Fair is "a little above" Ffynnon Dyfnog. The Royal Commission report in 1914 implies that Lhuyd identified the main spring as Ffynnon Fair, however it is probable that this is an incorrect assumption, and this is more likely Ffynnon Dyfnog.

The main spring now rises from beneath a concrete slab to the northern end of the pool. This represents the strong flow noted in the past. It now splits into two sections, one feeds the pool, the other forms a stream which flows past the pool and down the valley beside the church. The overflow from the pool rejoins this stream further down the valley. The CPAT visit report suggests that this stream may have at some time been diverted to the east as a leat, possibly to the gardens of Llanrhaeadr Hall; the now dry remains of this course can still be identified.

St Dyfnog's Well is located at Llanrhaeadr, Denbighshire. The well, which isn't signposted, is accessed from the church. A path running up the left hand side of the church follows a stream through the woods. The well is about 200 yards up from the church.






