HE GREEK EPI CAN BE TRANSLATED AS "in" or "on", both are valid. Epi can also be translated as "into", "in a place", and "among". All English versions prior to 1890 translate epi as in.

The Greek charagma is translated "a scratch or etching", "a badge of servitude", "graven", and "mark". Charagma is also closely related to charax which means "to sharpen to a point".

The English word graven (one of the definitions of charagma as listed above) is defined as "To sculpt or carve; engrave" and "To stamp or impress deeply; fix permanently."

The earliest use of the word charagma outside of the Bible describes the piercing bite of a snake. The fang of a snake closely resembles the syringe used to implant the Verichip.

The number 666 was written in the original Greek with the letters chi xi stigma (600 60 6).

The Greek stigma is defined as "to 'stick", "a mark incised or punched (for

recognition of ownership)", and "mark." This definition is very close to that of the Greek charagma.

The Greek letters chi and xi both resemble a snake ready to strike. This coincides with charagma as the bite of a snake and the "piercing serpent" Satan who is associated with the Beast of the sea.

Stigma made it into the English language where it's defined as "a mark of infamy or disgrace".

Charagma, epi, and chi-xi-stigma (666) all have important meanings. They paint the clear picture of a surface being punctured by a sharp point. After studying the Greek words its easy to see that the Mark of the Beast could be closely related to microchip implants like the Verichip which are injected through a syringe and are used heavily in commerce.

It's hard to ignore these similarities when the Verichip has already been used to buy and sell. We must honestly weigh all the evidence when considering such a possibility. It's much more than just hype and coincidence so take heed.



UPC Bar Codes:

So, what is this invention that the people at Microsoft decided to patent? The abstract of the patent application online states: "Human body activity associated with a task provided to a user may be used in a mining process of a cryptocurrency system.

A server may provide a task to a device of a user which is communicatively coupled to the server. A sensor communicatively coupled to or comprised in the device of the user may sense

body activity of the user. Body activity data may be generated based on the sensed body activity of the user. In other words, a chip will be inserted into the body that monitors a person's daily physical activity in return for crypto currency. If conditions are met, then the person receives certain bonuses that can be spent on something. A detailed description of the "invention" provides 28 concepts for how the device could be used.

Although inserting microchips into the body is nothing new – the Masonic Youth Child Identification Program has been in operation in the US for a while, and people calling themselves cyborgs exhibit various implants – Microsoft's involvement is interesting. And why has the patent been given the code number 060606? Is it a coincidence or the deliberate choice of what is referred to in the Book of Revelation as the number of the beast?

Bill Gates' name is constantly being mentioned these days in connection with his interests in pharmaceutical companies, vaccinations, and WHO funding. A BILL

To authorize the Secretary of Health and Human Services to award grants to eligible entities to conduct diagnostic testing for COVID–19, and related activities such as contact tracing, through mobile health units and, as necessary, at individuals' residences, and for other purposes. Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE

This Act may be cited as the "COVID-19 Testing, Reaching, And Contacting Everyone (TRACE) Act".

SEC. 2. COVID-19 TESTING AND CONTACT TRACING USING MOBILE HEALTH UNITS.



- (a) In General.—The Secretary of Health and Human Services, acting through the Director of the Centres for Disease Control and Prevention, may award grants to eligible entities to conduct diagnostic testing for COVID–19, to trace and monitor the contacts of infected individuals, and to support the quarantine of such contacts, through—
 - (1) mobile health units; and
 - (2) as necessary, testing individuals and providing individuals with services related to testing and quarantine at their residences.
- **(b)** Permissible Uses Of Funds.—A grant recipient under this section may use the grant funds, in support of the activities described in subsection (a)—
 - (1) to hire, train, compensate, and pay the expenses of individuals; and
 - (2) to purchase personal protective equipment and other supplies.
- (c) Priority.—In selecting grant recipients under this section, the Secretary shall give priority to—
 - (1) applicants proposing to conduct activities funded under this section in hot spots and medically under-served communities; and
 - (2) applicants that agree, in hiring individuals to carry out activities funded under this section, to hire residents of the area or community where the activities will primarily occur, with higher priority among applicants described in this paragraph given based on the percentage

- of individuals to be hired from such area or community.
- (d) Distribution.—In selecting grant recipients under this section, the Secretary shall ensure that grants are distributed across urban and rural areas.
- (e) Federal Privacy Requirements.—Nothing in this section shall be construed to supersede any Federal privacy or confidentiality requirement, including the regulations promulgated under section 264(c) of the Health Insurance Portability and Accountability Act of 1996 (Public Law 104–191; 110 Stat. 2033) and section 543 of the Public Health Service Act (42 U.S.C. 290dd–2).
- **(f)** Definitions.—In this section:
 - (1) The term "eligible entity" means—
- (A) a Federally qualified health centre (as defined in section 1861(aa) of the Social Security Act (42 U.S.C. 1395x(aa)));
- **(B)** a school-based health clinic;
- (C) a disproportionate share hospital (as defined under the applicable State plan under title XIX of the Social Security Act (42 U.S.C. 1396 et seq.) pursuant to section 1923(a)(1)(A) of such Act (42 U.S.C. 1396r–4));
- (D) an academic medical center;
- **(E)** a nonprofit organization (including any such faith-based organization);
- (**F**) an institution of higher education (as defined in section 101 of the Higher Education Act of 1965 (20 U.S.C. 1001));
- **(G)** a high school (as defined in section 8101 of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 7801)); or
- **(H)** any other type of entity that is determined by the Secretary to be an eligible entity for purposes of this section.
- (2) The term "emergency period" has the meaning given to that term in section 1135(g)(1)(B) of the Social Security Act (42 U.S.C. 1320b–5(g)(1)(B)).
- (3) The term "hot spot" means a geographic area where the rate of infection with the virus that causes COVID-19 exceeds the national average.

- "medically The term community" has the meaning given to that term in section 799B of the Public Health Service Act (2) such sums as may be necessary for each of (42 U.S.C. 295p).
- (5) The term "Secretary" means the Secretary of Health and Human Services.
- (g) Authorization Of Appropriations.—To carry out this section, there are authorized to be appropriated—

- undeserved (1) \$100,000,000,000 for fiscal year 2020; and
 - fiscal year 2021 and any subsequent fiscal year during which the emergency period continues.

Old Testament "Word for Word" Deuteronomy Part 17 **Translation by Stephen Howard Anderson**



Chapter 23

- 1. A man shall not take his father's wife, nor uncover 1540 his father's skirt 3651. Persons Excluded From the Congregation
- **2.** Shall not enter he that is wounded 6481 by crushing 1795 of the testicles, or has his penis 8212 cut off, into the congregation 6951 of Yahweh.
- 3. Shall not enter a mamzer 4464 into the congregation of Yahweh; even to the tenth 6224 generation 1755 shall he not enter the congregation of Yahweh.
- **4.** Shall not enter an Ammoniy *5984* or Moabiy 4125 into the congregation of Yahweh; even to the tenth generation they shall not enter the congregation of Yahweh until everlasting 5769,
- **5.** over the matter 1697 that they did not meet 6923 you with bread 3899 and with water 4325 upon the way 1870, when you came forth from Mits'rayim; and that they hired 7936 against you Bil'am *1109* son of Beor *1160* of Pethor *6604* of Aram-Nacharayim 763, to curse 7045 you.

- **6.** But would 14 not 3808 Yahweh Eloheycha listen 8085 to Bil'am; but turned 2015 Yahweh Eloheycha for you the curse into a blessing 1293, for loved 157 you Yahweh Eloheycha.
- 7. You shall not seek 1875 their peace 7965 or prosperity 2896 all your days forever 5769.
- **8.** You shall not abhor 8581 an Aromiy 726; for he is your racial kinsman 251: you shall not abhor a Mits'riy 4713, for you were a sojourner 1616 in his land.
- **9.** The children that are begotten 3205 of them in the third 7992 generation shall enter the congregation of Yahweh. Purity During War
- 10. When goes forth the army 4264 against your hated enemies 341, keep 8104 from all things 1697 of evil 7451.
- 11. If there is among you any man that is not clean 2889 because of a nocturnal emission 7137 at night, then he shall go forth to outside the camp, he shall not come within the camp.
- 12. But it shall be when evening comes, he shall wash 7364 with water: and when the sun is down, he shall come into the camp.
- 13. You shall have a place outside the camp, where you shall go forth outside:
- **14.** and you shall have a tool *3489* among your implements 240; and it shall be when you sit down 3427 outside you shall dig 2658 with it, and you shall turn back and cover 3680 your excrement 6627:

midst of your camp, to deliver you, and to give for yourself; but you shall not put any in your up your hated enemies before you; therefore your camp shall be set-apart 6918; so that He sees no naked 6172 thing 1697, and turn away from following you.

Various Laws

- **16.** You shall not deliver 5462 to his master 113 a slave 5650 which has escaped 5337 from his master unto you.
- 17. He shall dwell with you, among you, in that place he shall choose in one of your gates, where it is best for him: you shall not oppress *3238* him.
- 18. There shall be no <u>cult prostitutes</u> 6948 from the daughters of Yis'rael, nor a temple prostitute 6945 from the sons of Yisrael.
- 19. You shall not bring the hire 868 of a harlot 2181, or the price 4242 of a dog 3611 into the House of Yahweh Eloheycha for any vow 5088: because both of these are an abomination 8441 to Yahweh Eloheycha.
- **20.** You shall not lend with usury 5391 to your racial kinsman 251; usury 5392 of money, usury of food, usury of any thing that is lent upon usury.
- **21.** To a <u>racial alien</u> 5237 you may lend upon usury; but to your racial kinsman you shall not end upon usury; so that may bless you Yahweh Eloheycha in all that you put 4916 your hand to in the land that you go to possess.
- **22.** When you shall vow *5087* a vow *5088* to Yahweh Eloheycha, you shall not delay 309 to pay 7999 it, because would surely require 1875/1875 it Yahweh Eloheycha from you; and it would be to you sin 2399.
- **23.** But if you shall cease *2308* to vow, it shall be no sin to you.
- **24.** That which has gone forth 4161 from your lips 8193 you shall keep 8104 and do 6213; a freewill offering 5071, according to what you have vowed to Yahweh Eloheycha, which you have spoken 1696 with your mouth 6310.
- **25.** When you come into your neighbor's

15. because Yahweh Eloheycha walks in the vineyard, then you may eat your fill of grapes vessel.

> **26.** When you come into the standing grain 7054 of your neighbor, then you may pluck 6998 the ears of grain 4425 with your hand; but you shall not <u>lift up</u> 5130 a sickle 2770 to your neighbor's standing grain.

CHAPTER 23 NOTES

Chapter 23 is full of laws. Many are quite clear, but several need some explanation, mostly for newer students of Scripture, but not all.

Verse 1 – Lev. 18:8; Deut. 27:20;

Verse 2 in the KJV has "bastard", as if an illegitimate child, for 4464. In the Hebrew, it is mamzer, and means one of mixed race, a mongrel. This is shown in Strong's Exhaustive Concordance clearly. Only pureblood Yis'rael is Yis'rael. Any other bloodline disqualifies that person from being of Yis'rael. As a generation is usually about 40 years, ten generations would work out to be around 400 years for admittance to the congregation,

IF no further mixing was done in that person's lineage. Also it says EVEN to the tenth generation, so even ten generations were not enough. They could NEVER enter the Congregation. Yisrael was built on being a congregation of Yahweh, and it was of utmost importance to heads of families that following generations were in that congregation. NO Yis'raeliy would want to marry a son or daughter to a racial alien, as their line would be excluded from the congregation.



This forced any mixed breeds to marry other mixed breeds, and none of them were eligible to be in Yahweh's Congregation. Those calling themselves "Jews" today are all of mixed blood somewhere along their lineage, and openly claim Esaw as a patriarch. He married daughters of Cheth, a Kenaaniy (Canaanite), and Edom (above) is of mixed bloodline. They hated Yaaqob/Yis'rael then, and still hate pureblood Yis'rael today. Any congregation that has non-Yis'rael people in it is not a congregation of Yahweh, and should be avoided. Race-mixing is an abomination to Yahweh.

Verse 3-5 – Neh. 13:1,2;

Verse 3 - concerns Ammoniy and Moabiy (Ammonites and Moabites). This is where the Book of Ruth connects. Ruth was an Yis'raeliyth (Israelitess) living in the FORMER territory of Moab. She was not a racial Moabite. Boaz was a Prince of Yahudah, and for the aforementioned reasons would not have married a person of cursed seedline, as any children would forever be excluded from the Congregation. Down the line, Yahshua Messiah had Ruth and Boaz as ancestors. Yahweh would not manifest Himself in a cursed-seedline family. Yahshua was PERFECT, and the Christhaters will use any lie they can to blemish His lineage. They are of their father Satan, and their father's work they do.

Verse 4 – Num. 22:1-6;

Verse 5 – Num. 23:7-24; 24:9;

Verse 7 is a complete mess in the KJV and others. They have continued to misuse the word Edomite / Edomiy 130 where it should be Aramean /Aromiy 726. Strong's Exhaustive Concordance shows under 726 that 130 is a scribal error for 726. Aram 758 was a son of Shem, the son of Noach, and Aramean comes from that, and Yis'rael is definitely blood kindred to Shem.



As to the scribal error, when they switched from Paleo-Hebrew letters to the newer block form, they still had no Masoretic vowel points (above), and the letter D (daleth) and the letter R (resh) are similar in appearance in the block form. Any damage or smudging of the letters on the document being translated could have resulted in a switching of these letters.

This one letter change also changes the context of that verse. Scripture backs up Aromiy instead of Edomiy, because it goes heavily against Edom. Esaw, called Edom, married daughters of Cheth (Heth - Hittites), and a Mitsriyth (female Egyptian), and his descendants were of cursed-seedline, and mixed bloodline. These mixed with other Kenaaniy Canaanites), and the cursed seed of Qayin (Cain). Esaw hated Yaaqob (Jacob), who was named Yis'rael by Yahweh, and his seedline still hates pureblooded Yis'rael today.

The following list of references is long, but you really need to look at all of them. In English, in other Bibles, the words used are Esau, Edom, and Edomite(s) for recognition purposes. In my accurized translation the words are as they are spelled in Hebrew.

Yahshua Messiah spoke Aramean. Parts of Ezra and Daniel are in Aramean. Aramean is very close to Hebrew. See 26:5 as to Yis'rael's Aramean forefathers. Terah, father of Abraham was of Aram. On and on it goes. The continued use of a known error in these Bibles is due to the monetary influence of the descendants of Esaw today.

Verse 8 states 3 generations for children of mixed Aromiy and Mits'riy marriages. These were not of the chosen of the Exodus, but at that time period,

before they mixed with non-adamics, they were of derogatory idiomatic term for a male sodomite adamic bloodline. Today this is not so. All of that area is now of mixed bloodline, and we are not to marry with them anymore. Times, and racial demographics, have changed. Mits'rayim is Hebrew for Egypt, Mits'rayim was a son of Cham (Ham), and was not cursed like K'naan (Canaan), thus was of adamic seedline. No more. Gen. 10:22; Deut.

Verses 10-15 deal with sanitary purity in a military

Verse 11 – Lev. 15:16;

Verses 16,17 deal with an escaped slave, and fair treatment for him/her.

Verse 17 – Lev. 19:29;

Verses 18,19 deal with the pagan cult temple prostitutes, male and female. Sex orgies were part of pagan worship (fertility " gods"). A "dog" is a

prostitute, or other disgusting unclean people. Those nations that practiced these things were the ones Yahweh commanded to be utterly destroyed. We did not get the job done, and they plague us yet

Verses 19,20 - Ex. 22:25; Lev. 25:37; Deut. 15:7-11;

Verse 20,21 continue the prohibition of usury (interest) among Yis'rael. 251 can mean brother or kinsman, but ALWAYS has the meaning of blood kindred with it. 5237 is noch'riy in Hebrew, and means RACIAL alien/stranger. 
Some years ago, the Canadian British Israel Association put out a book on heraldry called, Symbols of Our Celto-Saxon Heritage. In the above list, under the heading 'Primary Emblems', we see the official emblems of the Twelve Tribes as displayed on their ensigns in accordance with the command: 'Every man of the children of Israel shall pitch—with the ensign of their father's house.'


Those listed under the heading 'Secondary Emblems' are the additional likenesses mentioned in connection with some of the tribes in the blessings given by Jacob and later by Moses or, as in the case of Simeon, they were adopted to commemorate some historic event. These were not the official emblems of the tribes and, so far as we have been able to discover. history.

Nevertheless, these secondary emblems would not be forgotten. Later, in some cases, they were used by a section of a tribe to distinguish it from the rest and, in one or two cases, secondary emblems of one tribe became the recognized emblem of a group of tribes.

The book also gives 'Camp' emblems. These were given to groups of tribes, three tribes a group, so four Camp groups-four emblems. Thus, each tribe had selfhood (individual) emblems as well as camp symbols.

While the Bible does not actually state what the emblems on the standards of the four Brigades or Camps were, nevertheless, it does offer evidence which clearly indicates that they were a Lion, a Man, an Ox and an Eagle.

We learn from this that the camp symbols, a lion, an ox, a man and an eagle, were taken on by a number of tribes. Seeing that the book is pitifully lacking in giving our German kinsfolk any coverage, I will give some even weight (balance) to it all by putting before you a few German



heraldic symbols. Bid thee (please) keep in mind that these are only a thin slice of the many Israelite symbols in Germany.

The March (land area like, say, a shire, state or land) of Brandenburg has as its symbol the eagle of Dan. This also the symbol of the Unified German Marches or the Bound States of Deutish-land-- otherwise known as Germany.

> As a double witness we see Gad's tribal emblem twice, that being a trooper on horseback, within a shield set upon the 'Great Bridge' in Grimma. This Gaddite emblem is quite lacking in other Israelite lands. This linked with the name Goth

Map Study


These maps show the state forming of Germany in keeping to God's oath to grow land area or enlarge the borders to befit the numbers of Adam.

ERE THEN WE HAVE THE ANSWER to the question whether Israel ever really entertained a resurrection hope, and we find the answer by discovering the place that the People of God had in God's plan for his whole creation.

We are to remember that throughout the whole OT period Israel's corporate relationship to God remains a vital factor in the thought of her prophets and historians (cf. 

'Whom have I in heaven but thee? and there is none upon earth that I desire beside thee. My flesh and my heart will fail; but God is the strength of my heart and my portion for ever 'le-olam' (Ps. 73. 25-26) (See p. 102) 'Therefore my heart is glad, and my glory (or perhaps 'liver' - the consonants are the same) rejoiceth; my flesh also shall rest in hope. For wilt leave my flesh in Sheol; neither wilt thou suffer thine holy one to see the pit' (P. 16.9-10).

The Teutonic Argument

HERE AROSE, HOWEVER, A
MAJOR DIFFERENCE OF
OPINION IN THE 1870'S OVER
THE TEUTONIC ORIGIN OF THE
ANGLO-SAXONS. There were two views as
to the relationship between the Germans and
British-Israel; either the British race, alone,
was identified with the Tribes of Israel (Hine)
or they included the landed German race with
the British being Ephraim (Wilson)[21]. A case
could be made that the Germans were a
'company of nations' and competed with the

British for the chieftainship of nations and the debate rage well into the 20th century until the defeat of Germany in the Great War. It appeared to some British-Israel that wherever there was an English Colony, there were Germans. Protestant Germans kept the Sabbath better than the British and helped the British win at Culloden, Boyne and Waterloo and helped in the start of the Bishopric of Jerusalem. The Royal family could be traced back not only through Scotland and Ireland but also Germany.

Advocators of the non-Teutonic Hine theory maintained Prussia and later Germany 'swarmed' Britain's possessions because they had none of their own[22]. Hine maintained that the Ten Tribes of Israel were included within the British race excluding the Continental Teutonic nations and the opinion, held by some, that they did include Teutonic was the reason why Identity had made no progress[23].

Rev. A H Sayce, reinforced this opinion in a speech to the Anthropological Institute, in 1875, when he maintained that despite the presence of German words in the English language 'if

asserted with equal precision that it is not a test (Centre) of the Royal Society of Edinburgh of race[24].'

Referring to the followers of the late John subsequent use it was originally constructed as Wilson, who maintained that the Germans, Dutch, Belgians, Danes and Norwegians formed the Teutonic tribes of Israel, he asserted they were wrong as it was only the British who operated the Imperial weights and measures system.

To Teutonic German, colonisation was proof that Germany was part of Israel - Gad - noting that the Germans 'attached' themselves to British colonies. Countering speculation that the new Germany, from 1870, was an ocean power holding a colonial empire and war was inevitable, it was pointed out that if Germany (and even France) was part of Israel the outlook would be peace.[25] However, it was

conceded that the German annexation policy, e.g. the north coast of New Guinea in 1884,[26] was causing concern and German colonial aspirations eventually became one of the issues which forced the topic of confederation of the British Empire to the front of British-Israel commentary at the beginning of the 20th century.

In particular, the **Standard of Israel**, mouthpiece of The Anglo-Israel Association criticised Hine's 'absurd' Anglian or anti-Teutonic Theory in which he sought to distribute the several tribes amongst the different social classes of the nation[27].

Hine had identified the Ten Tribes as being together in Britain, in that Ephraim were the drunkards and ritualists, Reuben the farmers,

Dan the mariners, Zebulon the lawyers and writers, Asher the soldiers etc[28]. They declared that the Germans spread God's word through the many missionaries of the Moravian churches and drew attention to the pettiness of condemning a nation because it differed in national commercial arrangements of weights and measures i.e. metric.

Teutonics queried how Hine managed to identify the 'cursed mark of the beast' with the metric system pointing out that Sharon Turner, on whom both sides depended, spoke of the Teutonic stock of Europe[29].

language is the test of social contact, it might be On 2nd April 1866 Professor Piazzi Smyth (left) gave an account of his measurements of the Great Pyramid concluding that whatever it's **Imperial** standard for weights measures[30]. Turner, Teutonics pointed out the Anglo-Saxons were not of German origin. The fact that they passed through the region now known Germany did not constitute them Germans.



Anthropological arguments were not confined to the Teutonic Question and went on to include both philological and phrenological debates as to the origin of British-Israel. Much of the 'historical' justification of British-Israel theories were based on John Wilson's 1840 tome Lectures on Our Israelite Origin.

Wilson argued that similarities between aspects of British and Hebrew language/institutions were more than coincidental. British-Israel contended that many European geographic names were Hebrew in origin for example the Danube, Danzig and Denmark were areas through which the tribe of Dan migrated, hence several of the tribes could be traced in their migration to the British Isles - their promised land.

British-Israel further noted the similarity between British and Hebrew Laws indicating the British were of Shemitic origin based on Anthropologists, in objecting to the British-Israel argument, maintained that a community of language did not imply a community of race and that language was only an index to contact

Bishop Titcomb agreed and maintained a philological proof of Hebrew in the English language 'English Jews speak English; German Jews, German, and so on. However, Dr James Andrew, in his *Hebrew Dictionary and Grammar* (1823) maintained 'The dispersion and incorporation of the Ten Tribes of Israel amongst the Assyrian and other northern nations, accounts most satisfactorily for the numerous traces of the Hebrew language that still remain amongst the languages of Europe[37].

Hebrew need not have turned into Anglo-Saxon but simply have dropped out of use with intermarriage obliterating physiological traits.

In 1876, The London Anthropological Society invited Edward Hine to present a paper on the British-Israel movement which was met with ridicule[38]. The Society rested its objections on the opinion that much of Identity rested on bible prophecy and that it was 'impossible for any scientific Society to bring prophecy to bear on the discussion of a purely scientific question[39].

British-Israel occasionally generated seemingly negative evidence such as alcohol abuse and a short anonymous article in The Standard of Israel listed drunkenness as a characteristic of the British race and observing that that Ephraim was noted for drinking in Isaiah's time with 'A woe is pronounced upon the drunkards of Ephraim' (Isaiah 28:1).

However, the subsequent passage, drunkards of Ephraim are to be trodden down and destroyed' (Isaiah 28:3) led the author to query as to why Christians and those concerned for the welfare of the nation did not relinquish liquor[40]. 40 The anthropologists maintained that his Identity of drunkenness with Israel could be applied to other nations, however Hine denied, untruthfully, ever using this form of identity[41].



I am confident that it will work because I know of this fact. A man was arrested on three occasions for offending the lockdown laws. At the police station he was quickly released on the first two times stating that they would issue him with a fixed penalty. After his third arrest at the police station he was told he was to be released executing abortionists as part of the UK anti- and they would issue him with a fixed penalty.

He stated that they have not issued him with a fixed penalty each time.



There have been other arrests where the station sergeant, who has a legal duty to confirm the lawfulness of the arrest, refused the charge. The establishment does not want the public to know that if challenged their laws are unenforceable.

Here is the suggested affidavit with an explanation.

Dear Requester of a copy of the affidavit proforma to be used if you are given a fixed penalty, summonsed or charged with offending the lockdown regulations.

You should be aware that a sworn affidavit, if served on those who seek to make a charge against you, becomes unchallengeable law if those that seek to charge you do not rebut your affidavit within a certain set time limit. It is the opinion of the writers of the proforma that the law stated is unchallengeable and that any charge against you is likely be dropped without the necessity for you to attend a court.

Should you be arrested from your home, other consideration may apply which are not covered here.

Please ask the presenter of this proforma being for further details.

After you have written or printed out the affidavit of sufficient number to serve on the Police, The CPS and the Courts, take them to a commissioner of oaths, (usually a solicitor). He will get you to swear on the bible, or swear and affirm, that it is true. Mine charges £5. Some

charge a lot more. That is the time to sign it in front of him.

Serve one original copy on the Crown court of the area where the 'offence' was committed by recorded delivery. You should also serve copies on the police and Crown Prosecution service. These can be by email. On the email add these words before your signature, " signed and served electronically according to the civil procedure rules." Sign your name all in lower case letter without using capital letters.

The next step depends on any response that you have.

If you are still required to attend a court, take the affidavit with you and when you are asked to plead state this is my truth, and hold your affidavit aloft. This may be rejected twice, but just repeat it. For some reason, three times is important. The third time they should ask for the affidavit and if things go according to plan the case will be dropped.

Should they try and continue with the case against you, I would consider leaving the court and wait for any written response that you may receive. Should they then convict you in your

absence then you should appeal. I truly doubt if they will convict you. My experience is that if, at the earliest opportunity, you present to those that try to prosecute you with evidence that there is no offence, that you do not hear anything further. They do not like admitting defeat.

Chronic Electrical Illness Bv **Arthur Firstenberg**



N 1859, THE CITY OF LONDON UNDERWENT AN ASTONISHING METAMORPHOSIS. A tangle of electric wires, suddenly and inescapably, was brought to the streets, shops, and residential rooftops of its two and a half million inhabitants. I will let one of the most famous English novelists, who was an eyewitness, begin the story.

"About twelve years ago," wrote Charles Dickens, "when the tavern fashion of supplying beer and sandwiches at a fixed price became very general, the proprietor of a small suburban pothouse reduced the system to an absurdity by announcing that he sold a glass of ale and an electric shock for four-pence. That he really traded in this combination of science and drink is more than doubtful, and his chief object must have been to procure an increase of business by an unusual display of shop keeping wit.

Whatever motive he had to stimulate his humour, the fact should certainly be put upon record that he was a man considerably in advance of his age. He was probably not aware that his philosophy in sport would be made a science in earnest in the space of a few years, any more than many what they know nothing about.

The period has not yet arrived when the readers of Bishop Wilkin's famous discourse upon aerial navigation will be able to fly to the moon, but the hour is almost at hand when the fanciful announcement of the beer-shop keeper will represent an every-day familiar fact. A glass of ale and an electric shock will shortly be sold for four-pence, and the scientific part of the bargain homes became even more densely woven when will be something more useful than a mere fillip the Universal Private Telegraph Company

to the human nerves. It will be an electric shock that sends a message across the house-tops through the web of wires to any one of a hundred and twenty district telegraph stations, that are to be scattered amongst the shopkeepers all over the town.

"The industrious spiders have long since formed themselves into a commercial company, called the London District Telegraph Company (limited), and they have silently, but effectively, spun their trading web.

One hundred and sixty miles of wire are now fixed along parapets, through trees, over garrets, round chimney-pots, and across roads on the southern side of the river, and the other one hundred and twenty required miles will soon be fixed in the same manner on the northern side.


The difficulty decreases as the work goes on, and the sturdiest Englishman is ready to give up the roof of his castle in the interests of science and the public good, when he finds that many hundreds of his neighbours have already led the way."

English citizens did not necessarily welcome the prospect of electric wires being attached to their homes. "The British householder has never seen a voltaic battery kill a cow," wrote Dickens, "but he has heard that it is quite capable of such a feat. The telegraph is worked, in most cases, by a powerful voltaic battery, and therefore the British householder, having a general dread of lightning, logically keeps clear of all such machines."

other bold humorists who have been amusing on Nonetheless, Dickens tells us, the agents of the London District Telegraph Company persuaded nearly three thousand five hundred property owners to lend their rooftops as resting places for the two hundred and eighty miles of wires that were crisscrossing all of London, and that were shortly to drop into the shops of grocers, chemists, and tavern-keepers all over the city.[1]

A year later, the electrical web above London

opened its doors. In contrast to the first By company, whose stations accepted only public consumers, Universal rented telegraph facilities to Antindividuals and businesses for private use. had Cables containing up to a hundred wires each thou formed the backbone of the system, each wire departing from its companions at the nearest approach to its destination.

By 1869, this second company had strung more than two thousand five hundred miles of cable, and many times as much wire over the heads and under the feet of Londoners, to serve about fifteen hundred subscribers scattered throughout the city.

A similar transformation was occurring more or less everywhere in the world. The rapidity and intensity with which this happened is not appreciated today.

The systematic electrification of Europe had begun in 1839 with the opening of the magnetic telegraph on the Great Western Railway between West Drayton and London. The electrification of America began a few years later, when Samuel Morse's first telegraph line marched from Baltimore to Washington in 1844 along the Baltimore and Ohio Railroad.

Even earlier, electric doorbells and annunciators began decorating homes, offices, and hotels, the first complete system having been installed in 1829 in Boston's Tremont House, where all hundred and seventy guest rooms were connected by electric wires to a system of bells in the main office. Electric burglar alarms were available in England by 1847, and soon afterwards in the United States.

1850, telegraph lines under construction on every continent except Antarctica. Twenty-two thousand miles of wire had been energized in the United States; four thousand miles were advancing through India, where "monkeys and swarms of large birds" were alighting on them[2]"; one thousand miles of wire were spreading in three directions from Mexico City. By 1860, Australia, Java, Singapore, and India were being joined undersea.

By 1875, thirty thousand miles of submarine cable had demolished oceanic barriers to communication, and the tireless weavers had electrified seven hundred thousand miles of copper web over the surface of the earth—enough wire to encircle the globe almost thirty times.

And the traffic of electricity accelerated even more than the number of wires, as first duplexing, then quadriplexing, then automatic keying meant that current flowed at all times—not just when messages were being sent—and that multiple messages could be sent over the same wire at the same time, at a faster and faster rate.

Almost from the beginning, electricity became a presence in the average urban dweller's life. The telegraph was never just an adjunct to railroads and newspapers. In the days before telephones, telegraph machines were installed first in fire and police stations, then in stock exchanges, then in the offices of messenger services, and soon in hotels, private businesses, and homes.

The first municipal telegraph system in New York City was built by Henry Bentley in 1855, connecting fifteen offices in Manhattan and Brooklyn. The Gold and Stock Telegraph Company, incorporated in 1867, supplied instantaneous price quotations from the Stock, Gold, and other Exchanges telegraphically to hundreds of subscribers.

In 1869, the American Printing Telegraph Company was created to provide private telegraph lines to businesses and individuals. The Manhattan Telegraph Company was organized in competition two years later. By 1877, the Gold and Stock Telegraph Company had acquired both those companies and was

operating 1,200 miles of wire. By 1885, the industrious spiders linking almost thirty thousand homes and businesses had to spin webs over New York even more intricate than the ones over Dickens' London.

In the midst of this transformation, a slender, slightly deaf clergyman's son wrote the first clinical histories of a previously unknown disease that he was observing in his neurology practice in New York City. Dr. George Miller Beard was only three years out of medical school. Yet his paper was accepted and published, in 1869, in the prestigious Boston Medical and Surgical Journal, later renamed the New England Journal of Medicine.

A self-assured young man, possessed of a serenity and hidden sense of humour that attracted people to him, Beard was a sharp observer who, even so early in his career, was not afraid to break new medical ground.

Although he was sometimes ridiculed by his

elders for his novel ideas, one of his colleagues was to say many years after his death that Beard "never said an unkind word against anyone[3]."

Besides this new disease, he also specialized in electrotherapy and hypnotherapy, both of which he was instrumental in restoring to good repute, half a century after the death of Mesmer. In addition, Beard contributed to the knowledge of the causes and treatment of hay fever and seasickness.

And in 1875 he collaborated with Thomas Edison in investigating an "etheric force" that Edison had discovered, which was able to travel through the air, causing sparks in nearby objects without a wired circuit. Beard correctly surmised, a decade before Hertz and two decades before Marconi, that this was high frequency electricity, and that it might one day revolutionize telegraphy[4].

George Miller Beard, M.D. (1839-1883)

As far as the new disease that he described in 1869, Beard (centre Page) did not guess its cause. He simply thought it was a disease of

modern civilization, caused by stress, that was previously uncommon. The name he gave it, "neurasthenia," just means "weak nerves." Although some of its symptoms resembled other diseases, neurasthenia seemed to attack at random and for no reason and no one was expected to die from it.

Beard certainly didn't connect the disease with electricity, which was actually his preferred treatment for neurasthenia—when the patient could tolerate it.

When he died in 1883, the cause of neurasthenia, to everyone's frustration, had still not been identified. But in a large portion of the world where the term "neurasthenia" is still in everyday use among doctors—and the term is used in most of the world outside of the United States—electricity is recognized today as one of its causes. And the electrification of the world was undoubtedly responsible for its appearance out of nowhere during the 1860's, to become a pandemic during the following decades.



when million-volt Today, power lines course through countryside, thousand-volt lines divide every neighbourhood, and sets of thirty-ampere circuit breakers watch over every home, we tend to forget what the natural situation really is. None of us can begin to imagine what it would feel like to live on an unwired Not since presidency of James Polk have our cells, like puppets on invisible strings, been given a second's rest from the electric vibrations.

The gradual increase in voltage during the past century and a half has been only a matter of degree. But the sudden overwhelming of the earth's own nurturing fields, during the first few decades of technological free-for-all, had a drastic impact on the very character of life.

In the earliest days telegraph companies, in countryside and in cities, built their lines with only one wire, the earth itself completing the electric circuit. None of the return current flowed along a wire, as it does in electrical systems today; all of it travelled through the ground along unpredictable paths.

Twenty-five-foot-high wooden poles supported third of a millivolt per meter—is given in the wires on their journeys between towns. In cities, where multiple telegraph companies competed for customers and space was at a premium, forests of overhead wires tangled their way between housetops, church steeples, and chimneys, to which they attached themselves like vines. And from those vines hung electric fields that blanketed the streets and byways and the spaces within the homes to which they clung.

The historical numbers provide a clue to what happened. According to George Prescott's 1860 book on the Electric Telegraph, a typical battery used for a 100-mile length of wire in the United States was "fifty cups of Grove," or fifty pairs of zinc and platinum plates, which provided an electric potential of about 80 volts[5].

In the earliest systems, the current only flowed when the telegraph operator pressed the sending key. There were five letters per word and, in the Morse alphabet, an average of three dots or dashes per letter.

Therefore, if the operator was proficient and averaged thirty words per minute, she pressed the key at a rhythm of 7.5 strokes per second. This is the very near the fundamental resonant frequency (7.8 Hz) of the biosphere, to which all living things, as we will see in chapter 9, are tuned, and whose average strength—about a textbooks.

It is easy to calculate, using these simple assumptions, that the electric fields beneath the earliest telegraph wires were up to 30,000 times stronger than the natural electric field of the earth at that frequency. In reality the rapid interruptions in telegraph keying also produced a wide range of radio frequency harmonics, which also travelled along the wires and radiated through the air. The magnetic fields can also be estimated.

Based on the values for electrical resistance for wires and insulators as given by Samuel Morse himself[6], the amount of current on a typical long-distance wire varied from about 0.015 ampere to 0.1 ampere, depending on the length of the line and the weather.

Since the insulation was imperfect, some current escaped down each telegraph pole into the earth, a flow which increased when it rained. Then, using the published value of 10-8 gauss for the magnetic field of the earth at 8 Hz, one may calculate that the magnetic field from a single early telegraph wire would have exceeded the earth's natural magnetic field at that frequency for a distance of two to twelve miles on either side of the line. And since the earth is not uniform, but contains underground streams, iron deposits, and other conductive paths over which the return current would travel, exposure of the population to these new fields varied widely.

The Banker, the Model and the Jewish Spy
– inside a Dresden Courtroom Drama

Hermann Abs was the most powerful German banker of the 20th century, despite his career having flourished under Adolf Hitler. Had the trial of Lady Renouf proceeded in Dresden last October, the Abs case would inevitably have been highlighted, because he was one of the closest friends and colleagues of her late husband Sir Francis Renouf (aka "Frank the Bank").

This would have been a double disaster for German state prosecutors.

The most serious embarrassment would have come from the Abs story being examined in court. We can today reveal for the first time some of the devastating facts that would have been presented in Dresden.

In this abbreviated extract from a forthcoming book by Peter Rushton, who was a research consultant to the Renouf defence team, we uncover a secret that has lasted for almost eighty years — the identity of a German-Jewish spy inside the Third Reich, and his role in the postwar rehabilitation of financial godfather Hermann Abs.

May 1990. The attacks had been shrugged off for decades, but 88-year-old Hermann Abs knew

the sharks were now circling. Yet another cycle of 'Holocaust hype' was being boosted worldwide – almost half a century after the Second World War – with construction of memorials and enacting of laws that turned 'Holocaust' history into an unchallengeable quasi-theological edifice. Researchers, scientists, publishers and even lawyers who dared to disagree were starting to be dragged into court, and would soon face heavy fines or even jail sentences.

Actual participants in the 'Holocaust' were by now few and far between, so professional 'nazi-hunters' were mainly reduced to pursuing small fry, such as teenage Ukrainians who had guarded a concentration camp.

The UK was midway through passing a new law that would allow the prosecution of elderly Soviet and East European émigrés who had taken refuge in Britain postwar, despite their 'crimes' having taken place well outside UK jurisdiction and prosecution 'evidence' coming from the now collapsing and discredited Soviet bloc. In May 1991 this War Crimes Act entered the UK statute book.

Hermann Abs himself was one of the few surviving (indeed flourishing) big name players from the Third Reich - he was described by David Rockefeller as "the most important banker of our time". A biographical summary prepared for the chief of the CIA's European Division in December 1974 quoted Rockefeller's assessment and added that while Abs "holds no governmental positions his influence is enormous and dates back to his successful leadership in 1952 of the German Delegation which regulated the post-war German reparation question and set the basis for the FRG [West Germany] to regain its sovereignty in 1955. He was awarded the Federal Service Cross First Class for this achievement and repeatedly declined Cabinet posts offered by Adenauer and succeeding Chancellors. ... As a rough comparison he might be called the Bernard Baruch of Germany."

In later life Hermann Abs (see photo next page) acted for German galleries and museums in major art purchases worldwide, most famously at Sotheby's London auction of the Robert von Hirsch collection in 1978 where he bought

sixteen masterpieces for German institutions.

Yet during that first weekend of May 1990 a special World Jewish Congress meeting in Berlin celebrated news that this eminent financier had at last been barred (as a "nazi") from entering the USA. Abs still held many honorary and advisory positions, and was in regular touch with old friends across the banking world including Sir Frank Renouf, the New Zealand-born tycoon who (largely thanks to his work with Abs to open up West German investment banking) had received the Federal Republic's highest honour, the Verdienstkreuz.

Semi-retired in the Taunus Mountains of central Hesse, Abs lost nothing in practical terms by being banned from the USA, but it was a big propaganda victory for the Zionist lobby. This time they weren't picking on the small fry: Hermann Abs was the biggest name in German finance, and arguably the most powerful individual in postwar banking.

He still had friends in the banking world: that very year his old ally Renouf visited Germany to collect a duplicate of his Verdienstkreuz (the original medal having been lost in a burglary).

Sir Frank was accompanied by his new fiancée Michèle, Countess Griaznoff, an Australianborn Briton and international model who had appeared worldwide in print and television advertisements for Deutsche Post, Tchibo coffee, Nescafé, Lenthéric, Helena Rubenstein, Oil of Olay, Avon, Supradyn vitamins, Rowntree's After Eight chocolates, Carlos I brandy, Wedgwood, Nissan cars, BMW, British Airways, ResidenSea cruises, C&A, Heinz, France Telecom, Cable & Wireless, Capital One Credit Cards, the Sunday Times, Daily Mail, Daily Mirror and many others. Speaking

to the Daily Mail's society columnist Nigel Dempster a few months later following their marriage, Sir Frank revealed that he had proposed "after a cocktail party at St James's Palace. Her title is Russian but it doesn't matter now – she's Lady Renouf."

Renouf remained a loyal supporter of Abs to the end, as did senior British bankers in his circle such as Lord Sandon (later Earl of Harrowby), deputy chairman of NatWest and Coutts.

But the verdict of history was already being written. Winston Churchill said that history would be hard on his old enemy Stanley Baldwin: "I know it will, because I shall write that history." Until now, the same has been true of Hermann Abs – to a very large extent his enemies (and the enemies of Germany) have been writing history.

Abs died in February 1994, aged 92. Five years later one of his most determined antagonists, Anglo-Jewish television journalist and historian Tom Bower, was able to dance on his grave. Millions of Daily Mail readers were treated to a full page article (accompanied by a huge photo of Abs) condemning the Deutsche Bank that he had chaired for a decade. Under the headline "The Genocide Bank", the Mail thundered:

"As the mighty Deutsche Bank finally admits it financed Auschwitz, we reveal how two Britons conspired to protect its Nazi founder."

Bower pulled no punches: by his account, Abs and Deutsche Bank had set out to "conspire with Adolf Hitler and Heinrich Himmler to murder thousands of innocent men and women for the benefit of the bank's shareholders." Half a century later, Bower

boasted, "Abs's success has been undone. His attempt to bury the past and disguise his own criminality, nearly successful in his lifetime, has been utterly destroyed."

To a large extent Bower's article was a rehash of his first book, Blind Eye to Murder, published in 1981 and in an updated second edition in 1995. Bower had targeted Abs on the very first page of Blind Eye to Murder, and his allegations were highlighted by The Times when serialising the book in July 1981.

The latest topical addition in 1999 was that Deutsche Bank, in order to satisfy New York regulators and facilitate its \$9.8 billion takeover of Bankers Trust of New York, had – as Bower candidly acknowledged – caved in to "Jewish lobby groups" and "after 54 years of adamant denials" had confessed that "their predecessors did after all partly finance the construction of Auschwitz, the Nazi concentration camp", in what Bower described as "a monumental humiliation for the Germans".



Hermann Abs: "The Most Import of Our Time"

Hermann Abs left school in the Rhineland soon after the end of the First World War. Amid the economic and financial chaos that followed Germany's defeat he went straight into banking rather than university, serving his first apprenticeship at the Jewish-owned Louis David bank in Bonn, then as a foreign exchange dealer in Amsterdam.

He swiftly advanced during the late 1920s with the elite private bank Delbrück, Schickler, where Adolf Hitler himself later held an account containing secret donations from German business leaders. By the age of 33 Abs was a partner in Delbrück, Schickler, and before his 37th birthday in 1938 he was on the managing board of the giant Deutsche Bank, becoming head of its international operations.

As a lifelong Anglophile whose father had spent two years tutoring in Victorian England, Abs's Catholicism also helped with the networking essential to his trade as an international banker. Without criticising his own government, he could discreetly put some distance between himself and both the earlier Protestant Prussianism of the Kaiser's Germany, and the National Socialist new order.

This distancing suited the authorities in Berlin also, who notably showed no interest in pressuring Abs to become a member of the National Socialist Party. When leading the German side in late 1390's negotiations on debt repayments in London or New York, it suited all concerned that Abs was not ostentatiously 'nazi'.

For a time Abs was seen as a protégé of Hitler's first Reichsbank President and economics minister Dr Hjalmar Schacht, but he survived Schacht's fall from power after 1939 and continued to extend his own influence as a director of no fewer than 45 companies during the war years, including IG Farben, the giant chemical and pharmaceutical conglomerate. Abs's role at Deutsche Bank and at Farben was the main reason for controversy that pursued him after 1945.

Mad Cow Disease Caused by Organo-Phosphorous By The Late Mark Purdey



Ed Above, the late Mark Purdey who was one of the first to expose the government's stance on the inappropriately named mad cow disease, which was a guise to cover-up the real cause, namely, the widespread enforced use of organophosphorus pesticides to control warble fly etc. It was an opportune moment to attack the country's food supply. MONG mainstream science, the current model of Mad Cow Disease (Bovine Spongiform Encephalopathy or BSE) involves "prions" -- protein rods allegedly without any DNA of their own, and an ability to survive most antiseptics and heat while remaining infectious. Mad Cow Disease is found in a number of other animals, and is called:

Mad Cow Disease (BSE - Bovine Spongiform Encephalopathy) in cattle,

CJD (Creutzfeldt-Jakob disease) in humans,

Scrapie in sheep, and CWD (Chroinc Wasting Disease) in deer and elk.

In 2002-03, CWD was a hot news topic. Deer and elk in the area of Mount Horeb, Wisconsin, were eradicated in a brutal and controversial government-sponsored shooting spree. The mass kill-off was allegedly designed to stop the spread of CWD to other herds, but was widely attacked as a public relations ploy, useful for little else than trying to convince hunters in Wisconsin that the wild meat supply was safe and covering up the true causes of the disease.

The infectious "prion" model of these diseases claims that prions found in diseased animals are then transmitted to other animals through rendered animal products in their feed. The prions in animal feed then go on to infect many animals who consume that feed. At least that's the official line in the U.S. and Great Britain. However, at the height of the Mad Cow epidemic in England, an organic farmer's personal observations led him to a different conclusion.

Mark Purdey and the Organophosphate model of Mad Cow Disease

Somerset farmer Mark Purdey observed that the UK's Mad Cow outbreak immediately followed the government's attempt to eradicate the parasite warble fly from cattle. Most farmers were required to treat their cows' spines and skulls with Phosmet, an organophosphate pesticide. Because Purdey was an organic farmer, he obtained special permission to avoid treating his cattle. He then observed that his neighbours' treated herds went on to contract Mad Cow Disease (BSE), whereas Purdey's untreated herds did not. Purdey also had purchased a non-organic herd which had been treated with Phosmet before he acquired it. That particular herd also went on to develop Mad Cow Disease.

He terms it 'a very limited amount of science by a few assumedevidence an infectious agent is present in either ers would be astronomical if Purdey's theory meat or milk.' " (Fintan Dunne, "Organophosphates Implicated In Mad Cow Disease")

Unfortunately, Purdey was unable to interest Britain's government or scientific community in this theory, so he proceeded to study the problem himself. Using his own money and some donations by private individuals, Purdey funded private research and came up with the following theory:

- 1.) Prions are naturally-occurring proteins, involved in protecting tissues (such as the eyes) from harmful UV radiation.
- 2.) When exposed to both organophosphates and manganese, prions change from coppertipped to manganese-tipped, and cause a chain reaction of prions switching to manganese "tips". (The organophosphate may serve as a chelating agent or catalyst.) Manganesetipped prions are virtually indestructible, surviving disinfectants, autoclaves, and incineration.
- 3.) These chain reactions cause periods of high oxidation which burn through tissues, as evidenced by the sponge-like brains found in Bovine Spongiform Encephalopathy. (Spongiform is pronounced "SPONGE-iform", because the brain will eventually resemble a sponge from so many holes.) Sometimes consuming the flesh, eggs, or milk of an infected animal can cause the disease, especially if the animal was consumed when a prion chain reaction was occurring. However, prion diseases are much less likely to be contracted from infected animal products than from organophosphate exposure coupled with available manganese.
- 4.) High-manganese, low-copper environments can create prion diseases without the organophosphate catalyst, as seen in deer and elk herds in Colorado who eat manganeserich pine needles.

Purdey's theory is corroborated by field data and lab tests funded with his limited resources. However, all such data is completely ignored by the UK and US governments, largely because politicians receive sizable campaign contributions from both GMO and organophosphate

reputable scientists.' He insists there is 'no producers. Liability of organophosphate producwere accepted as the true cause of prion diseases.



In the case of Wisconsin, Purdey's soil samples showed a natural high-manganese, lowcopper content in the CWD/Mount Horeb ar-

ea. Further evidence of high manganese soil can be seen underground a few miles from Mount Horeb, in Blue Mounds, Wisconsin. Cave of the Mounds has a number of purple and black formations which they'll tell you are coloured by manganese leached from the soil above. In contrast, Kickapoo Indian Caverns in Western Wisconsin has no CWD in the area, and the cave has patches of blue-green copper-rich areas on its walls, indicating the copper-rich soil above.

If Purdey's theory is correct, organophosphate pesticides and herbicides are of particular interest to vegetarians. This would put vegetarians at risk for contracting a prion disease from foods treated with organophosphate pesticides and/or herbicides. Of particular interest are soy products, specifically Roundup-Ready soybeans.

Roundup-ready soy is a GMO (genetically modified organism, a/k/a "Franken-food") specifically developed to tolerate higher levels of Roundup herbicide. Farmers who grow Roundup-ready soy are required by contract to use Roundup herbicide on their soy fields.

Roundup is in the glyphosate class of herbicides, a type of organophosphate. I drove to Mount Horeb, a small town only two hours away from my mother's home in Wisconsin, and asked some of the locals if soy is grown in the area. The answer was yes, but I really didn't have to ask --I could see the soy fields myself. How much of that soy is Roundup-ready? I haven't been able to obtain this information specifically on Mount Horeb, but there is plenty of information verifying that Roundup-ready soy is commonly grown on Wisconsin farms.

"A lobby group that includes Bayer, Monsanto, Novartis, Pfizer, Roche and Schering-Plough was behind the effort to discredit Purdey---Purdey has been consistently denied even exploratory funding to extend his privately supported research. Yet the Purdey/Brown chemical poisoning model matches with the epidemiological spread of CJD clusters in humans. It also predicts the incidence of BSE-type diseases in animals. The accepted infectious model fits neither." (Fintan Dunne, "Insecticide Causes Mad Cow Disease")

It's obvious that deer and elk in the Mount Horeb area are eating from local soy fields. If any of that soy is Roundup-ready, the high-manganese soil would provide the requisite manganese to produce CWD. And unlike humans, deer and elk don't remove soybeans from their pods or rinse them off prior to eating. In other words, they're getting the full dose of Roundup, a type of organophosphate. This would explain an outbreak of CWD in the soy-growing area of Mount Horeb.

Dr. Lawrence Broxmeyer, an expert in the class of TB bacteria, claims that Bovine tuberculosis may be the actual culprit behind Britain's Mad Cow outbreak. However, when asked about the organophosphate model, he admitted that organophosphates are one of several chemical agents which could have made the cattle more susceptible to the disease.

Avoiding Organo-Phosphates

Prion diseases are considered to be fatal in all animals. They vary in which part of the nervous system is attacked, and how long the organism will be able to survive after infection. Often the human form of prion disease, CJD, is misdiagnosed as Alzheimer's Disease, Dementia, MS, or other nervous disorders.

Steps can be taken to avoid CJD. To ensure that soy is NOT treated with Roundup, use only Certified Organic soy and soy products. Soybeans treated with organophosphates, or GMO soybeans, cannot be certified as organic. Also, all animal products should be avoided, as the infectious nature of the disease is occasionally manifested (as with hunters infected from eating diseased prey). According to Purdey, the disease is infectious when prions are causing active chain reactions, but there is no way to visibly ascertain whether prion chain reactions were occurring when the animal was slaughtered.

Another source of organo-phosphates are lice, flea, and tick shampoos. This includes lice shampoos distributed by public schools. Read the label of any such product provided to your child or purchased, and check its active ingredients with your pharmacist. An Internet search can also help -- in a good search engine like Google.com, type the word "organophosphate", followed by a space and then the active ingredient. Seeking natural remedies, such as neem and turmeric (see "The Green Pharmacy" by James Duke, Ph.D.), are a good way of circumventing possible organo-phosphates.

Finally, if farming or gardening, avoid organophosphate pesticides and herbicides. Research the products you use, then find alternatives or switch to organic farming/gardening methods. Farm workers who can't influence their employers could look into wearing protective gear, or even finding a job with a better employer.

Prehistoric London Its Mounds And Circles By E. O. Gordon (Published 1946) Part 24



WE **BRING** THESE FRAGMENTARY NOTES ON THE PREHISTORIC MOUNDS AND **CIRCLES** OF LONDON TO **CONCLUSION**, as we are about to do, with a description of an actual modern Gorsedd, (above) solemnized as in pre-Christian times, within a stone circle on "some green spot, in the face of the sun, the eye of Light," with all the ancient symbolic ceremonial laid down by the Founder, it is important to glance at the historical evidence that has reached us of the functions of a Gorsedd, the "oldest educational institution in Europe" (according to Matthew Arnold), an Institution, moreover, not known out of Britain.

Established in 1000 BC. by Aedd Mawr and the three Wise-men he selected to assist him in the organization of the Druidic Order, the laws and regulations of the "Gorsedd of the Isle of Britain" were handed down by oral traditions for the first five centuries after creation by Bards specially set apart to rehearse these laws in the audience of the people at the annual assembly of the Gorsedd or Eisteddfod.

From Barddas (being a collection of original documents illustrative of the Theology, Wisdom and Usages of the Bardo-Druidic system published by the Welsh MSS. Society in 1852), we now learn that the Druidic Gorsedd Laws were incorporated by the British King Dunwal Molmutius, who lived in the fifth century BC., in his famous code; and it is from this reliable source that we find the "Gorsedd of the Bards" is mentioned as "the oldest in its origin" of the "three privileged Gorsedds of the Isle of Britain."

And that there were three Gorsedds according to the privilege of the country and nation of the Kymry, having their respective duties for the improvement of society. "The first is the Gorsedd of the Bards of the Isle of Britain and their foundation and privilege rest upon reason, nature, and cogency; or according to other teachers and wise men, upon reason. Nature and circumstance.

And the privilege and office of those protected by the Gorsedd of Bards are to maintain and preserve and diffuse authorized instruction in the sciences of piety, wisdom, and courtesy; and to preserve memorial record of everything commendable respecting individuals and kindred; and every event of times: and every natural phenomenon; and wars; and regulations and country and nation; and punishments and commendable victories: and to preserve a warranted record of genealogies, marriages, nobility, privileges, and customs of the nation of the Kymry; and to attend the exigencies of other Gorsedds on announcing what shall be achieved, and what shall be requisite, and under lawful proclamation and warning; and further than this there is nothing either of office or of privilege attached to a Gorsedd of Bards.

"Second the Gorsedd of the country and commonwealth; or the Gorsedd of judicature and decision of law, for the right and protection of the country and nation, their refugees and aliens. These Gorsedds act severally; that is to say, the Gorsedd of federate support makes a law where an occasion requires, and confirms it in a country; and that is not allowed to a country distinct from a federate country. The Gorsedd of judgment and judicature decides upon such as shall transgress the law, and punishes him. And the Gorsedd of the Bards teaches commendable sciences, and decides respecting them, and methodically


preserves all the memorials of the nation to insure their authenticity. And it is not right for any one of these Gorsedds to intermeddle with the deliberation of either of the other two, but to confirm them, and to support them regularly.

"The third Gorsedd, or that of federate support in its original and determinate purpose, is to effect what may be necessary as to anything new, and as to the improvement of the laws of a country and federate country by a federate jury of chiefs of kindreds, wise men, and sovereign ruler. A sovereign prince, or ruler of paramount right, is the oldest in possessive title of the kings and the princes of a federate community: and he is to raise the mighty agitation of the country."

According to the tenor of this extract it was "the Gorsedd of judgment and judicature" that possessed the special right of determining national and social disputes, in conformity with the law that was enacted in a "Gorsedd of federate support." They were matters of a literary character mainly that came under the supervision of the Bards: nevertheless, there was some connexion between the three institutions. They were "to confirm, and support" each other "regularly."

The Bards were required more particularly to register the events that occurred in country and nation, to preserve the records of genealogies, marriages, nobility, privileges and customs, of the nation of the Kymry. There seems therefore no reason to dismiss as untrustworthy, and, as we have been so repeatedly told, "not worth the parchment they are written on," the genealogies of the British kings and the historical events recorded in the Welsh "Bruts," events which furthermore we find, for the most part, imperishably crystallized in the traditions of the localities where they occurred.

Having satisfied ourselves from original sources preserved in the original Kymric tongue, the "oldest living language in Europe," of the value of the Gorsedd institution as an organized "governing body," we must see what Sir Norman



Lockyer (above) and other scientists of our own time have discovered with regard to the scientific construction of these prehistoric open-air Sanctuaries which prove conclusively that these Circles were used by the ancients not only as places of worship, dedicated to the service of the Most High and as Courts of Justice, but were also Observatories.

The Rev. J. Griffith in an article in Nature (May 2, 1907) has been the first to set forth the scientific significance of a Welsh Gorsedd circle and to explain the meaning of the three stones pointing outwards that one sees lying on the ground at the entrance to a Gorsedd circle to-day. He states that "the present Gorsedd circle consists of twelve stones, 80° apart, with a larger stone in the centre.

Outside, on the East, three stones are placed to indicate the solstices and equinoxes to an observer at the central stone"; and he quotes the following nomenclature of the stones: "The stones forming the circle are called the White Stones, or Stone of Testimony, the circle itself is sometimes called the White Circle." The middle stone, or altar, is termed Maen Gorsedd, i.e. Presidential Stone.

"The stones pointing to the Equinoxes and Solstices are called Stones of the Sun. The Bards stand unshod, uncovered, within the circle; the Presiding Bard, who must be of the Primitive Order, stands by the Présidial Stone. All the other Bards attend around, standing near the White Stones or Periphery of the circle."

Mr. Griffith's researches enable him to prove solstice shows that we have to do with a very that the Solstitial Stones have really replaced high antiquity." others so located that the sunrise places in May and November were indicated. In Gorsedd history, then, the May year came first and was indicated by the position of the stones.

The sign which Mr. A. L. Lewis (Nature, June 6, 1907) associates naturally with the "broad arrow" is really a "miniature May Gorsedd."

Even more than the ancient codes of Welsh laws, says Mr. Griffith, the Bardic traditions of the Gorsedd are the most formally authenticated of any Welsh literature. Since the tenth century[7] the former have had to take care of themselves apparently, but the Bardic traditions were always recited at every proper Gorsedd.

> "From the twelfth century to the first quarter of the nineteenth we have accounts of a series of great Gorsedds (or Eisteddfods, the same thing) every one of which was convened for the chief purpose of re-codifying or otherwise dealing with the Bardic traditions. We have nothing so well and faithfully guarded in Welsh literature as our Bardic traditions."

"Mr. Griffith," says Sir Norman Lockyer, "has rendered another service to archaeology in its widest sense by pointing out in a subsequent article the enormous number of Welsh and English fairs held on the festival (quarter) days of the May year.



These, doubtless, are the modem representations of the assemblies at the festivals of places where circles existed, or where fires were lighted or Gorsedds erected; so that it may be said that fairs as well as many old churches mark for us the loci of the original circle worship, and the fact that we are dealing with the May Year and not the

"We are able to see," Mr. Griffith remarks, "at the Welsh National Eisteddfod in this twentieth century, the actual use to which the temple observatory was put. If such a broad assertion causes surprise it is considerably lessened by what seems to me to be an incontrovertible fact, that instead of having one Gorsedd, and that in Wales, a true survival from late Neolithic times (to fix a downward limit), we have in Britain thousands of Gorsedds, the pedigrees of which are as unimpeachable as that of the Welsh institution.

I refer to fairs still held on the quarter days of the May Year. To a student of the Welsh Gorsedd this at once dispels any à priori doubt as to the antiquity of that institution-- the Gorsedd and the popular fair is one and the same, constituting a true monument as ancient as a temple observatory in stone. A better way of putting it is, the temple observatory has survived:-

- 1) in stone,
- 2) in tradition, and
- 3) in festival.

The Welsh Gorsedd presents this three-ply evidence." (See Sir Norman Lockyer's Stonehenge and Other British Stone Monuments Astronomically Considered.)

Those of my readers who desire to recall a Druidic assembly on the site of St. Paul's, the Abbey, or within the precincts of any other of our British circles, cannot do better than be present at one of the National Gorsedds in Wales. The locality is chosen always at the Eisteddfod of the previous year—usually a meadow, just outside the town—large enough to afford standing room for the thousands of all sorts and conditions in life, and of all denominations who assemble to take part in these popular, purely educational contests, as they now are.

A circle is formed of 12 unhewn stones symbolic of the signs of the zodiac. In the centre is the large Maen Llog or Logan Stone, symbolic of the "Rock" which is Christ. Druidism itself was ordinarily known as "Y Maen," the stone.






