Introduction

“11 And it shall come to pass in that day, that the Lord shall set his hand again the second time to recover the remnant of his people, which shall be left, from Assyria, and from Egypt, and from Pathros, and from Cush, and from Elam, and from Shinar, and from Hamath, and from the islands of the sea.

12 And he shall set up an ensign for the nations, and shall assemble the outcasts of Israel, and gather together the dispersed of Judah from the four corners of the earth.

13 The envy also of Ephraim shall depart, and the adversaries of Judah shall be cut off: Ephraim shall not envy Judah, and Judah shall not vex Ephraim.

14 But they shall fly upon the shoulders of the Philistines toward the west; they shall spoil them of the east together: they shall lay their hand upon Edom and Moab; and the children of Ammon shall obey them.

15 And the **Lord** shall utterly destroy the tongue of the Egyptian sea; and with his mighty wind shall he shake his hand over the river, and shall smite it in the seven streams, and make men go over dry shod.

16 And there shall be an highway for the remnant of his people, which shall be left, from Assyria; like as it was to Israel in the day that he came up out of the land of Egypt.” - **Isaiah, Chapter 11.**

THAT HIGHWAY, IN VERSE 16, IS TODAY KNOWN AS THE DARIEL PASS. It is the pathway the children of Israel took through the Caucasus Mountains, thus becoming known as the Caucasian People. In ancient times, and even to today’s local residents of the area, the Dariel Pass is still known as “The Pass of Israel.”

Verse 11 describes how the children of Israel will one day be reassembled from the various places of their dispersion. Verse 12 says it will be the children of both Houses. It is not possible for that regathering place to be the tiny nation called Palestine. The Bible clearly teaches that the Israelites will be far too numerous to be contained by that small territory.

No, the main regathering place of the Twelve Tribes of Israel is the USA, the New JerUSAlem of the Holy Scriptures.

The Holy Bible is the most misunderstood book in the world. More mythology has been taught in the name of both Judaism and Judeo-Christianity than truth. Islam is another religion which has mythologized and distorted the historical facts of the Bible. “I say then, Hath God cast away His People? God forbid! For I also am an Israelite, of the seed of Abraham, of the tribe of Benjamin.” - Romans 11:1.

Neither Judaism nor Judeo-Christianity teaches those passages of Scripture which identify True Israel. Rather, they ignore those passages and teach self-serving doctrine, which is unrelated to the true identity of Israel. One of the most critical subjects of the Holy Bible, a subject which reveals Israel's True Identity, is the subject of the division of the Twelve Tribes into Two Houses.

5.) The House of Judah has the distinct mission of bringing forth the Messiah through the lineage of King David. Having fulfilled its mission in the land of Judah, the Judahite dynasty dies out for good, but only in Judea.


The Davidic Dynasty is alive and well in Europe. They are known as King Arthur and the British Kings, Charlemagne and the Germanic Kings, such as the Hapsburgs, the Czars, etc. All of the Kings and Queens of Europe are, in fact, descendants of King David!

6.) The various Tribes of Israel would found numerous nations: first in Europe and then all over the world.

8.) Ultimately, the Two Houses would one day be merged back together, so that they are no longer a House Divided. This re-unification is moral, spiritual and literal, taking

9.) The nation where the physical re-unification took place was the United States of America. “Word for Word” Exodus Part 4

Chapter 6

1. Then said Yahweh to Mosheh, “Now you shall see what I will do to Par’oh: for with a strong hand he shall let them go, and with a strong hand he shall drive them out of his land.”

2. Spoke Elohiym to Mosheh, and said to him, “I am YHWH.

3. Appeared I to Abraham, to Yitschaq, and to Yaaqob, as El Shadday 410/7706, but by My Name YHWH was I not known to them?

4. Established I also My Covenant with them, to give them the land of Kenaan, the land of their pilgrimage, in which they were foreigners 1481.

5. I have also heard the groaning 5009 of the children of Yis’rael, whom the Mits’rayim keep in bondage; and I have remembered My Covenant.

6. Wherefore say to the children of Yis’rael, ‘I am Yahweh, and I will bring you out from under the burdens of the Mits’rayim, and I will deliver 5337 you out of their bondage, and I will redeem you with a stretched out 5186 arm, and with great judgements 8201:

7. and I will take you to Me for a people, and I will be to you an Elohiym: and you shall know that I am Yahweh Eloheychem 430 which brings you out from under the burdens of the Mits’rayim.

8. I will bring you into the land, concerning which I did swear to give to Abraham, to Yitschaq, and to Yaaqob; and I will give it to you for a heritage, I am Yahweh.”

9. Spoke so Mosheh to the children of Yis’rael: but they did not listen to Mosheh because of the anguish 7115 of spirit 7307, and because of harsh bondage.


10. Spoke Yahweh to Mosheh, saying,

11. “Go in, speak to Par’oh king of Mits’rayim, so that he lets the children of Yis’rael go out of his land.”

12. Spoke Mosheh in the presence of Yahweh, saying, “Behold, the children of Yis’rael have not listened to me; how then shall Par’oh hear me, who *am* of uncircumcised 6189 lips 8193?”

13. Spoke Yahweh to Mosheh and to Aharon, and gave them a charge 6680 to the children of Yis’rael, and to Par’oh king of Mits’rayim, to bring the children of Yis’rael out of the land of Mits’rayim

(Mosheh and Aharon’s Family Lineage)



14. These are the heads 7218 of their ancestral Houses: The sons of R’uben, firstborn of Yis’rael; Chanoch, Pallu, Chetsron, and Charmiy: these are the clans of R’uben.

15. The sons of Shimeon; Yemuel, Yamiyn, Ohad, Yakin, Tsochar, and Shaul the son of a Kenaaniyth: these are the clans of Shimeon.

16. These are the names of the sons of Lewiy according to their generations 8435; Gereshon 1648, Qehath 6955, and Merariy 4847: and the years of the life of Lewiy were a hundred and thirty seven years.

17. The sons of Gereshon; Libniy 3845, and Shim’iy 8096 according to their clans.

18. The sons of Qehath; Amram 6019, Yitshar 3324, Chebron 2275, and Uzziyel 5816: and the years of the life of Qehath were a hundred and thirty three years.

19. The sons of Merariy; Machliy 4249 and Mushiy 4187: these are the clans of Lewiy according to their generations.

20. Amram took him Yochebed 3115 his father’s sister to wife; and she bore him Aharon and

Mosheh: and the years of the life of Amram were a hundred and thirty seven years.

21. The sons of Yitshar; Qorach 7141, Nepheg 5928, and Zichriy 2147.

22. The sons of Uzziyel; Miyshael 4332, El’tsaphan 469, and Sithriy 5644.

23. Aharon took Eliysheba 472, daughter of Ammiynadab 5992, sister of Nachshon 5177, to wife; and she bore him Nadab 5070, Abiyhu 30, El’azar 499, and Iythamar 385.

24. The sons of Qorach; Assiyr 617, El’qanah 511, and Abiyasaph 23: these are the clans of the Qor’chiy 7145.

25. El’azar son of Aharon took one of the daughters of Putiyel 6317 to wife; and she bore him Piynechas 6372: these are the heads of the ancestors of the Lewiyyim according to their clans.

26. These are that Aharon and Mosheh, to whom said Yahweh, “**Bring out the children of Yis’rael from the land of Mits’rayim according to their armies 6635.**”

27. These are they which spoke to Par’oh king of Mits’rayim, to bring out the children of Yis’rael from Mits’rayim: these are that Mosheh and Aharon.

28. It came to be on the day when spoke Yahweh to Mosheh in the land of Mits’rayim,

29. that spoke Yahweh to Mosheh, saying, “**I am Yahweh: speak you to Par’oh king of Mits’rayim all that I say to you.**”

30. Said Mosheh in the presence of Yahweh, “Behold, I *am* of uncircumcised lips, and how shall Par’oh listen to me?”



Chapter 6 Notes

Yahweh informs Mosheh that He was known as El Shadday (God Almighty) to those in the past, but they **Knew** the Holy Name, and the patriarchs called on it, so he put it in all five scrolls, thus the Name appears in B’reshiyth (Genesis). There is no such name as “Jehovah”. It was a scribal error with masoretic vowel

points, and has developed into an entire sect now. There was never a “J” in Hebrew.

Verse 2,3 - Gen. 17:1; 28:3; 35:11; Ex. 3:13-15;

Verse 3 - The Hebrew word order makes this verse a **Question**, not a statement. They knew The Name beforehand.

Verses 6:16-19 - Num. 3:17-20; 26:57,58; 1 Chron. 6:16-19;

Verse 6 - a “stretched out arm” is a major symbol of power.

Verse 12 - uncircumcised lips is a metaphorical way of saying he is unworthy to speak for Yahweh. Mosheh was a very humble man, and Yahweh loved him for it.

Verse 20 - The Book of Yashar (Jasher) shows that Miryam was the older sister of both Aharon and Mosheh. This book really is a wealth of information, and fills in a lot of gaps. Sepher Yashar (Book of Jasher) means Book of the Upright in Hebrew. Upright being those who behaved righteously. Miriam was born first **Yashar 67:3**.

The Crusades

WE HAVE HEARD THE JEWS CRY AND WHINE ABOUT THE CRUSADES AND THE INQUISITIONS ALL OUR LIVES. This study is to present you with just a little about what actually caused the crusades, and who they were directed against.

So what is the truth about the Crusades? Scholars are still working some of that out. But much can already be said with certainty. For starters, the Crusades to the East were in every way defensive wars. They were a direct response to Muslim aggression; an attempt to turn back or defend against Muslim conquests of Christian lands.

Christians in the eleventh century were not paranoid fanatics. Muslims really were gunning for them. While Muslims can be peaceful, Islam was born in war and grew the same way. From

the time of Mohammed, the means of Muslim expansion was always the sword. Muslim thought divides the world into two spheres, the Abode of Islam and the Abode of War. Christianity; and for that matter any other non-Muslim religion, has no abode.

Christians can be tolerated within a Muslim state under Muslim rule. But, in traditional Islam, Christian and Jewish states must be destroyed and their lands conquered. When Mohammed was waging war against Mecca in the seventh century, Christianity was the dominant religion of power and wealth. As the faith of the Roman Empire, it spanned the entire Mediterranean, including the Middle East, where it was born. The Christian world, therefore, was a prime target for the earliest caliphs, and it would remain so for Muslim leaders for the next thousand years.

With enormous energy, the warriors of Islam struck out against the Christians shortly after Mohammed's death. They were extremely successful. Palestine, Syria, and Egypt; once the most heavily Christian areas in the world, quickly succumbed.

By the eighth century, Muslim armies had conquered all of Christian North Africa and Spain. In the eleventh century, the Seljuk Turks conquered Asia Minor (modern Turkey), which had been Christian since the time of Paul. The old Roman Empire, known to modern historians as the Byzantine Empire, was reduced to little

more than Greece. In desperation, the emperor in Constantinople sent word to the Christians of western Europe asking them to aid their brothers and sisters in the East.

That Is What Gave Birth to the Crusades. They Were Not the Brainchild of an Ambitious Pope or Rapacious Knights but a Response to More than Four Centuries of Conquests in Which Muslims Had Already Captured Two-thirds of the Old Christian World.

At some point, Christianity as a faith and a culture had to defend itself or be subsumed by Islam. The Crusades were that defence.



Pope Urban II called upon the knights of Christendom to push back the conquests of Islam at the Council of Clermont in 1095 (above). The response was tremendous.

Many thousands of warriors took the vow of the cross and prepared for war. Why did they do it? The answer to that question has been badly misunderstood. In the wake of the Enlightenment, it was usually asserted that Crusaders were merely lacklands and ne'er-do-wells who took advantage of an opportunity to rob and pillage in a faraway land.

The Crusaders' expressed sentiments of piety, self-sacrifice, and love for God were obviously not to be taken seriously. They were only a front for darker designs.

But in fact it was the Jews who did the looting, robbing and assassinations; which antagonized both the Moslems and the Christians.

Castile was in a pitiful state during that summer of 1467. Robberies, burnings and murders were daily occurrences. A church in which three hundred and fifth men, women, children and tenants of the Count of Benavente, had taken

refuge, was burned by the Count's enemies and all within perished.

In Toledo There Was a State of Warfare between the Jewish Christians (Conversos, or Marranos, as they were called) and the "Old" Christians. The Canons of the Cathedral. There, Some of Whom Were Conversos, Controlled the Revenues of the Neighbouring Town of Maqueda, Including a Tax on Bread. This Privilege, so Hateful to the Half-starving Poor, They Sold at Auction to Certain Jews.

A Catholic Magistrate, or Alcalde, Beat the Jews and Drove Them Out of the City. The canons had the alcalde arrested, but while they were deliberating as to his punishment, Fernando De La Torre, a Rich Leader of the "Converted" Jews, Decided to Take the Law into His Own Hands. A Rash and Violent Man, He Announced That He and His Friends Had Secretly Assembled Four Thousand Well Armed Men, Six Times as Many as the Old Christians Could Muster.

On July 21 He Led His Forces to Attack the Cathedral. The Crypto Jews Burst through the Great Doors of the Church, Crying "Kill Them! Kill Them! This Is No Church, but Only a Congregation of Evil and Vile Men!" The Catholics in the Church Drew Swords and Defended Themselves a Bloody Battle Was Fought before the High Altar.

Reinforcements of Christians Now Came Galloping from Nearby Towns and Launched a Counter Attack on the Luxurious Section Where Most of the Conversos Lived. They Burned the Houses on Eight Streets. They Hanged Fernando De La Torre and His Brother, Then Massacred the Conversos Indiscriminately.

In Córdoba however, they found a powerful champion, Don Alonzo de Aguilar, who had married a woman of Jewish descent, a daughter of the Marqués of Villena. He and his brother, Gonsalvo de Cordoba, who was later to win fame in Italy as "the Great Captain," defended the Conversos. The Old Christians (bona fide Christians) led by the Count of Cabra, besieged them in the Alcazar.

The result was a state of war which lasted for nearly four years. Unhappily too, the periodical frenzy against the "New Christians" or Jewish converts (also Marranos), flamed up in a dozen



other places. One of the most brutal of the massacres occurred at Segovia on May 16, 1474. **the Man Most Responsible for It Was the Marqués of Villena, Himself of Jewish Descent (above). Hatred between Jews and Christians Had Always Been Intense in Segovia.**

In 1405 a Physician Named Mayr Alquades and Other Prominent Jews Had Been Accused of Stealing a Consecrated Host from the Cathedral and Had Been Executed, While Other Jews, Said to Have Attempted to Have the Bishop Poisoned in Revenge, Were Drawn and Quartered. When Isabel Was Seven Years Old Sixteen Jews, Including a Rabbi, Were Accused of Having Stolen a Christian Boy during Holy Week and of Having Crucified Him as an Insult to the Memory of Jesus.

In 1468. Sepulveda, Segovia, Spain: The Jews sacrificed a Christian child on a cross. The Bishop of Segovia investigated the crime, and ordered the culprits to Segovia, where they were executed. It is important to know that this Bishop was himself a son of a converted Jew; Jean d'Avila was his name.

Colmenares's History of Segovia records the facts of the case, which was juridically decided by a man of Jewish blood. That may be the reason that one finds no mention of it in Strack's book *In Defence of the Jews*, The Jew and Human Sacrifice.

When Isabel and Fernando arrived at Segovia, the place still stank of charred timbers, rotting flesh, carnage and pestilence. She commended Cabrera for his valour, affectionately welcomed his wife Beatriz and denounced all the misguided or fanatical tools of Villena who had shared in the massacre. Only recently she had prevented a

massacre of the Conversos at Valladolid, even though it meant the loss of many of her adherents and the necessity of fleeing from the city with her husband and Archbishop.

Now She Had an Opportunity of Seeing at Close Range the Frightful Results of the Hatred between the Christians and Jews. What Could save the Land from Utter Ruin and from a Second Conquest by the Mohammedans, Applauded by Jews and Conversos?

What Could Make the Jews Stop Exploiting the Christians and Proselytising, Even as Christians, to Destroy Christianity? What Could Make Christians, or Nominal Christians, Stop Massacring the Marranos on Every Provocation? Isabel and Fernando came to the conclusion that the great need of Castile was a government strong enough to be feared and respected by all classes.

To understand the bitterness of Spanish Christians against the secret Jews, who pretended to be Catholics, one must remember that **Spain Had Been at War with the Moors for Hundreds of Years and That the Jews, Who Had Invited the Mohammedan into the Country in the First Place, Had Always Been Considered Enemies within the Gate, Sympathizing with and Often Lending Assistance to the Hated Moors.**

Beyond Any Question the Jews and the Mohammedan Did Share a Common Hatred of Christ and His Church. Whenever the Moorish War Flamed Anew, the Jews Became Special Objects of Suspicion, just as German sympathizers in the United States were suspected and often persecuted during the World War. Unfortunately for the Jews, it was only too evident that Isabel and Fernando were on the eve of another long and dangerous conflict with the power in Granada.

It was the Jews of Spain, as the Jewish Encyclopaedia records, who invited the Mohammedan to enter the peninsula and possess themselves of the property and lives of the Christians. Under the tolerant rule of the Mohammedan," writes Lewis Browne, a modern Jew, "the Jews began to prosper. They who had been poor and bedraggled peddlers for centuries now became wealthy and powerful traders.

They travelled everywhere, from England to India, from Bohemia to Egypt. **Their Commonest Merchandise in Those Days Was Slaves. On Every High Road and on Every Great River and Sea, These Jewish Traders Were to Be Found with Their Gangs of Shackled Prisoners in Convoy.”**

After the Discovery That the Jews Were Plotting to Bring the Arabs from Africa to Overthrow the Gothic Kingdom, They Were Condemned to Slavery and even after their liberation were repressed by the cruel provisions of the Visigothic Code. In spite of all this they prospered and by the beginning of the eighth century they were so rich and powerful in all the principal cities that when in 709 AD.

The Saracens Finally Came, at the Jew’s Invitation from Africa, the Spanish Jews Were Able to Open the Gates to the Conquerors and Were Rewarded by Being Made Rulers of Granada, Sevilla and Cordoba. In the New Moslem State They Attained a Brilliant Height of Prosperity and Culture.

During the past two decades, computer-assisted charter studies have demolished that contrivance.

Scholars have discovered that crusading knights were generally wealthy men with plenty of their own land in Europe. Nevertheless, they willingly gave up everything to undertake the holy mission.

The Fall and Rise of Abraham’s House (Part 13)

The word ‘restore’ to most implies, all things made perfect. **BUT** that is **NOT** what it means here, it means **GIVE BACK**. Jesus told the Canaanites that ‘sat in Moses’ seat’ (ie. ruling from

Jerusalem, ie. kings of Salem) that the kingdom would be taken from them.

This is what Christ did when He took David’s throne and gave His underlings the authority to rule, but as Christians, not as Judeo-Christians. When will the Israelite believing folk get their authority?, verse 8, “But ye shall receive power; after that the Holy Ghost is come upon you ” When was that? well, way back then, verse 5,

“For John truly baptized with water (water was a fore-shadow of a better cleansing) but ye shall be baptized (cleansed) with the Holy Ghost **NOT MANY DAYS HENCE.”**

Thus pleased that Jesus had planted the kingdom seed, He was now ready to be everywhere all at once. The only way to do this is to be transformed in a way that would allow Him to function as His Father. It did mean that He would be lost to the spectrum we enjoy as sight. “And when He had spoken these things, while they beheld (were looking) a cloud received Him out of their sight. (A cloud engulfed Him, like mist, and He vanished from sight, as someone does in the mist)

And while they looked steadfastly toward heaven (heaven here is from *ovranos*, it means the air, so while they strained to look through

the mist) as He went ‘up’ (went up is meant in the sense of swallowed up, vanished. The word ‘up’ was added. The word ‘went’ is from the Greek which means to way fare or to walk) behold two men stood by in white apparel; which also said, Ye men of Galilee, why stand ye gazing up (up added) into heaven? (ie. why stand ye gazing into the mist or air, there is no upward implication) this same Jesus, which is taken up (up added, ‘taken’ is more correct, in the sense of being accepted, ‘analambano’ ‘ana’ is a prefix, on its own it means up but as a prefix it means by implication a sense of intensity, ‘lambano’- to take.

Rather than take up, it’s more like inter-take, ie. chosen or accepted.) from you into heaven...” Let’s now put it together, “Why stand ye gazing into the mist? This same Jesus which is accepted from you into the mist, shall appear in like manner as ye have seen Him walk into the mist.” Your Bible may read ‘come’ for appear. The word ‘erchomai’ has many meanings, but in the context ‘appear’ is the most apt rendering because it is the reversed of disappearing as shown to be the case in foregoing lines.

As you read the account, you will see that Jesus said the truth in verse 5, namely, they did not have to wait many days for the Holy Ghost to cleanse them and to empower them to put into practice the physical growth of Christ’s kingdom, albeit in earnest of the Ghost or mindset.

The kingdom is not in earnest, it is real, the Spirit or minds of the Israelites is only in earnest, namely, not fully there, half baked—the leaven not fully baked out, thereby Pentecostal by nature. Guess what? They understood this because on the day of Pentecost that followed that year about AD 33, the Holy Ghost, the ‘aparthood mindset’, came upon them, as Jesus said would happen.

Thus Jesus Christ’s Kingdom was planted with Jesus’ anointed Israelite men whose minds were cleansed in earnest. So began the wheat age, the Church age level of the Kingdom of Jesus.

When the wheat age ends, the last husks are threshed away, the churches empty. The kingdom is ready for a new work. Before a new work, God sends a teacher, a prophet. Teachers that are an Elijah type. It is time to see from the

Holy Writ what sets this teaching apart from the false teachers of the churches and what the outcome will be. Elijah types are the opposite to the Shittim-Balaam, pro-Gilgal types. Judeo-Christianity sits well with the wickedness of Gilgal. The churches love kings, constitutions and central government; teaching that these are needed for a ‘civilized’ society.

An American Christian puts it this way, “We’ve had central government for centuries, (Asoka had it) it has done nothing to help us (it helps only non-Israelites, a theme that is all too familiar with central government), it does everything to hurt us, (‘us’ being Israelites).

In controlling trade it is the greatest supporter of free trade for its lackeys and stifling all our honest work, (preferring to give trade to elite groups such as Canaanites and assorted proselytes such as freemasons and then sacking Saxons in affirmative action schemes ie. giving work to ‘minorities’ over Saxon-Israelites; sacking for more profit, sacking to set up shop in non-Israelite lands).

As for military protection, central governments have always caused wars and used our men and women as their cannon-fodder (re-read 1 Samuel), it was central government that causes internal strife and seeks to make other nations around them conform to their ‘ideals’.

As for the Constitution, well, we showed that it’s lofty, Godly claims were never upheld. But even if these were upheld, are the principles God-inspired? Firstly, only the Bible is the inspired Word of God, **NOTHING ELSE!** This Elijah-type Christian points out “Where the spirit of the Lord is, there is liberty (freedom)” 1 Corinthians 3:17. So freedom and Jesus Christ are inseparable.

The Australian Constitution came about due to Federation - Centralization. This is the track record of the Federal government under the constitution, and its giving of God's freedom. It sent our sons in 1914 to kill fellow Israelites who did not start the war--(WWI was started by a handful of Canaanites, that's true, but the central government could have been wiser and more levelheaded by obeying God's Laws. Instead, they slaughtered our sons.)



Never repenting, it did the same in World War 2, the Vietnam War and so on. It did not stop usury because they could tax it, it did not stop vaccinations, instead it took bribes to promote the poisoning of our folk, it did not stop the media, for it works hand in glove with the media to demoralize, propagandise and brain-dirty our folk. So, after some 100 years look where we are; abortion, drugs, loose sex, divorce, murders, theft, race-mixing, lies, and lots of crime; in short multiculturalism; Asoka's and Omri's tolerance of all things ungodly.

Seeing that the Constitution created the government which foredoes (destroys) freedom, it could not have been inspired by God (look how section 116 of the Constitution is blatantly against the First Commandment!). There is no benefit at all in having central government **OTHER** than for those who are in it or who prop it up. Central Government, be it headed by Presidents, Prime Ministers or man-kings from an unruly line of David, are not a blessing but a curse from God through Jesus, to thrash those that want to be ruled by men rather than by King Jesus directly.

Yet few Israelites wake up to their wickedness, all they know in the end, is that things don't look too good. If by the time this is printed the laws become worse, then guess what? Good! Yes,

that's right, because salvation from those that hate us is only a cry away.

Many times we were delivered from our foes, yet we never understood why we got the foes in the first place. But there comes a time when, before God delivers, He sends a teaching movement. In the book of Judges, God sent six deliverers, each time without a teaching movement. But in the case of Gideon, the folk cried out because of the weight of central government, (a Midianite government) was ruling over our folk, and we were 'greatly impoverished' (perhaps they had a GST?). Can you relate to that?

"...And the children of Israel cried out to the Lord." But no deliverer... yet. Instead, God sent a prophet. You can be sure the folk thought, that is not going to do.' But you see, they forgot that they were Israelites, they thought they were 'mere nations', like we do today. "—And the prophet said unto them, Thus saith the Lord God of Israel, **I BROUGHT YOU OUT OF EGYPT**, and brought you forth out of the house of bondage; and I delivered you out of the hand of the Egyptians and out of the hand of all that oppressed you, and drove them out before you, and **GAVE YOU THEIR LAND.**

And I said unto you, I am the Lord your God, fear not the gods (mighty men, their laws, their statutes, their central government) in whose land ye dwell: **BUT YE HAVE NOT OBEYED MY VOICE.**" (ie. my law that I showed to Moses) Judges 6:6-10. Then God sent the deliverer but first let's study the foregoing points in Judges and then some from Malachi, though there are many other good examples.

The prophet, whose name is not given, gives a history lesson; You lot were delivered out of Egypt, you lot are--**ISRAELITES**, you are not mere nations. You also have a God, a God that put you in bondage, then took you out and led you into other lands where others lived, and drove them out for you.

Notice, the teacher did not say; you are a bunch of Gentiles, you're all invaders and it's time to say sorry to the 'indigenous' ones that have been displaced and have an inter-faith prayer day. No, he said God **GAVE** you their land.

Then he says that you have not obeyed God's Laws. This means they obeyed man's laws, and that is why God is angry with you, He put you into bondage to make you cry out. That style of


teaching, teaching those things, is the spirit or mind of Elijah.

That prophet operated under the mindset or spirit of God. This prophet did not come from the churches of his day. Clearly his teaching was unknown, ie. unheard of or radical. Clearly the churches of the day did not preach this. Is it not interesting to see the parallels between this mindset of the prophet of Gideon's time and that of 'Identity' or 'Elijah Christianity'?

'Identity' does not teach what the churches teach. Identity teachings are not taught in the churches nor do the Identity teachers get authority to leach from the churches. In fact, Elijah (Identity) Christianity is not taught anywhere else in establishment circles; not at Universities, not at TAFE, not at public school and so on and on.

Yet, Identity teaches more truth than all the rest put together, because it teaches what God wants them to teach from His Word, without pandering to the triad and its melting-pot Fifth Columnists. It teaches; you are Israelites that you came out of Egypt, that God put you into bondage when you forsake His law because the Law still stands, that you should not fear man or his institutions, fear God, obey Him and you will be delivered. The Identity teaching is 100% identical to that of the prophet in Judges 6:7-10.

Now look at Malachi 4:5, "Behold, I send you Elijah the prophet (Elijah teaching) before the coming of the great (for us) and terrible (for them, our toes) day of the Lord." What is the hallmark of this teaching? Remember ye **THE LAW** of Moses my servant..."



For who is the Law meant? "—which I commanded unto him in Horeb **FOR ALL**

ISRAEL Malachi 4:4 "And he shall turn the hearts of the fathers to the children.." (Identity fathers are more concerned for their children's future, they seek to home-educate and to ensure their children wed Israelites, so that. the seed of Abraham is not mingled)."and the heart of the children to their fathers."

Besides shaping good family bonds, this verse also means that children are remembering their roots, learning that they are Israelites, remembering their father Abraham, to look 'to the rock from whence they were hewn and the pit from whence they were digged.' In so doing, they learn that God took **Their** forefathers out of Egypt.

When will this ministry happen? When "—all the proud (unbelievers) yea, and all that do wickedly—" Malachi 4:1. Well, today is when wickedness is widespread. I do not mean street crime alone, I mean institutionalised crime —government —central government itself is a **SIN**—It is full blown Gilgal'.

Those that remember the Law of God through Moses and seek to have their children be over-comers, by having their children learn their Israelite identity, also learn to fear God, not man. These are the over-comers, the called-out ones, the elect. Malachi 4:2-3, "But unto you that **FEAR MY NAME** (you who fit the description of knowing you are Israelites and remember the **LAW**) shall the son of righteousness arise with healing in His wings and ye shall go forth and grow up as calves of the stall **and** ye shall tread down the wicked, for they shall be ashes under the soles of your feet—" When? Malachi 4:1, when "—the day that cometh (that) shall burn them (the wicked) up..."

Multiculturalism is a sign of how close the end is for Babylon, not for us. The Identity teaching IS the Elijah prophet. The deliverer is soon to begin His second work. That deliverer is King Jesus. The churches are a false deliverer, they deliver us into bondage, and delivered the coloured to have our inheritance. They have delivered for Christ, that which He did not ask for, a melting pot justified by the Asoka, Omri, Gilgal, Balaam doctrine. The doctrine of the 'Brotherhood of man' or 'we are all God's children'.

And so, "When the Son of man shall come (appear) in His glory (ie. putting the finishing

touches to His kingdom) and His holy (called-out) angels (messengers, in this case the over-comers) with Him, then shall He sit upon the throne of His glory: **and before Him Shall Be Gathered All Nations.**” (from ‘Ethnos’, ie. a melting pot of all races) Shall Jesus say, ‘O thank you churches, what a lovely brotherhood of man?’ **Not at All!** “...and **He Shall Separate Them One from Another...**”

What is He separating? The group or throng called ‘Ethnos’, where we get the word ‘Ethnics’. The throng is not given a religious description, Matthew uses the word ‘Ethnos’. The community that needs splitting up is being split; not on religious grounds, but on **Race!** **King Jesus** with His over-comers (over-comers not just from this age but also from times past who will have been resurrected by then, will reverse everything the kings, priests, and peddlers have worked on for so long).


Like Sunday, the seventh day of a cycle, is a day of **‘Rest Work’**, the seventh millennium is a **SUN** of righteous day (or age). Yes, the Seventh Day Adventists will hate this, but the age to come is hallmarked by the sun. Malachi 4:2, “..The Sun of righteousness shall arise.” It is thus a Sun age, a long Sunday.

It is not a Saturn-age or a long Saturday. That age will burn like an oven. It is a cleansing age of fire; God’s Word is a consuming fire. Six long days of toil; six millenniums of toil the hard way. Then one long Sunny day of rest work, cleansing, then upon the eighth day; the world is clean.

I have rearranged the order of the verses in Malachi 4 to show the relevant points. So far I have simply used the term ‘Elijah’ teaching. One could take the term ‘Elijah the prophet’ as being literal. Notice, at the time of Christ, many did, but in Luke 1:13-17 we see that Elijah is a movement, a zeal, a mindset, a fuel, oil, spirit, teaching. “—But the messenger said unto him,

Fear not, Zachariah, for thy prayer is heard; and thy wife Elizabeth shall bear thee a son and thou shall call his name Johannes (meaning God’s gift). And thou shalt have mirth and gladness and many shall rejoice at his birth, for he shall be great in the sight of the Lord and shall neither drink wine nor strong drink and he shall be filled with the Holy Ghost even from his mother’s

womb. And many of the children of Israel shall he turn to the Lord their God, And he shall go before him in the spirit and power of Elijah to turn the hearts of the fathers to the children and the disobedient to the wisdom of the just; to make ready a people prepared for the Lord.” The folk made ready are those prepared for the Lord, the over-comers.

The patterns are the same as in Malachi and Judges. The message is for Israelites only; about them and their God. Turning hearts to the future through the children of Israel, grounded in the history of the forefathers of Israel, to make ready a **Folk**, Israelite Folk, **None Other** for the Lord (see The Exclusiveness of Israel, by Eliel, from CIM).

That means, the Lord is ready when we are. The Identity teaching is the prophet Elijah that comes as the false prophets, the churches, fade away. Where does this happen? In the lands of crowds, the mixed throngs. Only Israelite nations are multicultural, and only at this point in time in the church age which is now fading away. The melting-pot in the Hebrew tongue is Ar-ma-geddon! Armageddon does not mean ‘battle’. Revelation 16:16. The root word is Megiddo, meaning ‘place of crowds’, implying mixed. Now think of Jesus being before all the nations mixed together in Matthew 25.

Armageddon, the place of mixed throngs, this cross references to Joel. Joel 3:1 begins with setting the stage of our captivity. In verse 2, God gathers all the nations (recall Matthew 25 and

Revelation 16:16) into the dale of Jehoshaphat. Jchoshaphat means ‘God’s dooms’, ie. God’s judges. Dale or Valley of Jehoshaphat means, a pleasant land of God’s judgement. God’s judgement or doom denoting a land of God’s Laws, or a land of His inheritance.

These lands, God dooms/judges in a special way, a way to put right the lawlessness of His Israelite folk. A dale is hedged about by mountains. The word implies a land area shielded, fenced off. Think of the Kalash, folk of the Dales.

Technically, we are ail folk of the dales, we can be called Kalash! The words ‘garden’, ‘town’, ‘borough,’ ‘haven,’ or in Dutch garde, tuin and burg, hof, all mean ‘and enclosed area, a protected or shielded area. Hence the true English word for citizen is ‘burgess’, one who lives in a borough or ‘burger’ in Dutch and German, meaning also a ‘freeman’.

Love Not The World

WE FIND THIS IN THE: ORIGINAL NEW TESTAMENT (ONT)

See **Authentic New Testament** - Footnote: While much that was in his documentary source (the Memoirs of John the Priest) has been adapted by the Greek author to bring the text into line with his ideas, as here, some passages, largely by way of commentary, stand out as his distinctive contribution.

Whenever possible attention has been drawn to these, as in this instance, and some have been placed below the main body of the text and in slightly smaller type. The present passage is John 3:16-21. (This passage has been so placed by the translator)

The Ferrar Fenton Bible Translation has the following in bracket indicating that the verse **Was Added by the Translators** at some point in time.

(For God so loved the world that He gave the only- begotten Son, so that every one believing in Him should not be lost, but have eternal life. For God did not send His Son to the world that He might condemn the world; but that He might save the world through Him) —and ends with John 3:21, Therefore it would appear that all the verses from John 3:16 forward to John 3:21 were added.

It appears that John 3:16 was not in the original Gutenberg Bible. You can see for yourself at the following [url](#).

"Love not the world, neither the things that are in the world. If any man love the world, the love of the Father is not in him." (1 John 2:15)

If this is true, and we believe that it is, then why would Yahweh say that He so loved the world? We don't believe that He would do so.

Now the question that was put forth that so many began jumping up and down because it was even suggested that John 3:16 should not be in the Bible.

"For what is a man profited, if he shall gain the whole world, and lose his own soul? or what shall a man give in exchange for his soul?" (Matthew 16:26)

We also have the testimony of Luke:

"—take heed to yourselves, lest at any time your hearts be overcharged with surfeiting, and drunkenness, and cares of this life, and so that day come upon you unawares.

For as a snare shall it come on all them that dwell on the face of the whole earth. Watch ye therefore, and pray always, that ye may be accounted worthy to escape all these things that shall come to pass, and to stand before the Son of man." (Luke 21:34-36)

James said:

"—know ye not that the friendship of the world is enmity with God? whosoever therefore will be a friend of the world is the enemy of God." **(James 4:4)**

In Colossians we are told:

"Set your affection on things above, not on things on the earth." **(Colossians 3:2)**

Yet **John 3:16** is a direct contradiction to the above verses.

"For God so loved the world, that he gave his only begotten Son, that whosoever believeth in him should not perish, but have everlasting life." **(John 3:16)**

Therefore, we must research the word "world" and see what it actually means.

World: Strong's Concordance: #2889 kosmos (kos'-mos); probably from the base of 2865; orderly arrangement, i.e. decoration; by implication, the world (in a wide or narrow sense, including its inhabitants, literally or figuratively [morally]): KJV-adorning, world.

World: Strong's Concordance: #2865 komizo (kom- id'-zo); from a primary komeo (to tend, i.e. take care of); properly, to provide for, i.e. (by implication) to carry off (as if from harm; genitive case obtain): KJV-- bring, receive.

World: Thayer's Definition: #2889 kosmos-




Now does it make sense that Yahweh would tell us that He loved world affairs, the aggregate of things earthly the whole circle of earthly goods, endowments riches, advantages, pleasures, etc.— which although hollow and frail and fleeting, stir desire, **Seduce from God and Are Obstacles to the Cause of Christ.**

WORLD: "World is also associated with mankind. Christ said of His disciples, 'Ye are the light of the world' Matthew 5:14. **Often World Is Used to Indicate the Men of This World Who Are Said to Lie in Wickedness.** Ephesians 2:2; 1 John 5:19, **the Men Are Called 'the World,'** not only because they compose the greater part of the world's population, but mainly because they pursue and cherish the things of this world.

The Psalmist describes these men 'as having their portion in this life.' (**Psalm 17:14**)

"World may also denote the fleeting character of life's riches and pleasures and the folly of making them of central importance in life. Will a person gain anything if he wins the whole world, but loses his life?" **Matthew 16:26.** (from Nelson's Illustrated Bible Dictionary, Copyright (C) 1986, Thomas Nelson Publishers)

Now John 3:16 makes even less sense, and it certainly appears that it does not belong in the Bible or men have been interpreting it in error for a long period of time. It would appear that John 3:16, like the rest of the Bible is making reference only to the Israelites in the world; not to all mankind.



When reading John 3:16, seldom does the Judeo-Christian clergy mention the following verse: "For God sent not his Son into the world to condemn the world; but that the world through him might be saved." (**John 3:17**)

This is very clear, if men of Yahweh will only look with their eyes open and not closed by the lying, deceiving Judeo-Christian clergy, that

John is speaking of the Israelites who were, even then, scattered all over the earth. He is not speaking of the blacks, Chinese, and the other races or peoples, he is speaking only of the world of Israelites.

But men will deny this because their eyes have been blinded to the truth as the scriptures say:

"Let no man deceive you by any means: for that day shall not come, except there come a falling away first, and that man of sin be revealed, the son of perdition; Who opposeth and exalteth himself above all that is called God, or that is worshiped; so that he as God sitteth in the temple of God, showing himself that he is God. Remember ye not, that, when I was yet with you,

—I told you these things? And now ye know what withholdeth that he might be revealed in his time. For the mystery of iniquity doth already work: only he who now letteth will let, until he be taken out of the way. And **Then Shall That Wicked Be Revealed, Whom the Lord Shall Consume with the Spirit of His Mouth, and Shall Destroy with the Brightness of His Coming:**

Even him, whose coming is after the working of Satan with all power and signs and lying wonders, And with all deceivableness of unrighteousness in them that perish; because they received not the love of the truth, that they might be saved.

And for this cause God shall send them strong delusion, that they should believe a lie: That they all might be damned who believed not the truth, but had pleasure in unrighteousness." (**II Thesalonians 2:3-12**)

We full well realize that many will say we are the ones deceived, not them. But you be the judge, if we are explaining this and **Most Will Deny It**, and we know that most are deceived, who is telling the truth. It is those who are few in number, whom the masses will deny.

Many people who claim to be Christian don't know the meaning of the word; for they think all they have to do is run down to the altar and bow down on their knees and pray and that is accepting Yahshua as their Savior. **It Is Not.** For they will go out and not think about church again for the next week when they attend church again.

Oh yes some will listen to the television preachers, or listen to the radio preachers, never knowing that these people are not teaching them a thing; but are only regurgitating a politically correct sermon from some book or set of books.

John James Hughes - The Welshman Who Set Up A Large Industrial Complex In The Donetsk Area of The Ukraine From Our West Midlands Correspondent



John Hughes

IN 1869, JOHN JAMES HUGHES, an engineer from the South Wales industrial town of Merthyr Tydfil, travelled to Imperial Russia. There, on the wide empty plains (the steppes) he set up an ironworks which developed into a huge industrial complex. Around the works grew up a town: Hughesovka.

By the first decade of the twentieth century, the population of Hughesovka was around 50,000 people, most of them working for or dependent on the works. The city's industry continued to expand however.

In 1924, during the Soviet period, the city was renamed Stalino (Сталино), and by 1932 had become the centre of the Donetsk region. Finally renamed Donetsk in 1961, the city became a notable centre for coal mining and the steel industry with a population of over 982,000 inhabitants and a metropolitan area of over 2,000,000 people.

In 2014, Donetsk and its surrounding areas became a centre of political unrest with separatists and Ukrainian military forces fighting for control of the city and surrounding areas. As of May 8, 2018, the Donetsk People's Republic now has full control of the city, with Ukrainian and DPR forces still engaging in combat however outside of the city.

1869 to 2019

2019 will mark the 150th anniversary of the founding of Hughesovka / Donetsk, and the

130th anniversary of the passing of John Hughes. A number of events were held throughout 2019 to mark both these anniversaries, and Hughes' significant achievements, through a series of cultural events in Hughes' hometown of Merthyr Tydfil, and throughout South Wales and beyond, beginning in April.

Biography

John James Hughes (1814 – 17 June 1889) was a Welsh engineer, businessman and founder of the city of Donetsk. The village was originally named Yuzovka or Hughesovka (Russian: ЮЗОВКА) after Hughes, ("Yuz" being a Russian approximation of Hughes). The village became a town in May 1917, which was later renamed Stalino (Russian: Сталино) in 1924. In 1961 the name was changed again to Donetsk.

Hughes was born in Merthyr Tydfil, Wales, where his father was head engineer at the Cyfarthfa Ironworks. It was there that Hughes started his career, under his father's supervision. He later moved to Ebbw Vale, before joining the Uskside Foundry in Newport, Monmouthshire in the 1840's. It was here than Hughes made both his reputation and fortune, patenting a number of inventions in armaments and armour plating.

The resultant revenues allowed him to acquire a shipyard aged 28, and by the age of 36 he owned a foundry in Newport. It was also during this time that he married Elizabeth Lewis. Together they had eight children: six boys and two girls, all born in Newport.

In the mid-1850's, Hughes moved to London to become manager of C. J. Mare's forges and rolling mills, which was then taken over by the

Millwall Iron Works & Shipbuilding Company, part of the Millwall Iron Works, Shipbuilding and Graving Docks Company. Hughes was a director of the company when it floundered, and resultantly became manager of the residual Millwall Iron Works Company.

During this period, the various companies and successors won worldwide acclaim for the iron cladding of wooden warships for the British Admiralty, for which Hughes was given much of the credit. In 1864 he also designed a gun carriage for heavy cannons, which came to be used by the Royal Navy, as well as the navies of some other European countries.

In 1868, the Millwall Iron Works Company received an order from the Imperial Russian Government for the plating of a naval fortress being built at Kronstadt on the Baltic Sea. Hughes accepted a concession from the Imperial Russian Government to develop metal works in the region, and in 1869 acquired a piece of land to the north of the Azov Sea from Russian statesman Sergei Kochubey (son of Viktor Kochubey).

He formed the 'New Russia Company Ltd.' to raise capital, and in the summer of 1870, at the age of 55, he moved to the Russian Empire. He sailed with eight ships, with not only all the equipment necessary to establish a metal works, but also much of the skilled labour; a group of about a hundred ironworkers and miners mostly from South Wales.

He immediately started to build metal works close to the river Kalmius, at a site near the village of Alexandrovka. The state-of-the-art works had eight blast furnaces and was capable of a full production cycle, with the first pig iron cast in 1872. During the 1870's, collieries and iron ore mines were sunk, and brickworks and other facilities were established to make the isolated works a self-sufficient industrial complex.

He further built a railway-line-producing factory. All of Hughes' facilities were held under the 'Novorussian society for coal, iron and rails production.'

The Hughes factory gave its name to the settlement which grew in its shadow, and the town of Hughesovka (Yuzovka) grew rapidly. Hughes personally provided a hospital, schools, bath

houses, tea rooms, a fire brigade and an Anglican church dedicated to the patron saints St George and St David. The land around the metal works quickly grew to become an industrial and cultural centre in the region; the population of the city founded by Hughes later exceeded 1 million.

Over the next twenty years, the works prospered and expanded, first under John Hughes and then, after his death in 1889, under the management of four of his sons. Amazingly, John Hughes was allegedly only semi-literate, it being stated he was unable to write and could only read capital letters.

Hughes died on 17 June 1889 during a business trip to St Petersburg at the Angleterre Hotel. His body was immediately repatriated to the UK for burial; his wife had predeceased him in 1880 and he was buried beside her at West Norwood Cemetery. Several of Hughes' sons were later also buried there.

By the end of the nineteenth century, Hughes' works was the largest in the Russian Empire, producing 74% of all Russian iron by 1913. A period of relative decline in the early years of the twentieth century was followed by expansion during World War I. Many of the men who accompanied John Hughes settled in Hughesovka and brought their wives and families.

Over the years, although a Russian workforce was trained by the company, skilled workers from the United Kingdom continued to be employed, and many technical, engineering and managerial positions were filled by British (and especially Welsh) emigrants. A thriving expatriate community was established, living in good quality company housing, and provided with an English school and an Anglican church. Despite the cold winters, hot summers and occasional

cholera epidemics, some families remained in Hughesovka for many years.



Donetsk Today

The Bolshevik revolution of 1917 ended the Hughes family's connection to the works. The Hughes brothers and almost all of their foreign employees returned to Britain, but a few stayed on, and their descendents still live in Donetsk today. The works were assumed by the Bolsheviks in 1919. The town of Hughesovka was renamed Stalino in 1924, and then Donetsk in 1961. The works survived and prospered, and Donetsk remains a major metallurgical industries centre.

In March 2014, a period of unrest began in modern day Donetsk, during which time a campaign actually advocated for a period that Donetsk join the United Kingdom, because of the city's connection to Hughes. Shortly afterwards, Ukraine lost control of Donetsk and it is currently known as the self-declared Donetsk People's Republic, independent of Ukraine and advocating further integration again with Russia.




Sir____, I came across this interesting item about Pilton church's connection with Joseph of Arimathea and the copper and tin trade in that area.

God Works in Mysterious Ways



Sir—, This item below, by the Reverend Jim Rea (above), was passed on to me by a friend some years ago and thought your readers would be interested in it too as I was.

At a service in Shankill Methodist Church in January last, the preacher was Dr Wesley Sterling who lectures in medicine at Queen's University. He told a story which remains embedded in my memory.

It was about a William Mackay from Montrose in Scotland, who in 1856 at the age of seventeen set off to study medicine in Edinburgh. As he was leaving home his mother, a devout Christian, gave him the gift of a beautiful Bible, inscribing both her name and his on the flyleaf, alongside a verse of scripture.

Sadly, Mackay soon got into bad company and became a compulsive drinker. One day, running

out of money, he looked at the Bible and decided to pawn it in order to buy a drink.

During his medical training he became an atheist, so strident in his beliefs that he joined a group calling itself the Infidel Club. Despite his continuing fondness for alcohol, Mackay became a well-qualified and gifted physician, obtaining a senior post in a large Edinburgh hospital.

One day Mackay was called to see a young man who had sustained critical injuries in a work accident. The young man removed from his pocket his wage packet and asked a staff member to pay his landlady for his lodgings. He then asked for "the book" causing a little confusion as to what book he meant.

Despite Dr Mackay's efforts to save his life, sadly the young man died. Moments after his death the doctor noticed "the book" under the young man's pillow. It was a Bible. Mackay opened it. There on the flyleaf was the name of his mother and the name William Patón Mackay. The Bible he had pawned had become the property of the young man who earlier had assured the doctor that he was unafraid to die because his trust was in Christ.

Mackay was so overcome with emotion he immediately rushed to his office where he surrendered his life to Christ. It was to be a life-changing experience. Sometime later he felt the call of God to the ministry, and ultimately was to become the minister of Prospect Road, Presbyterian Church in Hull. He went on to write a book of sermons along with several hymns. One I recall singing in Mission Halls around Belfast has the chorus:

**Hallelujah,Thine the glory.
Hallelujah, Amen.
Hallelujah,Thine the glory.
Revive us again!**

Wesley Sterling's sermon emphasised how the Lord often turns up unexpectedly in people's lives and moves in mysterious ways. 



The Ukraine





Speeding up the Heart and Slowing it Down

BACK IN GERMANY, HUMBOLDT, armed with the same single pieces of zinc and silver, turned his attention next to the heart. Together with his older brother

Wilhelm, and supervised by well-known physiologists, Humboldt removed the heart of a fox and prepared one of its nerve fibres so that the armatures could be applied to it without touching the heart itself. "At each contact with the metals the pulsations of the heart were clearly changed; their speed, but especially their force and their elevation were augmented," he recorded.

The brothers next experimented on frogs, lizards, and toads. If the dissected heart beat 21 times in a minute, after being galvanized it beat 38 to 42 times in a minute. If the heart had stopped beating for five minutes, it restarted immediately upon contact with the two metals.

Together with a friend in Leipzig, Humboldt stimulated the heart of a carp that had almost stopped beating, pulsing only once every four minutes.

After massaging the heart proved to have no effect, galvanization restored the rate to 35 beats per minute. The two friends kept the heart beating for almost a quarter of an hour by

repeated stimulation with a single pair of dissimilar metals.

On another occasion, Humboldt even managed to revive a dying linnet that was lying feet up, eyes closed on its back, unresponsive to the prick of a pin, “I hastened to place a small plate of zinc in its beak and a small piece of silver in its rectum,” he wrote, “and I immediately established a communication between the two metals with an iron rod.

What was my astonishment, when at the moment of contact the bird opened its eyes, raised itself on its feet and beat its wings. It breathed again for six or eight minutes and then calmly died.”⁵ Nobody proved that a one-volt battery could restart a human heart, but scores of observers before Humboldt had reported that electricity increased the human pulse rate—knowledge that is not possessed by doctors today.

German physicians Christian Gottlieb Kratzenstein and Carl Abraham Gerhard, German physicist Celestin Steiglehner, Swiss physicist Jean Jallabert, French physicians François Boissier de Sauvages de la Croix, Pierre Mauduyt de la Varenne, and Jean-Baptiste Bonnefoy, French physicist Joseph Sigaud de la Fond, and Italian physicians Eusebio Sguario and Giovan Giuseppe Veratti were just a few of the observers who reported that the electric bath increased the pulse rate by anywhere from five to thirty beats per minute, when positive electricity was used. Negative electricity had the opposite effect.

In 1785, Dutch pharmacist Willem van Barneveld conducted 169 trials on 43 of his patients—men, women, and children aged nine to sixty—finding an average five percent increase in the pulse rate when the person was bathed with positive electricity, and a three percent decrease in the pulse rate when the person was bathed with negative electricity. When positive sparks were drawn the pulse increased by twenty percent.


But these were only averages: no two individuals reacted the same to electricity. One person’s pulse always increased from sixty to ninety beats per minute; another’s always doubled; another’s pulse became much slower; another reacted not at all. Some of van Barneveld’s subjects reacted in a manner opposite

to the majority: a negative charge always accelerated their pulse, while a positive charge slowed it down.

“Istupidimento”

Observations of these kinds came quickly and abundantly, so that by the end of the eighteenth century a basic body of knowledge had been built up about the effects of the electric fluid—usually the positive variety—on the human body.

It increased both the pulse rate, as we have seen, and the strength of the pulse. It augmented all of the secretions of the body. Electricity caused salivation, and made tears to flow, and sweat to run. It caused the secretion of ear wax, and nasal mucus. It made gastric juice flow, stimulating the appetite.


It made milk to be let down, and menstrual blood to issue. It made people urinate copiously and move their bowels.

Most of these actions were useful in electrotherapy, and would continue to be so until the early twentieth century. Other effects were purely unwanted.

Electrification almost always caused dizziness, and sometimes a sort of mental confusion, or “istupidimento,” as the Italians called it. It commonly produced headaches, nausea, weakness, fatigue, and heart palpitations. Sometimes it caused shortness of breath, coughing, or asthma-like wheezing. It often caused muscle and joint pains, and sometimes mental depression. Although electricity usually caused the bowels to move, often with diarrhoea, repeated electrification could result in constipation.

Electricity caused both drowsiness and insomnia. Humboldt, in experiments on himself, found that electricity increased blood flow from wounds, and caused serum to flow copiously out of blisters.

Gerhard divided one pound of freshly drawn blood into two equal parts, placed them next to each other, and electrified one of them. The electrified blood took longer to clot. Antoine Thillaye-Platel, pharmacist at the Hôtel-Dieu, the famous hospital in Paris, agreeing, said that electricity is contraindicated in cases of haemorrhage. Consistent with this are numerous reports of nosebleeds from electrification. Winkler and his wife, as already mentioned, got nosebleeds from the shock of a Leyden jar.

In the 1790’s, Scottish physician and anatomist Alexander Monro, who is remembered for discovering the function of the lymphatic system, got nosebleeds from just a one-volt battery, whenever he tried to elicit the sensation

of light in his eyes. “Dr. Monro was so excitable by galvanism that he bled from the nose when, having the zinc very gently inserted in his nasal fossae, he put it in contact with an armature applied to his tongue.

The haemorrhage always took place at the moment when the lights appeared.” This was reported by Humboldt. In the early 1800’s, Conrad Quensel, in Stockholm, reported that galvanism “frequently” caused nosebleeds.

Abbé Nollet proved that at least one of these effects—perspiration—occurred merely from being in an electric field. Actual contact with the friction machine wasn’t even necessary. He had electrified cats, pigeons, several kinds of song-birds, and finally human beings. In carefully controlled repeatable experiments, accompanied by modern-looking data tables, he had demonstrated measurable weight loss in all of his electrified subjects, due to an increase in evaporation from their skin. He had even electrified five hundred houseflies in a gauze-covered jar for four hours and found that they too had lost extra weight—4 grains more than their non-electrified counterparts in the same amount of time.

Then Nollet had the idea to place his subjects on the floor underneath the electrified metal cage instead of in it, and they still lost as much, and even a bit more weight than when they were electrified themselves. Nollet had also observed an acceleration in the growth of seedlings sprouted in electrified pots; this too occurred when the pots were only placed on the floor beneath. “Finally,” wrote Nollet, “I made a person sit for five hours on a table near the electrified metal cage.” The young woman lost 4½ drams more weight than when she had actually been electrified herself.

Nollet was thus the first person, back in 1753, to report significant biological effects from exposure to a DC electric field—the kind of field that according to mainstream science today has no effect whatsoever. His experiment was later replicated, using a bird, by Steiglehner, professor of physics at the University of Ingolstadt, Bavaria, with similar results.

Table 1 lists the effects on humans, reported by most early electricians, of an electric charge or small currents of DC electricity. Electrically

**Why Daylight Saving Time is Unhealthy:
A Neurologist Explains
By Beth Malow**



AS PEOPLE IN THE U.S. PREPARE TO TURN THEIR CLOCKS AHEAD ONE HOUR IN MID-MARCH, I find myself bracing for the annual ritual of media stories about the disruptions to daily routines caused by switching from standard time to daylight saving time.

About a third of Americans say they don't look forward to these twice-yearly time changes. An overwhelming 63% to 16% majority would like to eliminate them completely. But the effects go beyond simple inconvenience. Researchers are

discovering that "springing ahead" each March is connected with serious negative health effects.

I'm a professor of neurology and paediatrics at Vanderbilt University Medical Center in Nashville, Tennessee, and the director of our sleep division. In a 2020 commentary for the journal JAMA Neurology, my co-authors and I reviewed the evidence linking the annual transition to daylight saving time to increased strokes, heart attacks and teen sleep deprivation.

Based on an extensive body of research, my colleagues and I believe that the science establishing these links is strong and that the evidence makes a good case for adopting permanent standard time nationwide—as I testified at a recent Congressional hearing.

Missing Sleep - Worse Health

"Falling back"—going from daylight saving time to standard time each November by turning the clocks back one hour—is relatively benign. While some people may feel thrown off balance

and need a few weeks to recover, research hasn't linked it to serious impacts on health.

Springing forward is harder on the body, however. This is because our clock time is moved an hour later; in other words, it feels like 7 a.m. even though our clocks say it is 8 a.m. So it's a permanent shift to later morning light for almost eight months—not just for the day of the change or a few weeks afterward.

This is particularly notable because morning light is valuable for helping to set the body's natural rhythms: It wakes us up and improves alertness.

Although the exact reasons are not yet known, this may be due to light's effects on increasing levels of cortisol, a hormone that modulates the stress response or the effect of light on the amygdala, a part of the brain involved in emotions.

In contrast, exposure to light later into the evening delays the brain's release of melatonin, the hormone that promotes drowsiness. This can interfere with sleep and cause us to sleep less overall, and the effect can last even after most people adjust to losing an hour of sleep at the start of daylight saving time.

Because puberty also causes melatonin to be released later at night, meaning that teenagers have a delay in the natural signal that helps them fall asleep, adolescents are particularly susceptible to sleep problems from the extended evening light of daylight saving time. This shift in melatonin during puberty lasts into our 20's.

Adolescents also may be chronically sleep deprived due to school, sports and social activity schedules. For instance, many children start school around 8 a.m. or earlier. This means that during daylight saving time, many young people get up and travel to school in pitch darkness.

This video takes a deeper dive – all the way back to 1895 – into the history of daylight saving time.

The Western Edge' Effect

Geography can also make a difference in how daylight saving time affects people. One study showed that people living on the western edge of a time zone, who get light later in the morning

and light later in the evening, got less sleep than their counterparts on the eastern edge of a time zone.



This study found that western edge residents had higher rates of obesity, diabetes, heart disease and breast cancer, as well as lower per capita income and higher health care costs. Other research has found that rates of certain other cancers are higher on the western edge of a time zone.

Scientists believe that these health problems may result from a combination of chronic sleep deprivation and "circadian misalignment". Circadian misalignment refers to a mismatch in timing between our biological rhythms and the outside world. In other words, the timing of daily work, school or sleep routines is based on the clock, rather than on the sun's rise and set.

A Brief History of Daylight Saving Time

Congress instituted daylight saving time during World War I and again during World War II, and once again during the energy crisis of the early 1970's. The idea was that having extra light later into the afternoon would save energy by decreasing the need for electric lighting.

This idea has since been proved largely inaccurate, as heating needs may increase in the morning in the winter, while air conditioning needs can also increase in the late afternoon in the summer.

Another pro-daylight saving argument has been that crime rates drop with more light at the end of the day. While this has been proved true, the change is very small, and the health effects appear to outweigh the lower rates of crime.

After World War II, it was left to state governments to set the start and end dates for daylight saving time. Because this created many

railroad scheduling and safety problems, however, Congress passed the Uniform Time Act in 1966. This law set the nationwide dates of daylight saving time from the last Sunday in April until the last Sunday in October.

In 2007, Congress amended the Uniform Time Act to expand daylight saving time from the second Sunday in March to the first Sunday in November, dates that remain in effect today.

The law allows states and territories to opt out of daylight saving time, however. Arizona and Hawaii are on permanent standard time, along with Puerto Rico, the U.S. Virgin Islands, Northern Mariana Islands, Guam and American Samoa. Now, many other states are considering whether to stop falling back and springing ahead.

The question then becomes: Should they pick permanent daylight saving time or permanent standard time?

The Strong Case for Permanent Standard Time

Americans are split on whether they prefer permanent daylight saving time or permanent standard time. However, my colleagues and I believe that the health-related science for establishing permanent standard time is strong.

Standard time most closely approximates natural light, with the sun directly overhead at or near noon. In contrast, during daylight saving time from March until November, the natural light is shifted unnaturally by one hour later.

Based on abundant evidence that daylight saving time is unnatural and unhealthy, I believe we should abolish daylight saving time and adopt permanent standard time.

Abraham Lincoln and the Rothschilds By Father Charles Coughlin



THE CIVIL WAR WAS NOT FOUGHT OVER SLAVERY, But Financial Freedom (This article was originally published in the Feb. 12 and Feb. 19th issues of Social Justice)

TEXTBOOKS that have been carefully edited continue to teach American school children that the American Civil War was fought over the Slavery issue; that is, that the South did not wish to free the Negro-slaves. But if we look behind

The Missouri Com-promise was written in 1820. Thirty years later, a subsequent compromise of 1850 was effected. For thirty years America had worked out her problems — the problem of slavery and later the problem of State Rights — satisfactorily. Even as late as the Kansas-Nebraska Act, the give-and take of compromise was effective. Yet in the year of 1857 the war was decided upon, not in the prospering South, not in the prospering North, but in London, England.

Division of U.S. Plotted in London

In the year 1857, the money power of old Europe centred in the House of Rothschild. Disraeli represented them in England; Napoleon III in France; Bismarck in Germany and Mazzini in Italy. According to Mr. John Reeves, who wrote

on page 228, of an authorized biography entitled: "The Rothschilds, The Financial Rulers of Nations," based on research in their own archives, there was a famous meeting in the City of London in 1857.

The great Rothschild family was assembled from the countries of Europe for the marriage of Lionel Rothschild's daughter, Leonora, to her cousin, Alphonse, son of James Rothschild of Paris. Disraeli is reported to have said: "Under this roof are the heads of the family of Rothschild — a name famous in every capital of Europe and every division of the globe. If you like, we shall divide the United States into two parts, one for you, James, and one for you, Lionel. Napoleon will do exactly and all that I shall advise him."

Thus, in London, we see a plan fostered by the money power of Europe, moving in on America, and pitting the North against the South under the old principle of "divide and conquer." The North was to become a British colony annexed to Canada, while the South would go to Napoleon III of France!

"Napoleon's object was to assure the predomination of the French over the Latin races and to augment the influence of these races in America. Napoleon decided to recognize the independence of the rebellious American States and repeatedly urged the British government to join him in so doing," according to Mackenzie in his historical research entitled "The Nineteenth Century."

Judah P. Benjamin was chosen by the Rothschilds to do their work in the United States and he was the first adviser to Jefferson Davis, the President of the Southern Confederacy. Benjamin has been called "the brains of the revolt." He was also the Secretary of State of the Confederacy under Jeff Davis.

The Confederacy consisted of eleven Southern States bound by a written Constitution, modelled in part after our own Constitution.

It was founded on the fundamental principle that each one of its eleven constituted States had the right to secede from the Union, or to separate from the other 23 out of the 34 states of the Union. Nevertheless, at the instigation of Benjamin, and under pressure of Napoleon, Texas and Louisiana were placed on the bargain counter in exchange, presumably, for Napoleon's aid. The latter was supported by Disraeli of England, who had assured the Confederacy of the support of Britain behind the nine remaining States, after Texas and Louisiana were to be ceded to France.

Intervention of Czar Saved The United States

English, French and Spanish troops had landed at Vera Cruz in 1862. Since June 5, 1863, the French General, Bazaine, (who was Jewish) had occupied the capital of Mexico. The danger was great. The genius of President Lincoln was taxed. He knew the North, alone, could not have withstood such a combination.

Moreover, Archduke Maximilian had been induced to accept the throne of Mexico. But fate stepped in.

The Christian Czar of Russia, Alexander II, through his ambassadors at Paris and London, knew of the plan, knew of England's recognition of the Confederacy, knew the Rothschild plot behind the whole manoeuvre.

The Czar dispatched a fleet to San Francisco under the command of Admiral S. Lesowsky, on September 8, 1863, and a squadron to New York under Admiral A. A. Popoff. Both Admirals had orders from the Czar "to be ready to fight any power and to take their orders only from Abraham Lincoln." Needless to say, this generous and vigorous action saved the United States from foreign intrigue. James Rothschild

Booth S Code Found in Benjamin Trunk

The good Czar, after several unsuccessful attempts on his life, was murdered in 1881. Lincoln was murdered in 1865, on April 4th, by an actor, John Wilkes Booth, in whose trunk was found coded messages the key to which was found in Judah F. Benjamin's possession. Benjamin escaped to England where he later died.



The good Czar, Alexander II, (above) had been responsible on September 19, 1861, by imperial decree, for emancipating the Russian serfs, in number over 47 million. Serfdom was ended by the stroke of a pen. But in the United States, it took billions of dollars and oceans of blood to free three million, not serfs, but slaves — because of an infamous plot of English and European money lords. Bismarck knew the truth and revealed it in 1876 to a German, Conrad Siem, who published it in "*La Vieille France*," (No. 216, March, 1921), forty-five years later.

Bismarck Told Story in 1876

Bismarck wrote: "The division of the United States into two federations of (equal force was decided long before the Civil War by the High

Financial Power of Europe. These bankers were afraid of the United States, if they remained in one block and as one nation, would attain economical and financial independence, which would upset their financial domination over the world.

The voice of the Rothschilds predominated. The opium addictions created by Rothschild opium sales to China harmed China so much that China went to war on two occasions to stop it. These wars were known as the Boxer Rebellions or the Opium Wars.
