#### Proxy War in Ukraine Hotting Up



Chapter One: A House Divided I Kings 11:26-42.

26 AND JEROBOAM THE SON OF NEBAT, AN EPHRATHITE OF

**ZEREDA, SOLOMON'S SERVANT,** whose mother's name was Zeruah, a widow woman, even he lifted up his hand against the king.

- 27 And this was the cause that he lifted up his hand against the king: Solomon built Millo, and repaired the breaches of the city of David his father.
- 28 And the man Jeroboam was a mighty man of valour: and Solomon seeing the young man that he was industrious, he made him ruler over all the charge of the house of Joseph.
- 29 And it came to pass at that time when Jeroboam went out of Jerusalem, that the prophet Ahijah the Shilonite found him in the way; and he had clad himself with a new garment; and they two were alone in the field:
- **30** And Ahijah caught the new garment that was on him, and rent it in twelve pieces:
- **31** And he said to Jeroboam, Take thee ten pieces: for thus saith the LORD, the God of Israel, Behold, I will rend the kingdom out of the hand of Solomon, and will give ten tribes to thee:
- **32** (But he shall have one tribe for my servant David's sake, and for Jerusalem's sake, the city which I have chosen out of all the tribes of Israel):
- 33 Because that they have forsaken me, and have worshipped Ashtoreth the goddess of the Zidonians, Chemosh the god of the Moabites, and Milcom the god of the children of Ammon,

and have not walked in my ways, to do that which is right in mine eyes, and to keep my statutes and my judgments, as did David his father.

- 34 Howbeit I will not take the whole kingdom out of his hand: but I will make him prince all the days of his life for David my servant's sake, whom I chose, because he kept my commandments and my statutes:
- **35** But I will take the kingdom out of his son's hand, and will give it unto thee, even ten tribes.
- **36** And unto his son will I give one tribe, that David my servant may have a light alway before me in Jerusalem, the city which I have chosen me to put my name there.
- **39** And I will for this afflict the seed of David, but not for ever.
- **40** Solomon sought therefore to kill Jeroboam. And Jeroboam arose, and fled into Egypt, unto Shishak king of Egypt, and was in Egypt until the death of Solomon.
- **41** And the rest of the acts of Solomon, and all that he did, and his wisdom, are they not written in the book of the acts of Solomon?
- **42** And the time that Solomon reigned in Jerusalem over all Israel was forty years.

The controversy between Solomon and Jeroboam of Ephraim precipitated the division of All Israel into Two Houses. (The Biblical expression, "All Israel," always refers to all Twelve Tribes taken as a single nation.) Yahweh caused the prophet Ahijah to show Jeroboam what would happen. Verses 30- 32 explain the division along tribal lines.

**Verse 35** tells us that this eventuality is Yahweh's doing. All of these shortly came to pass, after the prophecy was given.

Solomon. Representatives of All Israel (all 12 tribes) assembled in Jerusalem to make him important distinctions between these two King. But Rehoboam refused to accept the elders and advisors that he had inherited from Solomon. Instead, he chose a bunch of "Whiz Kids," who made new regulations, contrary to God's Law.

In order to implement his new policies, he laid a heavy burden of taxation upon All Israel. But these taxes did not benefit the Ten Tribes in the north. They only benefited Rehoboam, his administration and palace.

When Rehoboam sent a tax collector, Adoram, into the north country, they stoned him to death. Just like people today, the ancient Israelites did not like tax collectors! The rebellion, very similar to America's Civil War, had begun; but in this case, the North seceded from the South. When Jeroboam, the Ephraimite, learned that Solomon had died, he returned from Egypt to fulfill Ahijah's prophecy.

#### II Kings 12:20-21.

**20** And it came to pass, when all Israel heard that Jeroboam was come again, that they sent and called him unto the congregation, and made him king over all Israel: there was none that followed the house of David, but the tribe of Judah only.

**21** And when Rehoboam was come to Jerusalem. he assembled all the house of Judah, with the tribe of Benjamin, an hundred and fourscore thousand chosen men, which were warriors, to fight against the house of Israel, to bring the kingdom again to Rehoboam the son of Solomon.

These two verses declare the historical breach. They contain the first mention of two different Houses, the House of Judah and the House of Israel. The House of Judah is defined as the two southern Tribes of Judah and Benjamin. The House of Israel is defined as the Ten Northern Tribes of Israel.

They have separate histories and separate destinies, but they will eventually be joined back together into one House.

In verse 24, Yahweh declares that this division of Israel into Two Houses is His Will: "For this thing is from me." So, we had better pay attention.

I Kings 12 tells the story of Rehoboam, son of Neither the Jewish rabbis nor the Judeo-Christian priesthood teach about the very Houses. Since they are either ignorant of this subject matter or give it short shrift, their usage of such words as 'Israel,' 'Judah,' 'Jew,' and 'Gentile' is extremely deficient.

> These deficiencies have given rise to mountains of doctrinal error. Unravelling this mountain of error is an absolute prerequisite to knowing the Truth, for you cannot tell the good guys from the bad guys, unless you understand the language of the Bible.

For example, the Jews use the word 'Gentile' to mean "non-Jew." But the Latin word 'gentilis' means "kinsman," which is the exact opposite of the sense in which the Jews use it. But, since the Jewish people aren't Israelites, it doesn't matter how they use the word. What matters is how the Hebrew prophets and the Israelite writers of the New Testament used the words goy and ethnos.

These are the words which have been erroneously translated into the word "Gentiles," which has no proper place in Scripture. It should never have been used to translate these words, for it causes much confusion. Throw that word out and never use it again. None of the Bible writers used it.

We must reject the language of the false priests and recognize the proper categories of people, as they are presented to us in the Holy Scriptures. Anything short of this leads to nothing but error and confusion. The reason the Christian world is today completely baffled by the history and prophecies of Scripture is because they have not paid attention to these clear categories of people.

Chapters 13 and 14 of I Kings give us more history of those days, culminating with this statement: "And there was war between Rehoboam and Jeroboam in all their days." (Verse 30.)

Not to be overlooked is the fact that there is also a third House declared by Yahweh. That is the House of David; and that House is the Davidic King line, which Yahweh has declared to reign in Israel as long as there exists a planet called Earth.

"I have made a covenant with my chosen, I have sworn unto David my servant, thy seed will I establish forever, and build throne to all generations." - **Psalm 89:3-4.** 

"My mercy will I keep for him [David] forevermore, and my covenant shall stand fast with him. His seed also will I make to endure for ever, and his throne as the days of heaven." - Psalm 89:28-29.

"My covenant will I not break, nor alter the thing that is gone out of my lips. Once have I sworn by my holiness that I will not lie unto David. His seed shall endure for ever, and his throne as the sun before me." – **Psalm 89:34-36.** 

Has the sun disappeared? Children of Israel, these prophecies cannot be spiritualised. They clearly teach that the "seed," or offspring, descendants of Israel – All Twelve Tribes - will exist forever and the Davidic Throne will also last forever. The Book of Revelation tells us

Chapters 13 and 14 of I Kings give us more that, when the Kingdom comes, the Bride of history of those days, culminating with this Christ will consist of All Twelve Tribes:

"And there came unto me one of the seven angels which had the seven vials full of the seven last plagues and talked with me, saying, Come hither, I will show thee the Bride, the Lamb's Wife. And he carried me away in the spirit to a great and high mountain, and showed me that great city, the Holy Jerusalem, descending out of heaven from God, having the glory of God, and her light was like unto a stone most precious, even like a jasper stone, clear as a crystal;

And had a wall great and high, and had twelve gates, and at the gates twelve angels and the names written thereon, Which Are the Names of the Twelve Tribes of the Children of Israel." - Rev. 21: 9-12.

Since the "Holy Jerusalem" comes down from heaven, it cannot be the literal city of Jerusalem in Palestine. Rather, it comes down from heaven to rest upon "the twelve tribes of the children of Israel" and upon planet earth, in order to renew it.

If we assume that the Jewish people are the Tribe of Judah, which is what many people teach, then where are the other 11 Tribes? Neither Judaism nor Judeo-Christianity can explain these verses, so they must pretend that the Bible doesn't mean what it says. I will show you that the Bible means exactly what it says.

[Note - In the Hebrew, Chapter 7 has 29 verses, not 25, as in the K.J.V. and others. This work will use the Hebrew format of Verse numbering, so it will not match up at the end with some other versions, nor will Chapter 8 that follows.]

29. and the frogs shall come up both on you, and upon your people, and upon all your servants."

#### **Chapter 7 Notes**

Verse 1 - has "elohiym" describing Mosheh's relationship with Par'oh. This does not put Mosheh in a status like a pagan "god", but means Yahweh will speak to Mosheh, Mosheh will relay the words to Aharon, and Aharon will speak like a prophet to Par'oh. This is to teach Par'oh the lesson that whatever Mosheh said, it had come directly from Yahweh, and he better listen. This is an example of the style of writing then. It makes Mosheh a "person of importance", as the word elohiym has multiple meanings, not just divine being. A judge was an elohiym, as used in Ruth, and has been mistranslated "God". Metaphorical usage is common in the Old Testament, and the literal reading all the time leads to error. Literal reading applies only part of the time, and extensive study of the original language, and idioms of the times is needed.

**Verse 9** - 8577 tanniym can figuratively mean "crocodile", as living on land, and also water, and can mean serpent, dragon, sea-monster as well. The crocodile was the symbol of Par'oh, Study Dictionary, Old Testament, Page 1237.

Verses 11,12 - Rod of Yahweh, not Mosheh or Aharon, therefore it could swallow up the rods of the "magicians", who were using powers of fallen angels, which were not equal to the power of the Supreme Deity, Yahweh. It was just a stick until Yahweh made it something else. Neither Mosheh nor Aharon had the power to change the stick. Refer to the Book of Jasher 79:36. Originally the rod had become a serpent, at the burning bush, and Yahweh had said "I will become whatever I please." The rod also became what Yahweh wanted as well.

Verses 13,14 - "Hardened" is incorrect, strengthened is the correct term. The term "hardened" has been used generically in the K.J.V. and others, and I will use the correct term depending on the Hebrew word used.

Verse 15 -Ex. 4:3;

Verse 17 - Revelation 16:4;

Verse 18 - "Loathe" is incorrect, "become weary" is correct. The Egyptians had to wear themselves out trying to find a drink of water.

Verse 20 - Yashar (Jasher) 80:3

# The Crusades (Part 2) By Willie Martin



RBAN II (ABOVE) GAVE THE CRUSADERS TWO GOALS, both of which would remain central to the eastern Crusades for centuries. The first was to rescue the Christians of the East. As his successor, Pope Innocent III, later wrote:-

How does a man love according to divine precept his neighbour as himself when, knowing that his Christian brothers in faith and in name are held by the perfidious Muslims in strict confinement and weighed down by the yoke of heaviest servitude, he does not devote himself to the task of freeing them?...Is it by chance that you do not know that many thousands of Christians are bound in slavery and imprisoned by the Muslims, tortured with innumerable torments?

"Crusading," Professor Jonathan Riley-Smith has rightly argued, was understood as an "an act of love;" in this case, the love of one's neighbour. The Crusade was seen as an errand of mercy to right a terrible wrong. As Pope Innocent III wrote to the Knights Templar, "You carry out in deeds the words of the Gospel, 'Greater love than this hath no man, that he lay down his life for his friends.'"

The second goal was the liberation of Jerusalem and the other places made holy by the life of Christ. The word crusade is modern. Medieval Crusaders saw themselves as pilgrims, performing acts of righteousness on their way to the Holy Sepulchre. The Crusade indulgence

they received was canonically related to the pilgrimage indulgence. This goal was frequently described in feudal terms. When calling the Fifth Crusade in 1215, Innocent III wrote:

Consider most dear sons, consider carefully that if any temporal king was thrown out of his domain and perhaps captured, would he not, when he was restored to his pristine liberty and the time had come for dispensing justice look on his vassals as unfaithful and traitors—unless they had committed not only their property but also their persons to the task of freeing him?

—And similarly will not Jesus Christ, the king of kings and lord of lords, whose servant you cannot deny being, who joined your soul to your body, who redeemed you with the Precious Blood—condemn you for the vice of ingratitude and the crime of infidelity if you neglect to help Him?

The re-conquest of Jerusalem, therefore, was not colonialism but an act of restoration and an open declaration of one's love of God. Medieval men knew, of course, that God had the power to restore Jerusalem Himself; indeed, He had the power to restore the whole world to His rule. Yet as St. Bernard of Clairvaux preached, His refusal to do so was a blessing to His people:

Again I say, consider the Almighty's goodness and pay heed to His plans of mercy. He puts Himself under obligation to you, or rather feigns to do so, that He can help you to satisfy your obligations toward Himself—I call blessed the generation that can seize an opportunity of such rich indulgence as this.

It is often assumed that the central goal of the Crusades was forced conversion of the Muslim world. Nothing could be further from the truth. From the perspective of medieval Christians, Muslims were the enemies of Christ and His Church.

It was the Crusaders' task to defeat and defend against them. That was all. Muslims who lived in Crusader-won territories were generally and always their religion.



Indeed, throughout the history of the Crusader Kingdom of Jerusalem, Muslim inhabitants far outnumbered the Catholics. It was not until the 13th century that the Franciscans began conversion efforts among Muslims. But these were mostly unsuccessful and finally abandoned. In any case, such efforts were by peaceful persuasion, not the threat of violence.

The Crusades were wars, so it would be a mistake to characterize them as nothing but piety and good intentions. Like all warfare, the violence was brutal (although not as brutal as modern wars). There were mishaps, blunders, and crimes. These are usually well- remembered today. During the early days of the First Crusade in 1095, a ragtag band of Crusaders led by Count Emicho of Leiningen made its way down the Rhine, robbing and murdering all the Jews they could find.

Without success, the local bishops attempted to stop the carnage. In the eyes of these warriors, the Jews, like the Muslims, were the enemies of Christ. Plundering and killing them, then, was no vice. Indeed, they believed it was a righteous deed, since the Jews' money could be used to fund the Crusade to Jerusalem. But they were wrong, and the Church strongly condemned the anti-Jewish attacks. Fifty years later, when the Second Crusade was gearing up, St. Bernard frequently preached that the Jews were not to be persecuted:

Ask anyone who knows the Sacred Scriptures what he finds foretold of the Jews in the Psalm. "Not for their destruction do I pray," it says. The Jews are for us the living words of Scripture, for they remind us always of what our Lord suffered--Under Christian princes they endure a hard captivity, but "they only wait for the time of their deliverance."

allowed to retain their property and livelihood, Nevertheless, a fellow Cistercian monk named Radulf stirred up people against the Rhineland Jews, despite numerous letters from Bernard demanding that he stop. At last Bernard was forced to travel to Germany himself, where he caught up with Radulf, sent him back to his convent, and ended the massacres.

> It is often said that the roots of the Holocaust can be seen in these medieval pogroms. That may be. But if so, those roots are far deeper and more widespread than the Crusades. Jews perished during the Crusades, but the purpose of the Crusades was not to kill Jews. Quite the contrary: Popes, bishops, and preachers made it clear that the Jews of Europe were to be left unmolested. In a modern war, we call tragic deaths like these damage." Even "collateral with technologies, the United States has killed far more innocents in our wars than the Crusaders ever could. But no one would seriously argue that the purpose of American wars is to kill women and children.

> By any reckoning, the First Crusade was a long shot. There was no leader, no chain of command, no supply lines, no detailed strategy. It was simply thousands of warriors marching deep into enemy territory, committed to a common cause.

> Many of them died, either in battle or through disease or starvation. It was a rough campaign, one that seemed always on the brink of disaster. Yet it was miraculously successful. By 1098, the Crusaders had restored Nicaea and Antioch to Christian rule. In July 1099, they conquered Jerusalem and began to build a Christian state in Palestine. The joy in Europe was unbridled. It seemed that the tide of history, which had lifted the Muslims to such heights, was now turning.

> But it was not. When we think about the Middle Ages, it is easy to view Europe in light of what it became rather than what it was. The colossus of the medieval world was Islam, not Christendom. The Crusades are interesting largely because they were an attempt to counter that trend. But in five centuries of crusading, it was only the First Crusade that significantly rolled back the military progress of Islam. It was downhill from there.

> When the Crusader County of Edessa fell to the Turks and Kurds in 1144, there was an enormous groundswell of support for a new Crusade in Europe. It was led by two kings, Louis VII of

France and Conrad III of Germany, and preached therefore, fell into Richard's lap. A skilled by St. Bernard himself. warrior, gifted leader, and superb tactician,

It failed miserably. Most of the Crusaders were killed along the way. Those who made it to Jerusalem only made things worse by attacking Muslim Damascus, which formerly had been a strong ally of the Christians. In the wake of such a disaster, Christians across Europe were forced to accept not only the continued growth of Muslim power but the certainty that God was punishing the West for its sins.

Lay piety movements sprouted up throughout Europe, all rooted in the desire to purify Christian society so that it might be worthy of victory in the East.

Crusading in the late twelfth century, therefore, became a total war effort. Every person, no matter how weak or poor, was called to help. Warriors were asked to sacrifice their wealth and, if need be, their lives for the defence of the Christian East. On the home front, all Christians were called to support the Crusades through prayer, fasting, and alms.

Yet still the Muslims grew in strength. Saladin, the great unifier, had forged the Muslim Near East into a single entity, all the while preaching jihad against the Christians. In 1187 at the Battle of Hattin, his forces wiped out the combined armies of the Christian Kingdom of Jerusalem and captured the precious relic of the True Cross.

Defenceless, the Christian cities began surrendering one by one, culminating in the surrender of Jerusalem on October 2. Only a tiny handful of ports held out. The response was the Third Crusade. It was led by Emperor Frederick I Barbarossa of the German Empire, King Philip II Augustus of France, and King Richard I Lionheart of England. By any measure it was a grand affair, although not quite as grand as the Christians had hoped. The aged Frederick drowned while crossing a river on horseback, so his army returned home before reaching the Holy Land.

Philip and Richard came by boat, but their incessant bickering only added to an already divisive situation on the ground in Palestine. After recapturing Acre, the king of France went home, where he busied himself carving up Richard's French holdings. The Crusade,

therefore, fell into Richard's lap. A skilled warrior, gifted leader, and superb tactician, Richard led the Christian forces to victory after victory, eventually re-conquering the entire coast.

But Jerusalem was not on the coast, and after two abortive attempts to secure supply lines to the Holy City, Richard at last gave up. Promising to return one day, he struck a truce with Saladin that ensured peace in the region and free access to Jerusalem for unarmed pilgrims. But it was a bitter pill to swallow. The desire to restore Jerusalem to Christian rule and regain the True Cross remained intense throughout Europe.

The Crusades of the 13th century were larger, better funded, and better organized. But they too failed. The Fourth Crusade (1201-1204) ran aground when it was seduced into a web of Byzantine politics, which the Westerners never fully understood. They had made a detour to Constantinople to support an imperial claimant who promised great rewards and support for the Holy Land.

Yet once he was on the throne of the Caesars, their benefactor found that he could not pay what he had promised. Thus betrayed by their Greek friends, in 1204 the Crusaders attacked, captured, and brutally sacked Constantinople, the greatest Christian city in the world.

Pope Innocent III, who had previously excommunicated the entire Crusade, strongly denounced the Crusaders. But there was little else he could do. The tragic events of 1204 closed an iron door between Roman Catholic and Greek Orthodox, a door that even today Pope John Paul II has been unable to reopen. It is a terrible irony that the Crusades, which were a direct result of the Catholic desire to rescue the

Orthodox people, drove the two further; and perhaps irrevocably, apart.

The remainder of the 13th century's Crusades did little better. The Fifth Crusade (1217-1221) managed briefly to capture Damietta in Egypt, but the Muslims eventually defeated the army and reoccupied the city. St. Louis IX of France led two Crusades in his life.

The first also captured Damietta, but Louis was quickly outwitted by the Egyptians and forced to abandon the city. Although Louis was in the Holy Land for several years, spending freely on defensive works, he never achieved his fondest wish: to free Jerusalem. He was a much older man in 1270 when he led another Crusade to Tunis, where he died of a disease that ravaged the camp.

After St. Louis's death, the ruthless Muslim leaders, Baybars and Kalavun, waged a brutal jihad against the Christians in Palestine. By 1291, the Muslim forces had succeeded in killing or ejecting the last of the Crusaders, thus erasing the Crusader kingdom from the map. Despite numerous attempts and many more plans, Christian forces were never again able to gain a foothold in the region until the 19th century.

One might think that three centuries of Christian defeats would have soured Europeans on the idea of Crusade. Not at all. In one sense, they had little alternative. Muslim kingdoms were becoming more, not less, powerful in the 14th, 15th, and 16th centuries.

The Ottoman Turks conquered not only their fellow Muslims, thus further unifying Islam, but also continued to press westward, capturing Constantinople and plunging deep into Europe itself. By the 15th century, the Crusades were no longer errands of mercy for a distant people but desperate attempts of one of the last remnants of Christendom to survive.

Europeans began to ponder the real possibility that Islam would finally achieve its aim of conquering the entire Christian world. One of the great best-sellers of the time, Sebastian Brant's *The Ship of Fools*, gave voice to this sentiment in a chapter titled "Of the Decline of the Faith":

Our faith was strong in th' Orient,

It ruled in all of Asia,
In Moorish lands and Africa.
But now for us these lands are gone
'Twould even grieve the hardest stone....
Four sisters of our Church you find,
They're of the patriarchic kind:
Constantinople, Alexandria,
Jerusalem, Antiochia.
But they've been forfeited and sacked
And soon the head will be attacked.

Of course, that is not what happened. But it very nearly did. In 1480, Sultan Mehmed II captured Otranto as a beachhead for his invasion of Italy. Rome was evacuated. Yet the sultan died shortly thereafter, and his plan died with him.



In 1529, Suleiman the Magnificent (above) laid siege to Vienna. If not for a run of freak rainstorms that delayed his progress and forced him to leave behind much of his artillery, it is virtually certain that the Turks would have taken the city. Germany, then, would have been at their mercy.

Yet, even while these close shaves were taking place, something else was brewing in Europe; something unprecedented in human history. The Renaissance, born from a strange mixture of Roman values, medieval piety, and a unique respect for commerce and entrepreneurialism, had led to other movements like humanism, the Scientific Revolution, and the Age of Exploration. Even while fighting for its life, Europe was preparing to expand on a global scale.

The Protestant Reformation, which rejected the papacy and the doctrine of indulgence, made Crusades unthinkable for many Europeans, thus leaving the fighting to the Catholics. In 1571, a Holy League, which was itself a Crusade, defeated the Ottoman fleet at Lepanto. Yet military victories like that remained rare. The Muslim threat was neutralized economically. As Europe grew in wealth and power, the once awesome and sophisticated Turks began to seem backward and pathetic; no longer worth a Crusade. The "Sick Man of Europe" limped along until the 20th century, when he finally expired, leaving behind the present mess of the modern Middle East.

From the safe distance of many centuries, it is easy enough to scowl in disgust at the Crusades. Religion, after all, is nothing to fight wars over. But we should be mindful that our medieval ancestors would have been equally disgusted by

leaving the fighting to the Catholics. In 1571, a our infinitely more destructive wars fought in Holy League, which was itself a Crusade, the name of political ideologies. And yet, both defeated the Ottoman fleet at Lepanto. Yet the medieval and the modern soldier fight military victories like that remained rare. The ultimately for their own world and all that makes Muslim threat was neutralized economically. As it up.

Both are willing to suffer enormous sacrifice, provided that it is in the service of something they hold dear, something greater than themselves. Whether we admire the Crusaders or not, it is a fact that the world we know today would not exist without their efforts. The ancient faith of Christianity, with its respect for women and antipathy toward slavery, not only survived but flourished. Without the Crusades, it might well have followed Zoroastrianism, another of Islam's rivals, into extinction.

# The Fall and Rise of Abraham's House (Part 14) By Adam de Witt



#### Armageddon

RMAGEDDON, THE PLACE OF MIXED THRONGS, this cross references to Joel. Joel 3:1 begins with setting the stage of our captivity. In verse 2, God gathers all the nations (recall Matthew 25 and Revelation 16:16) into the dale of Jehoshaphat. Jehoshaphat means 'God's dooms', ie. God's judges. Dale or Valley of Jehoshaphat means, a pleasant land of God's judgement. God's judgement or doom denoting a land of God's Laws, or a land of His inheritance.

These lands, God dooms/judges in a special way, a way to put right the lawlessness of His Israelite folk. A dale is hedged about by mountains. The word implies a land area shielded, fenced off. Think of the Kalash, folk of the Dales.

Technically, we are ail folk of the dales, we can be called Kalash! The words 'garden', 'town', 'borough,'haven,' or in Dutch garde, tuin and burg, hof, all mean 'and enclosed area, a protected or shielded area. Hence the true English word for citizen is 'burgess', one who lives in a borough or 'burger' in Dutch and German, meaning also a 'freeman'.

In an enclosed area, a dale, a garden, where the mindset of God is. there is freedom: there live freemen, the burgess, the Kalash; paraphrasing 2 Corinthians 3:17 hence the Garden of Eden. We read in verse 2 of Joel 3, that God dooms/judges the Israelites by using the heathen or nations which he brings into our 'dales' or pleasant lands, then when He is done with us, He dooms/judges the heathen. God dooms us to cleanse us, not to wipe us out, but He dooms the heathen because they overstep the length of time they are allowed to keep us in servitude (remember we were sold into their hands - the law of restitution), but they enjoy the plunder over us too much.

And so in verse 12, "Let the heathen be wakened and come up to the 'pleasant lands of God's doom' (valley/dale of Jehoshaphat) for there I will sit to judge all the heathen round about. Put ye in the sickle (for the wheat company, the

Tares and the Wheat), for the harvest is ripe, (they've reached the end of their age), come get you down for the press is full (the wine press crushes the Israelite grape company, those Israelites that do not know God in any way), the vats overflow (there are plenty of them), for their wickedness is great.



Multitudes, multitudes in the valley (dale) of decision (decision here means threshing, dale of threshing means the lands of the wheat harvest. Only Saxon lands have the wheat company, ie Judeao-Christians of Israelite stock), for the day of the Lord is near..." When is it near? When it is lime for threshing. We know when it is the right time because the title 'dale of threshing' is only apt when all the nations are gathered in our lands. So let's end that verse, "is near in the valley/dale of 'threshing'/ decision."

In verse 16 we read this is good news for His folk, the children of Israel. In verse 17 we see the outcome of Matthew 25, "--- and He shall separate the Ethnos (nations)." In other words He will undo the multi-racialism / culturalism "—then shall (new) Jerusalem be holy (in a state of apartness or fully under apartheid) and there shall no strangers (züwr) pass through her any more."

The same point is made very clear in Jeremiah 50:35-37. "A sword is upon the Chaldeans saith the Lord (Chaldea was by then multi-cultural as you'll see)—and upon the inhabitants of Babylon—and upon All the Mingled People that are in the midst of her.—" The fall of old Babylon sets the pattern for that of Neo-Babylon (which has overstepped her allocated time that she can lawfully hang onto us.)

We can see from all this that the Identity teaching is the 'prophet of Elijah' that has a special message for Israelites only.

#### Chapter 14

Abraham's Seed: Now and Forever?

AN THE WORDS, "FATHERS", "ABRAHAM", "ISAAC", "JACOB", 'AND "ISRAEL" IN THE NEW **TESTAMENT BE SPIRITUALISED?** Based on the booklet of the same name by Arnold Kennedy and adapted for "The Fall and Rise of Abraham's Kin" by Adam de Witt with permission. My apologies to Arnold Kennedy should parts adapted be displeasing to him, though all care has been taken not to make changes other than to make his booklet fit snugly into the format of my writ. (Italicised text by Adam de Witt)

The popular view is that the names, Abraham, Isaac, Jacob and Israel now have spiritual meanings in their application, since the promises made to these 'fathers' arc now meant to apply to those of every race who "accept Jesus" or are "born again" in the popular but wrong language. These of every race are meant to be "The Church" as a new identity.

It is not until we make a list of all the 150 New that they can not be missed. Think through the Testament verses with the words, "Fathers", "Abraham", "Isaac", "Jacob" and "Israel" that mean as you read. we can see these are all used in the historical application. We have to ask why they are all not commonly accepted in the way the New Testament uses them.

There are only 19 verses that could even remotely be taken to having spiritual meaning only, or of extending the application beyond Israel. How could any of the 19 over-ride the 131 other verses, yet that is what the churches try to do. In the list to follow, these 19 verses are printed with a star ♦ for quick find. The answer to each of these 19 verses is answered in the book, "The Exclusiveness of Israel", (available from CIM).

It is recommended that the reader reads right through all this list, because there are a multitude of points that deny the popular universal evangelistic way in which some of these 19 verses are interpreted and applied.

For instance, when we read how that, "the promise which was made unto the fathers, God hath fulfilled the same unto us their children", where 'children' means offspring, ask yourself how this could include any but offspring of Israel, as those children.

There is a huge weight of evidence through the Bible against the popular acceptance. The whole 150 verses show that Israel, as a folk is still very exclusive (Holy) in the sight of the Lord. There is no place for mixture or of a "spiritual Israel" and a "natural" Israel co-existing.

Our unchanging God could not have changed from the time He said: "The Lord God of your fathers, the God of Abraham, the God of Isaac and the God of **Jacob** hath sent me unto you (the Children of Israel) this is my name forever..." Exodus 3:15 We can see that this carries on through the New Testament, e.g. "I am the God of Abraham, the God of Isaac and the God of **Jacob....**" Matthew 22:32

So let us look through all the New Testament verses with the words, "Fathers", "Abraham", "Isaac", "Jacob" and "Israel" therein to see if anything really is changed in the New Testament. Then make up your own mind! The

"Faith was not so much a confidence that God's promises would some day be fulfilled, as a recognition that it had been fulfilled already, and fulfilled in a way that claimed the surrender of a man's life in love and gratitude and obedience."For all the promises of God in Him and yea, and in Him Amen, unto the glory of God by us"- II Cor. 1:20.

#### Reconciliation

"What makes sin an essentially lonely thing is not the separation of the sinner from his brother men or even from his own best self: is it his It is now coming to he generally accepted that isolation from God.

This is what Paul calls 'alienation'. 'You that were sometime alienated, and enemies in your mind by wicked works, yet now hath he reconciled'. He charges his converts that they 'walk not as other Gentiles walk— alienated from the life of God'.

Other religions take it for granted that God is the one who requires to be reconciled. Ritual acts and offerings are prescribed through which the offended deity may be placated. ... Is this the conception with which Paul is working? When he speaks of reconciliation, is he thinking of a change in the attitude of God? .- 'Or is it man-not God at all-who needs to be reconciled'.

With one voice the pagan creeds declare that man must take steps to reconcile his God, and so restore himself to favour. Christianity cuts clean across this, and declares the exact opposite. God Is the Reconciler. God has taken the initiative, has broken into the atmosphere of man's hostility, and has thrown down every estranging barrier that guilt and hopelessness and dull resentment can bring-- it is God who reconciles, man who is reconciled.

"All things are of God, who hath reconciled us to Himself by Jesus Christ" - II Cor 5:18. God was in Christ, reconciling the world unto Himself"- II Cor. 5:19. "If, when we were enemies, we were reconciled to God by the death of His Son, much more, being, reconciled, we shall be saved by His life". Rom 5:1

"A God who needs to be reconciled is not the apostolic God of grace. He is certainly not the God and Father of Jesus Christ.

#### **Propitiation**

'Being justified freely by His grace, through the Redemption that is in Christ Jesus; Whom God hath set forth to be a propitiation through faith in His blood" Rom. 3:24.

"He is the propitiation for our sins; and not for ours only, but also for the sins of the whole world" – 1 John 22. "Herein in love, not that we loved God, but that He loved us, and sent His Son to be the propitiation for our sins". - I John 4:10



When Paul affirms that Christ possesses 'propitiatory powers' he is careful to remark that it is God Himself Who has 'set Christ forth' in this character ...'

#### Wrath

What Paul means by the wrath of God... is the totality of the divine reaction to sin, your outlook is not Gods but man's – Matt. 16:23 (Moffett)



### What Is Wireless Technology? Mark Playne



TECHNOLOGY ANY MEANS OF SENDING INFORMATION OR ENERGY THROUGH SPACE WITHOUT WIRES. It includes: satellites, radar, radio, television, cell towers, cell phones, cordless phones, microwave ovens smart meters, WiFi, Bluetooth, fitness trackers, smart watches, baby monitors wireless keyboards, mice, printers, headphones and speakers, wireless security systems, wireless car keys, wireless garage door openers, wireless battery chargers, remote controls, wireless microphones RFID chips in credit cards and driver's licenses, radio collars and chips in wildlife, cattle and pets, chips in home appliances wireless hearing aids, assisted listening devices, medical alert pendants, chips in medical implants, wireless pacemakers autonomous vehicles, drones, and robots numerous other radio-enabled devices that are proliferating in today's world.

Every one of these devices, without exception, emits radiation. What's wrong with wireless technology? By substituting radiation for wires, we are swimming in an ocean of artificial electromagnetic fields that are interfering with life itself.

We are in effect electrocuting ourselves, our children, our pets, the insects, birds, animals, trees and plants around us and all of living creation. We are killing our planet. This is about long-term exposure, right? Cancer that takes years to develop? No. The effects are rapid. rises in minutes. Having wireless devices on in deadly poison.

your house interferes with your sleep and your memory. Using a cell phone destroys brain cells in minutes to hours, and can cause a stroke or a heart attack. Studies show that even cancer can develop within months of first exposure.

When a cell tower is turned on, birds leave the area immediately. Insects disappear. Even slugs and snails vanish. Most of this takes no time at all. What types of radiation are used in wireless technology?

All frequencies of radio waves, microwaves, infrared radiation, visible light, lasers, sound waves, even nuclear radiation. Most home devices use microwaves. Isn't microwave radiation natural? Don't microwaves come from the sun and stars? Almost all the radiation we receive from the universe is the light and heat from the sun, not microwave radiation.

The microwave radiation a person receives from an average cell tower is millions of times stronger than all the microwave radiation from the sun and stars.

The microwave radiation a person's brain receives from their cell phone is billions of times stronger than the microwave radiation from the sun and stars.

And at any particular frequency it is trillions of times stronger than the microwave radiation he or she receives from the sun and stars at that frequency. And the faint microwaves from the sun and stars are not pulsed and modulated.

It is the pulsations and modulation that cause much of the harm. Aren't light and microwaves both electromagnetic? Therefore isn't microwave radiation safe?


No. That is like saying arsenic is safe because oxygen and arsenic are both elements, or that cyanide is safe because water and cyanide are both chemicals. But oxygen and water are necessary for life, while arsenic and cyanide are deadly poisons. It is the same with electromagnetic radiation. Visible light is Heart rate changes immediately. Blood sugar necessary for life. Microwave radiation is a

electromagnetic radiation? Electromagnetism is more complex and more fundamental than chemistry. Electromagnetism shapes the sun and stars.

#### **Electromagnetism Animates Life.**

Electromagnetism is behind chemistry. There is no "chemical force" in the universe. Outside of atomic nuclei, there is only gravity and electromagnetism. Electromagnetism guides everything we see, including ourselves. Chemistry is an effect, not a cause. Can't we find safe frequencies? Won't that solve the problem? That is looking at both wireless technology and life too simplistically.

Most wireless technology has only one goal: to transmit information to computers, information of great complexity and variety. It is not simple, constant radiation of one amplitude and one frequency: such radiation would carry no information.



Instead, it is multiple large frequency bands, each divided into hundreds, thousands, and millions of individual frequencies of all different bandwidths, overlapping and interacting, pulsed at an enormous variety of intervals, in an enormous variety of shapes, patterns and durations, all over the world.

Even a single signal from a single device has a variety of amplitudes, frequencies pulsations, and is modulated in complex ways in order to carry all the information needed to be read by cell phone or computer.

Aren't toxic chemicals more harmful than Life has to also carry an enormous, almost infinite complexity of information in its nervous systems and its meridians, and to store and process this information in its cells, organs and chakras, and in its DNA which is shared and circulated among trillions of individuals of 50 million different species, all connected to one another and to the earth, sky and universe in a grand circuit of energy and information. The artificial cloud of energy and information is interfering with, overpowering and destroying the natural, living circuitry of energy and information. It cannot be otherwise.

> What about LiFi? If light is safe, why not use light instead of microwaves? Light is a nutrient. We absorb it with our eyes, and into our blood. It is necessary for health. It regulates our biorhythms. Green plants need it photosynthesis. We absorb more of the pulsations and modulation frequencies when they are carried into our bodies by light than when they are carried into our bodies by microwaves.

> LiFi is more harmful to life than WiFi. Cell phones are much smaller than cell towers. Doesn't that mean they are safer? Doesn't it mean the radiation does not travel as far? Cell phones and cell towers emit the same radiation; size has nothing to do with it.

> The main difference is that a cell tower emits as many signals simultaneously as there are cell phones communicating with it at that time, whereas a cell phone only emits one voice channel and one data channel.

> A cell tower therefore emits stronger radiation than a cell phone, but by the time it reaches your body, its radiation is much weaker than the radiation from a cell phone that you hold in your hand, near your body. And a cell phone emits signals that a cell tower does not: Bluetooth, WiFi, GPS and other signals. The radiation from a cell phone travels just as far as the radiation from a cell tower. The radiation from a cell phone will reach all people, animals, birds, insects and plants in line of sight with it, no matter how far away. It will reach a cell tower 90 miles away.

> It will reach a satellite 22,300 miles away. It will reach Mars 200 million miles away. With 15 billion mobile devices on the Earth, we are

polluting just our homes, neighbourhoods and our planet, but the entire solar system. My cell phone does not make me phones. But safety is not determined by power sick.

Why should I stop using it? Your cell phone is damaging your health whether you are aware of it or not. It is damaging your blood-brain barrier -- the barrier that keeps bacteria, viruses and toxic chemicals out of your brain tissue; the barrier that maintains the inside of your head at a constant pressure, preventing you from having a stroke. Since brain tissue has no pain receptors, plenty of damage can occur without pain. Instead, it will cause memory loss, difficulty concentrating, anxiety, depression, sleep disorders and so forth.

In rats, damage to the blood-brain barrier can be detected after just a two-minute exposure to a cell phone. After a two-hour exposure the damage is permanent. There is no reason for it to be different in humans. The radiation from your cell phone is also slowing your metabolism -- your ability to digest sugars, fats and proteins. This causes either obesity or weight loss, depending on your genetic makeup. It also causes diabetes, heart disease and cancer.

Wireless technology is the cause of more obesity, diabetes, heart disease and cancer than any other factor. The people who are aware of the damage in real time are the people who can feel it in their nervous system or their heart. That is maybe one-third of the population. It feels to them like they are being electrocuted. And they are, but so is everyone else.



The few who have heard of such a thing call themselves "electro-sensitive." Those who have not heard of it think they are suffering from anxiety, or that they have a neurological or cardiac disorder. Isn't a flip phone safer than a smart phone? Both are digital and both emit pulsed, modulated microwave radiation.

our And despite what many people think, flip phones can emit as much radiation, or more, than smart level. Damage to the blood-brain barrier is greatest at the lowest power level, at least in laboratory rats. The bandwidth is more important than power level. Smart phones use more bandwidth than flip phones.



The bottom line is that cell phones have been killing people since they were invented. In each city in the United States where 2G "flip phone" (above) service was turned on for the first time in 1996 or 1997, mortality rose immediately, on the day it was turned on in each city. And the overall health of the population was damaged permanently. At least ten thousand Americans died from the radiation within three months after 2G "flip phone" service was turned on in various cities in 1996 and 1997.

Whether more people died from their new phones or from the new cell towers is impossible to know: the radiation comes from both. Isn't a cell phone safe to use as long as you hold it away from your head? About 20 years ago someone started promoting the idea of the "near field plume" which was supposed to extend out six inches from a cell phone, and that if you held your phone more than six inches from your head, you were safe. That is a complete fiction.

There is no such thing as a near field "plume." It does not exist. The region very near to a source of radiation, where the electric field and the magnetic field are separate and complex, is called the near field. The space very far from the source, where the electric and magnetic fields are tied together and diminish with distance, is called the far field. The near and far fields blend into one another. There is no dividing line where one stops and the other begins. And it is certainly not true that the radiation stops at six inches. If that were true, the radiation would never reach been around. And if it were true of a cell phone, it would also be true of a cell tower, which emits the same radiation. Then a cell tower would be safe if you stood more than six inches away from one. How absurd! And your body is a conductor, so if you are holding the phone in your hand, no matter how far away from your head, the microwaves are conducted into your hand and throughout your body, and your arm is an extension of the phone and is part of the radiating antenna.

If you put the phone on a table in front of you and do not hold it, then the microwaves are just irradiating you and not being conducted into you. But since for some types of harm, for example damage to the blood-brain barrier, the damage increases with distance, that does not protect you either. If the radiation levels from cell phones and cell towers were reduced, wouldn't that make them safe?

No. It is the informational content, not power level, that causes the harm. A cell phone exposes the brain to microwave radiation at roughly 10 milli-watts per square centimetre. At power levels one trillion times lower than that, microwave radiation has been shown to affect ovulation, the immune system, plant growth, human brain waves, and the structure of DNA.

Don't we need more studies before we know if microwaves are dangerous? No. We already had 10,000 studies by 1980. Today we have at least 30,000 studies. There are more studies showing harm from microwaves and radio frequency radiation than from any other pollutants except tobacco smoke and mercury.



Above Guglielmo Marconi

How long has this been going on? How long have we known that wireless technology is harmful? For as long as wireless technology has been around. At Marconi's first public demonstration of radio in Salisbury Plain in 1896, spectators described various nerve sensations they experienced. When Marconi turned on the first French radio station in Wimereux, one man who lived nearby "burst in with a revolver" because the waves were causing him sharp internal pains.

On the evening of January 22, 1901, when Marconi fired up a new, more powerful transmitter on the Isle of Wight, Queen Victoria, in residence on the island, had a stroke and died. Within a few years, 90 percent of the bees on the island had disappeared. Marconi himself suffered from recurring fevers from the time he began experimenting with radio and for the rest of his life.

He suffered nine heart attacks, the last one killing him at age 63. Even prior to Marconi, in the early 1890's, Jacques-Arsène d'Arsonva published the results of experiments on humans and animals showing that high frequencies affect blood pressure and profoundly alter metabolism.

Do telecommunications company officials know their products are harmful? Are they doing this to us deliberately? They all use cell phones like the rest of the world and are as much in denial about them as everyone else. The denial, which runs deep in society, goes back to the beginning of the development of electricity in the 1700's. I keep my phone off except in emergencies.

Doesn't that protect me and others? A cell phone mobile devices aim narrowly focused beams at leaks radiation from all of its resonant circuitry, even if it is turned off, as long as the battery is in it. So does a modem or router that has WiFi, as long as it is plugged in. I have measured radiation coming out of modems in which the WiFi was disabled. I can always tell when someone is carrying a cell phone because I can feel the radiation, even if it is turned off and hidden in their pocket, even from across a room.

I have never been wrong. For whatever reason you have a cell phone -- any kind of cell phone -- all of the world's cell towers have to be there in order for it to work when you want it to. No matter how rarely you use the phone, all the cell towers have to be there. If you use it "only in emergencies," that is even worse, because you are likely to be using it in remote places where there are no cell towers and service is not good.

Every call you make from a location where there are no towers is recorded as a request for service, and your provider will eventually put up a cell tower there in response to those calls. When I am at home I use my cell phone connected by an ethernet cord to a modem. Doesn't that protect me? It does not protect you because it is still emitting radiation. It does not protect others because when you are not at home you need all the cell towers to be there and you are irradiating everyone around you simply by carrying the phone around.

There are no landlines available where I live. I need my cell phone. Unless people get rid of their cell phones, there will soon be no land-lines left anywhere. The existence of land-lines depends on demand. The existence of cell phones depends on demand. No one is doing this to us. We are doing it to ourselves.

Is fibre the solution? Fibre enables 5G. 5G antennas are connected to each other and to the Internet by fibre optic cables. Wireless companies are spending hundreds of billions of dollars laying fibre all over the world for 5G. When a fibre company or a city lays fibre optic cables, wireless companies pay for the right to use it. After the fibre is laid, they stick antennas into it and broadcast 5G.

How is 5G different from 4G? 5G can use much higher frequencies (millimetre waves). But the These are point sources that cannot duplicate a

each other instead of sending the radiation in all directions. If you are holding a 5G phone in your hand, the nearest 5G tower is tracking you and aiming a beam of radiation directly at your body. This is called phased array technology and it results in greater penetration of the radiation into your body, even at millimetre wave frequencies, than previous wireless technologies.



5G towers also send radiation in all directions because they are constantly scanning the environment looking for devices to connect with. Is 5G a weapon? No. 5G can use millimetre waves. There are also crowd-control weapons that use millimetre waves. But the weapons are a thousand times more powerful and they are not modulated and carry no information.

They are different technologies that were developed by different people for different purposes. Are there devices that can protect us from these frequencies? There are many companies today that prey on the gullibility of people who are desperate to protect themselves from an assault that is coming from everywhere.

They sell "protective" chips to put on your cell phone or computer, pendants and bracelets that will "neutralize" or "harmonize" the radiation, devices to plug into your wall that will "protect" an area hundreds or thousands of square feet around your house.

Some advertise that they are "quantum" devices, or are based on "scalar" technology or "torsion" fields, which are sexy words that sound scientific but mean nothing. You cannot "neutralize" or "harmonize" radiation. These devices, without exception, are ineffective and most will harm you. Many of these devices emit a 7.83 Hz signal which is supposed to duplicate the first Schumann resonance of the Earth.

### Abraham Lincoln and the Rothschilds (Part 2) By **Father Charles Coughlin**



#### PART TWO

S THE CIVIL WAR ENTERED THE CRITICAL DAYS OF 1862, President Lincoln was in dire need of money to carry out the obligations of the Government in that conflict. He was offered loans by the banking interests, but in December 1861 the banks had suspended specie payments.

A bill passed Congress on February 25, 1862, whereby the Government could issue \$150 million, which would be full legal tender for every debt in the United States and was an achievement for Lincoln. However, the banking interests were furious.

In July, 1862, the Bank of England (which was, and still is, dominated by the Rothschild family) issued the notorious Hazard Circular, which was judiciously circulated among the banking interests of America. It said:

"Slavery is likely to be abolished by the war power and chattel slavery destroyed. This, I and my European friends are glad of, for slavery is but the owning of labour and carries with it the care of the labourers, while the European plan, led by England, is that capital shall control labour by controlling wages."

"This can be done by controlling the money. The great debt that capitalists will see to it is made out of the war, must be used as a means to control the volume of money. To accomplish this, the bonds must be used as a banking basis. We are now awaiting for the Secretary of the Treasury to make his recommendation to Congress. It will not do to allow the greenback, as it is called, to circulate as money any length of time, as we cannot control that."

The term "greenback" was employed by the banking interests to deceive the masses. Ridicule and derision was attached to it for the simple reason that it bore no interest or tribute to the bankers and was simply non-cancelable United States currency issued by the Government.

On two other occasions, — July, 1862, and in March, 1863 — Congress issued a total of \$300 million of United States Notes, or greenbacks, but the bankers saw to it that they carried the following restrictive clause: "This note is legal tender for all debts, public and private, except duties on imports and interest on the public debt." This reservation permitted the Rothschilds, who had a corner on the gold, to make a market for their gold. Had the "greenbacks" been permitted to retain their full legal tender value, there would have been no need for Rothschild gold with which to pay import duties. The price of gold rose to approximately \$2.85 measured in greenbacks.

All importers were obliged to go to the banking interests to buy gold to pay duties on their goods, and the Wall Street financiers held the power to fix the price.

The Civil War was still raging. Lincoln was teaching the people that bonds were unnecessary and that paper money, issued in proportion to the country's wealth, debt-free at its source of origin, was the only kind of currency that should be permitted.

However, the restrictive clauses of the two later issues of greenbacks seriously crippled the President's efforts for an honest money system, and Mr. Lincoln was forced, in the heat of the Civil War, to permit -- because he could not stop the evil machinations of the money manipulators — the "National Banking Act" of February 25, 1863, which gave private banks a national charter to issue and lend money. In brief, it permitted private corporations to coin and regulate the value of money.

But Lincoln was determined to end this situation as soon as peace could be secured. He was determined to have a Constitutional money system because he saw that financial slavery was only less subtle than chattel slavery, a little more refined, but in the end, the cruel exploitation of the American people.



Rothschild Letter Reveals Whole Scheme

On June 25, 1863, the Rothschild Brothers sent a letter to Messrs. Ikleheimer, Morton and Vandergould at No. 3 Wall Street, New York, which said the following:

"Dear Sirs: A Mr. John Sherman has written us from a town; in Ohio, U.S.A., as to the profits that may be made in the National Banking business under a recent act of your Congress, a copy of which act accompanied his letter. Apparently this act has been drawn upon the plan formulated here last summer by the British Bankers Association and by that Association recommended to our American friends as one that, if enacted into law, would prove highly profitable to the banking fraternity throughout the world.

"Mr. Sherman declares that there has never before been such an opportunity for capitalists to accumulate money, as that presented by this act and that the old plan of State Banks is so unpopular, that the new scheme will, by contrast, be most favourably regarded, notwithstanding the fact that it gives the National Banks an almost absolute control of the national finance.

The few who can understand the system, he (Sherman) says, 'will either be so interested in its profits, or so dependent on its favours, that there will be no opposition from that class, while on the other hand, the great body of people mentally incapable of comprehending the tremendous advantages that capital derives from the system, will bear its burdens without complaint and perhaps without even suspecting that the system is inimical to their interests.'... Awaiting your reply, we are."

Here we have an admission that the national banks are to have almost absolute control of the country's finance; that the richer class will not question this method of having private banking corporations issue money, while the poor "incapable of comprehending the tremendous advantages —will bear its burdens (they admit that somebody must carry and pay the burden of debt) without complaint" or even suspicion that they are being fleeced —by an unjust money system.

But the greenbacks- were still in demand. They were not legal tender for all debts, public and

bankers were buying the greenbacks on Wall Street for 35 cents on the dollar for gold, which they controlled.

When the \$450-million of greenbacks were exhausted, and the necessity arose for more money, the Rothschilds demanded that United States notes or greenbacks no longer be issued in the form of dollars, but in the form of bonds. The \$450 million "exception clause" greenbacks were converted into \$1-billion, 640-millions of bonded indebtedness. Ever since that day, the American people have been in debt through bonds and their usurious yield.

#### **Gold Bankers Reap Big Profit on Deal**

Here was the banker's point of view: He saw an original Lincoln greenback of the year 1862. He read the frightful words, "This note is legal tender for all debts public and private."

There was not a dollar [a dollar's worth of interest - Editor] to be made privately on this kind of money. The shrewd banker immediately started his two-fold campaign. One was to substitute interest-bearing bonds for these legal tender notes.

The second was to qualify the legal tender provision by exempting the legal tender properties.

Consequently, on the second and third issue of Abraham Lincoln's legal tender notes, we find the substituted language, "This note is legal tender for all debts and private except duties on imports and interest on the public debt."

Gold would now be demanded for interest on the public debt and the source of the gold would be the duties on imports which must be paid in gold. Now the banker had his crooked scheme perfected.

private, on account of the restrictive clause. The The next issue of bonds was that of \$500 million. It brought interest at the rate of 7 per cent. The bonds fell in value below 70. But let us assume that on the particular day, the banker invested a million dollars in bonds.

> The million dollars was paper money, Abraham Lincoln's greenbacks. They bought precisely one million, four hundred twenty-eight thousand, five hundred seventy-one dollars' worth of bonds.

> The bonds, we repeat, drew interest at the rate of 7 per cent or \$100,000 per year. But this one hundred thousand now was payable in gold. Yet gold in relation to greenbacks was at times 240 and even higher.

> That meant that the banker who invested the million dollars bought a million, four hundred, twenty-eight thousand, five hundred seventy-one dollars' worth of bonds, yielding one hundred I thousand in gold or \$240,000 in paper money. The interest was 24 per cent.


> It was to the advantage of the banker to depreciate the legal tender notes, to depreciate the bonds, and to make interest payable in gold.

#### **War Left America in Debt to London**



They have been shelling with artillery Donbass villages, towns, and cities for 8 years, killing thousands of civilians, and the Ukrainian forces, although twice defeated by hastily assembled forces in the Donbass, managed to gain control over large areas of the breakaway republics.

It was the deployment of a 100,000 or more Ukrainian force on the shrunken borders of Donbass for an invasion to reconquer the territory that provoked the Russian intervention. Washington's refusal to give the Kremlin a security guarantee was a second reason for the Russian military intervention.

Russia told Washington in completely clear language that Russia would not permit Ukraine to be a member of NATO. Nevertheless, Washington persisted in its provocation. Most of Russia's military intervention in Ukraine is focused on clearing Ukrainian and neo-Nazi forces out of Donbass. This is the reason for Putin's go-slow war that rules out heavy weapons use on civilian areas.

The civilians are Russians, and, as Putin said, "we went in to liberate these people, not to kill them."



The West's media whores and government officials misrepresent the Russians' intention of avoiding the death of Russian civilians as a sign of a "stalled Russian invasion," as CNN and the NPR whores proclaim. Some of the Western media whores go even further and say it is a "Russian defeat."

If there is a Russian defeat, it will happen in negotiations, not on the battlefield. Russians are too trusting to be negotiators and never do well. The battle field has a higher standard of performance.

By then, the Rothschilds would once again morph themselves into a complete new identity not associated with Judaism in any form, not even World Zionism.

It is important to realize that the Rothschild KM took Germany down to nothing after WWI, created a vacuum for Fascism, and then rebuilt it, creating Naziism and installing Hitler as a counter-force to their Russian Bolshevism.

Hitler became a problem for the KM when he broke free and began acting in the interests of the German people and the free people of the free of the Rothschilds.

Hitler introduced a financial system that was free of usury and beneficial to the working class. This mandated the utter destruction of Germany and the German people, because the Rothschilds and the Khazarians could never allow an economic system that did not depend upon usury to exist.

We see the same thing today with the Khazarian war against Islam, because Islam forbids usury. That is why Israel is so vocal and aggressive about destroying the Islamic people of the world. The KM expected this to be a large WWII and when they supported both sides, this could be used to industrialize the whole world and maximize their bankster money-power.

The Rothschild KM then bribed and induced Members of Congress to send American Soldiers to their pre-stage and engineered WWI:

As a continuance of their well-proven pattern of financing both sides in any war to maximize profits, the acquisition of more federal tax monies and increased international power, the Rothschild Khazarians once again bribed, blackmailed and induced members of Congress to declare war against Germany in 1917.

This was facilitated by a KM false-flag attack with the sinking of the Lusitania.

The Rothschild KM has since developed the usual pattern of covertly staging false-flag attacks as a standard operating procedure for inducing Americans to fighting wars for the Khazarian Mafia.

After WWII was finished, the Rothschild KM deployed the Cold War, and used this as an excuse to bring Nazi scientists and mind-control experts to America under Operation Paperclip.

This allowed them to set up a worldwide spying and espionage system that far exceeded any of their prior efforts.

Under this new system, they continue to infiltrate and hijack all American institutions, including the various American church systems, Freemasonry (especially the Scottish Rite and York Rite, the US military, US Intel, and most private defence contractors, the Judiciary and most

world, and developed his own banking system agencies of the USG, including most State governments, and both major political parties as well.

#### **Rothschild Banking Meme**

The Rothschild KM sets up Nazi Work Camps as a pretext to later manipulate the Allies into granting them their own private colony in Palestine, using land stolen from the Palestinians: The Rothschild KM was able to use their self mislabelled, so-called "holocaust" to serve as a mind-control trigger to thwart and resist any criticism of their Zionist ways. The truth of the matter was that the Rothschild KM set up the Nazi work camps to make huge profits for their corporations that ran their work camps and supplied their Nazi war machine.






