The Sacred Names: Yahweh and Yahshua

WITHIN THE CHRISTIAN IDENTITY (CI) Movement, there is an ongoing debate about whether we should use the original Hebrew names for our God (Yahweh) and also for our Saviour and King, Yahshua, also known as Jesus Christ. The two sides of this issue are summarized as follows:

- 1.) The English names are good enough and we don't need to resort to the Hebrew or Aramaic languages in order to address our Divine Sovereign.
- 2.) The original Hebrew names convey meanings which are lost in the English translation.

I am an advocate of the latter position; and I am going to do my best to give all the reasons why I advocate the use of the Divine Hebrew appellations, Yahweh' and Yahshua.'

Let it be known that I have no objection to the use of the English name for our Messiah, Jesus Christ. We have all grown up using this name and there is a certain reverence evoked when this name is spoken, so I do not wish to detract from this in any way. Also, there is a particular singularity to the name, Jesus Christ, which is shared by no other human being, past or present. There is no mistaking whom you are referring when you invoke this name.

As a historian for my people, TRUE Jacob-Israel (the Anglo-Saxon, Celtic and Caucasian peoples, NOT "the Jews"), I have come to appreciate the

Hebrew Scriptures from a multi-generational standpoint. When I read the story of Adam and Eve or the story of Moses and the Exodus and the writing of the commandments in stone, I know that my ancestors were present there and that my very blood is witness to these events.

I feel no sense of disconnection at all. It is as if these events happened yesterday to my own parents and to my brothers and sisters. Indeed, I feel that I was present there. Their history is my history, plain and simple.

As a writer, I understand the power of words and how difficult it is to convey the full meaning and impact of a statement when translating from one language to another.

Considering all the problems of translating simple declarative sentences, when we add to this complicated clauses, figures of speech, idioms, slang, vernacular, etc., it is a wonder that we understand the intentions of the Hebrew scribes and prophets at all.

Most scholars agree that the King James Version is a poor translation, at best. It was written by Englishmen who had little working knowledge of spoken Hebrew or of Hebrew traditions.

In addition to this problem is the fact that these translators had little or no knowledge of their true Identity, meaning that the Celts and the Anglo-Saxons are the true heirs of the heritage of the Israelites. The King James Version perpetuates the absurd idea that the Jews are identical to the Israelites.

Even more problematic is the fact that the prevailing world view that these men were labouring under was the Flat Earth Theory, thus forcing them to translate God's Word from that limited point of view.

However, knowing that our Bibles are fraught with these defects, it is easy to reconstruct the language to harmonize with reality. We simply isolate these defects and adjust the language

accordingly. I can say that every time I have retranslated verses with these objects in mind, the Bible has become a very accurate book; and this accuracy is reflected in terms of history, science, prophecy, archaeology, linguistics, etc.

It is important to understand that the original Hebrew used by our ancient ancestors conveyed much more meaning than even modern interpreters have imagined. This is especially true of the individuals that the Bible names.

Their names are not just names. Their names are uniquely identifying trademarks which tell us what they were known for. There is a reason why Jacob was renamed Israel. There is a reason why Abram was renamed Abraham. There is a reason why Esau was renamed Edom. Esau was a Saxon (son of Isaac); but when he rejected his heritage and married into the hook-nosed Hittite race, he became a Jew and his name was changed to Edom.

Biblical names reveal much about the individual. So, to ignore their meanings is to ignore knowledge and wisdom. And the two most important names in the Bible are Yahweh and Yahshua.

The Tetragrammaton, YHWH



Commandment #3: Thou shalt not take the name of the Lord [Yahweh] thy God in vain; for the Lord [Yahweh] will not hold him guiltless that taketh his name in vain. (Ex. 20:7, Deut. 5:11.)

Now, here we have a very important development within Christianity. Israel has forgotten God's name. An equally important realization is that what is being discussed in this Commandment is not cursing or swearing while using the word 'God' in a sentence. What this Commandment is referring to is the name,

YAHWEH. Without the vowels, the name is known as the tetragrammaton, YHWH. This Commandment is telling us not to use 'Yahweh' in vain.


Israel's God has a name; and that name is YAHWEH. The titles, 'Lord' and 'God' are not His Name. Consequently, it has not even been possible to take His name in vain because we have forgotten it.

In fact, when Yahweh divorced the House of Israel and sent us into the wilderness for our purification, one of the main reasons was that we were using His name, Yahweh, in vain.

By causing us to forget His name, we were no longer able to violate this commandment. As we come into remembrance as to who we are and what our purpose is, the time has come for us to reclaim our heritage and start using our God's name again, with sincerity and purpose.


And Moses said unto God, Behold, when I come unto the children of Israel, and shall say unto them, The God of your fathers *hath sent me unto you; and they shall say to me, What is his name? What shall I say unto them?* And God said unto Moses, **I AM THAT I AM:** and he said, Thus shalt thou say unto the children of Israel, I AM hath sent me unto you. And God said moreover unto Moses:

Thus shalt thou say unto the children of Israel, Yahweh God of your fathers, the God of Abraham, the God of Isaac, and the God of Jacob, hath sent me unto you: this is my name forever and this is my memorial unto all generations. **Ex. 3:13-15.**



The Bible repeatedly admonishes us to revere God's name in prayer, praise and song; but, because of our punitive divorcement from Him, we haven't done this for centuries. Despite our

forgetfulness, His name is forever and it is to be a memorial unto all Israel.



So, why haven't we been using His name? One answer is provided by Strong's Concordance itself, although unintentionally. The English rendition, the LORD, from the Hebrew Yahweh is listed as word #3068. Strong, obviously influenced by rabbinical distortions of the Hebrew Scriptures, incorrectly uses the traditional Jewish spelling and pronunciation of Jehovah in this entry.

Jehovah is a medieval rabbinical concoction which is typically unbiblical. Virtually all scholars agree that the correct pronunciation is Yahweh, with the first syllable pronounced like the German Ya and the second syllable pronounced like the German geh as in *Gehen Sie heim*.

This German eh sound is longer than the English short eh as in *Ed* but shorter than the English ay sound, as in *way*. Phonetically, it is almost directly in between. And, in Hebrew, the W is pronounced like a V (*Yahveh*).

Historically, the letter W did not enter into our language until around 1,000 AD. Before then, we only had the vowel U and the consonant V. So, phonetically, the name should be pronounced **Yah-Vey**, although the anglicised pronunciation "YAH-WAY" has become very common among CI people.

Since we had forgotten we are Israel, we also had forgotten to use His name when praying to Him. God wants us to address Him by His name, Yahweh, which is the specific name that He had instructed Moses that we, His people, were supposed to use. Yahweh means Creator, or, more primordially, 'I am becoming', or 'I am that I am' ('I am that which I choose to be'), or even

more simply, 'I am.' Blessed is the people that know the joyful sound: they shall walk, O Yahweh, in the light of thy countenance. In thy name shall they rejoice all the day: and in thy righteousness shall they be exalted. Ps. 89:15,16.

Unto thee, O God, do we give thanks, unto thee do we give thanks: for that thy name is near thy wondrous works declare. Psalm 75:1.

Help us, O God of our salvation, for the glory of thy name: and deliver us, and purge away our sins, for thy name's sake. Ps. 79:9.

When we address God by His name, Yahweh, we are acknowledging His self-creating Being. His name means causation, creativity, will, and power. He is the One who creates everything and allows everything else to be created because of Him. This awesome power is reflected in His name and that's why we are commanded to both use it properly and not take it in vain.

In Judah God is known: his name is great in Israel. Psalm 76:1.

A major feature of the Restoration of Israel in the latter days is this rediscovery of His Name by His remnant people, Jacob-Israel. Revelation 22:4 tells us this: "And they shall see his face; and his name shall be in their foreheads."

We are Yah's people and Yah is our God. He has promised us that when we address Him by His Name, Yahweh (or, "Yah," for short), He will listen to us. God' is a title, not a name. A title denotes a position or office. A name denotes a particular individual.

In addition to its meaning as "Creator," Yahweh' is also an affirmation of life. In the Germanic languages, Yah' means 'yes'. Yahweh is the "ever-living One." We accept life with all of its challenges and responsibilities because life is His blessing given to us. The subject of our God's name is a very important one. It is the subject of many philological articles and sermons.

One of the main differences between Judaism and Biblical Christianity is the use of our God's name.

There is a common misunderstanding by non-Identity Whites that the use of Yahweh' is a

Jewish tradition and that the use of Yahweh' insults Christianity or the White race. This idea is completely false and is based on the erroneous assumption that the Jews are Hebrews. The Jews were never Hebrews.

The Hebrews, by definition, are racially pure Adamites descended from the patriarch, Eber. The Jews have always been a mixed multitude of mamzers (racially mixed mongrels) who possess only partial Adamite/Hebrew blood.

The first portion of Adamic blood they inherited came through Cain, who was a half-breed Adamite/Nephilite. These early Jews were known as Cainites and later became known as Canaanites because they settled in the land of Canaan.

The second infusion of Adamite blood into the Jewish people came from Jacob's brother Esau, who was a race traitor. The Bible tells us that "Esau despised his birthright [genetic heritage]."

Jacob and Esau were twins, but when Esau refused to reproduce after his own kind, his parents disowned him, and more importantly, Yahweh Himself disowned him. After being disowned, his name was changed to Edom. Having married into the Canaanite people, his Canaanite descendants became known as Edomites.

The third major infusion of Adamite blood into the Jewish people came as a result of an act by King John Hyrcanus, who merged the Edomite nation of Idumea with the Judahite nation of Judah around 150 B.C.

Despite repeated infusions of Adamic blood into the Jewish people, they cannot claim to be

Adamites, Israelites, Judahites, Hebrews, or even Semites, because all of those designations, by biblical definition, are reserved exclusively for pure-blooded Adamites.

This makes the Jews mixed-race stepsons at best and outright impostors at worst. Irregardless, the Jews were not, are not, and can never be the heirs of the Kingdom because Yahweh does not permit race-mixing in His people.

And as long as the Jews continue to impersonate Israel and pretend to be us, they hope and fantasize that they shall steal our inheritance by this grandiose deception. In truth, their main reason for being is to deceive True Israel.

By impersonating us, they hope to deprive us of the promised Kingdom, at which time Jesus Christ will return to claim True Israel as His Bride. At the same time, He will judge the Jews, and those who work for or with them, for their iniquity.

Even though the rabbis of Judaism love to fool gullible Christians with the slogan, Jesus was a Jew, they know full well that Jesus was a racial Judahite, and not a Jew. Jesus was not a mixed breed individual. He was a 100% Judahite. "I am the root and the offspring of David," – Rev. 22:16.

As part of the deception of True Israel, and contrary to the teachings of the Bible, Judaism forbids the use of God's name, Yahweh. Christians have to ask: "Why would God's purported 'chosen people' disobey their own God by refusing to use His name at all?"

Well, since the Jews aren't God's people, it is easy to understand why they don't use His name.

‘YAHWEH’ or ‘BAAL’?

The rabbis of Judaism very cleverly exploit the fact that we have forgotten His Name and claim that His Name is **Too Holy to Be Pronounced** – by anyone! In this way, they hope to prevent us from re-establishing our relationship with Him!

Most translations of the Bible contain the expression the **LORD** in place of the name Yahweh’. But Lord’ in English is the same as Baal’ in Hebrew!

As part of Yahweh’s Writ of Divorcement, the House of Israel was exiled away from Palestine in 745 B.C. (See Isa. 50:1, with elaboration in Hosea, Chapters 1-3.) This period of exile was prophesied to last 7 “times.” (Lev. 26:18.) This is known to Bible scholars as the “seven times punishment.”

Ask yourself: “Why would Yahweh want us to address Him as Baal’ (a pagan deity) when He condemns Baal worship?” Even more to the point: why would the translators want to use “Lord” knowing that it means “Baal”? Obviously, Yahweh does not want us to do so.

In prophetic reckoning, a “time” is equal to 360 years. 7 * 360 = 2520. 2520 years after 745 B.C. brings us to 1776 AD, the year in which America, a White Christian nation based on biblical law, was born.

The explanation for this curious phenomenon lies in the fact that the translators of the King James Bible had unquestioningly adopted the Jewish tradition of replacing Yahweh’ with “the Lord” wherever it occurred in the Old Testament.

The divorce period ended in 1776, and we, True Israel, remembering who we are, are also beginning to remember our God, Yahweh.

What is the Biblical justification for doing this? There is none!

The International Jew has been trying to destroy America ever since it was created by Yahweh, but he will not succeed. The Book of Revelation (Chapter 12) makes it very clear that the Bride of Christ will be composed of the “saints” of the Twelve Tribes of Israel -- and no one else.

But there are two reasons why Christians have accepted this tradition. The first is the false assumption that the rabbis are the authorities on this subject. As all CI people know, Judaism is **Not** the religion of the Old Testament.

The Jews, by forbidding the use of His Name, hope to prolong our national amnesia which has now fulfilled its prophetic purpose.



The Anti-Christ rabbis have no choice but to continue their fraud and mockery in perpetuity. Their only hope of avoiding the Judgment Day is to try to prevent the Wedding Feast of the Lamb, the event at which Yahshua will claim His Bride.

Their holy book is the Talmud (above), which often changes and even contradicts the Torah of the Old Testament. For the rabbi, it overrules the Old Testament.

If they can prevent us from rediscovering our Identity and prevent us from praying to our God, Yahweh, they can delay both our salvation and their death sentence.

The two religions are so diametrically opposed that it would not be erroneous to say that whatever the Torah forbids, the Talmud permits.

Their religion, Judaism, has one main purpose: to deceive True Israel and thereby separate us from our Father, Yahweh.

For this development, we can directly blame our ancestor, John Hyrcanus, for had he not merged Idumea with Judah, the mixed-race sect known as the Pharisees could not have emerged over the hereditary Levitical (i.e. Israelite) priesthood. It

The longer they can keep us apart, the more they can delay our true inheritance of everlasting life in His Kingdom as Yahweh’s chosen people.

was these Pharisees who invented the religion known today as Judaism.

The second reason can only be a sinister motive by the rabbis who want to keep True Israel from praying to their God in an effective way. If we don't know how to use our own God's name, we cannot expect Him to respond to us in a personal manner.

It's like the difference between saying Hey, you! versus Dear John B or the difference between wishing upon a star and making a personal appeal to your Creator.

To which do you think Yahweh is more likely to respond? What's your name? Are you more likely to respond to someone who uses your name or to someone who calls out Hey, you, Baal!? Of course, humility, faith and patience have a lot to do with effective prayer as well.

What does the Bible say about using His name?

I will publish the name of Yahweh: ascribe ye greatness unto our God. Deut. 32:3.

I will praise thy name, O Yahweh, for it is good. Ps. 54:6.


The Bible is full of admonitions for us to use His name and praise His name, especially in the book of Psalms. The Book of Psalms is a book of prayers in which almost every prayer is dedicated to His name and to the use and praise of His name.

This should be a lesson for all Israelites, especially when it comes to answering the question, Why doesn't God answer my prayers? When you start addressing Him by His name, Yahweh, then you will start getting answers. But when asking for personal help, be sure to make a plea for all of True Israel and for all of your friends and relatives, because selfish prayer is not what Christianity is about.

We pray for others and we do what we can to build the Kingdom of God here on earth. Remember what Jesus said: Seek ye first the kingdom of God and his righteousness; and all these things shall be added unto you.

Pray first for instruction and enlightenment, and the same for others; and only thereafter for

supplication. Our mutual seeking after righteousness will establish the Kingdom. Only if we are desperately ill should we pray more for ourselves; and then it is good to have other Israelites pray with you. Even here prayer should be done in a spirit of repentance and devotion to the Kingdom.



To underscore this topic about God's name, I would like to quote from the Preface of the Holy Bible, Revised Standard Version, 1972:

A major departure for the practice of the American Standard Version is the rendering of the Divine Name, the Tetragrammaton. The American Standard Version used the term Jehovah; the King James Version had employed this in four places, but everywhere else, except in three cases where it was employed as part of a proper name, used the English word LORD (or in certain cases GOD) printed in capitals.

The present revision returns to the procedure of the King James Version, which follows the precedent of the ancient Greek and Latin translators and the long established practice in the reading of the Hebrew scriptures in the synagogue.

Now, dear Christian, should we follow Jewish tradition just because the Jews do it or should we follow what the Bible tells us to do? Your answer may determine which side you're on at the Judgment Day.

The RSV Continues

While it is almost if not quite certain that the Name was originally pronounced Yahweh, this pronunciation was not indicated when the Masoretes [the Jewish scribes] added vowel signs to the consonantal Hebrew text. To the four consonants YHWH of the Name, which had come to be regarded as too sacred to be pronounced [without any Biblical authority!],

they attached vowel signs indicating that in its place should be read the Hebrew word Adonai meaning Lord (or Elohim meaning God).

The ancient Greek translators substituted the word Kyrios (Lord) for the Name. The Vulgate likewise used the Latin word Dominus. The form Jehovah is of late medieval origin; it is a combination of the consonants of the Divine Name and the vowels attached to it by the Masoretes but belonging to an entirely different word.

The sound of Y is represented by J and the sound of W by V, as in Latin. For two reasons the Committee has returned to the more familiar usage of the King James Version:

- 1) the word Jehovah does not accurately represent any form of the Name ever used in Hebrew; and
- 2) the use of any proper name for the one and only god, as though there were other gods from whom He had to be distinguished, was discontinued in Judaism before the Christian era and is entirely inappropriate for the universal faith of the Christian Church. pages 3 and 4 of the Preface (no printed pagination).

In other writings, I have discussed the merits of the Masoretic Text versus the Greek Septuagint and I have become convinced (as have many other scholars of numerous denominations) that the Septuagint is the more accurate text.

The Septuagint is a direct translation from the Hebrew into the Greek by **Judahite** scribes. The Jews, as the mixed-breed offspring of Idumeans and Judahites, had absolutely nothing to do with

the writing of the Septuagint. The fact is that the Septuagint is Israelite/Judahite literature. The Masoretic text is Jewish, not Israelite, literature.

The authenticity of the Septuagint was proved by the discovery of certain books of the Old Testament in the Dead Sea Scrolls. These Dead Sea Scroll versions proved to be older than either the Masoretic or any of the existing Septuagint texts.

The Septuagint almost always adheres more closely to the Dead Sea Scrolls than does the Masoretic heresy, thus verifying that the rabbis had made unauthorised changes to the original text. By “unauthorized,”

I mean the command of Moses that the Hebrew Scriptures are not to be tampered with by anyone. This command is found at Deuteronomy 4:1 & 2. As it stands, the entire Talmud, since it consists entirely of rabbinical additions and changes to the Torah, is in violation of this Mosaic command.

Many scholars have pointed out that where the New Testament writers quote the Old Testament, it is almost always in agreement with the Septuagint, thus suggesting that when Jesus Himself quoted from Scripture, He was quoting either the Septuagint, the original Hebrew scrolls, or the Aramaic Targums.

None of These Texts Are Jewish Literature. The rabbis pretend that this is their literature, but no rabbi ever wrote a word of any of it; and certainly no Pharisee ever wrote a word of it. Of course, the Masoretic text didn't even exist in Jesus' time, for it was not committed to writing until 1000 AD.

In all, the Masoretes deleted the Sacred Name a total of 7000 times! Who gave them the authority to do this? What arrogance! Moses, in Deuteronomy 4:2, declared that **No One** has the authority to add or subtract from God's word, yet these rabbis arrogate unto themselves the editorial power to delete the holiest of names!

Since the Masoretic text is the Jewish version, we must regard with suspicion any changes that the rabbis have made to the text, especially when it comes to crossing out the name Yahweh and replacing it with the title Lord. Such a practice can only be described as blasphemous, for the

Bible declares over and over that we are to use and praise His name. Nowhere does the Bible even suggest the idea that the name is too holy to be pronounced. This false piety is just that: **False** and deceptive.

You should know that the main job of all rabbis is to find clever and deceptive ways to use words to make their evil deeds sound good. They are hypocrites (Luke 12:1) the like of which the universe has never seen!

Unfortunately, the Committee, which is to be commended for dropping the use of the word 'Jehovah,' nevertheless falls into another trap. Conclusion number 2, to repeat, states The use of any proper name for the one and only God, as though there were other gods from whom He had to be distinguished, was discontinued in Judaism before the Christian era and is entirely inappropriate for the universal faith of the Christian Church.

Dear Christian Israel, it just happens to be a fact that we **MUST** distinguish between Yahweh and other gods. If we do not, then we fall into the same old predicament which befell the rebellious Israelites in the land of Canaan.

Even the New Testament tells us that there are many gods: There be gods many and lords many.(I Cor. 8:5). This is not a denial of monotheism. Monotheism does not deny the existence of other spiritual entities. It is, rather, the assertion that Yahweh has no equal.

Among the gods there is none like unto thee, O Yahweh.(Psalm 86:8).

The Old Testament frequently uses the expression Yahweh Elohim. Since Elohim' means gods, this expression clearly implies that Yahweh is the God of gods, or the highest ranking god of the universe (the Most High God), indeed the Creator of the universe. [Universe,' by the way, literally means One Word.(Yahweh's Word.)] It is only fitting that this Universal Being have a name unto Himself.

Considering the above-cited Biblical references concerning our God, Yahweh, and the commanded use of His proper name, I find it inconceivable that these apparently well-intentioned Christian editors could make such an egregiously stupid statement. Nowhere in the

Bible are we admonished not to use God's name except for taking His name in vain. On the contrary, honouring and praising His holy Name is one of the highest virtues of a Biblical Christian.

Let there be no mistake: the avoidance of the proper use of God's name is a Pharisaic deception. It is the leaven of the Pharisees at its worst; and all Christians should beware this Judeo-Christian subterfuge, which is an integral part of the Talmudic end-time strategy designed to weaken and destroy Christianity and True Israel.

The fact is that, in the hearts and minds of Israelites and of all mankind, Yahweh is indeed competing against other gods, whether we realize it or not.

The fact that He has given us His proper name is sufficient reason to use it. By using His proper name, Yahweh, we remind ourselves of His omnipotence rather than, as the Committee suggests, diminish the idea of His importance. This Committee was obviously influenced by deceptive Jewish fables.

We pray that the deleterious influence of these fables ends once and for all, in Yahweh's name. Amen.

Chapter 24

1. And said He to Mosheh, **"Come up to Yahweh, you, and Aharon, Nadab and Abiyhu, and seventy of the elders of Yisrael; and worship from afar.**

2. **And Mosheh alone shall come near Yahweh, but they shall not come near; neither shall the people go up with him."**

6. And took Mosheh half of the blood, and put it in basins 101; and half of the blood he sprinkled 2236 on the altar.



11. And He did not stretch out His hand against the nobles 678 of the children of Yisrael, and they saw 2372 Elohiym, and they ate and drank.



12. And said Yahweh to Mosheh, **"Come up to Me in the mountain, and be there: and I will give you tablets 3871 of stone 68, and a Torah 8451, and commandments 4687 which I have written 3789; so that you may teach 3384 them."**

13. And rose up Mosheh, and his minister 8334 Yahshua 3091: and went up Mosheh into the mountain of Elohiym.

14. And said he to the elders, "Wait 3427 here for us, until we return to you: and behold, Aharon and Chur are with you: if any man 1167 has any matters 1697 to do, let him come to them."

15. And went up Mosheh into the mountain, and a cloud covered the mountain.

16. And the Glory 3519 of Yahweh settled down 7931 upon Mount Siynay, and the cloud covered it for six days: and the seventh day He called to Mosheh out of the midst of the cloud.

17. And the appearance 4758 of the Glory of Yahweh was like a devouring fire on the top of the mountain in the eyes of the children of Yisrael.

18. And went up Mosheh into the midst of the cloud, and got him up into the mountain: and Mosheh was in the mountain forty days and forty nights.

Verse 8 - Matt. 26:28; Mark 14:24; Luke 22:20; 1 Cor. 11:25; Heb. 9:19,20; 10:29

In verses 9,10 and 11, the group of elders saw a vision of Yahweh, not a physical view of Him, as that would have destroyed them. Yahweh did not harm them by His presence, as "stretching out His hand against them", as they were commanded to come there. "Nobles" 678 has the meaning of root stock, or the support, of Yisrael, as the long time leaders of the people. They feasted in joy and awe.



Is God’s Name Jehovah? (The Jehovah’s Witnesses Created to Hide God’s True Name) By Charue H. Campbell



Richard Abanes, a nationally recognized authority on cults and religions, points out that:

The origin of the word Jehovah can be traced to the late Middle Ages (around the year 1500), when Jewish scribes began inserting the vowels from the Hebrew word adonai (“my Lord”) into the name YHWH. The insertion resulted in the hybrid term YaHoWaH. Scribes wanted this new word to remind readers that God’s name was too holy to pronounce, so they should substitute adonah for it when reading biblical passages aloud.

JEHOVAH’S WITNESSES INSIST THAT GOD’S NAME (YHWH in the ancient Hebrew manuscript copies of the Old Testament) is supposed to be pronounced “Jehovah.” So persuaded are they about this, they believe they are the only church (organization) that has God’s favour because they are the only ones who consistently call God by this name.

Then, when the term YaHoWaH was Latinised, the “Y” and “W” were changed to “J” and “V”—resulting in Jehovah.

Yet, Jewish and Christian scholars, who are thoroughly familiar with the Old Testament Hebrew language and how to pronounce Hebrew words, make it clear that the Hebrew word YHWH is more accurately pronounced “Yahweh” (Yaw-Way) rather than “Jehovah.”

In other words, Jehovah is a mistransliteration, compounded by the fact that, while “J” has a “Y” sound in Latin, it has a very different sound in English—as in the word jam. Jehovah appears in no literature earlier than about the thirteenth century, and it began to be popularised in the sixteenth century by well-meaning but mistaken Christians. (Richard Abanes, *The Truth Behind the Da Vinci Code*, p. 19, 83)

Here is what other scholars say about the name or pronunciation “Jehovah”:



The Jewish Encyclopaedia: “Jehovah” — a mispronunciation of the Hebrew YHWH the name of God. This pronunciation is grammatically impossible. The form ‘Jehovah’ is a philological impossibility.”

The New Jewish Encyclopaedia: “It is clear that the word Jehovah is an artificial composite.”

Encyclopaedia Judaica: “the true pronunciation of the tetragrammaton YHWH was never lost. The name was pronounced Yahweh. It was regularly pronounced this way at least until 586 B.C., as is clear from the Lachish Letters written shortly before this date.”

The Universal Jewish Encyclopaedia: “**Jehovah** is an erroneous pronunciation of the Tetragrammaton a four lettered name of God, made up of the Hebrew letters Yod He Vav He. The word “**Jehovah**” therefore is a misreading for which there is no warrant and which makes no sense in Hebrew”

Webster’s Collegiate Dictionary: “Jehovah” — “False reading of the Hebrew **Yahweh**.”

Encyclopaedia Americana: “Jehovah” “erroneous form of the name of the God of Israel.”


A Dictionary of the Bible by William Smith: “Whatever, therefore, be the true pronunciation of the word, there can be little doubt that it is not Jehovah.”

Encyclopaedia Britannica: “The pronunciation ‘Jehovah’ is an error resulting among Christians

from combining the consonants YHWH with the vowels of **Adhonay**—The Masoretes who from the 6th to the 10th century worked to reproduce the original text of the Hebrew Bible replaced the vowels of the name YHWH with the vowel signs of Adonai or Elohim. Thus the artificial name Jehovah came into being.”

Webster’s Third New International Dictionary: “Jehovah” –“Intended as a transliteration of Hebrew YAHWEH, the vowel points of Hebrew

Adhonay (my lord) being erroneously substituted for those of YAHWEH; from the fact that in some Hebrew manuscripts the vowel points of **Adhonay** (used as a euphemism for YAHWEH) were written under the consonants YHWH of YAHWEH to indicate that **Adhonay** was to be substituted in oral reading for YAHWEH. Jehovah is a Christian transliteration of the tetragrammaton long assumed by many Christians to be the authentic reproduction of the Hebrew sacred name for God but now recognized to be a late hybrid form never used by the Jews.”



New Catholic Encyclopaedia: “**Jehovah**” —

The New Schaff-Herzog Encyclopaedia: “Jehovah” — “is an erroneous form of the divine name of the covenant God Israel.”

The Interpreter’s Dictionary of the Bible: “Jehovah” — “is an artificial form.”

Encyclopaedia International: “Jehovah” —”the vowels of one word with the consonants of the other were misread as ‘Jehovah.’”

16 Scriptural Reasons NOT to Take The Bible Literally!

FROM TIME TO TIME I get e-mails asking why the Bible shouldn't be taken literally. One of the reasons is that the scripture itself makes this clear. I've decided to provide the scriptural reasons themselves all in one post so I can refer people to it. This is by no means an exhaustive list, but it gets the point across.

Old Testament Scriptures

1) Psalms 78:2: "I will open my mouth in a parable: I will utter dark sayings of old."

Dark sayings of old are ancient teachings in the forms of riddles and parables. The Biblical writers call them "dark" because the meanings are hidden, or concealed. They are meant to figure out through careful meditation, prayer, and contemplation.

Why would the Lord speak to us like this? The answer is provided in the following scripture.

2) Proverbs 25:2: "It is the glory of God to conceal a thing: but the honour of kings is to search out a matter."

God's glory is always concealed from the lower, or natural man. It's an honour to become a king and figure it out. How do we become a king? Kings are symbolic for the ruling quality of the soul.

We become symbolic kings by learning the spiritual meaning to the scriptures and applying them. As I stated in scripture number 1, we must involve our minds in careful meditation and

prayer when thinking about the scriptures in order to understand their deeper meanings.


3) Proverbs 1:5-6: "A wise man will hear, and will increase learning; and man of understanding will attain unto wise councils: to understand a proverb, and the interpretation; the words of the wise, and their dark sayings."

Notice how the above scriptures states that proverbs need an interpretation. This is not just referring to the book of Proverbs; it's speaking about all scripture. The dark sayings of the wise, which need to be interpreted, are parables and mythology that conceal spiritual truth.

4) Ezekiel 20:49: "Then said I, Ah Lord God! They say of me, doth he not speak in parables?"

Ezekiel is clearly stating God speaks in parables.

5) Ezekiel 17:2: "Son of man, put forth a riddle, and speak a parable unto the house of Israel."




Again, we can see that God loves riddles!

6) Isaiah 6:9-10: "And he said, Go, and tell this people, Hear ye indeed, but understand not; and see ye indeed, but perceive not. Make the heart of this people fat, and make their ears heavy, and shut their eyes; lest they see with their eyes, and hear with their ears, and understand with their heart, and convert, and be healed."

Besides being a prophecy fulfilled in the New Testament, God is telling us through this scripture that when most hear or see the scriptural

stories and sayings, they do not understand. Our hearts have to be opened to the spiritual truth which is beyond any literal interpretation or meaning.

New Testament Scriptures



7) Matthew 13:34: All these things spoke Jesus unto the multitudes in parables, and without a parable spake he not unto them.”

As you can see, Jesus didn’t speak to the multitude unless it was in a parable. Why would he do this?

8) Mark 4:11: “And he said unto them, unto you it is given the mystery of the kingdom of God, but unto them who are without, all these things are done in parables.”

Who are those without? It is those who do not realize that the kingdom of heaven is within (Luke 17:21). Notice also how Jesus said the kingdom of God is a mystery. It, too, is part of the dark sayings of old. The entire Gospel story and the Old Testament is all a dark saying of old.

9) 2 Corinthians 3:6: “Who also hath made us able ministers of the New Testament; not of the letter, but of the spirit: for the letter killeth, but the spirit giveth life.”

Paul is telling us that the New Testament is not of the letter (literal), but of the spirit (spiritual). The letter of the law or the literal leads to death because the literal interpretation has no life in it. Anyone who stops at the literal interpretation will eventually die in what they think (doctrines) when life has run its course.

The literal interpretation cannot transform a person’s mind. It is the spiritual interpretation, especially when understood properly, that opens the heart and mind to the truth which is beyond any literal or physical interpretation.

10) Galatians 4:24: “Which things are an allegory: for these are the two covenants, the one

from mount Sinai, which gendereth to bondage, which is Agar.”

Notice how Paul directly states that the story of Isaac, Ishmael, Sara and Hagar are an allegory. They are the two covenants, one of promise (faith) and the other of bondage.

The Greek word Paul uses literally translates as allegory, which in English means, an expressive style that uses fictional characters and events to describe some subject by suggestive resemblances.

11) 2 Corinthians 4:3: “But if our gospel is veiled, it is veiled to them that are lost.”

Paul is telling us that the spiritually lost see the Gospel through a veil. This is because without the proper understanding and knowledge, the Bible becomes a letter that kills and confuses (with hundreds of opposing doctrines), not one that gives life (the true understanding).



12) 2 Corinthians 3:14: “But their minds were blinded: for unto this day remaineth the same veil untaken away in the reading of the Old Testament; which veil is done away in Christ.”

I want to make a few important notes here. Paul didn’t consider any of his writings or any of the New Testament scripture. It is a known fact that he wrote his letters before the Gospels were penned, so Paul didn’t even have a New Testament, nor did the church during his day.


The Old Testament was the only thing considered scripture. This is why Paul emphasizes the Old Testament above. For him the New Testament was a spiritual interpretation that was not of the letter of the law, not some book we refer to as the New Testament.

For Paul, Christ is the spirit that is born in us, which also gives us the true interpretation to scripture. When the Christ arises, spiritual inter-

pretation comes in as intuition, for it is all spiritual anyway.

13)1 Corinthians 2:7: “But we speak the wisdom of God in a mystery, even the hidden wisdom, which God ordained before the world unto our glory.”

Notice how Paul states that the wisdom of God is a hidden mystery. The Greek word for hidden means higher spiritual wisdom, which is again is spiritual, not literal.



14)1 Colossians 1:26: “Even the mystery which has been hid from the ages and from generations, but now is made manifest to his saints.”

The saints are like the kings who interpret the word correctly. They are the spiritually pure and are able to peer beyond the literal for true understanding.

15) Matthew 22:29: “Jesus answered and said unto them, Ye do err, not knowing the scriptures, nor the power of God.”

Jesus is speaking to the Pharisees who interpret scripture by the letter, or literal interpretation. If the scriptures were meant to be literal, do you think Jesus really could have said this to the very experts who knew scripture by heart better than anyone in their day?

16) Hebrews 5:13: “For everyone that uses milk is unskillful in the word of righteousness: for he is a babe.”

Here the author of Hebrews is explaining that everyone who doesn't understand the hidden

meanings of the word is unskillful. A babe is the one who stops at the literal meaning instead of diving beneath it for the spiritual meat that is the only interpretation that gives life.

What Does All This Mean?

Wordsworth once stated: “Hebrew history, as written by the Holy Spirit in the Old Testament, is a divine parable.”

Even though Wordsworth boldly declared the Old Testament to be parables, he still called them “divine.” A lot of the time Christians get caught up in the idea that if the scriptures aren't literal history, then they'd be worthless stories and all their faith would be for nothing. This couldn't be further from the truth. As divine parables they illustrate the spiritual laws of the inner world through outer reflections. This was their purpose all along. And they were certainly inspired of the Spirit.

The Bible has always been one of the greatest road-maps for the soul ever compiled. It doesn't have to be literal history to fulfil this role.

"Mummies?! There are no mummies in China!" laughed George as he rolled his eyes.






"Uh, George. I don't think you want to go there my friend. You see..."

"This is ridiculous. I can't keep living like this. Let's go to the main city to see the Emperor. He's probably hanging out at one the pyramids.


"Flashlight? Sorry George, but Thomas Edison was an evil White man too—and he was never born.

The Two Witnesses, By Danny Shreffler

A Voice in the Wilderness



THE TWO WITNESSES

THE VISIONS OF REVELATION ARE VERY REPETITIOUS. Each and every one of them, show us the consequences of violating God's law. Today our Christian countries are languishing under the yoke of sin as witnessed by our collapse.

We have seen how the sixth trump speaks of the book of the law covenant written by Moses[1]. This is verified by the prophets Isaiah, Jeremiah, Ezekiel, and Daniel[2]. This was covered in part 3 where we explored the 'little book' and how it refers to this principle of law and the consequences of disobedience.

Time Periods as Applied to the Witnesses

Within the war cycle of the sixth trump; the subject of the two witnesses is introduced. In Revelation 11 there are two references to time as it relates to these witnesses. One is the macrocosm and the other the microcosm. (1260 days & 42 months.)

The 1260 Days

The 1260 days is mentioned only these two times in scripture. Its application to the two witnesses can be understood by looking at the Rev. 12 passage referring to the woman who fled into the wilderness.

1. Revelation 11 refers to the time the two witnesses testify in sackcloth; and

2. Revelation 12 refers to the woman who fled into the wilderness.

The woman in the twelfth chapter is a metaphor for Israel[3]. There can be no other logical explanation. The passage in Revelation 12 is talking about the period of time the woman, (Israel) spends in the wilderness[4]. Specifically, the time from the Exodus until the end of the calendar. There she is sustained for a period of 1260 days.

Rev. 12:6 says the woman fled into the wilderness where she would be fed for 1260 days. Rev. 12:14 says the woman is nourished for a time, times and a half time.

One can readily see both of these passages are talking about the same woman and both are talking about her time in the wilderness. They are both talking about her being sustained in that time (fed and nourished). We can then safely conclude that the '1260 days' and the 'time, times and a half time' are one in the same.

The 'time, times and a half time' is referring to 1000-year days. They are the great 1000-year days of God's calendar. They can be understood as a 'day, two days and a half day' or three- and one-half days. Converting that to a day for a year, we have 3500 years. This begins when the woman fled into the wilderness and ends with the return of Jesus the Christ.

Now, back to Rev. 11. The two witnesses 'prophecy' for 1260 days. Now that we have an understanding of what time period that is talking about, we can better understand the testimony of the witnesses. It must also refer to 3500 years in this passage.

Sackcloth denotes a period of mourning and sadness. It is obscurity and vagueness muffled by despair. The period of their mourning lasts for 3500 years, while they sit sobbing by the side of the road with no passer by caring to hear their

dirge. Very few have stopped and knelt down to hear the reason for their anguish. "My friend, why are you mourning?" Very few cares.

The 42 Months

The other period of time relating to the two witnesses, is 42 months. Most Bible scholars believe this period of time to be one in the same as the 1260 days. It is not. The 1260 days refer to the macrocosm. It is the period of Israel's existence from Egypt until the end of days.

The 42 months refer to the days of Jacob's trouble alluded to in Jeremiah 30. It is the actual 42 months at the end of the 1260 days. It too ends at the end of days.

How do we know this? Because the witnesses exist for that length of time prophesying in obscurity (sackcloth) from Egypt until the end of time. During the last 42 month their existence they are silent (dead) and lying in the street of the great city which is spiritually called Sodom and Egypt where our Lord was crucified. (The same city in spirit; but not the same physically. Remember Revelation is written in symbols. If the witnesses are allegorical, which they are, the city must also be allegorical.)



The account of the two witnesses is introduced in the midst of the sixth trump (the war cycle) telling us it is they who will be trodden down, slain (spiritually speaking) and lie dead in the street (silenced).

Still, their very presence continues to testify to the fact there is but one God and that God is the God of Israel. It also shows us when they are slain (silenced)[5].

It is in the midst of the final battle. We can already see this happening, here in America under the administration of Satanists and not without the complicity of our preachers! To speak evil even of evil we don't even dare!

Rightly Dividing the Word of Truth

So far there has been but a hint of who the two witnesses truly are. One more thing must be understood to fully understand their identity.

This cannot possibly be understood unless one understands how to discern the difference between the physical and the spiritual. Titus refers to this as rightly dividing the word of truth. We know this because that is exactly how the writers of the New Testament understood the Old Scriptures. They would read the scriptures and then discern what they meant in the spiritual realm.

Unfortunately, too many of our people stubbornly refuse to learn division. Half of them see everything as spiritual and ignore the physical, and the other half do just the opposite. They see everything only in a purely physical or material way.

The Keys to Understanding God's Word

This takes us on a side trip back to Genesis 1:1-5. Take the time to contemplate the first five verses of Genesis in a way you have never understood. Give your full attention and consideration.

The Christian Bible opens with the key to understanding exactly how God meant for man to understand scripture. Every expositor this author has ever read, believes the first five verses of Genesis, give a physical description of the creation of heaven and earth. Whether or not that is so, it in no way diminishes or negates another and even more important understanding.

That is the spiritual understanding. Those five verses (Gen 1:1-5) are God's key to understanding the scriptures.


Fact: On the first day, God did three things:

- He created the heaven and earth.
- He created light and divided the light from the darkness.
- He called the light day and the darkness night.
- Now ask yourself the following questions:
- Why does the Word tell us God created the heaven on Day 1 and then again on Day 2?
- Why does the Word tell us God created the earth on Day 1 and then again on Day 3?

- Why does the Word tell us God created light on Day 1 and yet in the physical world the bodies which give light were created on Day 4?

God has a reason for that which he does. A very good reason. He is giving us more than the physical.

He is giving us a spiritual understanding. He is giving us a concept he wishes us to understand. He is giving us keys to rightly dividing his word of truth.



He established a principle necessary for understanding his plan and his word. God spoke to his prophets, it is true. He also instructed them to do certain things such as build a tabernacle, establish the priesthood, build an ark, march around Jericho—etc.

Listening to his voice; observing his handiwork in the world about them; and contemplating what he meant by the things he taught them to make, all became the inspiration (light) bringing understanding to mankind (earth). This light (inspiration) came from heaven (God). It turned night into day and allowed man to see his plan.

Understanding God's written word in our day, at minimum, requires some understanding of figures of speech. God speaks to mankind in allegory, parable, metaphors, simile and many other figures of speech. Numerous books have been written on the figures of speech used in Scripture.

Matthew 13:34-35 reads "All these things spake Jesus unto the multitude in parables; and without a parable spake he not unto them: That it might be fulfilled which was spoken by the prophet, saying, I will open my mouth in parables; I will utter things which have been kept secret from the foundation of the world."

That which he says was spoken by the prophet was a quote from Psalms 78:2. Mark 4:34 also says Jesus spoke not except by parable.

In the first chapter of Genesis, the earth spoken of, was made to be inhabited by man. It was in fact created for man. God made mankind to be his friend and companion. He told them to build him a sanctuary "---that I may dwell among them[6]."

That was the Old Covenant way of bringing heaven to earth. In the auspices of the New Covenant, Jesus the light of the world, came to earth to dwell walk among us and sent the Holy Spirit to dwell within us!

"The heaven, even the heavens, are the Lord's: but the earth hath he given to the children of men." – **Ps 115:16**

"For thus saith the LORD that created the heavens; God himself that formed the earth and made it; he hath established it, he created it not in vain, he formed it to be inhabited: I am the LORD; and there is none else." – **Isa 45:18**

This concept is also the great clue to how we should view the scriptures. It helps us understand why Isaiah so often seems to go back and forth from talking about the laborious existence of mankind in the physical realm; and the glorious existence God envisioned for mankind.

His writings alone should tell us exactly why Jesus taught us to pray for God's will to be done on earth as it is in heaven.

Heaven, light, and day all represent the realm of God Almighty. It is the spiritual realm and exemplifies the attributes of God; love, joy, peace, holiness, perfection, goodness, purity, longsuffering, and mercy,——etc.

Earth, on the other hand, the abode of man, represents the flesh with its carnal appetites. It is there where the works of the flesh adultery, fornication, uncleanness, lasciviousness, idolatry, witchcraft, and hatred, ...etc. abound. It exemplifies the nature of man.

Man seeks God's will and His will is shown to us. Light comes from heaven and night becomes day. John said "God is light and in him is no

darkness at all.” Jesus said “I am the light of the world; he that followeth me shall not walk in darkness, but shall have the light of life.” Jesus also said if a man walks in the night, he stumbles because there is no light in him.

The New Testament has numerous passages showing us light is a spiritual concept. When men come to Jesus and he is in them, they become the children of light. (Eph 5:8) John said “But if we walk in the light, as he is in the light, we have fellowship one with another **and** the blood of Jesus Christ his Son cleanseth us from all sin.”

God’s intent was for us to seek his will (light), walk in that light and become that light unto others in a world where it is too dark to see. The first five verses in scripture teach us to study the physical things of the Old Covenant and contemplate what they represent in the spiritual world, rightly dividing the two.

Is it such a stretch, or illogical to think God used allegory as a method of teaching within the opening verses of the Bible?

The scripture constantly teaches us God uses parable to teach mankind. It is his way of shedding light. It is how the earth was meant to be as in heaven. Is it then such a stretch, or illogical to think God used the same method of teaching within the opening verses of the Bible? Of course not! That is exactly what he was doing! Those five verses are the keys to understanding his word!

Examples of Allegory in the Scriptures

Paul refers to the two sons of Abraham, one of a free woman and one of a bond woman. In Galatians 4, Paul tells us they represent the Old Covenant and the New Covenant. He also says “...which things are allegory...” This is but one of many examples where Paul interprets scripture from the viewpoint of allegory or parable.

The passing of our fathers with Moses through the sea is a ‘type’ or allegory for baptism. In turn baptism is allegorical for death of the ‘old man’

who is resurrected in newness of life when he is regenerated. **(1 Cor 10:1-2)**

Adam is referred to as an allegory of Christ who is the ‘last’ Adam. **(1 Cor 15:44-45)**

The temple, the sacrifices, the priest and the kings are all types or allegories. The real fulfillment of these symbols, is Jesus the Christ.

Hebrews 10:1 reads “For the law having a shadow of good things to come, and not the very image of the things, can never with those sacrifices which they offered year by year continually make the comers thereunto perfect.”



A shadow is an area where light is blocked. It is vague and obscure. Yet if we study it, we can get a glimpse of what the reality looks like. Look at the picture of the boy looking at his shadow. It resembles him and yet is not an exact representation. He cannot see his image as well as he could if the fence were a mirror; yet his image is a general outline of his appearance. The principle given in God’s word is simply this: The physical things are the shadow. Their substance is the spiritual counterpart!

Diabetes in Radio Wave Sickness

IN 1917, when Joslin was publishing the second edition of his book on diabetes, radio waves were

being massively deployed on and off the

battlefield in the service of war. At that point, as we saw in chapter 8, radio waves joined power distribution as a leading source of electromagnetic pollution on this planet.

Their contribution has steadily grown until today when radio, television, radar, computers, cell phones, satellites, and millions of transmission towers have made radio waves by far the predominant source of electromagnetic fields bathing living cells. The effects of radio waves on blood sugar are extremely well documented. However, none of this research has been done

in the United States or Europe. It has been possible for western medical authorities to pretend that it doesn't exist because most of it is published in Czech, Polish, Russian, and other Slavic languages in strange alphabets and has not been translated into familiar tongues.

But some of it has, thanks to the United States military, in documents that have not been widely circulated, and thanks to a few international conferences.

During the Cold War, from the late 1950's through the 1980's, the United States Army, Navy, and Air Force were developing and building enormously powerful early warning radar stations to protect against the possibility of nuclear attack. In order to stand sentinel over the air spaces surrounding the United States, these stations were going to monitor the entire coastline and the borders with Mexico and Canada.

This meant that a strip of the American border up to hundreds of miles wide—and everyone who lived there—was going to be continuously bombarded with radio waves at power levels that were unprecedented in human history. Military authorities needed to review all ongoing research into the health effects of such radiation.



In essence, they wanted to know what were the maximum levels of radiation to which they could get away with exposing the American population. And so one of the functions of the Joint Publications Research Service (above), a federal agency established during the Cold War to translate foreign documents, was to translate into English some of the Soviet and Eastern European research on radio wave sickness.

One of the most consistent laboratory findings in this body of literature is a disturbance of carbohydrate metabolism.

In the late 1950's, in Moscow, Maria Sadchikova gave glucose tolerance tests to 57 workers exposed to UHF radiation. The majority had altered sugar curves: their blood sugar remained abnormally high for over two hours after an oral dose of glucose. And a second dose, given after one hour, caused a second spike in some patients, indicating a deficiency of insulin.

In 1964, V. Bartoníček, in Czechoslovakia, gave glucose tolerance tests to 27 workers exposed to centimetre waves—the type of waves we are all heavily exposed to today from cordless phones, cell phones, and wireless computers.

Fourteen of the workers were pre-diabetic and four had sugar in their urine. This work was summarized by Christopher Dodge in a report he prepared at the United States Naval Observatory and read at a symposium held in Richmond, Virginia in 1969.

In 1973, Sadchikova attended a symposium in Warsaw on the Biologic Effects and Health Hazards of Microwave Radiation. She was able to report on her research team's observations of 1,180 workers exposed to radio waves over a twenty-year period, of whom about 150 had been diagnosed with radio wave sickness.

Both pre-diabetic and diabetic sugar curves, she said, “accompanied all clinical forms of this disease.”

Eliska Klimková—Deutschová of Czechoslovakia, at the same symposium, reported finding an elevated fasting blood sugar in fully three-quarters of all individuals exposed to centimeter waves.



Valentina Nikitina, who was involved in some of the Soviet research and was continuing to do such research in modern Russia, attended an international conference in St. Petersburg in 2000. She reported that people who maintained and tested radio communication equipment for the Russian Navy—even people who had ceased such employment five to ten years previously—had, on average, higher blood glucose levels than unexposed individuals.

Attached to the same medical centres at which Soviet doctors were examining patients were laboratories where scientists were exposing animals to the very same types of radio waves.

They, too, reported seriously disturbed carbohydrate metabolism. They found that the activity of the enzymes in the electron transport chain, including the last enzyme, cytochrome oxidase, is always inhibited. This interferes with the oxidation of sugars, fats and proteins.

To compensate, anaerobic (non-oxygen using) metabolism increases, lactic acid builds up in the tissues, and the liver becomes depleted of its energy-rich stores of glycogen. Oxygen consumption declines. The blood sugar curve is affected, and the fasting glucose level rises.

The organism craves carbohydrates, and the cells become oxygen starved. These changes happen rapidly. As early as 1962, V. A. Syngayevskaya, working in Leningrad, exposed rabbits to low level radio waves and found that the animals' blood sugar rose by one-third in less than an hour.

In 1982, Vasily Belokrinitskiy, working in Kiev, reported that the amount of sugar in the urine was in direct proportion to the dose of radiation and the number of times the animal was exposed. Mikhail Navakatikian and Lyudmila Tomashevskaya reported in 1994 that insulin levels decreased by 15 percent in rats exposed for just half an hour, and by 50 percent in rats exposed for twelve hours, to pulsed radiation at a power level of 100 micro watts per square centimeter.

This level of exposure is comparable to the radiation a person receives today sitting directly in front of a wireless computer, and considerably less than what a person's brain receives from a cell phone.

If there wasn't a public outcry when most of this information was concealed in foreign alphabets, there should be one now, because it has become possible to confirm directly, in human beings, the degree to which cell phones interfere with glucose metabolism, and the outcomes of such studies are being published in English.

Finnish researchers reported their alarming findings in the Journal of Cerebral Blood Flow and Metabolism in 2011. Using positron emission

tomography (PET) to scan the brain, they found that glucose uptake is considerably reduced in the region of the brain next to a cell phone.




Even more recently, researchers at Kaiser Permanente in Oakland, California (above), confirmed that electromagnetic fields cause obesity in children.

They gave pregnant women meters to wear for 24 hours to measure their exposure to magnetic fields during an average day. The children of those women were more than six times as likely to be obese when they were teenagers if their mothers' average exposure during pregnancy had exceeded 2.5 milligauss. Of course, the children were exposed to the same high fields while growing up, so what the study really proved is that magnetic fields cause obesity in children.

Vital Statistic

As with heart disease, rural mortality from diabetes in the 1930's corresponded closely with rates of rural electrification, and varied as much as tenfold between the least and the most electrified states. This is graphically illustrated in figures 3 and 4.

Figure 3 – Rate of Rural Diabetes in 1931



The overall history of diabetes in the United States is similar to that of heart disease.

Mortality from diabetes increased steadily from 1870 until the 1940's—this, despite the discovery of insulin in 1922.

The real change over time may have been even greater because the definition of diabetes, in the United States and worldwide, was relaxed in 1980. A two hour plasma glucose level of over 130 milligrams per deciliter was formerly taken as an indication of diabetes, but since 1980 diabetes is not diagnosed until the two-hour level exceeds 200 milligrams per deciliter. Levels between 140 and 200, which may not cause sugar in the urine, are now called “pre-diabetes.”


A sudden spike in diabetes cases occurred nationwide in 1997—a 31 percent increase in a single year. No one was able to explain why. But that was the year the telecommunications industry introduced digital cell phones en masse to the United States.

The first such phones went on sale in dozens of American cities during the Christmas season of 1996. Construction of cell towers began in those cities during 1996, but 1997 was the year that battalions of towers, previously confined to metropolises, marched out over the rural landscapes to occupy previously virgin territory.

That was the year cell phones were transformed from a rich person's luxury to the common person's soon to be necessity —the year microwave radiation from towers and antennas became inescapable over large parts of the United States.

The situation today is out of control. The Centres for Disease Control estimates that in addition to the 21 million American adults over the age of twenty who have diagnosed diabetes, 8 million have undiagnosed diabetes, and 86 million have pre-diabetes.

Adding these numbers together gives the shocking statistic that 115 million Americans, or more than half of all adults, have elevated levels of sugar in their blood.



Worldwide, it was estimated that more than 180,000,000 adults had diabetes in 2000. In 2014, the estimate was 387,000,000. In no country on earth is the rate of diabetes, or of obesity, decreasing.

Like diabetes, obesity has tracked exposure to electromagnetic fields. The first official statistics in the United States date from 1960, showing that one quarter of adults were overweight. That number did not change for twenty years.

The fourth survey, however, conducted during 1988–1991, revealed something alarming: fourteen million additional Americans had become fat.

The authors, writing in the Journal of the American Medical Association, commented that studies in Hawaii and England had found similar rises in overweight during the 1980's across the board throughout the population in both sexes and at all ages.

They speculated about “dietary knowledge, attitudes, and practices, physical activity levels, and perhaps social, demographic, and health behaviour factors” that might have changed, although they did not point to a single piece of evidence that any of those things had changed.

In Rebuttal

British physician Jeremiah Morris noted in a letter to the British Medical Journal that the average lifestyle had improved during this time, not worsened.

More people in England were cycling, walking, swimming, and doing aerobics than ever before. Average daily food consumption, even after adjusting for meals eaten outside the home, had declined by 20 percent between 1970 and 1990.

However, in 1977, Apple had marketed its first personal computer, and during the 1980's the majority of people in both the United States and England, either at home or at work or both, were suddenly—and for the first time in history—exposed to high frequency electromagnetic fields continuously for hours everyday.

The problem became so huge that in 1991 the Centres for Disease Control began retroactively tracking not just overweight but obesity. For an American man or woman of average height this is defined as being more than about 30 pounds overweight.

More than two-thirds of all adults today—about 150 million Americans—are overweight. Eighty million are obese, as are twelve and a half million children, including one and a half million children aged two to five.

Twelve and a half million adults are more than 100 pounds overweight. The experts at the Centers

for Disease Control have been able to do little more than shout that similar trends are being reported elsewhere—more than half a billion adults worldwide are obese—and to throw up their hands and say, “We do not know the causes of these increases in overweight and obesity.”

Obesity in Wild and Domestic Animals If obesity is caused by an environmental factor, then it should be occurring in animals too. And it is so.

A few years ago David B. Allison, professor of bio statistics at the University of Alabama School of Public Health, was looking over data on small primates called marmosets from the Wisconsin Non-Human Primate Center, when he noticed that the average weight of the animals had increased remarkably over time. Mystified, he checked with the centre, but could find no convincing reason for weight gain in this large population of animals living in a fixed laboratory environment on a controlled diet.

Intrigued, Allison searched online for previous studies of mammals that had lasted at least a decade and contained information about the animals' weight. He involved colleagues at primate centres, toxicology programs, pet food companies, and veterinary programs.

The final paper, published in 2010 in the Proceedings of the Royal Society B, had eleven coauthors from Alabama, Florida, Puerto Rico, Maryland, Wisconsin, North Carolina, and California, and analysed data on over 20,000 animals from twenty-four populations representing eight species, including laboratory animals, house pets, and feral rats, both rural and urban.

In all twenty-four populations, the average weight of the animals rose over time. The odds of this happening by chance were less than ten billion to one.


Chimpanzees gained the most weight: they were twenty-nine times as likely to be obese in 2005 as they were in 1985. But even among country rats there was 15 percent more obesity every decade, consistently for four decades.

The authors found similar studies with the same results elsewhere: 19 percent of light breed horses in Virginia were obese in 2006, versus 5 percent in 1998; 27 laboratory rats in France, under identical conditions, had increased in weight between 1979 and 1991.

Because wild and domestic animals were gaining so much weight, and had been doing so since at least the 1940's, Allison and his colleagues challenged the tired old wisdom that the rising tide of human fatness is due to lack of exercise and poor diet.

They held up these animals as a warning to us all about an unknown global environmental factor. They titled their report "Canaries in the Coal Mine".




While in hiding from his enemies in South Wales, he stayed in Llangynwyd on the farm where my grandfather was born.






Cacao unarguably is the best plant source of flavonols and polyphenols on the planet. It will take some beating to match it.




London's Lost Peak: What on Earth was Whitechapel Mount?

structure erected in bygone times to guard London's eastern approach.



WHITECHAPEL is one of the oldest districts of London. Hard by the old City of London with the towering glass skyscrapers of the business and financial district, it is a maze of roads, parks and old buildings. Today it is perhaps best known for being the area Jack the Ripper prowled, murdering prostitutes amid the dark alleyways.

Much of the old Whitechapel has been lost to urban redevelopment in the century since the Ripper, but some of the old character survives. The churches still stand, dwarfed by the buildings that surround them. Pubs and parks are somewhat as they used to be, and behind Liverpool St Station there are still a few alleyways of Victorian London, now home to karaoke and wine bars.

Even the great London Hospital, built nearby, was dwarfed by the great mound. Fully 400 yards (366 meters) long, it stood amidst the fields and houses, a part of the landscape clearly visible in many paintings until the early 1800's.

But perhaps the most significant feature of Whitechapel is one that most Londoners are not even aware of. A century before Jack the Ripper, in the 1700's, there was Whitechapel Mount, a huge mound taller than the nearby newly-built London Hospital.

Bedlam: The Evil Secret In The Heart Of London Were There Multiple Jack the Rippers?

This great hill, although completely gone now, once dominated the surrounding landscape. And nobody knows what it was.

We do know what happened to the Mount: records show it was levelled to the ground in 1807 to make way for new, more modern constructions. We also know why Whitechapel Mount was levelled, as Londoners of that time believed that the detritus from the Great Fire of 1666 had been collected into a huge pile of rubble. Looters and opportunists would scour the mount, looking for valuables.

The Origins of Whitechapel Mount

The origins of the Whitechapel Mount are still disputed, and there are many theories about how it came to be there, dominating one of the main roads into the old City. Historians believed that the mound was artificial, maybe a defensive

However, this was only a theory and there is no evidence that this is what happened. Much of the London destroyed by the fire was constructed of wood and plaster, and the remains could not have formed such a towering mound. Similarly, nothing of value has ever been conclusively proven to come from the Mount.

A Key Location?

Whitechapel Mount was situated at the south end of Whitechapel Road, an age-old route between the City of London and the port of Harwich,

running through such ancient towns as Colchester and in use since before the Romans invaded millennia ago.

Before it was levelled during the 19th century, the route was surrounded by fields and grazing pastures, dotted with trees and small houses. In fact, given its location and height, in the daytime Whitechapel Mount served as a scenic high point for visitors who wanted to get a bird's eye view of the old walled City.

The Mount was much more dangerous after dark, however, becoming a den of scoundrels and thieves who used it as a hiding place and stashing point for stolen goods. The Mount was also crossed with tracks and walking roads for travellers and visitors. People could even go up and down the Mount with the help of horse carts and mules.

What the Whitechapel Mount was, in reality, is still not clear. Some people think that it is almost as old as the City itself, raised by the early Saxons as a defensive structure similar to other great earthwork fortifications in the south of England.

Others think that it was a defensive structure dating back to the English Civil War, when the Parliamentarians of London faced off against the Cavalier royalist forces of Charles I in the 17th century. Some theories even pitch the idea that the Mount was the burial place of those who died in the Great Plague of 1665.

On the other hand, some people believe that it was the burial place of the victims of the Great Fire, which happened the following year – London was clearly particularly cursed at that point in history. Some people also believed that

the Whitechapel Mount was nothing more than a huge pile of cattle dung, as cattle driven to market were often corralled in the area before sale. The Mount was also called Whitechapel Dungshill, which would seem to support this theory.

In truth, the entire area in the 17th and 18th centuries would have been largely rural. Houses and travelling inns were few and scattered compared to today, surrounding the old St Mary Matfelon Church, a windmill, a ducking pond (a pond to duck criminals in, not a pond containing ducks) and a burial ground. The latter is perhaps the reason the Mount itself was thought to be a burial ground, although they are clearly separate.

What Can History Tell Us?

Records of the Mount most commonly refer to its' associations with brigands. The Whitechapel road was very busy and commonly full of highwaymen and bandits who stole from travellers and heckled them while they were either on their way to London or coming from it. Since the Mount was a good hiding place, it offered an advantage and a great hiding place for such riff-raff.

Many court reports dating back to when the Mount existed to talk about murders and robberies being common near the Whitechapel Mount. The Mount was infamous, a possible factor in the decision to level the area and allow urban development.

The earliest maps which clearly contain the Mount date from the 1600's and 1700's, where the location is always clearly marked. Interestingly the Mount is sometimes referred to as "The Fort" and described as a mud wall. From this, it is clear that historians and local people believed it to be a defensive structure erected for protection, and some surviving descriptions even refer to the Mount as a timber castle of sorts, although there seems to be no corroborating evidence for this.

However, the human activities that happened around the Mount in Industrial Era London

garnered its later identity, and new theories started revolving around it. In some maps, the Mount is referred to as a Dunghill and perhaps it grew with the cattle effluvia over the years as more and more cows were brought to market. Such great piles of rubbish and dung certainly existed, a key feature for example in the Victorian novelist Charles Dickens's *Our Mutual Friend*.



Whether the Mount was a fortified wall or a burial ground for unfortunate souls, it was once a part of the vast London landscape. There are many stories linked with the Whitechapel Mount that historians and history enthusiasts talk about even today.

But today all we have are theories. Eventually, the Mount was levelled with the plans of London's new constructions expanding London's docklands. After levelling the ground, the streets of Mount Terrace and Mount Place are all that remain to reference this great, strange, unexplained feature of the ancient City.


"Think Not That I Am Come to Destroy the Law, or the Prophets: I Am Not Come to Destroy, but to Fulfil."

delivered to him that is not learned, saying, Read this, I pray thee: and he saith, I am not learned." (Isaiah 29:9-12)

Paradoxically, this present age, which has received the greatest light, is also the age of greatest darkness and blindness.

"The earth shall quake before them; the heavens shall tremble: the sun (Jacob) and the moon (Rachel) shall be dark, and the stars (tribes of Israel) shall withdraw their shining—The sun and the moon shall be darkened, and the stars shall withdraw their shining." (Joel 2:10; 3:15)

Consequently the warning words of Jesus the Christ should be of special significance to our generation:

"If therefore the light that is in thee be darkness, how great is that darkness!...Can the blind lead the blind? Shall they not both fall into the ditch?"

So now we have The Doctrine of Racial Idiocy. Life is a behaviour of generations.
