The Tetragrammaton in the Septuagint

I HAVE OFTEN ARGUED that proper names should

not be translated from one language to another unless there is a common and satisfactory equivalent in the new language. This is not the case for Yahweh.’

There is no equivalent for ‘Yahweh’ any other language, therefore, all Bibles should contain the tetragrammaton, no matter what the language. There is no valid reason to translate a proper name if there is no equivalent in the object language.

Having established the non-translatability of the tetragrammaton, I was tremendously gratified to discover that the original Septuagint translators, scribes of Judahite descent commissioned by King Ptolemy of Egypt, chose to retain the name of Yahweh in the original Paleo-Hebrew script within the Greek body of the text.

Not only did they retain the Paleo-Hebrew script, they retained the original right-to-left direction of the Hebrew while using the left-to-right direction of the Greek translational text, confirming the non-translatability of Yahweh.’

The Judahite scribes saw no reason to translate ‘Yahweh’ into Greek. Indeed, they could not translate it into Greek because the Greeks had no word for it— and neither does English. The best we can do is to transliterate it into I AM’; but this does not do the name justice, as you shall see in the next section.

For those readers who might be sceptical of this claim regarding the Septuagint, I invite you to inspect the on-line pictorial evidence of the Dead

Sea Scroll version of the Septuagint. The Paleo-Hebrew script is unmistakable in its position. One web address is [Here](#). If this link is no longer active, just type the phrase Paleo-Hebrew in the Septuagint into your browser and you will get many references, many with pictorial evidence.

In my oldest copy of the King James Bible, I crossed out every instance of LORD, writing YHWH in its place. With regard to printed Bibles, such a change would be just the beginning of undoing the tremendous damage done to our heritage by the Jews.

I was again gratified to learn that the *Jerusalem Bible*, a Catholic version, retains the name of Yahweh throughout, even in the apocryphal books which are included as part of that Bible. There is also now available a Christian Identity version of the Bible which retains the name of Yahweh. It is called The Book of Yahweh. (The Book of Yahweh is available from The House of Yahweh, POB 2498 Abilene TX 79604.)

All of the preceding demonstrates that there is **no justification for substituting** the title LORD for the proper name YHWH. It is out of the question, for it is blatant human meddling in Divine affairs.

Were it not for the satanic conniving of the rebels of Judaism, this apostate tradition would have never crept into our religious experience. Only a Yahweh-hating bunch of serpents and vampires (like the Pharisees and Masoretes), conniving against us for the last two thousand years, could have accomplished this.



The Meaning of ‘Yahweh’



Catherine Ponder, in her book, *The Millionaire Joshua*, has this to say about the Sacred Name:

The Hebrews used the term I AM so much that they became known as the people of the I AM. They considered the term I AM the lost word of power which, when released in meditation and through spoken decrees, could perform miracles in an instant--Whereas the phrase I AM, meaning the God-power within, had been the song of Moses and his secret text for success, it was the expanded phrase I AM THAT I AM, meaning the universal God-power, that had been the song of Joshua and his secret text for success. (P. 14)

If Catherine Ponder is correct in her assertions, then it means that the Hebrews and the Israelites were known for their use of the Tetragrammaton, not for their denial of it. It would also mean that our proper use of the Sacred Name is a very powerful prayer tool. This tool has been lost to us for many centuries, thanks to Jewish

deception and Judeo-Christian complicity and stupidity.

Joshua, Chapter 1, tells us this:

“This book of the law shall not depart out of thy mouth; but thou shalt meditate therein day and night, that thou mayest observe to do according to all that is written therein: for then thou shalt make thy way prosperous, and then thou shalt have good success.” -- Verse 8.

The prosperity of our people is directly tied to our obedience to the Law. This is not true for the Jews. Their prosperity is based on deception, usury and theft. It must also be understood that we are talking here about **National Prosperity**. This is a national message.

We, True Israel, the Celto-Saxon People, as God’s Chosen People, have been designed by Yahweh to prosper as a nation, not as individuals. This is the Divine Economy: Saxons working together under Yah’s Law to build prosperous, just, and flourishing nations. This has always been our history until the point comes where we allow the Jews into our midst: and then the exploitation, corruption, vice, usury and chaos begin.

“Have I not commanded thee? Be strong and of a good courage; be not afraid, neither be thou dismayed: for Yahweh thy God is with thee wherever thou goest.” – Verse 9.

Our prosperity and national success are directly related to obedience to and conversation with Yahweh Himself. It must be **Both** a personal and a national walk with Him. Heretical Churchianity stresses only the personal walk. We should know better.

America became the most powerful nation on earth directly because we were once a “God-fearing people,” cooperating with one another in obedience to Yah’s Law. We are losing our nation in direction proportion to our loss of faith and heritage.

Jeremiah 33:2,3: “Thus sayeth Yahweh the maker thereof, Yahweh that formed it, to establish it; Yahweh is His Name. Call unto me and I will answer thee, and shew

thee great and mighty things, which thou knowest not.”

The Old Testament is clearly establishing a twofold pattern of success: first, we must obey His Law; second, we must call upon His Name to help us accomplish what we cannot do for ourselves. The New Testament completely verifies this twofold condition:

John 14:13-15: “And whatsoever ye shall ask in my name [Yahshua], that I will do, that the Father may be glorified in the Son. If ye shall ask anything in my name, I will do it. If ye love me, keep my commandments.”

The Gospel of John, Chapter 15, Verses 12-17:

“This is my commandment, That ye love one another, as I have loved you. Greater love hath no man than this, that a man lay down his life for his friends. **Ye Are My Friends**, if ye do whatsoever I command you. Henceforth I call you not servants; for the servant knoweth not what his lord doeth: but I have called you **Friends**; for all things that I have heard of my Father I have made known unto you.

Ye have not chosen me, but I have chosen you and ordained you, that ye should go and bring forth fruit, and that your fruit should remain: that whatever ye shall ask of the Father in my Name, he may give it you. These things I command you, that ye love one another.”

Of course, this type of “love” can only be the mutual respect created by virtue of communal obedience to Yah’s Law. Jesus was speaking to the Judahites, Benjamites and Levites of His own Family Tree. He was **Not** speaking to Christ-hating Jews of the Idumean/Edomite mixed tree, who are not capable of obeying His Law.

The Jews have always been lawbreakers, feigning piety while holding up the Torah as a prop to deceive us into thinking that they are the inheritors of the Covenants.

For True Israel, as a people, the message of biblical Christianity is clear: Call upon His Name and Keep His Commandments. This is our recipe for success. We are to work together, as a nation, as a people, calling upon His Name and obeying His Law, loving one another and

admonishing one another to do likewise. This is the only way in which we can both prosper and defeat the Anti-Christ.



In a pamphlet entitled Yahweh’s Name at the End of the Age by Yahweh’s New Covenant Assembly, we read these words:

Substitute names and titles cannot serve as translations, for the human mind cannot put into one word all that is meant by the Name Yahweh. These common substitutes conceal the Holy Name of our Creator Yahweh and make Him to appear as nothing more than just another deity, much like the pagan deities of heathendom.

Compare this statement with the diametrically opposite point of view of the editorial committee quoted above. Their opinion stated that we do not need to use His Holy Name because there are no other gods that can compete with Him. **but That Is Not the Point.**

The Point is that other gods **Do Compete with Him in Our Minds.** And when we use His Name, there is no competition because no other god is known by this name. By using His Name, Yahweh, we get closer to Him; and this is the means by which we develop a “personal relationship with God.”

Further on, the authors of this pamphlet say,

There are other arguments and excuses such as, You are trying to say that unless I pronounce a certain Hebrew name as you do, I have no salvation. Rest assured that He who created all things also created man’s tongue to pronounce His Name Yahweh. No one seems to have a problem with other biblical Hebrew names like Daniel, Ruth, and Saul, so why resist the most vital Name of all? Acts 4:12 says there IS no salvation in any other name, because Yahweh MEANS salvation!

Isn’t it simply common sense to suggest that the **Most High God, YHWH**, would have a Name reserved only for Himself? All the objections to the Sacred Name fall flat when you really

understand what His Name means and that there is no other entity like Him.

Now, it is true that the title, God,' shares some of the many connotations that His Sacred Name imply, such as majesty and power; but the word God' lacks the personal presence implied by Yahweh,' which, as Catherine Ponder pointed out, means God within. It can hardly be denied that modern religion has lost this sense of God within.

So many Christians seek their salvation through outside intercessors, such as charismatic priests and preachers, when Scripture tells us over and over, The Kingdom of heaven is within you. (Luke, 17:21.)

If it is within us, then we have the power to manifest it in the physical world. This is our challenge.

The Old Testament, in the book of Jeremiah, puts it rhetorically: "Am I a God at hand, saith Yahweh, and not a God afar off? Can any hide himself in secret places that I shall not see him? saith Yahweh. Do not I fill heaven and earth? saith Yahweh. (Chapter 23: 23 & 24.)

Indeed, Yahweh exists within our very souls, yet we perceive Him not – or better, we choose to ignore Him in favour of our earthly desires. But just as His Spirit indwells our being, His omnipresence indwells the universe itself. He is the author of all, within and without. Since He is everywhere and every time, there is nothing that can be hidden from Him.

It is ironic that so many sincere Christians are searching for something **Out There** (such as dynamic preaching) that instead needs to be brought into existence from **in Here!** Studies and questionnaires have shown that most people go to church in order to get something from the church experience.

Of course, True Christianity is the opposite of this spirit of Churchianity. That's why Jesus told us that It is better to give than to receive. Charity helps us to overcome our selfishness and narrow-mindedness because it allows us to share in Yahweh's Universal Mind.

All the self-help programs in the world cannot compare to the personal power which is

expressed by the simple phrase, I AM. This is an affirmation of Life, an affirmation of Power, and an affirmation of fearlessness in the face of overwhelming odds.

Far too many Christians go to church hoping to get something out of the church experience but they have nothing to give! The ideals of service, charity, and self-sacrifice for the benefit of one's fellow citizens are far from their minds. Rather, they look to Churchianity for validation of their self-centred lifestyles--and most of their preachers are happy to oblige with their gospel of personal gratification! -- Oh, sorry, the gospel of personal salvation.

In Matthew 22:37-40, Yahshua summarizes His instructions to those who would follow Him:

Thou shalt love the LORD thy God with all thy heart, and with all thy soul, and with all thy mind. This is the first and great commandment. And the second is like unto it, Thou shalt love thy neighbour as thyself. On these two commandments hang all the law and the prophets.

But how many of these Churchians practice these two Commandments? They hear lukewarm preaching, scarf down their pancake breakfast, and go home to their soap operas and secular, personal enrichment routines. Kingdom-building is the furthest thing from their minds, and, not surprisingly, some of them are pretty lousy neighbours!



This situation reminds me of another forgotten appellation for Yahweh, namely, **Providence**. This attribute recognizes Yahweh as our **Provider**: He who provides us with everything we need, not to mention all that we are, including our very consciousness and self-awareness.

All of these basic necessities of life and experience are provided by the Most High God, Yahweh; yet, so often we ignore Him or merely

pay Him lip service! When we act out of selfless charity, we partake of His nature, which is constantly giving of Himself to all of His creation.

When we give of ourselves we invite the divine essence to act through us and empower us. We grow in stature because we imitate Him. Contrast this philosophy with that of the so-called Gospel of Personal Salvation, which, in practice, is really the Gospel of Personal Gratification because it is not based on His Law.



Under this “dispensation,” Christians do little more than beg for personal blessings so as to be saved. Are you looking for love in all the wrong places? Instead of looking for it and asking for it, we should be giving it and doing it! Perhaps this concept is too simple to understand?

The world at large is stuck in a pitiful Woe is me attitude. They say to themselves, over and over, I am poor, I am sick, I am helpless. It’s no wonder they are sick, poor and helpless! We are looking to be loved BY others instead of bringing the Kingdom into being through our own love!

Perhaps, at this point, the problem is best stated in the form of a question: If the Kingdom of Heaven is within you, then what is preventing you from bringing it forth? With so little faith in the personal presence of Yahweh, even sincere Christians are no better than hedonistic atheists! Try affirming to yourself:

I AM a constant blessing to all those around me. See if this prayer produces a welcome attitude change. Or, try this one: “I AM a child of

Yahweh and a friend of Yahshua.” The Sacred Name is our direct connection to Him.

The Sacred Name is the means by which God enables us to share in His power, **but Only as Long as We Obey His Law.** We have to be of ONE MIND with the Father, otherwise we contradict His Will and His natural order of the Universe.

Holy Father, keep through thine own name those whom thou hast given me, that they may be one, as we are one. John 17:11. (Put yourself in the place of Jesus Christ, who is the reciter of this prayer, and see what a powerful prayer this is!)

Jesus also said “No one comes to the Father but through me.” (John 14:6.) Yahshua (Yahweh Saves) came in the flesh to redeem us for our past sins. No greater act of unselfish Love has ever been manifest under heaven.

The lesson is that we must become for our brethren what we expect them to be for us, by giving of ourselves. This is a complete reversal of worldly logic.

Worldly logic demands that we, as individuals, compete with each other for slices of a limited pie. Divine logic tells us that through brotherly love we create unparalleled abundance! – “on earth, as it is in heaven.” History has proven that there is no higher civilization than Christian civilization. When we obey His Law and are conversant with Him, we prosper nationally and individually.

There is no oneness outside of Yahweh’s Law. Combining obedience to Yahweh’s Law with this constant awareness of His presence is what Brother Lawrence called The Practice of the Presence of God. This is the True Faith! Modern Christians have such a distorted idea of faith that they substitute their own ideas for faith.

Today, it has become such a diluted idea that it means little more than I believe in Jesus, therefore I’m saved.

Talk about ignorance combined with self-flattery and self-deception! They neither obey His Law nor are they aware of His presence! It is a faith without practice! Actually, from these faithless, His Spirit has willingly departed!

“Thou believest that there is one God; thou doest well: the devils also believe, and tremble. But wilt thou know, O vain man, that faith without works is dead?” -- James 2:19,20.

Vanity indeed! We are witness to a form of Christianity which touts that salvation comes by faith only – a “faith” that works no charity! We pat ourselves on the back because we “believe in Jesus” and do absolutely nothing to follow His example—and some of us even mock His commandments.

Ernest L. Martin, in his booklet entitled, *The Divine Titles*, has this to say:

It is important to recognize the Name by which the Father of the universe is denominated. There is really nothing mysterious about His identity from the point of view of Scripture because his Name is used about 7000 times in the Old Testament alone.

It is not God or Lord alone (elohim, theos or kyrios which can refer to many lesser and even evil beings), but His actual Name is revealed in Scripture by four Hebrew letters which transliterates into English as YHWH, whom theologians today recognize as Yahweh.

He is the Supreme Elohim over all other elohim (gods), theoi (gods) or kyrioi (lords). This name is of far more esteem than Christ (Anointed One) because even human beings who were anointed priests in the Old Testament were called Messiahs or Christs (e.g. Num. 35:25). But in the Scripture there is only one Yahweh who is the Supreme God and Father of our Lord Jesus Christ. He is also the head over all things and is the one and only true Deity from whom all things exist and consist.

“Word for Word” Exodus Part 19

Translation by Stephen Howard Anderson



Chapter 25

1. Spoke Yahweh to Mosheh, saying,
2. "Speak to the children of Yisrael, so that they bring Me an offering 8641: of every man that gives it willingly with his heart you shall take My offerings.
3. And this is the offering which you shall take of them; gold 2091, and silver 3701, and bronze 5178,

4. and blue 8504, and purple 713, and scarlet 8438/8144, and fine linen 8336, and goats hair 5795,

5. and skins 5785 of rams 352 dyed red 119, and skins of [t'chashiym 8476], and wood of Shittiyim 7848;

6. olive oil 8081 for the luminary 3974, spices 1314 for oil of anointing 4888, and for incense 7004 of spices 5561,

7. stones of onyx 7718, and stones to set 4394 in the ephod 646, and in the breastplate 2833.

8. And let them make for Me a Holy Place 4720; so that I may dwell among them.

9. According to all I have shown you, after the pattern 8403 of the Tabernacle 4908, and the pattern of all the instruments 3627 of it, so you shall make it.

10. And they shall make an Ark 727 of wood of Shittiyim: two cubits 520 and a half shall be the length of it, and a cubit and a half the

width of it, and a cubit and a half the height of it.



11. You shall overlay ⁶⁸²³ it with pure gold, from inside and outside you shall overlay it, and you shall make upon it a molding ²²¹³ of gold around it.

12. And you shall cast ³³³² four rings ²⁸⁸⁵ of gold for it, and put them in the four corners ⁶⁴⁷¹ of it; and two rings shall be in the one side of it, and two rings in the other side of it.

13. And you shall make poles ⁹⁰⁵ of wood of Shittiyim, and overlay them with gold;

14. and you shall put the poles into the rings by the sides of the Ark, so that the Ark may be carried with them.

15. The poles shall be in the rings of the Ark, and they shall not be taken from it.

16. And you shall put into the Ark the Testimony ⁵⁷¹⁵ which I shall give you.

17. And you shall make a kaporeth ³⁷²⁷ of pure gold, two and a half cubits shall be the length of it, and a cubit and a half the width of it.

18. And you shall make two kerubiym ³⁷⁴² of gold, of beaten work ⁴⁷⁴⁹ shall you make them, in the two ends of the kaporeth.

19. And make one kerub on the one end, and the other kerub on the other end: and on the kaporeth you shall make the kerubiym on the two ends of it.

20. And the kerubiym shall stretch forth ⁶⁵⁶⁶ their wings ³⁶⁷¹ on high ⁴⁶⁰⁵, covering over the kaporeth with their wings, their faces one to another; toward the kaporeth shall be the faces of the kerubiym.

21. And you shall put the kaporeth upon the Ark from above ⁴⁶⁰⁵; and in the Ark shall you put the Testimony that I shall give you.

22. And there I will meet with you, and I will speak with you from above the kaporeth, from between the two kerubiym which are upon the Ark of the Testimony, concerning all things which I will give you in commandment to the children of Yisrael.

23. You also shall make a table ⁷⁹⁷⁹ of wood of Shittiyim, two cubits shall be the length of it, and a cubit the width of it, and a cubit and a half the height of it.

24. And you shall overlay it with pure gold, and make for it a molding of gold around it.

25. And you shall make for it a border of a handbreadth around it, and you shall make a golden molding for the border around it.

26. And you shall make for it four rings of gold, and put the rings in the four corners that are on the four feet of it.

27. The rings shall be over against the border for places of the poles to carry the table.

28. And you shall make the poles of wood of Shittiyim, and overlay them with gold, so that the table may be carried with them.

29. And you shall make the dishes ⁷⁰⁸⁶ of it, and the spoons ³⁷⁰⁹ of it, and covers ⁷¹⁸⁴ of it, and cups ⁴⁵¹⁸ of it, to cover ⁵²⁵⁸ all of it: of pure gold shall you make them.

30. And you shall set on the table bread ³⁸⁹⁹ of the presence ⁶⁴⁴⁰ in My presence always ⁸⁵⁴⁸.

31. And you shall make a menorah ⁴⁵⁰¹ of pure gold: of beaten work shall the menorah be made: its base ³⁴⁰⁹ and its branches ⁷⁰⁷⁰, its bowls ¹³⁷⁵, its knobs ³⁷³⁰ and its flowers ⁶⁵²⁵, shall be of the same.

32. And six branches shall come out of the sides of it; three branches of the menorah out of one side, and three branches of the menorah out of the other side:

33. Three bowls made like almonds ⁸²⁴⁶, with a knob and a flower in one branch; and

three bowls made like almonds in the other branch, with a knob and a flower: so in the six branches that come out of the menorah.

34. And in the menorah shall be four bowls made like almonds, with their knobs and their flowers.

35. And there shall be a knob under two branches of the same, and a knob under two branches of the same, and a knob under two branches of the same, according to the six branches that proceed out of the menorah.

36. Their knobs and their branches shall be of the same, all of it shall be one beaten work of pure gold.

37. And you shall make the seven lamps 5216 of it: and they shall lift up 5927 the lamps of it, so that they may give light 215 upon all sides before it.

38. And the snuffers 4457 of it, and the snuff holders 4289 of it, shall be of pure gold.

39. Of a talent 3603 of pure gold he shall make it, with all these utensils 3627.

40. And see that you make them after their pattern, which was shown to you in the mountain.



Earliest New Testament Was from Edessa

WHEN WAS THE NEW TESTAMENT (NT) FIRST WRITTEN? Although some NT fragments date from the 2nd century, the first complete texts only date from the 4th century.

The Greek Codex Sinaiticus is regarded as the oldest New Testament, and that was written circa AD 370 in Greek. But what if I told you, that the earliest complete NT actually dates from AD 78?

That it was written in Edessa by Achaeus-Aggai, in the Edessene-Syriac language and script? And that it still resides in the Vatican even today?

Could that be possible?

There is a mention of this very early NT by Bishop Machicha of Gesluna in Mesopotamia (AD 1096-1110). The following quote comes from the 1721 Bibliotheca Orientalis by Vatican librarian Joseph Assemani. The Bibliotheca Orientalis is an index of eastern manuscripts held in the Vatican Library. 
went to Edessa in the (supposed) classical date of the late AD 20's, his Edessian disciples were Achaeus-Aggai and Mari-Palut. But Achaeus-Aggai then delayed a further 50 years, before writing the first New Testament in AD 78. Why was that?

The answer from my Edessian Gospel Theory is obvious. The visit of Thomas-Addai to Edessa actually took place in the AD 50's, during the Council of Jerusalem, and the NT gospels actually detailed the Jewish Revolt of the late AD 60's. So the most reasonable decade for the compilation of these texts was in the AD 70's.

Just as Josephus (Saul) was scribbling away in Roman Judaea in the AD 70's, so Achaeus-Aggai was similarly scribbling away in Nazarene Edessa in the AD 70's. Once again, the novel Edessa Gospel Theory explains the previously inexplicable.

Thirdly:

The problem for the Catholic Church that this very early NT represents, is that it was written in Edessa before Catholic censorship had been invented, so it could have said anything. It could have detailed many Christian heresies.



Remember that the Edessian Old Syriac Sinaiticus New Testament mentioned in a previous post, was from the 4th or 5th century, while the earlier Greek Codex Sinaiticus was from the mid 4th century. And this was an era when much of Christianity had been brought much closer to the Catholic canon.

But a New Testament written just eight years after the revolutionary events that it detailed, could have said anything. Remember that the 4th century Codex Sinaiticus contained thousands of textural variations, in comparison with the King

James Version which was regarded as authoritative at that time, including the Gospel of Mark ending on verse 16:8 instead of verse 16:20.

So what might a 1st century NT have said, that had been written in the city that had known the secular Jesus? That understood that Jesus had been a king of their very city?

What might the Edessian NT have said?





Strange Deaths of Racehorses at Churchill Downs

Racehorses at Churchill Downs

Horse named **Lost in Limbo** dies at Churchill Downs

Racehorses are among the most finely tuned, exquisitely sensitive creatures on earth. So what happens when you give them all cell phones to wear during a race? They start dropping like—well, horses.

That is exactly what started happening this spring at Churchill Downs in Louisville, home of the world-famous Kentucky Derby. Churchill Downs hosts three “meets” every year during which there are horse races four to five days a week -- a spring meet lasting all of May and June; a September meet; and a fall meet throughout November.

The spring meet this year at the Downs began on April 29 and was to continue until July 3. And beginning on April 29, and in every race on every day thereafter, every horse was fitted with a device they had never worn before. It is a wireless device, shaped like an iPhone, that fits into the cloth underneath the saddle on the horse’s back. Horses also began wearing these devices this spring during morning workouts.

This **STRIDE-Safe** device monitors the horse’s movements 2,400 times per second throughout the race, sending 2,400 pulses of radio frequency (RF) radiation every second through the body of the horse. It also contains a GPS component that communicates with global positioning satellites.

It also communicates with the RFID chip implanted in the left side of every horse’s neck, ensuring that the chip also emits radiation

throughout the race. And because every racehorse wears horseshoes made of aluminum, which is one of the best conductors, the frequencies that are conducted from both the **STRIDE-Safe** device and the RFID chip throughout the horse’s body are absorbed and reradiated by its four shoes.

Each horse, then, carries not one but six continuously radiating antennas throughout each race at Churchill Downs. So with 14 horses normally competing in each race, there are 84 antennas among animals in close proximity to one another running around the track.

And on April 29, 2023, horses racing at Churchill Downs began to die during races or suffer such severe injuries during races that they were euthanised. So many horses have died this spring that on June 2 it was announced that the spring meet at the Downs would be suspended as of June 10. Officials at Churchill Downs are panicked because horses racing there have died in much larger numbers this spring than ever before.

Churchill Down Race Course



In 2022, nationwide, about 1.25 deaths occurred for every 1,000 horses starting at the gate. But since April 29, 2023, 12 deaths have occurred among just 1,600 starts at Churchill Downs, a sudden and unprecedented 8-fold increase in racehorse mortality.

Officials have carefully inspected the track and every part of the racing grounds and have found

no change in any part of it from previous meets, and no reason for horses to be more prone to injury or collapse. But they have the same blind spot as the rest of society: they treat wireless devices, and the radiation they emit, as if they do not exist.

The horse named Parents Pride simply collapsed and died for no apparent reason during a race on April 29. No drugs were found in her system, and no poisons. She was running normally before the race. No abnormalities were found in her heart, brain or lungs.

Code of Kings “flipped” and broke his neck in the paddock just prior to a race and was euthanised, also on April 29. The paddock, also called the parade ring, is where horses are paraded before a race so the race-goers can get a good look at them.

Take Charge Briana suffered catastrophic damage to her right foreleg during a race on May 2 and was euthanised.

Chasing Artie completed his race on May 2 and then collapsed and died on his way to the unsaddling area, for no apparent reason.

Chloe’s Dream suffered a “catastrophic injury” to his right knee during a race on Derby Day, May 6, and was euthanised.

Freezing Point fractured his left forelimb during a race on Derby Day, May 6, and was euthanised. His jockey said that he was not bumped during the race and that the track was in good condition. Bosque Redondo finished his race on May 13 but was taken away in a horse ambulance and was euthanised due to unspecified injuries.

Rio Moon was at the finish line of a race on May 14 when he suffered a “catastrophic injury” to his left foreleg and then was euthanised.

Swanson Lake finished his race on May 20 but was immediately taken to a veterinarian where he was euthanised because of a “significant injury” to his left hind leg.

Lost in Limbo, the horse pictured at the top of this newsletter, was removed from the track near the finish of a race on May 26. He had crashed nose-first on the track and lay heaving in the dirt. He was so jittery even before the race that he

threw his jockey before it started and bolted. After the race a veterinarian found a “significant injury” to his left front leg and he was euthanised. Kimberley Dream ruptured a ligament in her left front leg during a race on May 27 and was euthanised.

And two days before the spring meet began, while training on the racetrack on April 27, Wild on Ice broke his left hind leg and was euthanised. We have known for decades that horses’ lives are shattered by radio waves.



Hearings were held in Christchurch, New Zealand, and racehorse trainer Penny Hargreaves (above) spoke out in an interview published in 1998. An FM radio tower in Ouruhia had had such devastating effects on her 90 horses that she was forced to relocate them to a different part of Canterbury. All her horses were affected, some more than others, and two died.

“They were very nervous and jumpy,” she said. “They all seemed to have sore feet. Horses who had travelled by trailer for years were losing balance while travelling. We have several hot spots around our yard where the horses become very volatile and hurt themselves and us.

“Our very valuable colt had serious health problems and walked as if his feet hurt. He could not bear to be shod. We had many vets look at him to try and solve his problems, but without any satisfactory answers.

We finally turned him out in a paddock which has a large hay barn and trees between him and the tower. Within a month he had no problems at all. Back in his old yard, the problem returned.

“The blacksmith gave evidence at our hearing on the effect of the radio waves on our horses’ feet. The aluminum conducts electricity and their feet had changed shape, had huge cracks where the nails went and were very sensitive inside.

“We had weekly problems with infections we have never had before, our vet bills were horrendous.”

Integrity and Safety Authority (HISA). She has been leading a review of the records of the horses that died.

Nervous and jumpy racehorses with sore feet and lack of coordination. Exactly what has been happening at Churchill Downs during the spring meet this year.



When I learned what was happening at Churchill Downs this spring I sent an email to Dr. Jennifer Durenberger, suggesting to her that the STRIDE-Safe devices, which have been deployed at Churchill Downs for the safety of the horses, are instead killing them. She has not responded.



almost constantly. In the heart of this religious upheaval stood Edmund Bonner, the enigmatic Bishop of London.

Revered by some and reviled by others, Bonner's name became synonymous with persecution and zealotry.

As a staunch defender of Catholicism, he sought to extinguish the flames of Protestantism and restore the authority of the Catholic Church.

His actions during the reign of Queen Mary I earned him infamy, but his ultimate fate would be shaped by the winds of change that swept across the English landscape.

THE ENGLISH REFORMATION was a tumultuous era during which religious convictions clashed and power shifted

Edmund Bonner and His Crimes

Born in 1500, Edmund Bonner was an incredibly influential figure during the English Reformation, serving as Bishop of London from 1539 to 1549 and again from 1553 to 1559. Today he is primarily remembered for his role in persecuting Protestant reformers under England's Catholic Queen Mary I, known as Bloody Mary.

But interestingly, before he made a name for himself killing Protestants, he actually played a key role in separating England from Rome during the reign of Mary's father, Henry VIII. It was Bonner who the King sent to the Vatican to argue for his divorce, and he stayed loyal to the King after his split from the Catholic Church.

However, unlike other religious figures involved in the English Reformation, Bonner stayed loyal to Catholicism. It was only after King Henry VIII died on 28 January 1547 Bonner's views began to change.

He started to put his loyalty to his religion ahead of his loyalty to the Royal family. This shift in loyalty only hardened as he became increasingly enraged by the reforms being brought in by Protestants like Edward Seymour, 1st Duke of Somerset, and Archbishop Thomas Cranmer.

Bonner's antagonism towards Protestantism landed him in jail twice during the reign of Edward VI, Bloody Mary's predecessor. He was first imprisoned in 1547 but quickly wormed his way out by apologizing to the King. He was then imprisoned again on 7 February 1550 after being found guilty of breaking religious laws and

failing in his duties. He stayed in prison until Mary came to power in 1553.

Papal Resignation and Papal Murder: Popes Celestine V and Boniface VIII

As soon as Queen Mary was crowned Bonner was released and once again made the Bishop of London. Mary was a die-hard Catholic and she made it his job to restore Catholicism to the land and submit once again to papal jurisdiction (despite his role in severing it in the first place).

Mary believed that religious dissidents (aka Protestants) would be best dealt with by ecclesiastical tribunals rather than by civil power.

This meant that Bonner was essentially given free rein to deal with dissidents however he wished. He chose a stick rather than a carrot approach, earning him the name "Bloody Bonner." He carried out:

1. Heresy Trials and Executions: He presided over heresy trials where those accused of holding Protestant beliefs were prosecuted. He used this position to condemn prominent figures of the English Reformation who he'd fallen out with in the preceding years. Men like Thomas Cranmer, Hugh Latimer, and Nicholas Ridley were all sentenced to death. Their deaths were not pleasant, they were burned at the stake for heresy.



2. Suppression of Protestantism: To be fair, Tudor England wasn't exactly known for religious freedom, but Bonner took it to new heights. He ordered the removal of Protestant texts and images from churches and replaced

them with Catholic equivalents. He also oversaw the enforcement of Catholic doctrines and rituals, including the use of Latin in religious services. Possession of Protestant texts and images was made a punishable offence: [Video Here](#).

3. Persecution and Imprisonment: Bonner authorized the imprisonment and torture of individuals suspected of being Protestant reformers. Many Protestants were held captive in the notorious Newgate Prison in London, often subjected to harsh conditions and mistreatment.

Bonner's actions contributed to the atmosphere of fear and persecution that characterized the reign of Queen Mary I. Official numbers vary but between 250- 320 people are thought to have been tried and burnt at the stake. Countless others died during their incarceration due to the grim conditions.

4. Enforcement of Marian Religious Policies: Bonner was a key enforcer of Queen Mary I's religious policies, which aimed to restore Catholicism as the official religion of England. As such he worked diligently to tear down all the changes made in recent years and he actively supported the revocation of Protestant reforms implemented by Henry VIII and Edward VI, and worked to reinstate Catholic practices and doctrines.

Motives

One might wonder why a supposedly pious man would so ruthlessly pursue the imprisonment and persecution of other Christians. Well, his motivations can only be understood within the context of his strong Catholic beliefs and his loyalty to the Catholic Church.

Sir Francis Walsingham: Who was Queen Elizabeth's Spymaster in Chief?

The Duke of Buckingham: Was Dumas's Hero also James I's Lover?

Bonner was a fervent, fire-brand Catholic who was utterly devoted to the teachings and doctrines of the Catholic Church. There was no room for doubt in his mind and he saw Protestantism as a heretical deviation from the true faith.

He saw it as his duty, his mission from God, to combat and suppress what he saw to be false beliefs. Bonner believed that by eradicating Protestantism and restoring Catholicism, he was safeguarding the spiritual welfare of the people. In his eyes, he was the good guy.

Bonner was also loyal to the crown. He had once been one of Henry's most loyal servants and his loyalty was renewed when Mary, a fellow staunch Catholic, was crowned. Mary was determined to return England to Catholicism and reverse the religious reforms implemented by her predecessors, particularly her father, Henry VIII, and her brother, Edward VI. Bonner's actions can be seen as an expression of his loyalty to the queen and his commitment to implementing her religious policies.

The Fall Of Bloody Bonner

Unfortunately for Bonner, Mary's reign was short-lived, and she was soon replaced by her sister, Elizabeth, a protestant. When Elizabeth was crowned in 1558, she made it clear she wished to pursue a religious settlement that aimed for religious moderation and tolerance in the country. There was no room in her church for Bloody Bonner.

He was quickly asked to resign his bishopric, but he replied that he would rather die than resign. In 1559 he was forcefully removed from his position and was replaced by a Protestant Bishop of London. On 20 April 1560, he was once again sent to Marshalsea prison.

Bonner spent the last nine years of his life imprisoned. The Protestant Party spent that entire time trying to have Bonner and other Catholic

figures like him executed on religious charges as well as high treason. They never got their way, but Bonner did die in prison. He died on 5 September 1569 and was quietly buried in St George's, Southwark. He was still a high-profile enough figure that this burial was conducted in secret to avoid violent protests.

Edmund Bonner's legacy remains a haunting reminder of the religious conflicts that defined the English Reformation. His fervent pursuit of Catholic orthodoxy, coupled with his relentless persecution of Protestants, left an indelible mark on history.

While his actions were driven by his deep-seated religious convictions and loyalty to the Catholic Church, they also sparked outrage and resistance among those seeking religious reform.

Ultimately, Bonner's fall from grace mirrored the shifting tides of religious and political power, as the ascension of Queen Elizabeth I relegated him to a life of arrest and obscurity. Edmund Bonner's controversial tale serves as a poignant reminder of the price paid during an era of religious strife and the lasting impact of individual convictions on the course of history.




Remember there are ten virgins, but only 5 of them had enough oil to get into the wedding. Oil is knowledge. Look it up. Run references throughout the Old Scriptures. True believers (disciples) seek knowledge.

In this article we will explore the actual identity of the two witnesses using the Biblical principle

of understanding God's word through the principle of allegory.



Touching on the Bible definition of **the Two Witnesses**, almost all eschatologists have a theory about who the two witnesses are. Enoch and Moses. Moses and Elijah. Enoch and Elijah and so on. As far as this author knows; no other author has written on what this article is about to expound.

The Bible tells us in plain language, which we should all understand, exactly who the two witnesses are. Still even after having the Bible opened in front of their faces of so many; they will walk away and tenaciously hold to their former belief.

It is much like when you try to tell them about the lie that damns our people. They jab their fingers so deep into their ears they could not hear Gabriel's trumpet if it were to sound at that moment.

Without further ado; let's go straight to the scripture and see what it tells us and see how readily this truth will be received. We will examine the scripture carefully parsed (divided) with commentary. Read Carefully. "But now thus saith the Lord that created thee, O Jacob, and he that formed thee, O Israel, Fear not: for I

have redeemed thee, I have called thee by thy name; thou art mine." **Isa 43:1.**

Most readers will immediately balk at the notion that Jacob and Israel are two separate entities. How often they will say 'But Jacob IS Israel' or vice versa. Certainly, Isaiah sees them as 'two'.

They must be two if they are one in the same as the witnesses in the Revelation passage that refers them as "two witnesses," Look and learn. The first thing we note about this passage is the very thing that throws most students, pastors, and eschatologist completely off the mark. The passage plainly says:

1. Jacob is created, and
2. Israel is formed.

In spite of the fact that one is created and one formed; most readers go right on never seeking to understand the significance of that conundrum. It is not the first place that particular verbiage is used. We will see both usages have the same import and the first usage shines light on this passage in Isaiah. So, let's look at awdam/Adam first. **See above table.**

Genesis 1:26-28 talks about God **creating** man. Verse 27 reads "*So God **created** man in his own image, in the image of God created he him (mankind): male and female created he **them.***"

Most expositors tell us the man created on day 6 and the man named Adam are one in the same.

They tell us Genesis 2 is just an elaboration of the original creation and gives more specifics on how it was done. That cannot be true because if it is true then the Bible contradicts itself right from the beginning.

Created

Mankind was created on the sixth day. The word created in the Hebrew is generally understood to refer to something being made from nothing which only God can do. In contrast to this man, sometime after the creation week (including the seventh day sabbath) God decided he needed a man to till the garden and Adam was chosen from mankind created on the sixth day.

This is in keeping with the Bible concept of being chosen. *'Many are called but few are chosen.'* Day six man was called. Adam was chosen. This concept is exactly the principle of the allegory given by the reality of the original creation. Mankind was called. Adam was chosen.

After Genesis one; the Bible is about the man named Adam and his progeny. Other races were not addressed except when and where they interacted with the Adamic race.

The Bible does not tell us when they were created; nor does it tell us much about them at all other than to separate ourselves from them lest they lead us away from our God. Science tells us humans have existed in Africa for 60 thousand years; Asia 90 thousand years and Micronesia for 150,000 years.

The Adamic race has been here for about 5998 years. The truth is we do not know when they came into being.

26 And God said, Let us make man in our image, after our likeness: and let them have dominion over the fish of the sea, and over the fowl of the air, and over the cattle, and over all the earth, and over every creeping thing that creepeth upon the earth.

27 So God created man in his own image, in the image of God created he him; male and female created he them. – Gen 1:26-27

Mankind created on the sixth day was created in the image and likeness of God. They looked like and acted like God.


IMAGE – LIKENESS

An image is a physical representation which has physical attributes suggesting the attributes of the idea or thing the image represents.

In the meaning of the word image in the original language, it represents a shadow or phantom; a resemblance. In the case of man; he is an image of God. His physical traits would then have things which represents who God is and what he can do. What as we are, gives us insight into what God can and does do.

Man has a mouth which tells us God has some means to communicate with us. Many examples of the Lord speaking to his people exist in scripture. He speaks through parable, inspiration and the written word; all of which can be likened to his mouth.

Man Has Ears and Eyes



“The hearing ear, and the seeing eye, the LORD hath made even both of them.” – Prov 20:12

“He that planted the ear, shall he not hear? he that formed the eye, shall he not see?” – Ps 94:9

The Lamb (God) is clothed in white, is represented by the aura of the man created that day. White alludes to the purity and holiness of God.

We can readily see none of these things are physical when it comes to the Supreme being. In the image God made, they are physical representations of God's attributes.

They also had the means to reproduce. These things mean they had physical attributes which allegorically symbolized the attributes possessed by their heavenly Father. Logically, that leads us to understand they were to be his emissaries to a darkened world. They were the original lights to show God to the world. They were His messengers. (SEC OT:4397 ambassador, angel, king, messenger.)

LIKENESS

In contrast to image, God's likeness simply means they had God's spirit (character, will, desires, nature) from the beginning. Had they maintained those things

they would have likely never died but continued to this day. They were God's messengers (angels) to dominate and restore the earth; to go forth and to multiply more images of the Almighty. This race of man failed and lost their first estate, reserved in everlasting chains under darkness unto the judgment of the great day[2] This does not say they are eternally damned as many teach. It simply means their original state could never be regained short of a great redeeming plan ordained by the Almighty.



Earth is a type of mankind. Water is a type of the spirit of God. Physically the men created on day six, contained within their cells the same material and atoms contained in the earth. Once they fell (lost their likeness to God) they became dry and clay turned to dust.[3]

This image of God (adamic man) was a living breathing creature. That is the very definition of the word **SOUL** given in scripture (more below).

God does not make mistakes. One should recognize the difference between his plan and his will. He knew from the creation he would need Adam to fulfill his plan. He knew from the creation that Adam would also fail. He knew from creation mankind and the Adamites would need a Savior and hence the reference to Jesus as *'the Lamb slain from the foundation of the earth.'*

Baptised - Formed

The Bible tells us the man named Adam after the original creation (adamites), was **formed** from the dust of the earth. Using the Biblical method

of operation ordained by God we can recognize the dust he came from was the original creation of mankind. That dust had failed in its assignment and became very dry.

You cannot form or mould dry dust. It had to be made wet and the ceremonial observance of baptism was born. God had to make this man wet for him to be moulded. He had to be immersed in the Spirit of the almighty. Then the forming process could begin. This too is a great allegory.

The baptism of individuals as well as the baptism of the race is implied throughout scripture. Both mankind and the Hebrew race are likened to 'earth'. The forming of individuals, mankind and the Hebrew race are all filled with indeterminate periods of time in which they dry out and must be re-immersed in the water of God's spirit.

The forming process can take years with some, and shorter periods of time with others. In the case of the Hebrew race, it has taken thousands of years and is still in action. God is at this time completing his work in the moulding of mankind.

The Breath of Life

Once the dust was gathered and the baptism performed the forming process could begin. Considering the allegorical nature of this account, we can see that the moulded creature God had formed physically was nothing short of an exquisite piece of artwork. A magnificent sculpture of a good-looking hunk of inanimate clay lying lifeless on the ground. Something else was needed.

“And the Lord God—breathed into his nostrils the breath of life; and man (Adam) became a living soul.”

We know the original creation were living and breathing souls because they were given dominion and had power to reproduce and replenish the earth. Remember the principle God gives in scripture. They physical always precedes the spiritual. Hence, we can know the story of the man named Adam in Genesis two (while it really happened in a real physical way) must represent the spiritual principle of:

1.) baptism and 2.) the forming process in a spiritual way.

Breath in this passage comes from the Hebrew word *neshamah* meaning a puff or wind. It is the wind or life we know as air. It is carried in the blood stream and animates the brain and we **become** a living soul. When it ceases to enter our lungs and flow through our blood; we die. When God breathed his breath (life essence) into Adam; he was giving him another change. He was reanimating one dead in trespasses and sins into a new creature.

The word soul, simply means that which lives and breathes or that which has life. When the Bible is talking about mankind, it is translated as soul. When it is talking about an animal; it is translated creature. In the scriptures we find the penalty for certain violations of the law required souls being cut off. That meant killed.

We find souls committing trespasses and sinning; souls eating; souls touching unclean things; dead souls, hungry souls, tired souls, thirsty souls, guilty souls, bound souls and many, many other usages showing us that soul is nothing more than the living creature be it man or beast.

“The soul that sinneth it shall die.” – Eze 18:20. When a soul dies, their breath is taken away, they die and return to dust[4]. Just as God told Adam later under the curse for disobedience; ***“In the sweat of thy face shalt thou eat bread, till thou return unto the ground; for out of it wast thou taken: for dust thou art, and unto dust shalt thou return.”***

Ecclesiastes 12:7 tells us when a man dies; ***“Then shall the dust return to the earth as it was: and the spirit shall return unto God who gave it.”*** The word translated spirit in this passage also means ‘air; anger; blast; breath—In this instance, it is literally the essence of life. When a man dies, his soul, made of dust returns to dust and rots in a grave.

The spirit (life) returns to God who gave it. God is the creator, purveyor and repository of all life. One who has his name written within the book of life, even though he is dead, will have life given to him again at the moment of his resurrection.

Until then, biblically speaking he is dead, he is asleep and knows nothing at all. This is always how it was referred to by both Jesus and Paul[5]

God chose Adam. The only logical thing to believe is that Adam was chosen because God knew his heart. God did not need to send a SWAT team to bring Adam to the garden. He simply drew him there by his Spirit. There he was baptized and the breath of life entered into him. Can you see it?

- *“For many are called but few are chosen.”*
- *“No man can come to me, except the Father which hath sent me draw him.”*
- *“Repent and be baptized every one of you in the name of Jesus Christ for the remission of sins... and ye shall receive the gift of the Holy Ghost.” **This is the anti-type of what happened in the garden.***



Breath of life in the Hebrew comes from **neshamah**: a puff, i.e., wind, angry or vital breath. It is the life essence for a mortal man. The counterpart in Greek is **pneuma**: a current of air; i.e., breath. It is the word we get pneumonia or pneumatic from in our English language.

In the New Scriptures it is often translated ghost. When Holy Ghost is used; it is the life essence of a mortal man’s spirit. It is the spirit and nature of God. In other words, it is necessary for the spirit to be alive in Christ.

In the second chapter of Acts, Peter was speaking to Israelites. Verse 36 says:

“Therefore, let all the house of Israel know assuredly, that God hath made that same Jesus, whom ye have crucified, both Lord and Christ...”

“...now when they heard this, they were pricked in their heart and said unto Peter and to the rest of the apostles, Men and brethren, what shall we do?...”

*“...Then Peter said unto them, Repent, and be baptized every one of you in the name of Jesus Christ for the remission of sins and ye shall receive the gift of the Holy Ghost.” **The essence of life for a true Christian.***

In short, the spirit of man has dual meanings. Firstly, it is the breath of life. The animating power of God breathed into a man until the day he dies. Secondly, it is his character; his mind-set; his moral code which is either of man with its avarice and lust of the flesh exuding the fruit of the flesh; or it is of God bearing the fruits of the Spirit; joy, peace, longsuffering, kindness —etc.

When a man dies; the first spirit returns to God who gave it. That is the spirit of life imparted to us by God. The spirit of man ceases to exist until the great day when the dead in Christ are resurrected (at the last trump) and the spirit (breath) of life again reenters their being.

“Then shall the dust return to the earth as it was; and the spirit shall return unto God who gave it.” Ecc 12:7

Praise ye the LORD . Praise the LORD , O my soul.

² While I live will I praise the LORD : I will sing praises unto my God while I have any being.

³ Put not your trust in princes, nor in the son of man, in whom there is no help.

*⁴ His breath goeth forth, he returneth to his earth; **in that very day his thoughts perish.**” – Ps 146:1-4*

*“For the living know that they shall die: **but the dead know not anything,** neither have they any more a reward; for the memory of them is forgotten.” – Eccl 9:5*

“For the Lord himself shall descend from heaven with a shout, with the voice of the archangel, and with the trump of God: and the dead in Christ shall rise first...” – 1 Thes 4:16

Neither time nor space will allow the study on what people perceive about spirit life or near-death experiences. Death in the scripture is likened to sleep and it is much like that or like when one becomes unconscious due to anaesthesia. One minute he is conscious, the next

he is not ... until he is again. For the time he is unconscious; time stops still. Therefore, we can see this. The living believe our loved ones have been gone for some time; yet when they wake up; it will be the instant after they physically died. One should be able to see that time stopped for them and it is as they never died if indeed they died in Christ.

Either we believe the Bible or we do not. Think on these things.

Restrictions Placed on Adam



The remaining differences between mankind of Genesis one and Adam in Genesis two pertained to domain, occupation and diet.

1. DOMAIN – In contrast to mankind of Genesis one who was given the entire earth, Adam’s dominion was restricted to the garden in Eden.

Both Eden and garden are words that are important to understanding this passage.


Eden in the original language comes from a word meaning delicate, delight or pleasure. In addition to God’s word and salvation, it was also an allegory for the bosom of God. God had indeed chosen to place Adam in a location that would be for his delight and pleasure.

The other word; '**garden**' means a fenced place. It also means 'defence' or protection (*SEC OT:1598 ganan*: to hedge about, protect, defend. The fence God provided, not only contained Adam and kept him separated from the rest of the 'earth', it also **provided protection from anything outside which could or would harm him.** Everything except one.

The only thing in the garden that could possibly harm the original couple was themselves. God had given them dominion; free will and the only

thing that could possibly trip them up was their own carnal lust. This alone should forever put the notion of Lucifer being in the garden aside. Not possible. What would be the purpose of a wall of protection if it didn't work?[6]

In the description given of the garden in Eden we also see a pattern very similar to the tabernacle. Could it be the pattern God showed Moses on the mount?[7]



had never felt immediately flooded their beings and they were afraid. It is death referred to in Ephesians 2:1:

“And you hath he quickened, who were dead in trespasses and sins.”



Adam was meant to be the instrument of God to bring the original creation back to their original likeness and image of God. Adam failed and consequently left all

mankind in their fallen state. HIS act brought death into the world. This moment of Adam and Eve's spiritual death was demonstrated by the curse placed upon them by God in Gen 3:16-19.

“Wherefore as by one man sin entered into the world, and death by sin,

and so death passed upon all men for that all have sinned.” – Rom 5:12

“For if by one man's offence death reigned by one; much more they which received abundance of grace and of the gift of righteousness shall reign in life by one, Jesus Christ.” – Rom 5:12 & 17

Do you recall what happened to those who entered without a right to do so?

2. OCCUPATION – In contrast to mankind, Adam was given an occupation. He was to till the Garden in Eden. Eden meant delicate, delight or pleasure. It was a delight to God and an indication of his desire to share with mankind. Undoubtedly it was allegorical for his word or salvation. It was his will and intention to be expanded and distributed to all mankind. It was a type of salvation which provided spiritual life to mankind (the earth).

3. DIET – In contrast to man's diet, Adam's diet was restricted. At least it was more specifically restricted than the man of Genesis one. He was expressly commanded **“...the tree of the knowledge of good and evil, thou shalt not eat of it: for in the day that thou eatest thereof thou shalt surely die.”**

Adam did later eat from this tree. In as much as he did not die a physical death that very day, reveals the greater allegorical meaning that it is talking about a spiritual death. It is not talking about the great 1000-year day as many suppose. The spiritual death Adam and Eve experienced was immediate the moment they ate of the tree. They knew it immediately and knew they were naked and ashamed. An unknown emotion they




I was unable to find the version which you quote, but here in the UK, rapturists point to this KJV verse:

The screen shots of the dictionary translations give lots of useful information.

It's easier to read them than it is for me to retype what is already stated and make this post much longer than it needs to be.

I should probably mention for those who are unaware, you will often see the use of the letter Z in the words, I won't go into the explanation as to why this is, but it is the equivalent of DD.

I will be showing that the term Celt/Celtic is not a recent term and it goes back before Romans were in Britain, however it's the definition/way it's used, that is the issue, not the existence of the term itself.

Another term which falls under the same issue, is the term Wales and I will be explaining its true meaning.

Also I will be explaining why the term Wales and it's true origin Gâl is also important and all 3 terms are very important when you know their true meaning and why it was so important to hide and disguise their true meaning as is true of the history of Britain as a whole, it's all part of the same conspiracy.

I will start with the word Celt, from which Celtic derives.

As you can see on the previous page screen shot, shows Celt is a Welsh word meaning a covert/shelter.

The English word Celtic takes the welsh word Celt with the English suffix -ic. The -ic suffix mean "of or pertaining to".

The Welsh equivalent of Celtic is Celtiad meaning, one that abideth in a covert or an inhabitant of the wood, a Celt (as in the English term Celt).

It is the same import as Gwyzel (Gwyddel), Ysgodawg, Celyz (Celydd) Gwyddel, that is of the woods, it is the Welsh for a native of Ireland.

There is also a Gwyddelwern in Denbighshire, Gwyddel + (G)wern, Gwern was the son of Matholwch, King of Ireland and Branwen, sister of Brân the Blessed, King of Britain Ysgodawg, Sheltered, Shadowed, frequenting shades, it is the Welsh for a Scot, the Scots were Irish and the origin of Scotland. Celydd, a sheltered place, a retreat, a woody shelter.

Celyddon is the welsh name from which the romans named Caledonia.

Coed Celyddon The Forest of The Celts

Culhwch from the story Culhwch and Olwen was the grandson of Celyddon Wledig (Prince of the Celts).

So a Celt was anybody who inhabited woods/forests, they were a primitive being, a savage, a wildling, the stereotypical depiction of a pagan in modern literature, a Pict for example. Essentially a Celt was a term like caveman but instead of living in caves, they lived in a wood/forest, a treed area.

It was not geographically specific, they would have been referred to as a Celt anywhere in the world if they lived in a treed area.

After the end of the ice age when Britain stopped being under ice and the treed areas came to be and the land became inhabitable again, those who re-inhabited the land would have been 'Celts'

In today's time, there are no Celts in Britain, maybe a handful if I am being generous, but they are more likely to be just homeless than anything, you don't really see people living in the woods, not in the manner that the term Celt means anyway, it's a way of life that has pretty much gone extinct.

Gwýzel, s. m.—pl. t. od (gwýz) That is of the woods, that is in a fylvan ftate; a savage. It is an appellative, synonymous with *Celt*, and *Yfgotiad*, for an individual of such tribes as lead a venatic life in woods, in contradistinction to the *Gâl*, living by cultivating the ground. Whichever of these two primary classes of mankind had the ascendancy gave its name to the whole country: Hence *Gwyzel* is the general term in Welsh for a native of Ireland, because the tribes of which the name is descriptive appeared predominant to those who imposed it. There is a tradition of Wales's being once inhabited by the *Gwythelians*, or more properly its first inhabitants were so called; and the common people, in speaking of it, ascribe some ruins about the country under the name of *Cytiau y Gwyzelod* to them; and the foxes are said to have been their dogs; and the polecats their domestic cats, and the like.

Now when the migrations happened to Britain from the Middle East, they were an advanced, educated, sophisticated group of peoples.

This is where the term Gâl comes in.

In Welsh Gâl was the open plains, as opposed to the woods. The Gâl inhabited the open plains and built structures and cultivated the land, made settlements, built the star maps, mined the land, mined the copper in the Great Orme and the tin in Cornwall and used the coal in the south of Wales to create the Bronze.

Galles - Corsican

Gales - Galician

Galles - Italian

Tara Galilor - Romanian (the country of the Gal)

Gales - Spanish

Gal Ulkesi - Turkish (Country of the Gal)

Galler - Turkish

Celyz, *s. m.*—*pl.* on (cêl) A sheltered place, a retreat, a woody shelter. *Celyz Ieuan*, a house in Glamorgan, the inheritance of a family that is in possession of a Welsh Manuscript Bible, translated by an ancestor, about a hundred years before the printed version. *Coed Celyzson*, the Forest of *Calidonia*, in North Britain; but, as may be easily supposed from the import of the word, other extensive woods in the island were also called by the name of *Celyzson*.

It would be logical that the place so many refer to as Gal would be the origin of the Gals in Europe, suggesting that the Gals spread from Britain to Europe and not from Europe to Britain.

The Great Orme copper mine is the biggest prehistoric copper mine in the world and bronze would have been of high value and a big reason for many to travel to Britain to trade, it would have been considered an extremely important place for the wealthy to trade, Britain would have been very well known far and wide,

This is why it had to be hidden as part of the rewriting of British history and what better way to belittle the most advanced group of people in Europe than to refer to them as Celts, the primitive group of peoples. Redefine Celt and make it so they came from Europe to Britain and suddenly you have hidden the truth, you also change Gâl to Gaul for that extra touch of deception.

The Gâls would then spread from Britain to Europe into the likes of Brittany and the Celts in what we now call France were pushed south.

Gwâl is the welsh for a cultivated country, referring to a country of Gâl.

In welsh the suffix -es creates a collective noun, so Gwâl becomes Gwâles to get a collective of cultivated countries, so all the kingdoms in Britain that were Gâl.

In welsh the mutation of words beginning with G is to drop the G, so Gwâles becomes Wâles. So for example Pays de Galles and Wales, both mean lands of the Gal.

The same will apply to Cornwall, the welsh words Corn + Gwâl, the G being removed because of the soft mutation, resulting in Cornwal.

Gâl, s. m.—pl. gelli (ga—al) What is uttered, ejected, spread out, or cleared; an epithet for milk; a cleared or fair spot; a plain; a goal, or conspicuous station; also what breaks out, or makes an irruption; an enemy. The *Cymry*, though they were generally careful of preserving their patronymic name, were often called after names characteristic of the countries they inhabited. The two most universal of which being the open plains and the woods, hence originated the two grand distinctions of *Gâl* and *Celt*, or the *open plain* and the *covert*, with others of similar import. Of the same meaning with *Gâl* and its derivatives are *Gwâl*, *Prydain*, *Paithyw*, *Gwynnes*, *Gwent*, and *Sylkrog*, fair or clear regions. With *Celtaid*, may be classed the *Gwyzyl* or *Gwyzelod*; the *Ysgotaid*, or *Ysgodogion*, and *Celysion*,—the people of the coverts; of whom it is remarkable to observe that not one became so powerful and stationary as to confer its name on the country. These two classes subsisted by different means, the result of which must of necessity have been a state of warfare; hence with the *Celt* the appellation of *Gal* came to be synonymous with *Enemy*; for as the *Gâl* or cleared region, became too fully peopled, it sent out colonies in search of other settlements, to occupy which war must frequently have been the consequence.

schooling system, and what realisations did you have?

David Adelman [DA]: I was eight years old, having just enjoyed a Year 4 of immense fun with one particular classmate who loved clowning around as much as I did. We were then deliberately separated and put in different classes; school was never the same again. I soon realised that schooling was no laughing matter. Having fun, apparently, is seen as a threat to the status quo. Of course, I didn't fully appreciate all the implications, but the seeds of disillusion and discontent were well and truly sown.

RICHARD HOUSE [RH]: David, as we're both Oxbridge-educated, we know the education world close-up. When did you wake up to the nature of the

RH: That's an early awakening. Did you later start to put theoretical bones on your disaffection, e.g., by reading literature challenging institutional schooling?

DA: I'm not much of an academic. 'Academic' means 'of no practical use or value' (Oxford English Dictionary). I've never really read much about schooling; I prefer hands-on observation.

In Spain in my early thirties, I taught English as a foreign language, and saw how the Spanish education system turns out generation after generation of young people with substantial English Language qualifications, but who can barely understand or speak a word of it.

Learning a language is an organic, multi-sensorial experience, while learning a language in school is mainly a textbook exercise that simply gives the teacher a job and the student a worthless paper qualification.



RH: Can you describe how the current schooling system militates against multi-sensorial experiential learning? - including the damage this does to healthy child development.

DA: How long have we got? Young children are bundles of restless energy and boundless creativity. Incarcerating them in a room and confining them to a chair traumatises them both psychologically and physically.

It deprives them of life and lived experiences. Without lived experiences in a risk-filled environment, they do not develop wisdom, common sense or a moral compass. Playful, fun and engaging activities are not seen as relevant to learning in schools - it's all about mechanical tasks and checking boxes, so any natural eagerness to learn and innate imaginative creativity inevitably take a nosedive.

A study sponsored by NASA, following 1,600 boys and girls from 2005 to 2015, found that schooling decimates creative, out-of-the-box

thinking and the amazing outcomes it can produce. At age 5 (in 2005), 98% of the boys and girls were found to be creative geniuses.

After five years of schooling (in 2010 at age 10), it was less than one third. After a further five years of schooling (in 2015 at age 15), barely one in ten had their creative genius intact.

In a class of 30 children, with the centre of attention mostly being the teacher, each child gets 10-20 seconds per hour of class airtime to express who they really are and what they feel, think or want. I call this 'oxygen starvation'. Without oxygen we cannot breathe or show up as living individuals; we die.

I refer to the outcome of this schooling model as 'collective solitary confinement', and to the effect it has on us as 'complex post-traumatic stress disorder'.

It's complex in the sense that it's acquired overtime, is subtle and endured by all of us, and therefore hidden in plain sight.

RH: That's a damning testimony. Can you say something about the implications of all this for later in life? And tell us something about your book.

DA: You'll likely have noticed a recent deterioration in humanity. People leave school demoralised, addicted to all kinds of things (especially AI-related) and, above all, dumbed down. There is a pandemic of nescience, i.e., not knowing what we don't know. And if we don't know what we don't know, how on Earth can we fix any problems brought about by that not knowing?



The Globalists know exactly what we do not know. That's the upper hand they have, and it's the secret of mainstream schooling. The global agenda can only be achieved inside classrooms that are captured - and they have been.

The system is a Godless, faithless platform in which materialism is rife, and the spirit and joy of learning and living are compromised, usually for life.

Schools are churning out generations of what I call narcissistic cynics [narcynics?]

[-Ed.] It's the 'me, me, me' generation with an overblown sense of its own importance. God's been removed from the bigger picture - replaced by the expert or celebrity, with people now self-identifying as always right, always righteous. Any dissenting voice is quashed as not coming from approved authority figures.

Today's youngsters also have an unbearable arrogance towards their elders, seeing them as the great uneducated - 'If you don't have a recent qualification, you're a nobody'. I'm always keen to stress how schooling is now virtually 100 per

cent academic, therefore 'of no practical use or value!'

Much of this philosophy is expanded in my book. Many parents have removed their children from school simply after reading chapter one.

Today, keeping your children out of school is the only humane option. But if not immediately practicable, I've developed an in-class remedy which we might feature in a future interview.

We're safeguarding the children's future, and it's they who must learn the art of self-affirming, peaceful non-compliance. Sources:

THE CHOICE OF RACIAL NONEXISTENCE OVER EXISTENCE, of racial death over racial life, of racial discontinuation over continuation, and willingness to reject and repudiate the racial behaviours to which one belongs, is Racial Nihilism.

The term "nihilism" is derived from the Latin "*nihilum*," which means "nothing." Nihilism is literally Nothingism. There are various forms of Nihilism, each denying the existence; through a reduction to nothing, of a behaviour that has existed through many generations.

Laterally and artistic Nihilism rejects and repudiates distinctions or standards in literary or artistic merit or value. Nihilism is the rejection and repudiation of moral distinctions or standards in literary or artistic merit or value.

Moral Nihilism is also the rejection and repudiation of moral distinctions, standards and values. Racial Nihilism is the rejection and repudiation of all racial distinctions and values. It either denies racial existence or seeks its annihilation; literally, its reduction to nothingness or nonexistence.

The ideological motivation for Nihilism is often a radical or extreme Egalitarianism which seeks to abolish all inequalities by abolishing all distinctions, differences and diversities, as well as all values and standards. But whatever its motivation or form; whether moral, cul-

tural or racial, Nihilism is an ideology of denial and destruction. It denies the very existence of the behaviour it seeks to destroy. As Moral Nihilism commonly asserts that morality does not exist, so Racial Nihilism denies the existence of races, claiming that nothing exists to preserve or conserve.

This is racial Deconstructionism, the ideological reduction of race to nothingness, defining race out of existence by “deconstruction” its terms or classifications.

This denial is often implied or indirect, as in the following statement by Miami Herald columnist Joel Achenbach, who writes that “...’races’ are the arbitrary inventions of the Colonialist era.” (Robertobaby, Tropic, April 5, 1992, p. 19)



Sometimes the denial by deconstruction is explicit and direct, as in the following assertions by Joan Steinau Lester, (left) executive director of Equality Institute, a “diversity consulting firm,” who writes:

“The idea of ‘white’ is a fiction, created at a time when Europeans were labelling and classifying everything—’Race’ is a system of thought created for the purpose of maintaining separation and power.

As we attempt as a nation to dismantle “racial” divisions and inequities, it is time to disassemble the ideas and words made to fortify the old ways—Folks, race is a bigger scam than Santa Claus.

Not only does this dog not hunt, it doesn’t exist.” (Is He White? Is He Black? And, Can You Always Really Tell? The Miami Herald, February 20, 1994)

Actually, it was during the era of Western discovery and exploration; of which the colonialists era was the final expansionist phase, that the different races of humanity became aware of each other, that actual knowledge of human racial diversity began to replace centuries of myth and speculation, and that the study of human racial diversity became a serious scientific discipline.

Yet, This Has Not Resulted in the Masses Accepting the Fact That Every Single Civilization Can Be Ascribed Only to the White Race.

The Blacks have never had a civilization for they are not capable of creating one; the Yellow race has never had a civilization until members of the White Race went into Asia, which were most likely Abraham’s children from his wife Keturra, as they were sent east so they would not come into conflict with Abraham’s children, the Israelites.

Racial Nihilism can be defined as any system of ideas, beliefs, and values that opposes racial preservation and conservation, that supports or promotes the causes of racial destruction, or that denies racial rights, especially the racial right to life and the conditions of separation required for continued racial life (racial preservation).

Those who reject the continuation or preservation of their own race are Racial Nihilists regardless of whether or not they also oppose the continuation of other races. Thus some Racial Nihilists only reject the continuation or preservation of their own race, while approving the continuation of other races.

Other Racial Nihilists reject the continuation of all races, all racial differences and all racial diversity, seeking an egalitarian leveling of all humanity into one uniform race consistent with the goal or dream of the "One World" ideology. These people are those who believe they are more intelligent than God; which

shows that instead of being intelligent they are fools.

Racial Nihilism, in its rejection of racial values, caring and love, holds that it is wrong to value, care for and love one's own race, and even more wrong to value, care for and love it more than others, or to accord it any preference or special concern.

Racial Nihilism demands the egalitarian elimination of all racial particularities and distinctions, preferences and concerns, and asserts that it is wrong to value, and care for and love one's race in any degree, even the same as others, if that valuing, loving and caring includes a desire for the preservation and continuation of one's own race in distinction from others.






